On April 9, 1968, Lieutenant LOURNE PHELPS, Richmond, California Police Department, advised that he received a call from his mother, Mrs. THELMA PHELPS, 2001 Mitchell Avenue, Oakland, California. She requested this information be treated in confidence as to source.

Several months ago an individual, white male, GEORGE EDWARD MURRAY, an ex-convict from California Prison System, was living in her home. He has a record at the California State Bureau of Criminal Identification and Investigation (CII) with photograph. He left a few months ago to move to Chicago, other whereabouts unknown. He fits the general description of the assassin of MARTIN LUTHER KING, JR., and made a comment before he left that he was going to Chicago to "shoot a nigger." She has no further information.
