AROUND THIRTYFIVE. HIS EYES HAVE A STARE AND YOU FEEL LIKE HE IS LOOKING THROUGH YOU. HE IS STAND-OFFISH, HE DOES NOT MIX IN THE PARTY. HE IS A SLENDER MAN, AROUND FIVE FT. TEN TO SIX FT. HE HAS DARK HAIR THAT APPEARS TO BE A CREW CUT GROWING OUT AS IT IS NOT EVEN ON HIS HEAD. HE HAS A SIDE GRIN OR SMIRK ON THE LEFT SIDE OF HIS MOUTH, PULLS HIS MOUTH BACK LIKE A GRIN. WHEN HE PULLS HIS MOUTH BACK TO SIDE, SPACE IS NOTICEABLE BETWEEN UPPER TEETH. THIS SPACE CANNOT BE SEEN EXCEPT WHEN HIS MOUTH IS DRAWN BACK. HE HAS A SMALL GOLD BAND ON HIS RIGHT LITTLE FINGER. IT IS PLAIN GOLD AND MIGHT POSSIBLY HAVE AN INITIAL ON IT. HE IS A MEAT DRESSER, BEING CONSERVATIVE. USUALLY WEARS A SUIT. SHE SAW HIM ONE TIME WITH A REAL SPLASHY SPORT SHIRT ON. SHE HAS NEVER SEEN ONE LIKE IT BEFORE OR SINCE. IN OTHER WORDS, HE DIDN'T BUY IT AROUND HERE.

SHE HEARD HIM MENTION NAME "JIM RUBINO." WHO IS SUPPOSED TO BE A MEMPHIS MAN, AND THE NAME OF DUKE, WHO IS SUPPOSED TO BE A MEMPHIS PARTY. FROM WHAT SHE COULD FIND OUT ABOUT HIM, HE IS FROM AROUND BIRMINGHAM, AND ATLANTA. HE TAKES GREEN PILLS AND TRAVELS BETWEEN BIRMINGHAM, ATLANTA, AND CALIFORNIA, AND IS MIXED UP WITH SOME SUPPOSED TO BE BIG TIME SAFE BURGLARS, ONE

Referenced teletype indicated that one ROBERT OWEN SHERIDAN was arrested by local authorities at Holly Springs, Mississippi on 4/8/68 on vagrancy charge.

When interviewed SHERIDAN advised that he had arrived in Millington, Tennessee on Thursday, April 4, 1968, and was currently registered at the Rip Van Winkle Motel in that city. SHERIDAN advised that he had gone to Holly Springs, Mississippi, on 4/7/68 and had registered at the Holly Inn Motel because he was unable to make long distance telephone calls from Tennessee as all the phone lines were tied up.

Investigation at Memphis indicates SHERIDAN registered at Rip Van Winkle Motel 4/6/68 and was still registered on 4/8/68. Registration card at Rip Van Winkle Motel indicates subject driving 1966 Cadillac with Illinois License NJ 167. Miscellaneous clothing, a polaroid camera and one U. S. Royal Laredo tire 900x15 had been removed from his room by the manager and was being kept in the manager's office.

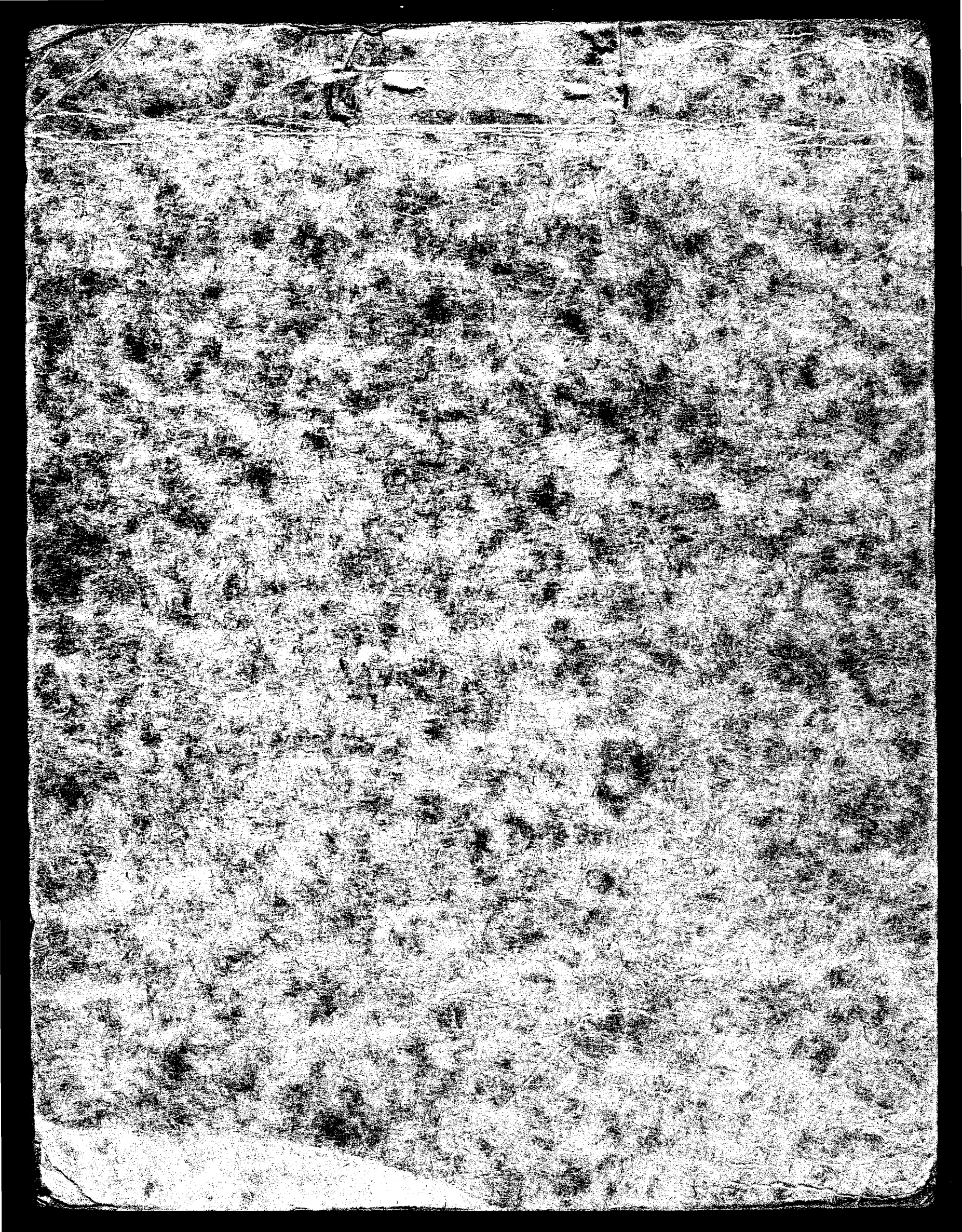
