On April 9, 1968, EDWARD BURGARDER, 917 6th Avenue, Erie, Ellinois, was interviewed and furnished the following signed statement regarding his attendance and activities of a training camp held by the Minute Men at Coal Creek Canyon, Colorado.

"April 9, 1968 Erie, Illinois

"I Edward Bungardner, 917 6th Avenue, Erie, Illineis make the following and voluntary statement to J. Glenn McEenzie who has identified himself to me as a Special Agent of the Federal Bureau of Investigation.

"On approximately the first week of August 1967 I attended a training camp for Minutemen at Coal Creek Canyon, Colorado for approximately two weeks. Instructors at this camp were primarily Robert DePugh and Walter Payson. The primary purpose of this camp was to familiarize the persons in attendance with with guerilla warfare in the United States when decided by DePugh that the country had been taken over by the Communist Party. This warfare was to be conducted by the members of the Minutemen Organization headed by DePugh.

"Among the training sessions held at this camp, one or more sessions was taught by DePugh and delt with the physicological and monetary advantages of robbing Federally insured banks. DePugh stated that this would be done and the time was new. He also included as prospects for robbery and bombings, U.S. Post Offices and other Federally insured or endowed organizations where money could be obtained for the continued operation of the Minutemen and to create fear and have among the employees of these institutions. He stated that this would also create publicity to draw the criminal element and extremists over to the Minutemens side. He also stated that stickers were being printed that would indicate them. > were done by the Minutemen and that they would be left whenever a bank was robbed or boabed so as to create the fear among the bank employees.

In order to accomplish these robberies and bombings, strike teams were appointed by DePugh consisting of four to seven members. I was appointed to a team consisting of Vincent DePalma, Jim Peters, true name Bagwell, and Mary Tallerton. We were not furnished with the identity of the members of the other strike teams but we were told that teams had been set up at points all over the country. Our strike team had cabin located in Green Mountain Resovoir, Colorado which was rented by DePalma. This cabin contained food, clothing, arms, amounition, dynamite, radio equipment and other miscellaneous supplies to be used by our strike team when needed to commit a robbery or bombing and as a hideout following such an activity.

Our first strike team assignment was to be the robbery or burglary of a Coin dealer in Aurora. Illinois, but this did not take place as I quit the organization when I found out its plans and aims were not that I had though them to be.

"After I completed the training at this camp I returned to Independence, Missouri, the Headquarters of the Minutemen where I acted as a guard because of a previous bombing of the Headquarters. It was at this time that I contacted the FBI in Mansas City and related to them the activities and identities of the people that participated in the Colorado training school. Thereafter I returned to Denver, Colorado where I contacted Bob Whearley of the Denver Post newspaper and related by stery to him. BUMGARDNER furnished the following named pamphlets issued to him by the Minutemen Organization at the training camp in Colorado: (1) The "Minutemen" America's last line of defense against communism; (2) Principles of Guerrilla Warfare; (3) Minutemen Training Program; (4) Field Expedient Flame Land Mine Devices used by the United States Army; (5) Training Tape B-2 Outline; (6) Combat use of the Rifle. These pamphlets have been made a part of the Chicago file.

BUMGARDNER further advised that he has a large quantity of printed material and personal noted regarding his activities with the Minutemen stored at his father's residence, HARRY L. BUMGARDNER, 4212 Wells Drive, Fort Worth, Texas.

On 4/16/68, BUMGARDNER furnished the identify of the following persons whom DE PUGH might contact and who could possibly furnish his present whereabouts: KENNETH GOFF, head of the Soldiers of the Cross, Evergreen, Colorado; TERRY HELM, 11216 Flamingo Lane, Dallas, Texas, head of the Young Patriots, the Youth Division of the Minutemen; RICHARD RUPERT, 2811 SRD Mize Road, Blue Springs, Missouri, who reportedly devotes large sums of money to the Minutemen.

BUMGARDNER further advised that he recalls that the Minutemen had a farm house rented for possible hideout use in September or October, 1967, that was located 11 or 12 miles out from Independence, Missouri. He said he was taken there on one occasion at night and does not recall any directions. He stated the house was rented by VINCENT DE PALMA from a local real estate dealer in Independence.

BUMGARDNER further related that DE PUGH always stays in Holiday Inn Motels when traveling and that he has thought that DE PUGH might have some connection with the head management of the Holiday Inns as he had at one time observed numerous Holiday Inn room keys in the possession of DE PUGH and that they did not look like the normal Holiday Inn room key. He surmised that they may have been management keys but did not know for sure.

DIRECTOR J. EDGAR HOOVER SAID THAT A SYSTEMATIC AND EXHAUSTIVE SEARCH OF LATENT FINGERPRINTS UNCOVERED IN THE DR. KING CASE AGAINST THE FINGERPRINTS OF THE OVER 53,000 PERSONS FROM WHOM "WANTED NOTICES" HAVE BEEN POSTED IN THE FILES OF THE FBI"S IDENTIFICATION DIVISION LED TO THE DETERMINATION THAT GALT AND RAY ARE IDENTICAL.

MR. HOOVER SAID THAT RAY, WHO IS 40 YEARS OF AGE, WAS REPORTED MISSING FROM THE MISSOURI STATE PENITENTIARY AT JEFFERSON CITY, MISSOURI, SINCE APRIL 23, 1967. HE HAD BEEN RECEIVED AT THAT INSTITUTION ON MARCH 17, 1960, TO SERVE A 20-YEAR SENTENCE FOLLOWING CONVICTION IN ST. LOUIS FOR ARMED ROBBERY AND FOR OPERATING A MOTOR VEHICLE WITHOUT PERMISSION OF THE OWNER.

HE HAS SERVED TERMS IN THE LOS ANGELES COUNTY JAIL IN 1949; IN STATE PRISONS AT JOLIET AND PONTIAC, ILLINOIS, IN 1952-54; AND IN THE FEDERAL PENITENTIARY AT LEAVENWORTH, KANSAS, IN 1955-58.

RAY WAS AN ENLISTED MAN IN THE UNITED STATES ARMY FROM FEBRUARY, 1946, TO DECEMBER, 1948, AT WHICH TIME HE WAS GIVEN A GENERAL DISCHARGE DUE TO INEPTNESS AND LACK OF ADAPTABILITYFOR MILITARY SERVICE.
