On April 4, 1968, MARTIN LUTHER KING, JR., was shot and killed at Memphis, Tennessee.

JAMES EARL RAY, also known as ERIC STARVO GALT, W. C. HERRON, HARVEY LOWMYER, JAMES MC BRIDE, JAMES O'CONNER, JAMES WALTON, JAMES WALYON, JOHN WILLARD, and "JIM" has been identified as the murderer of KING.

A Federal warrant was issued on April 17, 1968, at Birmingham, Alabama, charging RAY, as ERIC STARVO GALT, with conspiring to interfere with a Constitutional Right of a citizen (Title 18, United States Code, Section 241). A Federal warrant was also issued on July 20, 1967, at Jefferson City, Missouri, charging RAY with Interstate Flight to Avoid Confinement for the crime of Robbery (Title 18, United States Code, Section 1073).


