At the present time the inmate's mother is living in Elgin, Illinois, and the rest of the family is scattered, with some of the siblings living in Mississippi, and Missouri, while three of them reside in Illinois. Apparently both of the parents had prior marriages; there is at least one half-brother who is reported to be a policeman in Toledo, Ohio. The inmate denies that other members of his immediate family have been involved in criminality. Following his father's death, the inmate was raised alternately by his mother and by the older brother in Deering, Missouri. According to the inmate, he gets along well with all the other family members. The family economic status was considered to be below average. The inmate grew up mostly around Gunison, Mississippi, where he attended public school to about the sixth grade. About this time he was in a serious car accident and because his grades were poor and he was a disciplinary problem, he dropped out of school. He admits that he is unable to read very well at this time. The inmate did considerable farm work in the South before beginning his several periods of incarceration. He married in 1958, in Kennett, Missouri, only about a month and a half after his discharge from the Mississippi State Prison. One child has been born to this union, a son who is eight years old. The inmate says his wife was only fifteen years old when they married and he was twenty-three years of age. There has been considerable marital dissension due to difficulty with him getting along with her family. Also, the inmate describes some problems relating to his desire to be away from home a great deal and "chasing around". Although we do not have verification, the inmate said he got along well while he was at the State Penitentiary in Parchman, Mississippi, where he was sent when he was nineteen years old. He says that he and three associates had broken into a store. He says all of his work was on the farm and despite having a few fights, he considered his adjustment record satisfactory. This inmate also served at the State Penitentiary at Jefferson City, Missouri, for forgery, but while assigned to an Honor Farm at that Institution, he escaped and received an additional sentence period. Inside the walls he worked in the Soap Factory, Cannery and Block Factory. Between incarcerations the inmate has worked as a construction laborer and has travelled around the country a great deal. He was in Texas in 1965, then to Missouri, and back to Illinois. He was again in Elgin, Illinois, for only three months when he was arrested on the instant charges. In respect to his drinking activities, the inmate says he occasionally drinks to excess,

but does not feel that this has particularly interfered with his work. He does admit that there may be some relationship between his drinking and his arrest. He denies any use of narcotics and says his gambling has not been heavy. Leisure time activities include participating in sports, fishing and hunting.

Personality

This is a slender, wiry 31 year old recidivist, who has had major sentences previously for forgery, burglary, and escape. He is a quite unstable individual with very loose family ties and a background of heavy drinking. He impresses us as being a poorly motivated, irresponsible individual who is pleasant enough in the interview situation but usually does pretty much as he pleases and drifts along in life without much ambition or long range goals. He has a number of rather grotesque tattoos on his person which generally detracts from his appearance. He is of dull normal intelligence, according to the psychological screening report. Based upon his background in other institutions, it is quite possible he might have a difficult time serving this sentence.

Classification

Group III. Without need for mental treatment and not mentally retarded. Inadequate and unstable personality with periodic alcoholism. Doubtfully improvable offender. Doubtful prognosis. Dull normal intelligence."

Interview of JAMES ROBERT WILLETT, also known as "Crazy WILLIE", "Mississippi".

JAMES ROBERT WILLETT inmate number 61027, ISP, Joliet Branch, Joliet, Illinois, advised that he is sometimes referred to as "Crazy WILLIE" and "Mississippi". He advised as follows:

He was an inmate at the Missouri State Penitentiary (MSP) at Jefferson City, Missouri, from approximately December 1, 1960, to March 13, 1965. While at MSP he never had any personal contact with JAMES EARL RAY, although he believes he knew who RAY was by sight. The prison population at MSP approximated 2400. He had no opportunity to meet RAY prior to MSP or after he left because he was arrested at Blazeville, Arkansas, on or about January 11, 1967, before RAY escaped from MSP.

WILLETT said that while at MSP he celled in "C" house and worked in the Soap Factory, Block Plant and Farm. He formed a close relationship with another inmate, RAY CURTIS, whom he would see for extended periods on weekends in the yard. He never was assigned to the same cell house or work assignment with CURTIS or for that matter with RAY.

CURTIS, to his knowledge, always occupied a one-man cell. CURTIS was in "J" cell house before going to the farm and in "G" or "F" cell house after he returned from the farm. CURTIS was assigned to the "Tag Plant" and farm.

WILLETT stated that some time before his release from MSP he had a falling out with CURTIS, when CURTIS "stooled" on him over an incident that had taken place.

WILLETT said that he can recall no conversation transpiring in his presence while at MSP to the effect that President JOHN F. KENNEDY had a "bounty" on his head or that Reverend MARTIN LUTHER KING, JR. had "bounty" on his head. He knew of no conversation to the effect that the "KKK of the South" had raised money to assassinate KING and never was privy to any conversation in this matter.

WILLETT denied knowing a CHARLES WILLIE or a A. D. CARTWRIGHT, owners of a houseboat. WILLETT stated that when he was released from MSP he went to his sisters, Mrs. LLOYD BOYD, Clarksdale, and stayed with her for approximately seven weeks. He was employed at "Billups" Service Station, Route 61, as a night man from 6:00 p.m. to 6:00 a.m. He spent his leisure time in the taverns in the Clarksdale area. He said that he had never had occasion to go to the Mississippi River.

After leaving Clarksdale, he went to Longview, Texas, for approximately three months, where he was employed by "Miles High Line" Construction Company. He resided at 413 Green Street,

WILLETT advised that he was not aware of any association between CURTIS and RAY. He said he could not say that if there was some arrangements between CURTIS and RAY that CURTIS would have told him.

WILLETT said subsequent to his release from MSP in March, 1965, he was never in a Vicksburg, Mississippi, except to pass through it on his way to Clarksdale, Mississippi.

AT TIME OF ARREST, MEMPHIS POLICE DEPARTMENT, JULY 9, 1968.

PCI THOMAS BUCKLIN, owner, Glenbrook Patrol Service, Glenview, Illinois, advised SA HARRY A. WALKER on July 19, 1968, that GLENN E. TIBBS, telephone number 729-3921, was former lieutenant for his patrol service; however, due to a foot operation TIBBS had to leave his company about June 1, 1968.

BUCKLIN advised that TIBBS resides in the Sunset Trailer Park with an address of 508 5th Street, Northfield, Illinois; however, the trailer park is just located north of Glenview, Illinois, on Waukegan Road. He explained that for the last approximately two years TIBBS had the job of checking the security of the Sportsman Country Club, Northbrook, Illinois, for the patrol service checking the Sportsman Country Club area in a roving patrol approximately three times a night and in this capacity became well-acquainted with JERRY RAY, brother of JAMES EARL RAY, and had coffee with JERRY RAY on a nightly basis during this period at the Sportsman Country Club where JERRY was employed. BUCKLIN stated that TIBBS is an extremely capable guard and a person that can be trusted in every respect.

RE: INVESTIGATION REGARDING ITEMS IN JERRY RAY'S POSSESSION
AT TIME OF ARREST, MEMPHIS POLICE DEPARTMENT, JULY 9, 1968.

The following investigation at Zion, Illinois, was conducted on July 18, 1968, by SA O. ARTHUR GRAN:

Mrs. PETER URBATES, 3803 Sheridan Road, advised that GJERDES OLSEN, previously unknown to her, had rented a cabin-apartment for one month up to July 13, 1968, when she was requested to move. Mrs. URBATES said that the reason for the request was that "men, particularly an unidentified negro, were coming to that apartment all hours of the night." GJERDES told Mrs. URBATES that she was moving to Evanston, Illinois, where she had obtained a new job. When GJERDES rented the apartment she furnished her home address as 1344 Hazel, Deerfield, Illinois, and had worked a few days at Pierce's Corner House Restaurant in Waukegan, Illinois.

According to Mrs. URBATES, GJERDES had identified herself to her as the former wife of JERRY RAY, brother of alleged assassin of MARTIN LUTHER KING, JR. Mrs. URBATES further advised that during conversations with GJERDES, she had disclaimed any recent contact with either JERRY or JAMES EARL RAY.

The following investigation was conducted at Glenview, Illinois, by SA HARRY A. WALKER, on August 6, 1968:

GLENN TIBBS, Sunset Trailer Park, 508 5th Street, Northfield, Illinois, phone 729-3921, advised that for the past two years he had been employed by the Glenbrook Patrol Service, Glenview, Illinois, as a lieutenant, and one of his assignments had been checking the security of the Sportsman Country Club, Northbrook, Illinois. This was a roving patrol and the club was checked approximately three times during the night. During this time, TIBBS became well-acquainted with JERRY RAY and had coffee with him on a nightly basis at the country club. He further stated that after the publicity broke concerning JAMES EARL RAY being suspect in the KING murder, JERRY RAY told him that JAMES EARL RAY was his brother.

TIBBS, who is presently employed as a guard at the Crane Company, Morton Grove, Illinois, by the Pinkerton Agency, advised that after JAMES EARL RAY was identified, JERRY RAY drove to St. Louis, Missouri, to see a brother, JOHN RAY, and a sister, name unknown, who also lived in St. Louis on either one or two occasions. He stated that JERRY RAY also flew to Philadelphia, Pennsylvania, on another occasion and before JERRY RAY departed the Sportsman Country Club to fly to Philadelphia, Pennsylvania, he expressed concern about transportation from O'Hare Field to Sportsman Country Club upon his return from Philadelphia; therefore, he (TIBBS) gave him his telephone number telling JERRY RAY that in the event that he could not obtain a ride from O'Hare Field to Sportsman Country Club upon his return from Philadelphia, to phone him and he would drive to O'Hare Field and return him to the Sportsman Country Club.

Note that JERRY visited an acquaintance in Camden, New Jersey, on June 5, 1968.

TIBBS stated that other than the fact that RAY told him that he had a brother JOHN RAY, and a sister, name unknown, in St. Louis, Missouri, he spoke little about his relatives or life before he became employed at the Sportsman Country Club; however, JERRY RAY did say that JOHN RAY asked him to go into the tavern business with him in St. Louis, Missouri, and JERRY RAY appeared to be very close to his brother JOHN RAY.

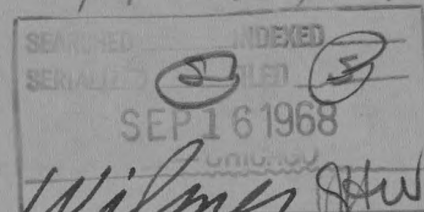

CANALE STATES THAT AFTER REVIEW OF DATA WHICH IS AVAILABLE AT LABORATORY, HE PROPOSES THAT REPRESENTATIVES OF HIS OFFICE THEREAFTER CONTACT PERTINENT FIELD DIVISIONS AND DISCUSS WITH AGENTS WHO SECURED EVIDENCE THE INFORMATION THEY CAN TESTIFY TO, AND HE WOULD AT THIS TIME ALSO TALK TO WITNESSES IN THE RESPECTIVE DIVISIONS WHOM HE MIGHT HAVE TO SUBPOENA.

CANALE ALSO MENTIONED THE POSSIBILITY THAT IN CONNECTION WITH LINING UP WITNESSES, A REPRESENTATIVE OF HIS OFFICE MIGHT HAVE TO BECOME INVOLVED IN FOREIGN TRAVEL. SPECIFICALLY, HE MENTIONED THE POSSIBILITY OF GOING TO LONDON, TO MEXICO CITY, AND TO MONTREAL AND TORONTO.

BUREAU REQUESTED TO ADVISE SUITABLE DATE ON WHICH REPRESENTATIVES OF DISTRICT ATTORNEY GENERAL'S OFFICE CAN MEET WITH LABORATORY REPRESENTATIVES TO REVIEW PERTINENT EVIDENCE AND DISCUSS FINDINGS SO THAT APPROPRIATE WITNESSES CAN BE LINED UP.

IT WAS OPINION OF CANALE THAT IF THIS PRELIMINARY WORK CAN BE COMPLETED, HE CAN BETTER EVALUATE WHAT HE NEEDS FOR THE TRIAL AND FEELS THAT ON THIS BASIS HE WILL NEED A MINIMUM OF FBI PERSONNEL TO TESTIFY AS TO THE VARIOUS ITEMS THAT MAY BE OF PERTINENCE IN THIS CASE.
