JERRY RAYNES advised that he is the stenfather of JAMES EARL RAY as JAMES EARL RAY was born in at Alton, Illinois, and Mr. RAYNES stated he married LUCILLE MAHER at Jacksonville, Florida, in the spring of 1929, 1930 or 1931. He believes he was 30 years of age at that time and that she was 23 years of age. Following their marriage, they lived in Quincy and Galesburg, Illinois, and in St. Louis and Ewing, Missouri. It was his understanding that LUCILLE was born in Bridgeton, New Jersey.

Mr. RAYNES stated he believes he was the father of all of the other children born to LUCILLE MAHER and himself. Their son, JERRY, was born in Quincy, Illinois, date unknown, under the name JERRY RAYNES. Several of the other children were born in Ewing, Missouri. His daughter, CAROL, was born there on

Mr. RAYNES stated he had received a telephone call from his son, JERRY, in Chicago, Illinois, on April 19, 1968, advising him that it appeared JAMES EARL RAY was involved in the KING assassination.

The following investigation was conducted by Special Agent JAMES A. DUFFEY:

Mr. JERRY RAYNES, Rural Free Delivery, Center, Missouri, was re-interviewed April 25, 1968. He admitted he had lived with RUBY CARPENTER, from about 1952 until 1963, off and on, as they would split up and then go back to living together.

During this period they lived in St. Louis, and Clarence, Missouri.

He could not recall the St. Louis addresses, but when 4149 West Pine was suggested to him, he stated he believes that to be the address, where RUBY and he lived from about 1952 to 1961 when they moved to a farm near Clarence, Missouri.

While in St. Louis he stated that FRANKLIN, also known as "Buzz", and CAROL lived with him, but subject never lived with him to his recollection. He stated that subject from the time they left Ewing, Missouri, did not live with him, but with Mrs. MARY MAHER, subject's grandmother.

He stated that in the late 1950s subject visited "Buzz" and he recalled subject was then employed at some bakery but he did not know which bakery. He stated if subject ever lived on Pine Street, it was news to him.

Mr. RAYNES stated that he has always been known as JERRY RAYNES, sometimes spelled RAYNS, as the former is the name his mother claims was his. He denied using the name JAMES GERALD RAY.

Mr. RAYNES also denied ever living in Des Moines, Iowa, and added he has never lived or even been in Des Moines.

He stated that when in Clarence, Missouri, he and RUBY had lived on a farm which belonged to her. He stated while there he did not go to town more than on one or two occasions, had no associates, and can not recall the names of any persons there. They lived there two years.

After leaving Clarence, he went alone to St. Louis where he had various employments. He was employed as a service station attendant for the Site Gasoline Station on Lemay Ferry Road.

He stated he owned an old store building with sleeping rooms upstairs, that he rented, operated a second hand store, and a dry cleaning store.

He sold this property in St. Louis and bought the small acreage at Center, Missouri, last September (1967). He added he is drawing social security and is retired.

He stated that he does no approve of subject's actions, is afraid of him, and what the publicity is doing to his daughter, CAROL, and her family. He stated that if he should hear anything about the subject's whereabouts he will advise the Federal Bureau of Investigation.

JERRY RAYNES

AT CENTER, MISSOURI

Mrs. HAROLD MAIDEN, next-door neighbor of JERRY RAYNES, was contacted by Special Agent JAMES A. DUFFEY on April 24, 25, 26, 1968, and May 2, 3 and 4, 1968. She stated that RAYNES had no visitors to her knowledge and no strange cars were observed by her at the RAYNES' residence.

She stated her son works for RAYNES on Saturdays and after school when needed and that he had observed no unusual activity at the RAYNES' residence. She advised that RAYNES is more or less a recluse and rarely leaves his home. He does not visit with his neighbors but is pleasant when he meets them.

Special Agent DUFFEY conducted spot checks of the RAYNES' residence on April 24, 25 and 26, 1968, and May 3 and 4, 1968, but noted no visitors or unusual activity.

SISTER MARY CLARA, Head Sister, Catholic School of Specialized Reading, 4149 West Pine, advised that that property had been a school for approximately seven years and is owned by the Archdiocese of St. Louis who also own the property immediately to the west, known as 4151 West Pine, which is used as a convent. She advised that she had no knowledge of the former occupants of 4149 West Pine but stated that a Mrs. RADKE at 4147 West Pine and Mrs. COULTER at 4157 West Pine might have information about former occupants.

Mrs. ALICE RADKE, 4147 West Pine, advised that 4149 West Pine was formerly owned by RUDY and RUTH KRACK, who sold the property to the Roman Catholic Church about seven years ago. She recalled that the KRACKs kept roomers in her home but she did not know any of these people. She did not know the KRACKs' current address except she thought they lived in the western part of St. Louis near University City, Missouri. She examined a copy of an Identification Order #4182, and stated that JAMES EARL RAY was unknown to her.

Mrs. JEWELL A. COULTER, 4157 West Pine, advised that Mr. and Mrs. RUDY KRACK lived at 4149 West Pine from the early 1940's until 1961 or 1962 when they sold their home to the Catholic Church and moved to 5950 McPherson, St. Louis, Missouri. Mrs. COULTER recalled that the KRACKs kept roomers in their home but she did not know any of these people. She examined a photograph of JAMES EARL RAY and advised that he was unknown to her.

Mrs. RUDY KRACK, 5950 McPherson, advised that she could not recall anyone named JERRY RAYNES or JERRY RYAN ever having occupied an apartment in her home at 4149 West Pine. She

stated that she and her husband purchased 4149 West Pine in 1940 and lived at that address until they sold the property in late 1961 to the Catholic Church. They moved to their present address in early 1962. Mrs. KRACK advised that she felt certain she would remember a roomer who had lived in her home for approximately eight years and she could not recall anyone ever having used the name JERRY RAYNES or RYAN. She examined a photograph of JAMES EARL RAY and advised that he was unknown to her.

Mrs. WILLIE MANNING, 1731 South 11th Street, owner of 1727 and 1729 South 11th Street, recalled that a person named JERRY RYAN (not sure of last name, could have been RAYNES) lived in an apartment at 1727 South 11th Street with a teenage son and daughter around 1960. She recalled that the children were both in their late teens and that the girl was the oldest. RYAN had no wife that she knew of. These people lived at 1721 South 11th Street for several months and moved to an unknown address, she thinks, on Menard Avenue. Mrs. MANNING stated that none of the present occupants of 1727 or 1729 South 11th Street lived at those addresses in 1960. She was unable to recall the names of persons who did live at those addresses in 1960. She examined a photograph of JAMES EARL RAY and stated that he definitely was not one of the children who lived with JERRY RYAN and further that she cannot recall ever having seen him before.

Efforts to expand the neighborhood investigation in the area of 1727 South 11th Street were not determined feasible since the entire northern end of the block on the west side of the street is occupied by a truck dock and the entire eastern side of the street is the back wall of a warehouse.

Efforts to locate residents at 1135 South 10th Street met with negative results. The southern most building in the block is now known as 1133 South 10th Street and this address is occupied by the FEDERHOFER Truck, Leasing and Rental, Inc., which occupies the entire south half of the block on the west side of Tenth Street. The buildings across on the east side of the street are abandoned and ready to be razed.

Mrs. FLORA SARR, 1012 Hickory, around the corner from 1133 South Tenth Street, recalled that the corner of Tenth and Hickory used to be occupied by a rooming house which was demolished when the present building was built about 1962. She thinks that this corner was numbered 1135 at that time. Mrs. SARR advised that the old rooming house on the corner of Tenth and Hickory was managed by a Mr. FOWLER whose first name and address she does not know. She was very sure FOWLER did not own the property but merely managed it. She stated that FOWLER was quite elderly eight years ago and may well have died by this time; in any event, she does not know his present whereabouts. She further advised that she never knew any of the occupants of the rooming house.

The following investigation was conducted by Special Agent HOWARD G. SLACK based on a communication from the Springfield Office of the FBI concerning relatives of JAMES EARL RAY:

JACK RANDOLPH, owner of J & R Auto Sales, 5901 South Broadway, St. Louis, Missouri, advised on April 23, 1968, that JERRY RAYNES was an employee of his approximately eight years ago as a salesman. RANDOLPH stated that RAYNES was employed by his firm for approximately one year. He stated that RAYNES was a peculiar individual who came to work and left when he pleased and was engaged in selling cars. RANDOLPH stated that he was not aware that RAYNES had a son but did know that RAYNES had a young daughter who he sometimes brought to work and left in the car. RANDOLPH viewed a photograph of JAMES EARL RAY and stated he had never seen this individual.

RANDOLPH stated he did not know RAYNES' address while he worked for him and had no idea where RAYNES was now although he had mentioned that he wanted to go to Acapulco, Mexico.

The following neighborhood investigation was conducted at 1915 Hickory:

The Reverend PATRICIA ANN JONES, Apartment #8, advised that she has been living at that address for three months and stated that she did not know any of the previous occupants. She further advised that this address was a rooming house and people frequently moved in and out and no one in the building had been there longer than a year.

HELEN CREAMER, 1915 Hickory Street, stated that she had resided at this address for sometime but had never heard of LUCILLE RAY, LUCILLE RYAN, or LUCILLE BERNES. She stated this is a transient neighborhood and no one residing in that neighborhood would have knowledge of previous occupants at 1913 Hickory.

On April 21, 1968, HOMER TOWNSLEY advised SAS ROBERT L. BENDER and EARL E. BROWN, a man named SMITH operates a confectionary on Hickory Street about four houses west of 18th Street, north side, in a basement. This should be about the address where RAY's mother lived on Hickory, and TOWNSLEY felt SMITH should know the mother, whether or not she is dead, and might possibly know RAY.

On April 22, 1968, SA EARL E. BROWN determined that SMITH is AUBREY SMITH, 1811 Hickory. SMITH said he is familiar with newspaper publicity concerning this matter, and while RAY may have been a customer, he does not remember him nor his mother. He stated that the two best sources of information in the neighborhood would be COLLEEN TURNBOUGH, 1902 Hickory, and SOPHIE MARTIN, 1917 Hickory.

Mrs. TURNBOUGH was interviewed and it was determined she had previously been contacted on this matter by SA GEORGE M. PEET. It was also determined SA PEET has contacted SOPHIE MARTIN. During the contact with Mrs. TURNBOUGH, however, she stated she knew LUCILLE RYAN was dead through Mrs. LLOYD BIRDSONG, who now lives at 2929 Lafayette. Mrs. TURNBOUGH said that she talked to LUCILLE only once, but that Mrs. BIRDSONG was a frequent visitor with LUCILLE.

On April 25, 1968, LLOYD BIRDSONG, 2929 Lafayette Street, phone PR 3-4894, advised that his wife is out oftown, but was expected to return during the day of April 25, 1968. He stated that since the publicity on RAY has appeared he has discussed this matter with his wife. He stated he had no independent recollection of RAY or his mother, as during that time he worked nights and slept during the day, and thus had little contact with his neighbors. He stated that his wife was not well acquainted with LUCILLE RYAN, as RYAN had a very bad reputation as a drunk and was simply not the type anyone would befriend. Mrs. BIRDSONG told her husband that RYAN was living with an older women believed to be RYAN's mother. She was known as "Old Mary." BIRDSONG believes that RYAN and her mother occupied the entire house and had no

roomers, although he understands that numerous men came and went there.

BIRDSONG was recontacted later in the day and said that his wife's return had been delayed because of illness in the family. She is visiting with Mrs. FLOYD HEADY, Fredericktown, Missouri, phone STate 3-3104. BIRDSONG stated he had discussed RAY with his wife when she called to tell him she would not be returning on April 25, 1968, and she had no information he had not already furnished. She told her husband that she was not on friendly terms with RAY's mother because of her drinking.

BIRDSONG stated that the only persons still around who lived in the neighborhood who might be able to furnish information is a Mrs. TURNBOUGH, a Mrs. MARTIN, both of whom still live on Hickory, and SMITH, the proprietor of a basement confectionary on Hickory.

Mrs. HAROLD P. TOOMBS, 2027 Bellevue, advised upon interview that the ALBERT PEPPER family had resided next door at 2025 Bellevue since around September, 1967. It was her understanding that the PEPPER family had probably purchased the property from the HOLTZ family who live on Almeda Street near above addresses. She stated the WAGNERS had rented the property next door for approximately 20 years prior to the time the PEPPER family moved in.

Mrs. TOOMBS stated she had not observed any automobiles parked in front of the PEPPER home or in the drive leading to the garage other than the white fairly late model Ford automobile driven to and from work by Mr. PEPPER. She stated she had visited with Mrs. PEPPER briefly on one occasion but had not been invited inside the home. She stated the two PEPPER children, ALBERT, age 5, and JAMES, age 4, had been overheard on one occasion talking about going fishing with their grandfather on a farm believed to be somewhere in out-state Missouri. She also recalled having heard Mrs. PEPPER remark on one occasion that either her brother or a brother of her husband had been helping Mr. PEPPER in fixing up the house.

A photograph of subject JAMES EARL RAY was exhibited to Mrs. TOOMBS and she advised she had not observed anyone resembling such a person visiting the PEPPER family.

The following investigation was conducted by Special Agents ROBERT A. HESS and HARRY C. JUNG, at St. Louis, Missouri, on April 22, 1968:

Mrs. FLOYD J. (ROSEMARY) SHIRLEY, JR., 2115 Edmond Avenue, Wellston, Missouri, advised that she formerly resided at 718 Shenandoah Street, St. Louis, Missouri, where she became acquainted with CAROL and AL PEPPER, as neighbors. This was approximately three years ago. She stated that she is not related to either CAROL or AL.

Mrs. SHIRLEY stated that she visits telephonically with CAROL on occasion but has not seen her since Christmas, 1967. She said that she had met CAROL's father, who now lives somewhere in the vicinity of Troy, Missouri, and also met her brother, JACK, who cerates a bar on Arsenal at Indiana or Illinois Streets, St. Louis, Missouri. She said she had never heard CAROL mention any other relatives other than a brother who was killed in an accident several years ago.

Mrs. SHIRLEY was exhibited photographs of JAMES EARL RAY but stated that she had never seen this individual.

The following inquiries were conducted by SA ALBERT J. RUSHING in the vicinity of 712A Shenandoah, the former residence of ALBERT and CAROL PEPPER.

On April 26, 1968, Mrs. ERNEST (JEAN) COOK, 712 Shenandoah, advised that ALBERT and CAROL PEPPER were neighbors of hers, having lived upstairs at that address for about three years until they moved away in approximately September 1967. Mrs. COOK recalled that the PEPPERS had two young sons - a boy called about five years of age, and a boy called about four years of age.

Mrs. COOK viewed photographs of subject JAMES EARL RAY stating that she did not recall ever having seen this individual and she believed he had not visited the PEPPERS at any time to her knowledge. She recalled that CAROL PEPPER's brother, who she believed was named JOHN RAY, visited the PEPPER residence occasionally and Mrs. COOK had an impression he lived somewhere in St. Louis. She had an impression that JOHN RAY was married but she could not recall having seen his wife and could not advise how she gained this impression. Mrs. COOK also recalled that CAROL PEPPER's father, who apparently lived somewhere in St. Louis, was also an occasional visitor at the PEPPER residence and not long before the PEPPERS moved away CAROL PEPPER mentioned that her father had bought a farm somewhere in Missouri and Mrs. COOK believed that CAROL PEPPER mentioned this farm was located near Poplar Bluff, Missouri. Mrs. COOK recalled that CAROL PEPPER spoke of her mother as being dead. While the PEPPERS lived there CAROL PEPPER worked at a nearby school on 12th Street near Russell Avenue where she was apparently assisting in the "Headstart" school which her older boy attended. Mrs. COOK believed this work by CAROL PEPPER was probably volunteer work Mrs. COOK understood that when the PEPPERS moved away they moved to a new address in Maplewood, Missouri.

On April 29, 1968, Mrs. MARY JEAN GOLLUBSKE, 714 Shenandoah, advised that she recalled ALBERT and CAROL PEPPER who formerly resided at 712A Shenandoah for two or three years and in approximately September 1967 when they moved to Maplewood, Missouri. Mrs. GOLLUBSKE furnished information corresponding to that previously furnished by Mrs. ERNEST COOK. She did not recognize photographs of subject JAMES EARL RAY stating she had no knowledge that this person was ever a visitor of Mr. and Mrs. PEPPER. Mrs. GOLLUBSKE also recalled that the older son of the PEPPERS was actually named ALBERT but was called "HUGHIE", which was apparently a nickname. Mrs. GOLLUBSKE also recalled that the school at which Mrs. PEPPER was apparently a volunteer worker in the "Headstart" program was a Catholic school located at 12th Street and Russell Avenue.

Both Mrs. COOK and Mrs. GOLLUBSKE stated they did not recall Mr. and Mrs. PEPPER ever having made mention of CAROL PEPPER's brother JAMES EARL RAY.

Mrs. ALBERT . (CAROL) PEPPER, age 27, of 2025 Bellevue, advised interviewing Agents that she had been married to ALBERT S. PEPPER for approximately six years. She stated she had not seen JAMES EARL RAY since some time prior to her marriage and that her husband had mever met her brother JAMES EARL RAY.

With reference to her brothers JOHN "JACK" RAY and JERRY RAY she stated she had not seen either of these individuals since they were visiting in St. Louis around Christmas, 1967. She advised JERRY RAY resides in the vicinity of Chicago, Illinois, and it is her understanding that JACK RAY is residing there also.

When questioned concerning her father she stated that her father, JERRY RAY, age about 59 years, is presently residing on a farm he owns which is located in the vicinity of Hannibal. Missouri. She denied knowing the exact location of this farm stating she had never visited it. However, she had visited in the general area near Hannibal some months ago at the time her father was looking for a farm to purchase in that area. ing to Mrs. PEPPER she is normally in contact with her father approximately once a week at which time he calls her by telephone, usually on Saturday morning. She denied having ever made a telephone call to her father, JERRY RAY, stating that she did not know his telephone number. When questioned specifically in this respect she stated she had not misplaced his number but had never been in possession of his telephone number. She advised that her father was retired, and that his only source of income was what he received from Social Security.

With respect to other members of the family Mrs. PEPPER furnished the following information:

SUSIE RAY, age 20, was raised by some unknown well-to-do family residing in the vicinity of Quincy, Illinois. Within the past several months SUSIE was married to some uknown band leader who works out of the vicinity of the Quincy, Illinois, area.

She vol-

untered the information that the last time she heard from MELBA was at Christmas last year at which time she was in jail in Quincy, Illinois.

According to Mrs. PEPPER another brother, FRANKLIN "BUZZY" RAY was killed in an automobile accident which occurred approximately four years ago on a bridge west of Quincy, Illinois. She stated when she last saw JAMES EARL RAY he was with this brother "BUZZY" in St. Louis approximately two or three years prior to the death of "BUZZY" RAY.

With respect to her mother LUCILLE RYAN, Mrs. PEPPER advised that she had died in the City Hospital at St. Louis approximately seven years ago of complications resulting from sclerosis of the liver and heart trouble.

Mrs. PEPPER emphatically denied having any knowledge or information whatever concerning the whereabouts of her brother, JAMES EARL RAY. She was specifically advised of the provisions of the harboring statute during the course of the interview.

The other deposit of size noted above, November 6, 1967, in the amount of \$460.35, is supported by deposit tickets reflecting \$100.00 in cash and checks in the amount of \$125.00, \$87.07, \$93.95, \$6.67, \$43.40, and \$4.26.

Since January 1, 1968, the only checks written on this checking account were six in January, one in February, and two in March. Checks drawn on the account in April 1968, (six in all) consisted of the following:

The application for this loan was dated August 14, 1967, and signed by ALBERT PEPPER. The application reflects that this is a five room house, the total selling price being \$10,500. At the time of the application ALBERT PEPPER resided at 712A Shenandoah and was employed by Ace Construction Company - New Market Hardware at \$100.00 per week plus overtime. His wife was employed by "Arch. Dietries" (Project Headstart) at \$50.00 a week. On the application no liabilities were listed and assets were a \$5000.00 life insurance policy on the life of ALBERT PEPPER with his wife beneficiary; cash in a savings account of \$7256.43; a 1963 Plymouth valued at \$800.00; and furniture valued at \$800.00; or total assets of \$8856.43.

Two checking accounts were located in the name of JOHN RAY both of which were closed as of April 30, 1968.

The *** account was opened November 3, 1966, with a deposit of \$339.12. At the time the account was opened JOHN RAY listed his address as 1812 Lafayette. This was changed to 712A Shenandoah and there was also a notation of an address at 1822 North 21st Street.

Three deposits were made after the account was opened ranging in amount from \$48.00 to \$68.18.

Eleven checks were drawn on this account ranging in amount from \$5.88 to \$152.00. Reference shown at the time the account was opened was JERRY RAYNS. This account was closed on July 18, 1967.

He did admit knowing his wife's brother JOHN "JACK" RAY, present whereabouts unknown, and a brother JERRY RAY who resides in the vicinity of Chicago, Illinois. He stated that the last time he had heard of these individual was at Christmas time 1967 at which time they visited briefly in the PEPPER home in Maplewood, Missouri.

PEPPER was advised of the provisions of the harboring statute and emphatically denied any information whatever which might be of value in trying to locate JAMES EARL RAY.

PEPPER advised that he and his wife were in the process of purchasing their home at that address. He further stated he was employed at the New Market Hardware in St. Louis and the salary that he makes barely meets living expenses and the amount necessary to make the payments on the home.

HARRY SCHNEIDER also made available a copy of Application for Employment for ALBERT BENNY PEPPER, dated September 17, 1964, which sets forth the following information:

Regarding information that PEPPER had allegedly seen subject JAMES RAY since his escape from prison, MURRAY and HARRY SCHNEIDER stated they had no evidence to support this, and it was merely an "impression" since PEPPER is very close-mouthed about RAY.

Regarding information that PEPPER made a comment to an employee mamed "FRED" that "his brother-in-law was arrested the same day he (PEPPRR) was arrested", FRED NEY, employee, New Market Hardware, stated he knows nothing further regarding the statement made by PEPPER, and PEPPER did not identify the brother-in-law. NEY stated it was his impression that the arrest of PEPPER was made by the Ninth District, St. Louis Police Department, and Sergeant HACKETT may know more of that.

Above individuals were shown photographs from WF-442, but each stated that person is unknown to them. Each stated that any information regarding subject RAY or JOHN LARRY RAY which comes to their attention, will be immediately relayed to the FBI.

ALBERT PEPPER was contacted on the morning of April 22, 1968, by Special Agent ALBERT J. RUSHING and Special Agent HARRY C. JUNG at the New Market Hardware Company, 4064 Laclede, St. Louis. Missouri.

PEPPER said he did not want to talk with the agents. He said he had tried to be cooperative when he was interviewed by FBI Agents at his home on the preceding Friday. He said he had nothing more which he could tell the agents and that he did not intend to cooperate any further. He said that he was at this time about to begin his daily work and that he wanted to go on about his work and not be bothered any further. He said if he continued to be bothered in connection with this investigation, he might see a lawyer and see if something could be done about it.

Inquiry was made by Special Agent RUSHING of PEPPER as to whether he was aware of the importance and significance of the investigation to locate JAMES EARL RAY, a Federal fugitive, and PEPPER replied that he was aware of this. Special Agent RUSHING advised PEPPER that there was a Federal Harboring Statute which might be applicable if PEPPER should harbor this fugitive or should withhold information concerning him. He replied he was not concerned about this because he had already supplied all the information he had at the time of a previous interview and that he was not harboring a fugitive.

The following investigation was conducted by SA GEORGE M. PEET on April 22, 1968:

Records of the Ninth District, St. Louis Police Department, under complaint number 142436, reflect that ALBERT PEPPER, 2025 Bellevue, Maplewood, a white male, born was arrested at approximately 10:00 p.m., April 16, 1968, charged with individual peace disturbance, and was released after issuance of a summons, instructing him to appear at 9:00 a.m., May 31, 1968, in Division #1, Municipal Court Building, 14th and Market Streets.

A review of the police report reflects that at about 10:00 p.m., April 16, 1968, WILMA SHIRLEY, 4318 Forest Park, a white female, 27, housewife, walked out of the liquor store at 4304 Laclede and while in front of the liquor store observed PEPPER and "JOE", whom she recognized as a tenant in the same house she had lived in. As she came out, both men put an arm around her and started hugging and kissing her. She tried to get away and walked north on Boyle Street but the men hung on and when in front of 13 North Boyle, she cried out for help. JOE ran but a witness held PEPPER until the police arrived. This report reflects PEPPER has a prior record, so he was booked as indicated above.

On April 22, 1968, Mrs. WILMA SHIRLEY, '4318 Forest Park, advised that at about 10:00 p.m., she and her six-year-old daughter LINDA went to the store, according to Mrs. SHIRLEY, for Kotex. As she came out of the liquor store, JOE, later determined by Mrs. SHIRLEY, to be JOE PRESLEY (phonetic), and another fellow (PEPPER) started kissing and hugging her and pulling at her clothes. Both were drunk and one said something to the effect, "I can give you what you've been looking for." They pulled her a short distance into the alley and when she started hollering and told her six-year-old daughter to get help, Mrs. SHIRLEY said that she was scared to death and that in a few minutes the men ran. One of them was caught and was held until the police arrived. She exhibited a brown skirt on which the side seam was torn about eight inches down from the zipper and stated this was the skirt

she was wearing at the time. Mrs. SHIRLEY indicated that she had four children, the youngest being not quite a month old, and that it was difficult for her to get downtown to the address given her by the police officer so that she could prosecute. (It is to be noted that Mrs. SHIRLEY did not know what prosecute meant and stated she did not know where to go nor whether she would go down and sign any papers. She indicated she had learned the identity of PRESLEY from his brotherin-law who resides in the same building she is currently in).

ALBERT B. PEPPER was interviewed at his place of employment, the New Market Hardware, 4064 Laclede. PEPPER stated he had never seen subject RAY inasmuch as RAY was serving time in the Missouri State Penitentiary at the time he married CAROL RAY, subject's sister. He denied having any information whatsoever concerning the present whereabouts of subject or having been contacted either directly or indirectly by subject since his escape from the Missouri State Penitentiary at Jefferson City, Missouri.

With respect to subject's brother, JERRY RAY, presently residing in Chicago, Illinois, he stated he had not seen JERRY in a couple of months. When questioned concerning the subject's brother, JACK RAY, he stated he had not seen him in approximately one nonth. He further stated he did not mix with his wife's relatives and her contact with them was her own business.

When questioned specifically concerning any communication from the Missouri State Penitentiary addressed to the Albert J. Pepper Stationery Company 712a Shenandoah, St. Louis, Missouri, PKPPER stated he and his family formerly resided at that address but he was not aware of any mail addressed to such a stationery company. In discussing this matter, he admitted that his wife might have received such a communication but denied having any information concerning this. He mentioned the possibility that if such a letter had been sent it very well could have been stolen from the mailbox and never received as they have had in the past checks stolen from the mailbox.

PEPPER was asked if he would discuss this matter with his wife CAROL and endeavor to determine whether or not she had ever received any mail or any money mailed to her addressed to the Albert J. Pepper Stationery Company, 712a Shenandoah, and he agreed to do so. During the entire course of the interview, PEPPER appeared friendly, but obviously volunteered no information whatsoever.

It was pointed out to PEPPER that this matter would undoubtedly be discussed with him again at some future date and he was apparently agreeable to this suggestion.

At approximately 9:09 this P.M. Patn. Douglas Daugherty, DSN 5531 and Patn. Gary Pratt, DSN 5934, in charge of car Adam-3 received a call to Illinois and Arsenal, at the tavern, for a report of a "Disturbance"

Upoh arrival at that location the officers were met by the barmaid of the Grapevine Tavern at 1982 Arsenal, one Neoma Regazzi, who stated that three subjects had just ran out of the tavern after coming in and starting a fight, beating one man, firing a shot in the tavern and then taking approximately Eighty Dollars (\$80.00) from the cash register. Regazzi further stated the subjects, one known to her as James VanHorn, entered a residence at 1963A Arsenal and were at that location at this time,

Investigation at 1963A Arsenal was conducted by the above officers and upon entering the building, same being an apartment building, heard the sound of persons yelling and cursing coming from the third floor Proceeding there the officers knocked on the door and informed the occupants they were Police Officers at which time one of the occupants told the officers to get lost. After repeated attempts to gain entrance to the apartment the officers were finally admitted.

Upon being admitted to the apartment the officers observed the three arrested subjects who were arguing with each other and appeared to be intoxicated. The officers also observed abrasions and blood on the subject's faces and clothing.

Upon viewing the subjects the officers then informed the subjects they were under arrest for NoStebilingtlOver \$50,00 Hill at which time all three subjects were immediately advised of their rights per MPD Form 200-19

At the time the subjects were placed under arrest Patn. Daugherty observed subject #1, James E. VanHorn, walk out of the kitched toward the front of the apartment at which time Patn. Daugherty again informed the subject he was under arrest and James VanHorn stated "Fuck you, I'm not going anywhere". At this time Path. Daugherty attempted to take hold of James VanHorn's left arm and VanHorn then jerked free backing away from the officer stating "You keep you hands off me". VanHorn was again taken by the arm and again attempted to break away from the officer by flailing his arms around. At that time the officers grabbed both arms of the subject and pushed him against the kitchen wall to handcuff him. As the officers were attempting to handcuff the subject

he again began pulling away from the officer to keep from being handcuffed. The officer then forced the subject, face first, against the wall and handcuffed the subject, at which time the subject's face struck the wall causing injury to his lower lip.

All of the arrested subjects were then conveyed to City Hospital. "I where they were treated by Dr. Goldman who pronounced James E. VanHorn suffering from a Laceration of the right index finger" and Laceration of the lower lip, treated and released. Jimmy D VanHorn was given a diagnosis of "No apparent injuries". Eugene Vaughn was treated as a Laceration of the right hand.

Above grrested subjects were then conveyed to the District Station via car 39A where James E. VanHorn was again advised of his rights per MPD Form 200-19 at which time he stated he was aware of his rights and signed Waiver MPD Form 200-18. James E VanHorn was then questioned relative to the above incident and stated he and his brother Jimmy VanHorn along with arrested subject Eugene Vaught went to the above tavern for a beer and after arriving there he and the other two subjects got into a family argument. Vanhorn stated they did get boisterous and the barmaid told them to be quiet or leave. After a few minutes VanHorn stated his wife Tina entered the tavern and the barmaid refused to serve his wife as she had no identification. VanHorn continued by stating they then decided to leave and the barmaid bogan cursing him and another man in the bar, later identified as victim Clarence Haynes, began arguing with him at which time they got into a fight. stated as they were fighting he heard a shot and thought Haynes did the shooting at which time they then got out of the tavern. Vanhorn was then questioned relative to the money taken from the cash register and stated he knew of no money taken during the fight.

Subject Jimmy D. Vanhorn was again advised of his rights per MPD Form 200-19 and stated he was aware of his rights and signed Waiver MPD Form 200-18. When questioned as to the above incident Jimmy VanHorn stated he and his brother James Vanhorn and Eugene Vaughn went to the above tavern and were having a family argument when the barmaid began cursing them. VanHorn stated another man in the bar (Haynes) also began arguing with them at which time they began fighting with Haynes and while fighting he heard a shot fired at which time they then ran out of the tavern. Jimmy Vanhorn was also questioned relative to the money taken and refused to make any statement concerning the money.

Subject Eugene Vaughn was advised of his rights per MPD Form 200-19 and stated he was aware of his right and signed Waiver MPD Form 200-18. Vaughn was then questioned relative to the incident and stated they had gone to the above tavern and while there had gotten into an argument among themselves and after a while the barmaid told them she could not serve them any more and began cursing them. At that time another person in the bar (Haynes) also began arguing with them and they got into a fight. While fighting Vaughn stated he heard a could not serve them.

shot and they then left the tavern. Vaughn was also questioned concerning the money taken and stated he knew nothing of any money taken.

The barmaid of the tavern, Neoma Regazzi, came to the District Station and was questioned relative to the incident and stated at about 9:05 this P.M. the three arrested subjects entered the tavern where she works. Same subjects being apparently intoxicated. Regazzi further stated after being in the bar for a while one of the subjects wives entered and asked to be served and she refused to serve her as she could produce no identification. Regazzi stated when she refused to serve her the men began arguing with her and cursing her and she told them to leave. After telling them to leave they then told her she had better serve them or they would get the drinks themselves and get her too. She stated she again told them to leave at which time one of the subjects them jumped over the bar and began throwing glasses around at which time a customer, Clarence Haynes attempted to stop them and the three subjects them began beating Haynes. Regazzi stated All three of these subjects continued beating Haynes until he fell to the floor behind the bar after which she ducked down to avoid being injured and she heard a shot fired by one of the subjects. Regazzi stated after the fighting stopped she then heard the cash register drawer open and the subjects then ran out of the tavern. Regazzi also stated to the officers that at the time she refused to serve them any longer prior to the fighting she also gave them their money back and asked them to leave.

Victim Calarence Haynes was interviewed and stated he was seated at the far end of the bar when the three arrested subjects were seated in the bar and a young blonde girl joined them. Firther stated that when the bar maid refused to served the young lady for a lack of proper identification the three men became argumentative and beligerant, shouting vulgar phrases one of which was "fuck you bitch, we'll get our own drinks". The three then proceeded to go behind the bar and he stood up and told the three to leave that woman alone, referring to the barmaid. One of the three subjects said "fuck you" and hit him in the face. Then all three proceeded to beat him to the floor with their fists. Haynes continue by stating after beaing beaten to the floor he pretended to be unconcious to avoid further injuries and while being beaten he heard a shot fired, but did not see anyone fire the shot nor did he see any gun. Haynes stated while faking unconciousness he heard the cash register ring open, however he did not look up to see who opened the cash register for fear of being beaten again.

Victim Ruby Wright was interviewed and corroborated the statement by Haynes adding that while the three subjects were beating Haynes she attempted to pull two of them off and they then turned and hit har twice in the face with their fists.

Witness to the incident, Leonard Young, residing 1925 Virginia, stated he had entered the tavern as the fight was going on and as he entered he heard a shot fired, however he neither saw acgunordobserved anyone with a gun. Young further stated after the shot was fired the three subjects ran out of the tavern.

Owner of the above tavern, Carol Pepper, could not be located at this writing. Licenses are issued to the above Carol Pepper and are as follows:

City #5056 Full Drink Expires 5-28-68 State #6243 Full Drink Expires 6-30-68 Federal#249659 Full Drink Expires 6-30-68

Wish to state at this time that victim Clarence Haynes was also conveyed to City Hospital #1 where he was treated by Dr. S. Eduardo who gave a diagnosis of Laceration and abrasions of the face, treated and released.

Victim Ruby Wright was also conveyed to City Hospital #1 via 39A and treated by Dr. S. Eduardo who gave a diagnosis of Contusion of the left eye, and released.

A further investigation was conducted at the scene by the officers at which time the officers observed a large amount of broken bottles and glass behind the bar, located along the east wall. Also found at the scene by Patn. Pratt was a .38 Calibre Iver-Johnson, five shot, blue steel revolver, serial #D10558. Same revolver was found in a store room south east corner of the building, lying on a shelf behind stacked beer cases in the north east corner of the store room. Same revolver contained four (4) live cartridges.

Also recovered at the scene by Patn. Pratt was a .32 Calibre spent pellet embedded in the wall south wall of the store room approximately seven (7) feet from the floor and three feet from the east wall. A one half inch diameter hole was also found in a metal venetian blind on a door leading to the store room.

The above recovered revolver was brought to the District Station at which time the three arrested subjects were questioned as to the ownership of the revolver and all three denied any knowledge of same.

The victims Haynes, Wright, and witness Regazzi also viewed the revolver and all three denied seeing the revolver or any knowledge of ownership.
