He further stated that it would not be unusual for several tires to bear the same numbers as there is no effort to definitely establish that the serial number is changed on each molded tire.



RE: THERMO SEAL LAUNDRY TAG

The following investigation was conducted by SA JAMES F. KELLY on April 10, 1968:

WILBUR LEECE, Secretary, Laundry Institute of Cleveland, 9840 Lorain Avenue, was questioned regarding his knowledge of the use of Thermo Seal Laundry tags by local Cleveland laundrys. He advised that he has no knowledge of the use of such tags and points out that he represents various laundry companies in their business contacts and has not knowledge of the actual laundry operations. He suggested, that each individual laundry would have to be contacted to determine if Thermo Seal Laundry tags were in use by each company.

R.E. SOUTHERLAND, West End Laundry Company, 10610 Madison Avenue, Cleveland, advised that his company does not use the Thermo Seal Laundry tag but uses a system known as "Permanent marking" which is a machine which prints out the first two or three letters of the customer's name on each shirt, and is permanently stamped thereon. SOUTHERLAND stated that he believed that the Bob White Laundry of Lakewood, Ohio, uses some kind of a tag and suggested that that company be contacted.

JACK ENGEL, Bob White Laundry Company, 1624 Contant Avenue, Lakewood, Ohio, advised that his company uses the "Polymark" laundry tag. He stated that this machine is made in England and is distributed by the Polymark Division of Pinnacles Products Corporation, Blaufelt, New York. ENGEL was furnished a description of the Thermo Seal Laundry tag in question and advised he was unable to recognize the code and stated that it was his opinion that such a code was not used in the Cleveland area.

He stated that the Polymark System is as follows: Assume that a tag contained the following numbers "37A31". He stated that "37" is the lot number and that each lot contained up to 80 bundles of laundry. The "A" stands for the week of the year and "31" would be the last two numbers of the customer's order number. He added that each lot is distinguished by the use of a different colored tag and that he uses 10 different colors.

ENGEL stated that he believed that at the present time only the Swift Cleaners and the Menk Brothers Laundry Company in Cleveland are the only uses of the Thermo Seal Laundry tag.

JACK HOFFMAN, Menk Brothers Laundry, 643 East 103rd Street, advised that his company uses the Thermo Seal Laundry tag which is used with the Thermo Seal Laundry marking machine which is manufactured by Textile Marking Machine Company, Syracuse, New York. HOFFMAN was furnished a description of the laundry tag found in Memphis, and stated that he did not recognize the particular code and added that it was his opinion that such a code is not used in the Cleveland area. He stated that he believed that the only other laundry company in Cleveland which uses the Thermo Seal Laundry tag is the Swift Cleaners, East 89th and Euclid Avenue. Mr. HOFFMAN pointed out that each individual laundry uses its own distinctive code. He stated that the system used by the Menk laundry is as follows: He stated that the tag appearing on a particular piece of laundry is actually cut from a roll of tape which is run through the Thermo Seal making machine. He stated that they use five different colors, each color representing a day of the week. He stated that under his system their tags could be a five letter or numbered code; such as "2H7". He stated that the "2" which also could be a two digit number indicates the lot number. He added that numbers are used to indicate men's shirts, whereas a letter would be used to indicate other garments. He stated that the "H" which is the second digit and which is always a letter, designates the week of the year. He added that in this regard the letters "O" and "X" are not used in his system. The "7" or third digit is the bundle number in the lot and there are up to ten bundles in each lot. There is one bundle for each customer. He stated that normally his company does not use laundry tags on men's shorts or other small items and that ordinarily such tags are only used on men's shirts.

HOFFMAN stated that he purchases his Thermo Seal tape from which they make their laundry tags from the Sam Bernzweig Supply Company, 2061 Gehring Avenue, Cleveland. He also pointed

out that only a large company handling volume business would normally use the Thermo Seal Laundry system since it is an expensive operation.

WALTER BESSING, Plant Manager, Swift Cleaning and Laundry, Inc., East89th and Euclid Avenue, advised that his company uses the Thermo Seal Laundry tag in the course of their business. He was furnised a description of the laundry tag in question and he advised that it was not the system used by the Swift Company nor did he believe it was used by any laundry in the Cleveland area. He stated that it would appear that the laundry tag in question is the same size as that used by Swift Company and apparently the color system is also similar. He again pointed out that each individual company uses their own code system and pointed out the system used by Swift. He stated for example a tag as the following: "54J10". He stated that the "54" stands for the Swift Reail Store where the laundry was picked up. The letter "J" stands for the company operator who handled this particular bundle. The number "10" is the last two numbers of the customer's order number. He added also that the color of the tag would denote the time that the laundry was to be delivered.

BESSING stated that he buys his Thermo Seal tape from Fry Brothers Company, 10131 Elk Avenue, Cleveland. He added that as far as he knew the only company, besides himself, in the Cleveland area that uses the Thermo Seal tape is the Menk Brothers Laundry.

JOSEPH MOLNAR, Sam Bernzweig Supply Company, West 20th and Gehring Avenue, advised that there are only two companies who use the Thermo Seal tape, namely the Swift Laundry and the Menk Brothers Laundry. He pointed out that his company furnishes supplies to laundries in the greater Cleveland area from Lorain, Ohio east to Painesville. He added that the tape in question can only be used on a Thermo Seal making machine which is made by the Textile Making Machine Company of Syracuse, New York.

JOHN KNIFIC, Warehouse Manager, Fry Brothers Company, 10131 Elk Avenue, Cleveland, advised that his company furnishes supplies to laundrys throughout the Northern, Ohio area from Toledo on the west to Mansfield, Akron, and Canton in the South, Conneaut in the east and to New Castle, Pennsylvania in the southeast area. He stated that his only customer in the Cleveland area is the Swift Laundry and the Strater Cleaners, 2757 Monroe Avenue, Toledo, Ohio. He stated that his company also maintained distribution points in Cincinnati and Louisville, Kentucky. He stated that the only company to his knowledge that uses this particular Thermo Seal tape in Cleveland, is the Menk Brother Laundry.



Textile Marking Machine experts also stated this machine is defective in that it is producing a tape 1 1/16" long instead of 1 1/8" long and is not projecting the tape far enough resulting in cutting off a portion of the first letter. The code used in the Northeast part of the U.S. is as follows:

The first letter O stands for lot number; the first number 2 indicates the day of the week, two being Tuesday; the second letter indicates the first letter of the store name, this is the letter B; the last number is the bundle number, this is 6. Color coding of the tag may designate various things such as a different month or the identity of a store in a chain. Experts also state the use of this system on laundry items is unusual in that the system is normally used on garments being dry cleaned.

The Bureau has instructed that all textile machines using this type tape be located and machines using this code be identified.
