Complainant, who was assured following info would be (strictly stated that on this date he noticed an article with pictures in the new issue of Life re subject RAY. *confidential*)

He stated that after consulting with his wife, because he did not want any publicity if anything occurs with his info, he had decided to notify the FBI that he believes he saw [REDACTED] on 4-22-68 on the corner of routes 46 and Old 82, Holland, Ohio. This area is referred to as Holland Corners.

The [REDACTED] noticed male as he "looked out of place" in this area. The doctor further described male as wearing tweed sport coat, green trench coat, had chisled nose, bright eyes, slight beard.

Male could have been headed for Ohio turnpike, Niles or Youngstown, Ohio.

By airtel dated April 19, 1968, the Memphis Division advised as follows:



She revealed that she had read quite a bit about the murder of Reverend MARTIN LUTHER KING, JR., in Memphis, Tennessee, on 4/4/68, and felt that there was a remote possibility that [REDACTED] could have been involved. She stated that when she last saw her [REDACTED] was driving a white Mustang and this was on Saturday, 4/13/68. She stated that she hadn't previously heard anything from [REDACTED] since 7/67, and knows that during part of that time he was in Florida.

She described her husband as follows:

[REDACTED] had been in telephonic contact with her recently and had tried desperately to get her to leave her present husband and go away with [REDACTED] indicating he had plenty of money.

She stated that she is unaware of any current employment her [REDACTED] might have although she knows that for a number of years, [REDACTED] has been a member of Local 18 of the Operating Engineers Union.

She revealed she divorced [REDACTED] and on a number of occasions in the past, when he has been drinking, he has threatened to blow her head off and on one occasion, [REDACTED] actually tried to shot her and her daughter.

She revealed that his last known employment was working for his cousin, [REDACTED] who operates a wrecking company.

Mrs. [REDACTED] indicated that the FBI should be extremely discreet in checking out [REDACTED] because if [REDACTED] learned that she had turned him in as a suspect, [REDACTED] wouldn't hesitate to kill her.

On 4/16/68, [REDACTED] Vice President, Operating Engineers Local 18, advised that [REDACTED] had paid his Operating
