On April 10, 1968, it was determined through inquiry that there are seven laundries in Amarillo that do family-type laundries. None of the seven use the "Thermo-Seal" machine. The laundries in Amarillo that use this type marking machine are one engaged in commercial type laundry work.

It was determined that the "Thermo-Seal" machine is sold in this area by the State Chemical Co., 200 S. Houston St., and this company employs two salesman, one that works in Amarillo, and an outside salesman. The Amarillo salesman is WILLIE EVERETT, and the outside salesman, who covers all towns in the Texas panhandle, is JOE SADDOKIS.

The above salesmen were contacted, and could furnish no information of value.

All of the laundries doing family type laundries were contacted in Amarillo, and nothing of value was learned.

The following investigation was conducted by SA Del D. Drake, Jr. 4-10-68 and all investigation in an attempt to identify laundry markings OZB-6, DZB-6, O2B-6, and D2B-6 met with negative results. It will be noted that there were three RIBBON RITE marking machines found in the Paris, Texas RA territory and these machines, which are manufactured by Textile Marking Machine Co. INC., Syracuse, N. Y. are not used and never have been used with red ink.

The persons contacted and their remarks are set out:

Paris, Texas

Eddie Andrews, Ideal Laundry such a machine described above but does not use it as it has been held as a spare. Much of his marking is done with pen and he uses a heating process machine for other marking. Never has used red ink and his records failed to reflect any such a mark as described above.

Andrews also stated that he does all of the laundry for Southern Cleaners, East Side Cleaners, Paris, Texas as well as Modern Cleaners, Clarksville, Texas. Andrews also said that he is the only company in Paris which has in possession a Textile Marking Machine Company, Inc. Ribbon Rite machine. He also said that he felt sure that the six located in the pertinent laundry mark indicates a sub-station or a Route number.

at Greenville, Texas

Quality Cleaners and Laundry - T. H. Hudson, owner, advised that he pen marks all laundry and that he does all of the laundry for Parisian One Hour Cleaners, Zenith Cleaners, George Roy Cleaners, and Sanitone. He stated that all of the laundry work in the area is done by his concern and the White Star Laundry and that White Star took care of the laundry for the balance of the cleaning establishments in the area.

White Star Laundry - Harold Robinson, manager, advised that he pen marks and also uses a Ribbon Rite marking machine manufactured by Textile Marking Machine Co., Inc., but that he had never used red ink. He pointed out that his concern does all of the laundry for Felts Dry Cleaners, Master Cleaners, Patterson Cleaners, and Serv All Cleaners and that all of the markings for these concerns are the same as his own, some penned and some on the machine. Robinson stated that he did not keep a record of his laundry markings but he could not recall such a marking nor could his other employees who operate the marking machine. He stated that under no circumstances would he use the digit "6" at the end of one of his markings since this would mean a route or sub station designation.

at Commerce, Texas

Commerce Steam Laundry - J. T. Roberts advised that he did all of the laundry work for all of the dry cleaners in Commerce and vicinity in addition to his own and that he used pen markings. He advised that the following cleaners were in the Commerce area: DeLuxe Cleaners, Lambert Cleaners, Model Cleaners, Sparks Cleaners, and Vernon Cleaners.

at Bonham, Texas

Bonham Steam Laundry and Dry Cleaners. Jean Howard, manager, advised that her concern uses both pen markings as well as the Ribbon Rite Marking Machine, manufactured by the Textile Manufacturing Company, Syracuse, N. Y. She said that she never uses red ink and that her concern does all of the laundry work for the Cleaners in Bonham and the surrounding area and they are as follows: Jess Bono Cleaners; Bontex Cleaners; Center Street Cleaners; Davis Cleaners; Duff Cleaners.

at Mt. Vernon, Texas

Hogan and Campbell Laundry - Laverne Campbell, manager, advised that pen markings were used for laundry marks and that the Zachery Cleaners and the Margarets's Cleaners both send their laundry to Mt. Pleasant, Texas for handling. There are no other cleaning establishments in Mt. Vernon.

at Clarksville, Texas

Oriental Cleaners and Laundry - Jim Missledine, owner, advised that he uses nothing but pen markings at his laundry and that Wood Cleaners and Hatters work is done by his establishment and Modern Cleaners in Paris, Texas and pen markings are used.

at Sulphur Springs, Texas

Sulphur Springs Laundry and Linen Service - George Ward, manager, advised that his concern uses practically all pen markings for laundry marks and that on occasion he uses a marking machine but that he never uses red ink. He stated that he does the laundry work for all cleaners in Sulphur Springs and they are as follows:

Edwards Personalized Service; Hines Cleaners; Mitchell Cleaners; Morgan Cleaners; and Salmon Sanitone. Ward stated that he did not keep any record of laundry markings but that he had never used such a marking as quoted to him and that he had no recollection of ever having seen such a marking and he was cognizant of most of the laundry markings since he was in such a small community. He stated that his concern also did laundry work for the communities of Quitman, Winnsboro, Picton, and Como, Texas.

at Honey Grove, Texas

Pearce Laundry - Opal Pearce, owner, advised that she did no commercial laundry and that she owned the only laundry in Honey Grove. All commercial laundry was done by laundries in Paris and Bonham, Texas. She said that what laundry work was done by her concern was on a local basis and that she used pen markings.

Recommended Action : Route to SA Holloman and then file.

He could identify no laundry in Center, Texas but noted there is a large laundry at Carthage, Texas.

On 4/10/68 Mr. W. T. JONES, Manager, Bonita Laundry, Nacogdoches, Texas, advised his is the only local laundry to use the Thermo Seal machine. His marking code consists of numbers only. He advised he has seen markings, believed to be only laundry of traveling persons, similar to the questioned markings but has no idea as to the origin of those markings. He could not identify a laundry at Center, Texas.

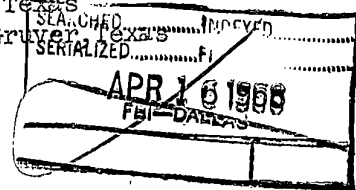
