The following investigation was conducted on 5/3/68.

AT DALLAS, TEXAS

THOMAS EDWARD RANDALL, 4800 Cole Ave, Tel 521-4968, advised he is a student at S.M.U. in his Junior year. He stated he was on American Airlines Flight 338 going home for Easter Vacation on 4/6/68. He stated his home is at 122 E. Charlotte, Millersville, Pa. He viewed a copy of I.O. 4182, advised he had seen no one similiar to the person pictured. He advised he would try to recall the persons, but was certain he had never seen anyone similiar to RAY'S photos.

He furnished the following description of himself:

W/M, 20 yrs, 5'11", 155, Dark Brown, Long hair.

He advised he had been seated in the tourist class section between a woman (on his right) and a thin man with a crewcut and briefcase (on his left).

BILLY BROWN AEBY, Stark Road, Seagoville, Texas, phone AT 6-3042, interviewed in the Dallas Office, advised he is unemployed and his wife, MARY, works at the General Office of Gibson Products Company, Seagoville. AEBY advised he has five brothers as follows:

AUBREY, an inmate at the U. S. Penitentiary, Leavenworth, Kansas;
NEAL, an inmate at the Texas State Penitentiary;
OTIS, a shampoo salesman residing in Houston, Texas;
FRANKLIN, engaged in the lumber business in Wisconsin;
JAMES, a Dallas, Texas businessman who operates a Mobil Station, Lovers Lane and Preston Road.

AEBY stated he is on bond at this time in connection with possession of narcotics charges in Dallas and Fort Worth, Texas. He said he expects to plead guilty to these charges if he can get an agreement on about eight years in the penitentiary as a sentence. He desires to begin serving his sentence as soon as possible. These are state charges.

AEBY said he entered Missouri State Penitentiary in 1961 to serve three concurrent nine year sentences for armed robbery out of St. Louis, Missouri. He was transferred to a prison farm in 1964. During the period of 1961-64 he was acquainted with JAMES EARL RAY, whom he knew as JIMMIE RAY. Both were employed in the prison bakery where RAY was considered a good worker. RAY worked both in the pastry crew and bread crew and in the latter capacity was a bread slicer and packager. AEBY speculated that if RAY were to seek a legitimate job on the outside, it might be in the bakery field since he would appear to be qualified to some degree in this area.

AEBY classed RAY as being "money hungry" and he dealt extensively in the sale of amphetamine powder and benzadrine to other inmates, such items apparently being obtained by RAY through prison guards. RAY used amphetamine on a restricted basis himself, but AEBY thought he was more interested in the money derived from sales. The amphetamine

powder is injected in solution in the human body.

AEBY stated RAY kept to himself a great deal and did not attempt to meddle in other peoples' business. The only inmate with whom RAY was apparently associated to any degree, was a man, name not recalled, 50 years old or more, who got caught with bullets in his pocket and was sent to an isolation ward as a result. AEBY recalled that on one occasion, RAY had an inmate named GREEN beaten up by two other inmates because of non payment to RAY for amphetamine powder. One of the inmates who beat GREEN up was recalled as (first name unknown) WADE from Kansas City. AEBY mentioned that one EARL HARRIS, a Negro "kingpin" from St. Louis, sold amphetamine powder to Negroes and was believed to have known RAY. He recalled also one RALPH OVERTON would possibly have known RAY, but not intimately.

The only relative RAY ever spoke of was a brother in St. Louis who was apparently a middle man for money paid by relatives and friends of inmates for amphetamine powder. This was a ~~devious~~ device by which persons on the outside would pay for the powder on behalf of their relatives and friends. RAY'S brother, in turn, was believed to have turned the money over to a lawyer who was trying to get an appeal on RAY'S robbery conviction. AEBY believed RAY'S brother was undoubtedly in the hoodlum element.

AEBY recalled RAY as having the general appearance, except for hair, of the 1960 photos of RAY which appear on the FBI Identification Order No. 4182. He said RAY normally wore his hair medium length, possibly with a part which was believed on the left side. AEBY stated he would not have recognized RAY from a stand up photo which appeared in some newspapers and would not have recognized him from a 1968 photo of RAY under the name of ERIC STARVO GALT. This name is unknown to AEBY.

AEBY described RAY as having a normally modulated voice, possibly having a midwestern accent. He said RAY had clean personal habits, did not use profanity or vulgar language to any marked degree, is likely a good dresser, and would likely have the general appearance of a businessman on the outside. He said it appeared to him RAY probably has a high school education.

AEBY said RAY was not recalled to have had any special

interest or to have ever commented regarding Negroes, Ku Klux Klan, his army service, sports, foreign travel, women friends, homosexuality, clubs, drinking, and the outside world in general. He liked to play poker and AEBY considers he was a good player. He is not a braggart, is usually mild mannered and might appear timid to persons who do not know him well. AEBY has no knowledge that RAY had any interest in "hard narcotics".

AEBY said he considered RAY'S normal criminal occupation as apparently armed robbery, based on conversation, that he would be of the "hit and run" type covering wide areas. He said he cannot conceive that RAY would have killed MARTIN LUTHER KING except for money. He said since RAY was "on the lam" he would only be asking for trouble to have killed KING except for money.

AEBY said he does not specifically recall anything unusual regarding RAY'S features or personal nervous habits. He said he would not know where to begin looking for RAY if it was his job to find him. He said he does not anticipate RAY will attempt to contact him, although RAY unquestionably knew AEBY was from the Dallas area. He stated he expects to be "on the street" for a week or more at best, but would cooperate if RAY should contact him or should other information of value comes to his attention.

Mrs. SHIRLEY VANCE, Assistant Manager, Roller Home Trailer Court, 216 South Grant's Lane, Fort Worth, stated that Mr. and Mrs. RALEIGH D. STARK moved into their trailer court about 4/15/68. She stated that they had been there prior to that date looking, but she had none until about two weeks later and she called the STARKs. She stated it was her understanding with Mrs. STARK's parents who she believes are Mr. and Mrs. B. L. PATE who reside at 8105 Tumbleweed Trail, Fort Worth, Texas. Mrs. VANCE stated that STARK is employed at General Dynamics. Mrs. VANCE examined the photograph of JAMES EARL RAY and stated she had never seen anyone resembling JAMES EARL RAY around the trailer court. She stated that STARK definitely did not resemble RAY in any way. She pointed out that STARK is a W/M, about 5'8", 210, large stomach, blue eyes, blue eyes, approximately 45 years of age. She said that the STARKs have no children. She said the STARKs appear to be very fine people in every respect.

Mrs. VANCE stated that the STARKs had a white mustang and it does have Georgia license, but she does not recall the number.

He was employed and entered on duty 4/22/68. He presently resides at 216 South Grant's Lane. His file reflects that STARK is married, no children, was a member of Veterans of Foreign Wars, Box 665, Columbus, Georgia, and is a member of Georgia Police Officer's Association. His record reflects that he was in the Army from 1944 to 1967 and for most of this time was in the Military Police Unit. The file reflects his description as W/M, born 1/5/27, 5'10", 200 lbs., brown hair, blue eyes, scars - sharpnel wounds in left leg, discharged from Army 12/67, worked as a security guard for Security Engineers, 2201 Woodard Building, Birmingham, Alabama from 12/67 to 3/68, person to be notified in event of emergency - B. L. PATE, 8105 Tumbleweed Trail, Fort Worth, Texas.

Inasmuch as it appears STARK is not identical with JAMES EARL RAY, no further investigation is being conducted regarding STARK.

On 5/4/68, ARIAN BRODHEAD, manager of the Hamilton House Apartments, 7140 Gaston Avenue, advised V. MAI TEDDER has the apartment number 103 and telephone DA 8-5533. TEDDER is a woman over 40, and spends little time at the apartment. BRODHEAD has never seen TEDDER although TEDDER has been a resident more than three years, and during the time BRODHEAD has been manager, more than a year. TEDDER has talked to her on the phone, and pays her rent regularly. She spends most of her time on a ranch in Oklahoma, believed to be the "Biffo" Ranch (phonetic). BRODHEAD stated when TEDDER is gone her (TEDDER's) nephew stays at the apartment. She described him as approximately 22 years of age, 5' 10", slight build, dark hair. BRODHEAD could furnish no information as to the occupation, relatives, current whereabouts, or the name of the nephew. She described TEDDER as obviously wealthy.

Attempts were made to contact someone at 7140 Gaston Avenue, Apartment 103, from 5/4 to 5/14/68, without success.

On 5/7/68, MRS. BIRDIE SUE BELCHER, Credit Bureau Service, advised her organization has no record of a V. MAI TEDDER.

On 5/8/68, MRS. FRANCYS WALLS, 7140 Gaston Avenue, Apartment 104, advised she lives just across the hall from a MRS. TEDDER and TEDDER had been living in the apartment across the hall regularly until the fall of 1967. She has not been living at that apartment since then except for irregular visits. She allegedly got married to a NED (LNU). WALLS did not know where TEDDER was living or whether she was employed or by whom. She advised a young man stays at the apartment and seems to keep irregular hours. She does not know this person's name as he keeps to himself and she does not know what kind of car he drives or where he works. To her knowledge,

he has no friends in the apartment building. She believes this person is TEDDER's nephew.

On 5/14/68, JERRY WYATT, 7140 Gaston, Apartment 103, was contacted and advised he is MRS. V. MAI TEDDER's nephew and he works at LTV Industries at Grand Prairie, Texas. He advised he does not know how to reach MRS. TEDDER, whether she is married or unmarried at this time, whether she is working or not. He advised he does not ask her her business and she does not ask him his. He advised he had been staying at the apartment during December, 1967, and did not recall whether or not MRS. TEDDER might have been visiting at the apartment during that month. He advised he does not know anyone in Alpine, Texas, and does not remember receiving a call from anyone there. He advised TEDDER is the sister of Deputy JOE TEDDER, Kaufman County Sheriff's Office, Kaufman, Texas, and that perhaps that person might know more about the activities of MRS. TEDDER.

WYATT was shown identification order #4182 and advised he knew no one that was possibly identical to the individual pictured.

On 5/15/68, Deputy JOE TEDDER telephonically advised his sister had married a NED BIFFLE who owns the Biffle Ranch outside of Allen, Oklahoma, telephone Area Code 405 FE 2-3516. He advised MRS. TEDDER could be reached at that location. He stated he did not believe MRS. TEDDER was involved in anything illegal or associated with subject RAY.

On April 30, 1968, Justice of the Peace S. B. CHENAULT advised he resides in the Beauclaire Hotel with RICHARD G. SHOTWELL. He considers SHOTWELL to be quite a "talker" and "bragger" and noted he had been discharged from the Merchant Marines for physical and mental disturbances.

On April 30, 1968, RICHARD G. SHOTWELL, Beauclaire Hotel, advised as he did in the letter to the Bureau. He observed photos of subject RAY and stated he cannot positively state the man he previously met was RAY, but that he believed there was a resemblance. He stated he met the individual in the Seattle Union Hall in January or February, 1968, and that RAY showed him a National Maritime Union Membership Card. SHOTWELL believes that the union would possibly have a copy of the photograph which would appear on the membership card as well as handwriting specimens. He could offer no further information. He exhibited papers reflecting that the U.S. Health Service, Seattle, Washington, had found him unfit for work due to arthritis and mental disorders.

On 5/17/68, Mr. N. L. FERRIS, Legal Attache, Mexico City, telephonically advised that ERIC STARVO GALT had been definitely determined to be in Puerto Vallarta, Mexico in Oct. and early Nov., 1967; that they were checking telephone calls and they have come up with a number of telephone calls that were made from the telephone office by an individual using the name of RAY. One such call on 11/8/67 was a collect call made to Dallas, Texas, presumably to DON LIVELY, area code 214, AD 9-5447. He stated that apparently there were eight separate telephone calls made to this number, but they have not been able to determine the other dates. There were also calls made by this same individual to Los Angeles and to San Francisco.

He stated not necessary to call him back unless we determine there is some connection, but that he is going to call Los Angeles and San Francisco and advise the Bureau that these leads were set out by telephone. The number to contact FERRIS is 25-9100 Ext. 10 or Ext. 700.

ADDENDUM: I called JAMES M. VAUGHN, JR., Security Manager, JGS:mfr Southwestern Bell Telephone Company, and requested 5/17/68 information as to a listing of AD-9-5447 as of Nov. 8, 11/8/67 1967. Mr. VAUGHN called back and advised that as of this date, this telephone was an unlisted number to DON LIVELY, 7215 Palado. The number has now been changed and his unlisted number now is AD 9-8515. It shows his business as RI 2-6620, Room 1606 LTV Tower, apparently in the investment business. His previous address as of 2/16/66 was 4324 Buena Vista, with the same business listing. He did have extra service through number LA 6-7186. VAUGHN stated that this individual has high toll records, but they are not available at this time.

his release in April, 1967, he became very friendly with an inmate identified as LEROY MC MANAMAN. MC MANAMAN was originally from western Kansas and was alleged to have bootlegged in Mississippi. According to NISSEN, he and MC MANAMAN worked together in the shoe factory at Leavenworth.

NISSEN said he had previously met MC MANAMAN before going to the penitentiary in Jackson, Mississippi, and he recognized MC MANAMAN again at Leavenworth.

Just before NISSEN was scheduled to be parolled from Leavenworth, MC MANAMAN approached him and stated that he knew NISSEN was going to Atlanta and that he wanted NISSEN to set things up for him.

MC MANAMAN told NISSEN that \$100,000.00 had been offered by the WKKKKOM to be paid to anyone who would kill MARTIN LUTHER KING.

MC MANAMAN allegedly instructed NISSEN to contact a Mrs. (first name unknown) EURE, at the Eure Realty Company, Jackson, Miss. MC MANAMAN claimed Mrs. EURE is listed as a correspondent by him at Leavenworth Penitentiary. According to MC MANAMAN's instructions, NISSEN was to contact Mrs. EURE and ask her when she next writes to MC MANAMAN at the Penitentiary to tell him "DON" had arrived. MC MANAMAN indicated he would write and tell EURE that NISSEN was "O.K."

If NISSEN wanted to try to "pull this" himself, Mrs. EURE would put him in contact with two people identified only as FLOYD (lnu), an Honorary Colonel in the National Guard at Jackson, Miss., and a second person whom NISSEN could not now recall. NISSEN stated that the unidentified person, according to MC MANAMAN had recently been appointed Deputy United States Marshal at Jackson.

A review of Leavenworth Penitentiary Parole Progress Report for LEROY BASIL MC MANAMAN dated October, 1966, disclosed MC MANAMAN began his sentence at Leavenworth on January 18, 1963. The offense is listed as receiving and concealing stolen vehicle from interstate commerce. Under the Sentence Captioned there is an entry "Harboring a Fugitive 9 Years". The codefendants were listed as BURTON HARRY HERPEL, RUBIE CHARLES JENKINS and CHARLES E. TESCHER.

The Classification Study Sheet discloses the following description of LEROY BASIL MC MANAMAN:

The Arrest Record Sheet in the Classification Study shows MC MANAMAN was arrested 12/22/34, Dodge City, Kansas, for investigation. He has numerous arrest since that time in Kansas, Omaha, Nebraska, Colorado Springs, Colorado, Oklahoma City, Oklahoma, and Springfield, Missouri.

MC MANAMAN is a native of Kansas and has resided in that state most of his life. He has been somewhat nomadic in the past several years, drifting throughout both Kansas and Oklahoma. His last residence was with his parents in Dodge City, Kansas.

Under the New Social Information, section it is indicated that MC MANAMAN writes very often to his mother who lives in Dodge City, Kansas. He has a grown son and daughter living in Dodge City and they occasionally bring his mother to the institution to visit him. He is divorced and his former wife never writes. MC MANAMAN has been writing often to a woman friend, SYBIL EURE who lives in Jackson, Mississippi. MC MANAMAN has received seven visits from SYBIL EURE and four visits from his mother and son.

The Penitentiary file indicates MC MANAMAN plans to work with SYBIL EURE in the real estate business in Jackson, Mississippi, upon his release from Leavenworth.

The file further indicates SYBIL EURE shows much interest in assisting MC MANAMAN and there seems some possibility that they may marry in the future.

Upon receiving the information from DONALD JAMES NISSEN concerning the alleged offer of \$100,000.00, Mrs. SYBIL EURE was interviewed at Jackson, Mississippi, on 8/8/67.

At that time Mrs. SYBIL M. EURE advised that she is well acquainted with LEROY MC MANAMAN and frequently corresponds with him at the Leavenworth Penitentiary. She explained that early in 1964 after becoming acquainted with MC MANAMAN she rented a room to him at her residence where MC MANAMAN stayed for a few weeks. As far as she knows this is the only time MC MANAMAN has spent in Mississippi. She does not believe that MC MANAMAN is involved or ever has been involved in any Klan activity or associated with anyone whom she new to be involved in Klan activity and that she has never been involved in any Klan activities herself.

She stated that she does not know any of MC MANAMAN's associates, does not know anyone by the name of DONALD JAMES NISSEN, nor has MC MANAMAN ever mentioned NISSEN's name. She does not know of any alleged offer of \$100,000.00 by the WKKKKOM to kill MARTIN LUTHER KING, JR. She has never heard of anything similar to this mentioned and claims not to be involved in any such plot.

She does not know anyone by the name of FLOYD who is a Honorary Colonel in the National Guard or anyone recently appointed as a United States Marshal at Jackson. She stated that her brother's name is FLOYD GARDNER but he is not in the National Guard, not a member of any Klan group, and he does not know MC MANAMAN.

The only person she knows in the United States Marshal's Office at Jackson is CHARLES SUTHERLAND, the Chief Deputy, who is a distant cousin of her former husband, JOHN EURE. She also knows BOB THOMAS, who is associated with the United States Marshal's Office. She considers both SUTHERLAND and THOMAS to be respectable people and she thought most assuredly that they would have no association with any Klan group.

On 5/13/68, Mrs. SYBIL G. EURE, 423 Raymond Road, Jackson, Miss., was reinterviewed.

At the outset she inquired as to the nature of the interview.

It was explained to Mrs. EURE that since the murder of MARTIN LUTHER KING, JR., her past association with MC MANAMAN may be of a more significant nature.

The alleged offer of \$100,000.00 by the WKKKKOM was explained to her again.

Mrs. EURE, who appears to be a reasonably successful business woman, neat in appearance, and well spoken, said she now recalls how this alleged offer all started.

She said she recalls that in 1964 when she first met MC MANAMAN, he was out on some kind of a bond waiting for an appeal. At the same time the murder of the three civil rights workers in Neshoba County, Mississippi, was at the height of publicity. Sheriff RAINEY of Neshoba County was presumed to be, at the time, an official in the Klan in Neshoba County. At least the newspapers, radio and television news stories indicated this much. During the same period her real estate business was in minor financial difficulty and she recalls casually mentioning that if she approached the Sheriff of Neshoba County she could probably get \$100,000.00 to kill KING. She said she now feels in all probability that MC MANAMAN took her casual statement seriously. She said she now realizes the seriousness of such a statement since KING's murder.

Mrs. EURE stated that she is an outspoken business woman and often passes remarks of this nature more to attract some prospective customers than anything else. She said she believes that this is the basis for MC MANAMAN's information concerning the offer of money by the Klan in Mississippi to kill MARTIN LUTHER KING, JR.

In attempting to determine the circumstances concerning her meeting MC MANAMAN in 1964, Mrs. EURE said she met him through a mutual business friend. Her association with MC MANAMAN was business. She said in her opinion MC MANAMAN had a world of knowledge

in real estate business and that if he ever gets out of prison she will always be willing to hire him as an assistant in her real estate business.

After his appeal was denied in 1964, MC MANAMAN was returned to Kansas and began serving his sentence. She said she went out to the Penitentiary on two occasions in 1964, the first time to pick up MC MANAMAN's automobile which she financed for him. All other visits, two or three times in 1965 and once in 1966, were just friendly visits. She said the last time she visited him was early in 1966 and that she has not seen him or heard from him since that time. She said as far as she knows he is still in prison.

Mrs. EURE was very apologetic, very cooperative, and stated that she has no information whatsoever concerning the person or persons responsible for the assassination of MARTIN LUTHER KING, JR. If, in the event she receives any information which may be of help in this matter she will immediately contact the FBI.

Mrs. EURE is a white female, approximately 5 feet 9 inches, slender, moderately attractive, approximately 50 years of age.

A further review of the Leavenworth Penitentiary Classification Sheet for MC MANAMAN discloses that his nine year sentence was in an operative status for 375 days due to an appeal. The Classification Study form of MC MANAMAN, Register Number 81371-L indicates that MC MANAMAN was received at Leavenworth Penitentiary in April, 1964 after his appeal had been denied.

The Bureau, through FBI Identification Division records, may wish to compare the records of DONALD JAMES NISSEN, FBI Number 607320A; LEROY BASIL MC MANAMAN, FBI Number 1244125 (as indicated in prison records) with the known arrest record of JAMES EARL RAY to determine if they were ever confined in the same prison at the same time with subject RAY.

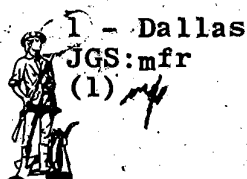

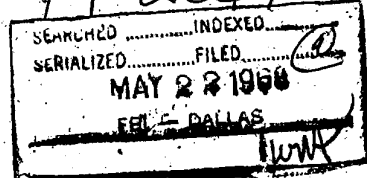

Each Special Agent in Charge and Legal Attache is instructed to promptly remind their established cooperative news sources, in a discreet and tactful manner, of the existence of substantial reward money for information leading to the arrest and conviction of the killer of Dr. Martin Luther King. This money now totals at least \$100,000. The FBI should not, however, be publicized as the source of this reminder.

While the Bureau's continuing policy is to encourage the public to furnish information to law enforcement authorities as a matter of good citizenship, without expectation of financial reward, it is fully recognized that monetary rewards are often necessary to motivate some individuals. The knowledge of the existence of the substantial rewards available in the Murkin case could possibly prove of value in the solution of this major investigation.
