SIXTYSEVEN. EMPLOYEES DO NOT REMEMBER RECEIVING SUCH A  
CALL. REVIEW OF HERTZ RECORDS DECEMBER FIFTEEN THROUGH  
SEVENTEEN, SIXTYSEVEN SHOWS ONLY RENTALS IN AND OUT OF LAKE  
CHARLES TO PERSONS WITH COMPANY CREDIT CARDS ALL KNOWN TO  
HERTZ EMPLOYEES. PHOTOS OF JAMES EARL RAY SHOWN TO HERTZ  
EMPLOYEES. RAY UNKNOWN TO ANY EMPLOYEE AND EACH ADVISED  
THEY DO NOT RECALL HAVING RENTED CAR TO ANY SUCH PERSON.

RAY REGISTERED AT PROVINCIAL MOTEL, NEW ORLEANS,

RE ANTHONY CHARLES DECARVELHO, FRIEND  
OF CHARLES STEIN.

DECARVELHO INTERVIEWED FOUR TWENTYSIX SIXTYEIGHT AND ADVISED THAT CHARLES STEIN WAS IN NEW ORLEANS THE WEEK BEFORE DECEMBER, TWENTYFOUR, LAST. ON UNRECALLED DATE HE FOUND A NOTE IN HIS DOORWAY FROM STEIN, AND THAT EVEING HE MET STEIN AT RESIDENCE OF MARIE LEE. HE HAS KNOWN STEIN FOR APPROXIMATELY TWENTY YEARS, AND IS A CLOSE FRIEND OF STEIN.

DECARVELHO ADVISED THAT STEIN WAS WEARING A BEARD, WHILE HE WAS IN NEW ORLEANS, AND HE AND STEIN HELD NUMEROUS CONVERSATIONS CONCERNING THE "COSMIC PHILOSOPHY", WHICH DEALS WITH FLYING SAUCERS, SPACE PEOPLE ON EARTH, AND ATTEMPTS TO GET CLOSER TO THE CREATOR. DECARVELHO STATED THAT STEIN IS A BELIEVER IN THIS PHILOSOPHY, AND TRIED TO CONVERT HIM.

DECARVELHO STATED THAT STEIN ADVISED " THE CREATOR PROVIDED FOR ME", IN REFERENCE TO HIS TRIP TO NEW ORLEANS. DECARVELHO ADVISED THAT STEIN CLAIMED AN INDIVIDUAL WHOM HE HAD JUST MET, NAMED GALT, HAD DRIVEN HIM TO NEW ORLEANS, AND HE WAS REFERRING TO THIS INDIVIDUAL WHEN SPEAKING ABOUT THE CREATOR PROVIDING FOR HIM. STEIN ADVISED DECARVELHO

THAT GALT WAS TRAVELLING THROUGH NEW ORLEANS TO A NEIGHBORING STATE, EITHER MISSISSIPPI OR ALABAMA, ON BUSINESS, AND WAS TO PICK UP STEIN AND TAKE HIM BACK TO LOS ANGELES, AFTER COMPLETION OF HIS BUSINESS.

DECARVELHO STATED THAT STEIN LEFT LOS ANGELES WITH APPROXIMATELY THIRTY DOLLARS, AND THAT GALT PAID FOR EVERYTHING ON THE TRIP. STEIN ADVISED DECARVELHO THAT HE FELT HE WAS ON THE THRESHOLD OF CONVERTING GALT TO THE "COSMIC PHILOSOPHY", AND HOPED TO COMPLETE THIS CONVERSION ON THE RETURN TRIP TO LOS ANGELES.

DECARVELHO STATED ON THE DAY STEIN LEFT NEW ORLEANS, DECARVELHO DROVE TO MARIE LEE'S RESIDENCE TO SAY GOOD-BYE. AS HE WALKED UP TO THIS HOUSE, HE OBSERVED AN INDIVIDUAL STANDING ON THE FRONT STEPS AND CHARLES STEIN TOLD HIM, THIS IS GALT. DECARVELHO AND GALT DID NOT HOLD A CONVERSATION, AND GALT REMAINED ON THE STEPS AS DECARVELHO AND STEIN CARRIED SUTICASES TO GALT'S WHITE MUSTANG.

DECARVELHO STATED THAT GALT HAD SOME PERSONAL ITEMS IN THE TRUNK, WHICH HAD TO BE MOVED BEFORE THE LUGGAGE FOR

RITA STEIN'S TWO CHILDREN, COULD BE PLACED IN THE TRUNK, AND GALT WALKED FROM THE PORCH AND RE-ARRANGED THE TRUNK TO MAKE ROOM FOR THIS LUGGAGE. DECARVELHO STATED HE OBSERVED SOMETHING THAT APPEARED TO BE A SURVEYOR'S TRANSIT, THAT WAS WRAPPED IN A BROWN LEATHER CASE, SIMILAR TO A GOLF BAG. HE NOTICED NOTHING ELSE UNUSUAL IN THE TRUNK. DECARVELHO ADVISED HE GAVE STEIN AND GALT A MAP WITH DIRECTIONS TO GET OUT OF THE CITY, AND THEY LEFT IMMEDIATELY.

DECARVELHO STATED THAT GALT DOES NOT RESEMBLE THE PICTURE TAKEN AT THE BARTENDER SCHOOL IN LOS ANGELES. HE STATED GALT'S FACE IS MUCH MORE SHALLOW.

HE DESCRIBED GALT AS A WHITE MALE, LATE TWENTIES OR THIRTIES, FIVE FEET TEN INCHES, ONE SIX ZERO POUNDS, SLIM BUILD, DARK HAIR, LIGHT BROWN EYES, WITH NO DISTINGUISHING MARKS OR CHARACTERISTICS. DECARVELHO ADVISED THE PHOTOGRAPH THAT APPEARS ON THE IO AND WANTED FLYER THAT WAS TAKEN IN ONE NINE SIX ZERO, IS A GOOD LIKENESS OF GALT WITH THE EXCEPTION OF THE SHORT HAIR.

STEIN SINCE THIS TIME, AND ALSO HAS NOT SEEN ANY MEMBER OF STEIN'S FAMILY SINCE THIS TIME. DECARVELHO STATED THAT STEIN, BY HIS VERY NATURE, WOULD BE RELUCTANT TO FURNISH INFORMATION TO ANY POLICE AGENCY, AND THAT STEIN WAS FORMERLY MARRIED TO MICKIE MEDINA.

STEIN INTERVIEWED NEW ORLEANS OFFICE FOUR TWENTYSIX SIXTYEIGHT, ADVISED BELIEVES MET FATHER, CHARLES STEIN, SUNDAY WEEK PRIOR TO CHRISTMAS (PROBABLY DECEMBER SEVENTEENTH) AT RESIDENCE OF AUNT MARIE STEIN LEE IN NEW ORLEANS, LA. HE INQUIRED AS TO HOW FATHER ARRIVED IN NEW ORLEANS AND WAS ADVISED THAT HE GOT A RIDE AND FATHER STATED WAS GOING TO STAY ONE OR TWO DAYS AT MOST. STATES NO CONVERSATION CONCERNING NAME ERIC OR GALT BY FATHER ON THAT DATE OR THE FOLLOWING DAY WHEN HE AGAIN SAW HIS FATHER AT THE SAME ADDRESS. DID NOT SEE RAY ON ANY OCCASION AND COULD NOT IDENTIFY PHOTOS OF RAY. MOTHER'S MARRIED NAME MARIE MCLEOD AND BOTH RESIDE THREE FOUR THREE SIX PEOPLES AVENUE, NEW ORLEANS.

MRS. MARIE MCLEOD ADVISED DID NOT SEE EX HUSBAND STEIN AT ANY TIME WHILE HE WAS IN NEW ORLEANS DURING DECEMBER SIXTYSEVEN. STATED HAS NEVER SEEN ANYONE RESEMBLING PHOTO OF GALT OR RAY AS SEEN FROM NEW ORLEANS NEWSPAPERS.

DARK HAIR, CURLY AND COMBED BACK, WEARING SHABBY CLOTHES.  
OTHER DELTA AIRLINE PERSONNEL INTERVIEWED IN CONNECTION WITH  
THIS PHASE OF INVESTIGATION AND INDICATED REHKOPF IS FLIGHTY  
AND EMOTIONAL.

ON APRIL TWENTY SIX NINETEEN SIXTYEIGHT SA PHIL RODRIGUEZ, OSI ADVISED HIS COMMANDING OFFICER AT SHREVEPORT HAD RECEIVED A CLASSIFIED MESSAGE FROM PARENTS OF RITA REHKOPF INQUIRING AS TO WHETHER OR NOT THEIR DAUGHTER WAS IN PROTECTIVE CUSTODY OF THE FBI. RODRIGUEZ STATED THAT REHKOPF WAS TO MEET HER PARENTS NOW IN THAILAND IN CALIFORNIA UPON THEIR RETURN FROM OVERSEAS BUT HAD ADVISED HER PARENTS SHE COULD NOT MEET THEM UNTIL "AFTER THE TRIAL" REFERRING TO THE TRIAL OF RAY AND THAT SHE WAS FLYING TO FLORIDA, REASON NOT INDICATED. 

On 4/25/68, JAKE STEVENS, Manager, Treasure Isle Motel, Port Aransas, Texas (an island resort community approximately 30 miles from Corpus Christi, Texas) advised as follows: On Sunday, 4/21/68, a man registered at the motel as JOHN J. De SANTIS, JR., residence Checker Board Hill Lodge, Wilmington, Vermont; driving Volkswagen 1600, bearing Bermont license 141929. He inquired if he could pay for his room in advance, stating he had no American money, only 700 Mexican pesos. STEVENS told him he could not accept the pesos, but De SANTIS could exchange them the next date at the bank.

The man was unshaven and seemed to be trying to conceal a scar on his forehead. Shortly before 2:00 PM on 4/22/68 the man left without paying his room bill or paying for food he had charged, total bill being \$15.98. He had left his room for one trip to the beach and to go to the restaurant in the motel. STEVENS was of the opinion this man very closely resembled the artist's conception of subject JAMES EARL RAY. Photographs of subject were exhibited to STEVENS and he advised he did not believe the person using the name DeSANTIS was identical with subject. However, they have very similar physical descriptions, except DeSANTIS appeared to be about 32 to 34 years of age.

On 4/25/68, BILLIE HOWELL, waitress, Treasure Isle Motel, Port Aransas, advised as follows: She waited on a motel guest using the name DeSANTIS on three occasions

At 11:00 AM this date, JOHN FORD, Legal Attache's Office, Mexico City, telephonically advised regarding information furnished San Antonio by Deputy Sheriff ANGEL STICKE GAULT regarding passengers on bus which left Nuevo Laredo on 4/6/68 that investigation thus far has developed that the bus company involved is called the Transportes Del Norte and the bus which left Nuevo Laredo is number 362. In Monterrey the passengers transferred to bus number 359 of the same company.

As regards the identity of the individual described by GAULT, Legat's Office has determined that the best possible suspect is one GRAHAM ROBERT SMITH, single, 22 years old, student, British passport, from Houston, Texas. This information was obtained through tour records.

FORD advised that SMITH was seated one-half of the way back in the bus on the left side and the source (GAULT) was in the front of the bus on the right side. The source advised that suspect was alone and was somewhat nervous and read the Reader's Digest while on the trip. Source stated that suspect did not talk to anyone during the trip.

Source also advised that suspect got off at San Luis Potosi, which is a capital of a state in Mexico by the same name. This town is located west and south of Monterrey.
