MRS. JONES ADVISED RAY EUGENE WARREN DURING NINETEEN FIFTY FOUR OR NINETEEN FIFTY FIVE INCARCERATED AT ST. LOUIS CITY JAIL FOR A PERIOD OF ONE YEAR PRIOR TO BEING SENTENCED TO A THIRTY YEAR SENTENCE AT STATE PRISON, JEFFERSON CITY, MISSOURI. MRS. JONES ADVISED IT IS HER OPINION THAT RAY EUGENE WARREN IS NOT IDENTICAL WITH JAMES EARL RAY AS NONE OF THE PHOTOGRAPHS OF RAY DISPLAYED TO HER APPEARED TO BE IDENTICAL WITH RAY EUGENE WARREN.

On 4/29/68, Mrs. ATKINSON, Secretary, Dean of Men, Rice University, advised GRAHAM ROBERT SMITH is an Abraham Scholar and a British exchange student studying Econ, Rice University, terminating study June, 1968. University records reflect SMITH at Rice University through 4/4/68 departing Houston 4/5/68 on mountain climbing trip to Mexico over the Easter holiday and has returned to Rice University.

Re phone call described SMITH as single, 22, student, British passport from Houston.

SMITH, Rice University student, identical with SMITH, Legat call and eliminated as suspect.

At 7:40 PM, 5/1/68, HUNTER HELGESON, Night Supervisor, SOG, called ASAC and stated we should obtain a photo of SMITH and forward same to San Antonio.

SA WEIR checked with the University today and determined photograph not available.

I called Supervisors LONG and KELLY, Civil Rights Desk, told them I thought this was a ridiculous lead, however, we had attempted to comply and determined no photograph available. I furnished background of SMITH, which completely eliminated him as a suspect, and both of the above stated they would advise Legat that photograph not available, and Houston would not have to take any further action.

SUBJECT: MURKIN

RE: SUSPECT GRAHAM ROBERT SMITH

At 1:40 PM, 5/2/68, Supervisor JOE KELLY, Civil Rights Desk, advised to completely eliminate SMITH as a suspect in this matter, it would be most helpful if a photograph of SMITH could be obtained for display to the Sheriff in San Antonio Division who observed a person on a bus going to Mexico that the Sheriff felt strongly resembled the subject in this case. KELLY suggested if a photograph could not be obtained any other way, then SMITH should be invited to the office and requested to submit to a photograph. He also noted that the Sheriff had recalled the person he was referring to read a Readers Digest at great length and was never observed to smoke. KELLY stated SMITH could be asked if while SMITH was on the bus did he read the Readers Digest and does he smoke. He said affirmative answers to these questions plus display of the photograph to the Sheriff for elimination purposes would negate the necessity of checking out everyone on the bus if the Sheriff would view SMITH's photograph and see that this was the person he had in mind as possibly identical to the subject.
