#### Result of examination:

Examination of Q176 ("Arrow" map of Atlanta) revealed the following markings: In area number 17, ink lines were noted on Daniel Street between Arbor Avenue and Boulevard Drive; in area number 03 an ink circle approximately 3/8 inch in diameter the center of which would be approximately on Auburn Avenue at Courtland; in area number 14, two ink circles which are approximately concentric with diameters of about 1/4 inch and 1/2 inch. The centers of these two circles lie approximately at the intersection of Simpson Road and Paines; in area number 09 an ink circle approximately 1/2 inch in diameter and the numeral 10 were noted. The center of this circle lies approximately on 14th Street between Crescent Avenue and Peachtree Road; in area number 03 an ink circle approximately 3/8 inch in diameter appears. The center of this circle is approximately at the meeting place of Highland View and Ponce de Leon Terrace.

The notations set out below were observed on Q196 ("Atlantic Richfield Co." street map of Los Angeles.") On the top of that side of this map which contains the alphabetical street listings a small pencil circle was noted in the "Van Nuys District" at the intersection of Buffalo Avenue and Oxnard Street.

On the large map on the other side of this map the following markings were noted in the Beverly Hills area. Two vertical lines in ink at the east end of the park which is located at Olympic Boulevard and Heath Avenue; vertical lines in ink at San Vicente. Boulevard and Masselin Avenue; an ink line running between the two vertical lines previously mentioned generally following Pico Boulevard and Packard Street; an ink line extending from the vertical lines at the park along Olympic Boulevard to Alfred Street.

An ink line at the intersection of Beverly Glen Boulevard and Woodruff; an ink line at the intersection of Beverly Glen Boulevard and Warnall Avenue.

Also noted was an ink marking at Sunset Boulevard and Palm Drive.

Ink parentheses were noted around the words "Somma Way" and "Rocca P1" which are located in Stone Canyon.

The pair of trousers, specimen Q202, is old and soiled. The lining and pockets are yellowed, the two front pockets have holes in them and the edge of the left front pocket is threadbare. The trousers have a "NEEDLECRAFT" label. The waist is 34 1/2 inches and the inseam is 26 inches. A name handwritten in black on the right rear pocket is probably a cleaners mark. This name appears to be "Z SOLOFF;" however, the last two letters are not clear. No invisible cleaners marks were found on Q202.

Several brown to dark brown head hairs of Caucasian origin were found on the trousers and in the pocket debris. These hairs are different from the hairs from the Mustang and Memphis scene. It was concluded that they did not originate from the same source. No hairs were found on the Q201 necktie.

Nofibers were found on the Q202 trousers or on the Q201 necktie that could be associated with cloth items previously submitted in this case.

No marks or labels were found on the Q201 necktie.

Examination of the other items described above disclosed no other pertinent information.

The submitted evidence has been retained.

"An exact copy of my letter to 7 various officers as of yesterday, Good Thursday, II-th of April, 1968 Coon Amen, Harlem, New York.

Good Friday 12-th of April, 1968

"TO WHOM IT MAY CONCERN:

"Please pass on to all the authorities wherever possible - to discontinue the search of a white man, as the killer of Martin Lucifer King, because the smart killer is right now in his own family. He is one of his own Civil Rights Urinators and a negro, not a white I was among them myself in 1965, there were many young nuts, such as was I, and also many whites. However, God opened my eyes in Alabama, when I witnessed the behavior of our marchers under King's leadership. He was a devil's minister, taking all the money he could from the jews, and was doing his work under their leadership and demand. Those were communist jews.

"Wile marching in Alabama in 1965-it was in spring-we were instructed by King's advisers-red-rat-jews to do the following:

"A group of our negroes forced their way into a nice restaurant; on a given signal, all the negroes grabbed the sugar bawls off the tables, stood up and urinated into them, amid laughter, replaced the bals on the tables-MLK laughed approvingly.

"This is the reason why I, and many others, turned against him, and it was God's will that he was shot by one of his own disciples, a negro, not a white. Please stop all your sham broadcastings and grateful homage for that killed Martin Lucifer King - he was against our best President LBJ - for the nut hippie Bobby Kennedy, who hates the President because he was not appointed as Vice Pres. when his brother JFK was murdered the same way as was MLK. Senate should prohibit all marches at least for the duration of this war, and specially in our Capital. Now the white people are to be more against us for the crazy revolts, murders and damages.

Amen!

"Our hope is still in LBJ - God let him be again our President. The second best is HHH, but Hippie Bobby and his conspirators are politically just as good as dead. God save USA with LBJ all the way.

"I am mailing the Police drawing of suspected killer of Dr.K. which appeared on page 2 in yesterday's Daily News, as a white man, who actually is a negro, but a brown one, made white with cream etc. - however, I made it with a crayon darker so they may find him in Atlanta in the King's family.

"You must understand that I cannot reveal my real name and address, although I actually do live in Harlen. Please do not hesitate to use my information, because it is God's truth.

"I am mailing 7 Of these letters to various places - why 7? Because yesterday was Good Thursday, the last supper of Jesus Christ, as a reminder of HIS seven words on the Cross:

'Into Your Hands I command my soul!'May your Easter be blessed!

"Sincerely,

"Coon Amen, 23 years old"
