# Standard Rent Agreement

For Apartment-Hotels, Apartments and Bungalow Courts

Unit No. 303

Agreement, entered into this 5 day of March, 1967, by and between  
Smith operator of Granary Park Apts herein called lessor,  
Mr. & Mrs. Tom Flikeid herein called lessee,  
 the lessee rents from said lessor those certain premises known and described as #303 No. 1831 N. Granary Pl. (Apt., Rm., Suite, Unit) California.  
 Tenancy from month to month commencing on the 5 day of March, 1967.  
 at a rental of One hundred & thirty dollars Dollars (\$130.00) per month (Mo. or Wk.)  
 which rental the said lessee expressly agrees to pay each term in advance, commencing on the last day mentioned. It is agreed that the tenancy hereby created shall terminate at 12 o'clock Noon on the day of the termination of the tenancy. It is further agreed that the said premises shall be occupied as living quarters for residence, and for no other purpose, of the following named persons and no others:

Mr. & Mrs. Tom Flikeid  
 that if any additional persons in excess of the number herein specified occupy the premises, lessee agrees to pay additional rent in the amount of \$ 10.00 per month for each such additional person, but no such additional person may occupy the premises without lessor's prior written consent.  
 This agreement is subject also to the following covenants and conditions:

- Any failure by lessee to pay rent or other charges upon day due, or to comply with any other term or condition hereof shall terminate forthwith this tenancy, at the option of lessor, and the lessee hereby expressly waives any notice to quit and surrender possession of said premises, and lessor or his agent may enter said premises and take and retain possession of the same and exclude lessee therefrom. Upon such entry the lessee shall be liable to the lessor as follows: (a) for the installments of rent and other sums falling due hereunder for the period or periods after entry during which the premises remain vacant which sums shall be payable as they become due hereunder; (b) for all expenses including commissions, which may be incurred by lessor from time to time during the term hereof for re-letting the said premises, which expenses shall be payable as they are incurred; and (c) while said premises are subject to any lease or leases made by lessor pursuant to this paragraph, for the amount by which the monthly installments payable under such new lease or leases is less than the monthly installments of rent payable hereunder, which deficiency shall be payable monthly as the same is determined.
- Said tenancy may be terminated by either party by giving written notice to the other of intention to terminate at least 30 days before the expiration of the term of tenancy, and said lessor, or his agent, shall have the right to enter and take possession of said premises upon expiration of said notice in addition to any other remedy provided by law. Lessor may change the terms of this agreement at any time by giving written notice to lessee of such change or changes at least 30 days before expiration of the term of this tenancy.
- In the event of lessee's failure to give such notice of intention to terminate, he shall be liable for another term, and in event he shall abandon, or attempt to abandon, said premises or remove his property therefrom, the rental for such additional term, at the option of lessor, shall be immediately due and payable.
- Failure by lessor to exercise any of his rights under this agreement, or lessor's acceptance of rent after any default, shall not be considered or construed to waive any right of lessor or to affect any notice or legal proceeding theretofore given or commenced.
- Lessee agrees that he will not keep or permit to be kept in said premises any dog, cat, parrot or other bird or dumb animal.
- Lessee agrees not to violate any City ordinance or State law in or about said premises; not to commit or permit any waste or nuisance in about said premises, or in any way annoy, molest or interfere with other occupants of said premises; not to use in a wasteful, unreasonable or hazardous manner any of the utilities furnished by lessor, and to comply with the house rules of lessor, receipt of a copy of which lessee hereby acknowledges.
- Lessee agrees to pay the following as a part of the rental of said premises: All charges for electricity, gas and telephone and all charges for laundering of linens, blankets, and curtains of said premises; also to pay to lessor, on demand, the following: The reasonable estimated cost of laundering blankets and curtains of said premises after vacation thereof, and for cleaning said premises \$ 25.00 for quarters of two rooms and bath or less, or \$25.00 for quarters of three or more rooms and bath prior to delivery of possession.
- Upon incurrence by lessee of any charge it shall become immediately due and payable.
- Lessee shall not transfer his interest in or to this agreement, nor shall lessee assign or sublet said premises, nor any part thereof.
- Should lessor or owner or owner's agent be compelled to commence or sustain an action at law to collect said rents or parts thereof or to dispossess the lessee or month to month occupant or to recover possession of said premises, or to recover damages done to furniture (if unit be furnished) or fixtures or from any other cause arising from said lessee or month to month occupant, the lessee or month to month occupant shall pay all costs in connection therewith including counsel fees of attorney of said lessor or owner or owner's agent.
- Change in any provision hereof may be made by mutual agreement of the parties, endorsed hereon, without affecting any other part hereof.
- Lessor reserves the right to himself or his agent to enter said premises at reasonable times to inspect, clean or repair same, or to show same to prospective lessees, or for any lawful purpose. Lessee agrees not to change any lock or add any lock to said premises without written consent of lessor.

# Standard Rent Agreement

Agreement, entered into this 5 day of Dec, 1967, by and between Smith operator of Granbery Park Apts herein called lessor, and Mr. & Mrs. Tom Flikeid herein called lessee,

the lessee rents from said lessor those certain premises knowr. and described as #303 (Apt., Rm., Suite, Unit) No. 28 1831 N. Granbery Pl. LA 28 California.

from month to month commencing on the 1st day of Dec, 1967.

at a rental of One hundred & thirty five Dollars (\$135.00) per month (Mo. or Wk.)

the said lessee expressly agrees to pay each term in advance, commencing on the last day mentioned. It is agreed that the tenancy hereby created shall terminate at 12 o'clock Noon on the day of the termination of the tenancy. It is further agreed that the said premises shall be occupied as living quarters for residence, and for no other purpose, of the following named persons and no others:

Mr. & Mrs. Tom Flikeid

that if any additional persons in excess of the number herein specified occupy the premises, lessee agrees to pay additional rent in the amount of \$ 10.00 per month for each such additional person, but no such additional person may occupy the premises without lessor's prior written consent.

- This agreement is subject also to the following covenants and conditions:
- Any failure by lessee to pay rent or other charges upon day due, or to comply with any other term or condition hereof shall terminate forthwith this tenancy, at the option of lessor, and the lessee hereby expressly waives any notice to quit and surrender possession of said premises, and lessor or his agent may enter said premises and take and retain possession of the same and exclude lessee therefrom.   - Lessee shall not transfer his interest in or to this agreement, nor shall lessee assign or sublet said premises, nor any part thereof.
  - Should lessor or owner or owner's agent be compelled to commence or sustain an action at law to collect said rents or parts thereof or to dispossess the lessee or month to month occupant or to recover possession of said premises, or to recover damages done to furniture (if unit be furnished) or fixtures or from any other cause arising from said lessee or month to month occupant, the lessee or month to month occupant shall pay all costs in connection therewith including counsel fees of attorney of said lessor or owner or owner's agent.
  - Change in any provision hereof may be made by mutual agreement of the parties, endorsed hereon, without affecting any other part hereof.
  - Lessor reserves the right to himself or his agent to enter said premises at reasonable times to inspect, clean or repair same, or to show same to prospective lessees, or for any lawful purpose. Lessee agrees not to change any lock or add any lock to said premises without written consent of lessor.

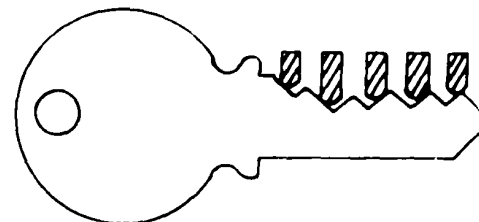
LESSON CORRECTION

Lesson No. *1*

The successful completion of any key fitting assignment depends entirely upon directing your efforts and attention to spacing and shaping the key cuts to conform to manufacturing standards so that the key you fit will operate smoothly and dependably.

Let's review some of these important details and apply them to every key fitting assignment.

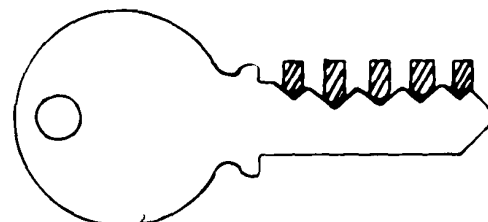
First of all the spacing of the cuts must be accurate so that the pins or discs will sit in the very bottom of the cuts. If the spacing is not accurate the tumblers will sit on the slopes of the cuts like this: This will cause you to file the cuts deeper than necessary and the pins will sit at different heights each time the key is inserted in the keyway.



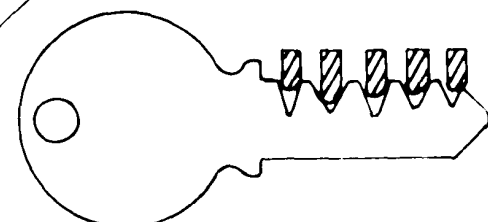
Assuming now that the cuts are spaced accurately, let's take a good look at the importance of the angle formed by the slopes of the cuts.

For general key cutting the standard angle formed by the slopes is 100 degrees. This angle provides enough room for the pins or discs to seat in the very bottom of the cut and presents a gentle slope for the pins to ride up on when the key is inserted and withdrawn. The angle also eliminates those high, steep points between cuts that appear when the angle is not correct.

NOTE: Use key gage supplied in Lesson #2 to help you maintain the correct angle as you file for depth.



When the angle is not correct, or too steep, the pins hang between the slopes like this: Again the cuts will be deeper than necessary, weakening the key and preventing the pins or discs from meeting at the shear line each time the key is inserted in the plug. The very steep slope and high, sharp points between the cuts makes insertion and withdrawal of the key difficult and will cause excessive wear. Worst of all the pins or discs can get wedged in the cut, trapping the key in the plug.



Students very often want to know about the shape of the bottom of the cut. The bottom of the cut can be rounded or flat. This provides a base for the pins or discs to rest on and a tolerance for minor deviations in spacing.
