ON or about the 7 of Sept 1966 I was committed to the Biggs Building on order of the Cole County Circuit Court. On my arrival at Biggs Building I had with me my trial transcripts and other legal papers valued at about \$300.00 I also had \$19.00 in commissary books. Mr. Perry said I could not take them to the word that they would be kept in my personal property upon leaving Biggs bldg.
