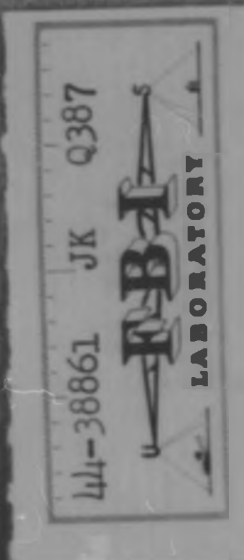

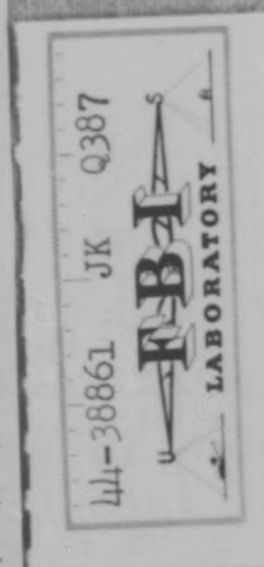
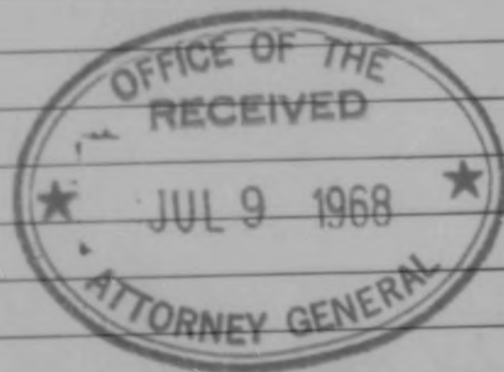
Dear Sir;
