



A preliminary inspection of these rifles indicates what appears to be full set of latent fingerprints. Owner indicates he has serious doubts these weapons have been handled by anyone else since handled by Unsub, 3/29/68.

Laten Pingerprint Section is requested to examine these rifles and conduct apprepriate comparison and search. Sutel results Memphis and Birmingham.
