VERNON WAS SHOWN A PHOTOGRAPH OF THE T-SHIRT AND SHORTS WHICH WERE FOUND IN THE APARTMENT IN MEMPHIS. HE STATED THE SHORTS WERE SIMILAR TO THE ONES WHICH GALT ORDINARILY WORE AND SAID THE SIZE OF THE SHIRT MATCHED THE SIZE OF GALT. HE COULD NOT STATE FOR SURE WHETHER OR NOT THE TWO PIECES OF UNDERWEAR BELONGED TO GALT.

VERNON IDENTIFIED THE LAUNDRY MARKING ON THE UNDERWEAR AS BEING SIMILAR TO THE MARK USED AT HIS LAUNDRY.

VERNON DOES NOT KNOW GALT BY HIS FIRST NAME; HOWEVER, ENTRIES IN THE LAUNDRY BOOK WHICH WERE OBTAINED FROM VERNON INDICATE THAT GALT'S FIRST NAME WAS GIVEN TO THE LAUNDRY AS ERIC. VERNON STATED GALT USUALLY WORE BERMUDA SHORTS, A SPORTS SHIRT WITH A T-SHIRT UNDERNEATH WHEN HE CAME INTO THE STORE. HE SAID THAT GALT NEVER WORE GLASSES NOR DID HE EVER OBSERVE HIM TO HAVE SUNGLASSES IN HIS POSSESSION. VERNON COULD NOT RECALL WHAT TYPE OF FOOTWEAR GALT WORE WHEN HE CAME INTO THE STORE. HAIR WAS CUT NEAT, SOMEWHAT LIKE BUSHY FLATTOP AND A WIDE FOREHEAD.
