

## ST. LOUIS COUNTY JAIL MAIL and VISITING REGULATIONS

All mail to inmates is to be addressed by both Name and Number to 7900 Forsyth Blvd., Clayton-63105, Missouri.

Money may be mailed in but it is preferred that it be left at the Receiving Desk on visiting day. Personal checks are not acceptable as they are difficult to cash.

Letters to inmates may not exceed one a day, written on standard sized sheets (8½xll) on one side of the paper and not to exceed two sheets. Only if typewritten.

Inmate sending out letters are restricted to one sheet written on one side and the heading filled out completely.

Parents, wife, children, brothers and sisters may visit once each week on Saturdays only, between the hours of 9:00 a.m. and 4:00 p.m. No visiting is permitted between 12:00 and 1:00 p.m. which is the lunch period. Children under the age of seventeen must be accompanied by an adult. Number of visitors will be restricted to space available. Relatives on their first visit must have positive identification of relationship. Visit will be denied if the odor of alcohol can be detected. Former inmates WILL NOT be permitted to visit. The only items which can be brought in are clean under clothing which will be left at the Receiving Desk. Clothing must be in a sturdy bag and plainly marked with both the inmates name and number.


