KEELEY said that GALT had no telephone. He said that due to the irregular hours that GALT maintained, he believed him to be unemployed. KEELEY said he had no knowledge as to whether GALT owned or operated an automobile.

KEELEY said that each desk clerk utilizes the same procedure in handling rental payments at the St. Francis Hotel. He advised that at the end of each shift, the money and checks are placed in a plain white envelope and sealed. This envelope is then date stamped and then placed into a safe through a mail slot. KEELEY said that the owner of the hotel, Mr. DAVIDSON, periodically opens the safe and deposits the receipts at a bank with whom he does business.

BECKMAN was shown Chevron service order No: 423676 which was made out in the name of GALT. BECKMAN related he had filled in the service order with the name GALT, no first name given, and had finalized the service order wherein the notation was made "Pd. Cash" and his initials. BECKMAN could not clearly recall the transaction where a Mustang, license 1-38993, no state given, was brought to his service station on February 13, 1968, to have some repair work performed. Mr. BECKMAN related that to the best of his recollection he and AL BALLAN had a brief conversation with the individual who brought this vehicle into the station at approximately 12 noon on February 13, 1968. From looking at the service order, he assumes AL BALLAN had made out the service order containing the work to be performed on the Mustang. Mr. BECKMAN further related the individual bringing the vehicle into the service station had told him that he did not have a telephone number where he was staying as he would only be in Los Angeles for a few days. The individual left the vehicle at the service station, gave the station a time as to when he would like to have the vehicle, and left the area of the station proceeding on foot west on Sunset Boulevard, Los Angeles. The individual returned to the station at approximately 4:30 or 5:00 P.M. in the afternoon. BECKMAN did not observe what direction he came from when returning to the station to pick up the vehicle. Mr. BECKMAN recorded his name at the top of the service order and at the time the bill was paid, made the notation "Pd. Cash" with his initials. BECKMAN does not recall this individual asking for maps at anytime. BECKMAN stated the work performed on the Mustang would have had to have been performed at his service station at 1506 North Normandie as he has not sent any work to either of his other two stations in approximately seven months.

BECKMAN described the individual who left the Mustang bearing the license number 1-38993 at his station on February 13, 1968, as follows:

BALLAN located H. Beckman Chevron Service Station copy of Chevron Service Order No. 423676 which was made out in the name of GALT. The service order indicated that on February 13, 1968, a Mustang with the license 1-38993, no state recorded, speedometer reading 34,185, was brought to the H. Beckman Chevron Service, 1506 North Normandie Avenue, Los Angeles, where two front wheels were replaced. The front end was aligned, and the front wheels were repacked. The total charge for the bill was \$12.47 which, according to the service order, was paid in cash.

BALLAN stated he recognized the handwriting on the service order to be that of his own, with the exception of the name "GALT", "Pd. Cash" and the initials of the person receiving the cash from GALT for the work performed. BALLAN stated he did not know the employee who had filled out this portion of the service order.

BALLAN stated he could not recall having taken the service order for the above described vehicle, but this could have been done by another employee and he had been advised orally of the work to be performed on the vehicle. He could have, based upon another employee's instructions, then made out a service order. BALLAN related he could not recall the individual bringing the vehicle into the service station for the above repair work, nor could he recall whether the individual stayed at the station while the work was being performed. BALLAN could not recall the time of the day the vehicle was brought into the service station nor could he recall the time it was picked up from the service station.

BALLAN advised the work performed on the Mustang would take an hour to an hour and a half to complete if an individual did nothing else at the service station, such as pumping gas and waiting on customers. BALLAN stated that while performing work on the Mustang he would have had to wait on customers and assist with the other duties of the station. The time it would have taken for the job would have depended upon how busy the station was on February 13, 1968. BALLAN further stated that he was not sure he had performed the work on the Mustang as H. Beckman has another service station located at 8th Street and Western Avenue, Los Angeles, where work is sometimes sent if too large a volume of work is at the Chevron station located at 1506 North Normandie Avenue, Los Angeles.

BALLAN added that had the work been performed at the service station on 8th Steet and Western Avenue, Los Angeles, no additional record would be made other than the one at the Chevron service station on Normandie Avenue, Los Angeles.

BALLAN related he did not believe the Mustang had been serviced at the H. Beckman Chevron Service Station anytime prior inasmuch as a record is maintained on the service orders of all regular customers. The service order which he had in his possession did not indicated GALT to be a past customer.

Mrs. VERA BERNHARDT, 1539 North Serrano Avenue, Los Angeles was interviewed and furnished the following information:

She is the current manager and owner of the apartment building at 1535 North Serrano Avenue, Los Angeles. She said she had no records for this residence regarding former tenants as the building has been in receivership and these records are maintained by DALE L. DYKEMA, 3335 Wilshire Boulevard, Los Angeles. Mrs. MARGARITA (WRANK) POWERS, 6121 Western Avenue, Buena Park, California (telephone 714-522-71440), was interviewed at her residence on April 12, 1968, at which time she furnished the following information:

She was, together with her husband, FRANK POWERS, the manager of the apartment building at 1535 North Serrano, Los Angeles (Hollywood), California, from July 1967, to December 15, 1967. During the time she managed the apartment building, she and her family resided in apartment 12-A, on the first floor of the building.

She recalled that during a day of bad weather in November 1967, Mr. ERIC GALT came to the building and said that he was seeking an apartment to rent. He said that he had seen a vacancy sign out in front of the building, and was seeking an apartment that he could rent immediately. She said that a bachelor apartment (apartment number 6) on the first floor of the building was available. She showed it to him and he said he would take it.

Mr. GALT explained the he was normally employed as a salesman; and that he had left applications for positions as a salesman with several firms. He asked if it would be permissible for him to use her telephone until he could get one installed. She saidt hat it would. He did not receive any telephone calls over her phone; nor did he ever use it following that first encounter, to the best of her recollection.

Mrs. POWERS said that as his apartment only had one chair in it; she made arrangements to get another chair for him. The day she took the extra chair to his room she saw he had a telephone installed in the apartment.

Mrs. POWERS said that Mr. GALT paid her in cash, one hundred dollars basic monthly rent, plus twenty-five dollars fee for cleaning the apartment, plus a two dollar and fifty cent key deposit. Mr. GALT was instructed, by Mrs. POWERS, that he could use the apartment building's utilities for the first three days; but that during that time he should go to the utility companies and make personal arrangements

to have the utilities for his apartment installed in his own name. Some time after the three day grace period had lapsed, Mrs. POWERS learned that Mr. GALT had not gone to the utility companies and had not made the arrangements for installation of utilities in his own name. Mrs. POWERS said when she learned this she contacted Mr. DALE DYKEMA, the court-appointed receiver managing the financial affairs of the apartment building, and obtained permission for Mr. GALT to continue use of the building's utilities upon payment of an additional ten dollar payment. It was her understanding that Mr. GALT would be expected to make such an additional payment above his basic \$100.00 basic rent on a monthly basis.

Mrs. POWERS said she never saw GALT have any visitors, nor did he have anyone living with him in Apartment #6, to the best of her knowledge. She did not know him to have any employment; and he did not mention to her the names of any of the firms he allegedly had placed applications with for jobs. He was a very quiet tenant, and did not mix with the other occupants of the building. She did not recall Mr. GALT ever using the swimming pool at the apartment.

He drove a small white car, make or model not recalled by Mrs. POWERS. He parked it in the basement and usually walked to the nearby shopping areas. Mrs. POWERS said she had the distinct impression that his car did not have California license tags; as she recalls sceing it on several occasions when there was some discussion as to whether it was parked in the space in the basement garage alloted to apartment number six.

Mrs. POWERS said she recalled putting Mr. GALT's name up on the apartment directory posted near the front entrance to the building. He did not object; but she said it was possible that he never noticed it posted there.

Mrs. PO ERS said that she had filled out a rent receipt for Mr. GALT, when she first rented him the room. She said that she and her husband moved from the apartment building on Serrano approximately December 15, 1967, and so did not take any more rent payments from Mr. GALT, who was still residing in Apartment 6, when they moved to Buena Park, California.

Mrs. POMERS furnished the green "Stub-Tite" Receipt Book (made by the Springfield Photo Mount Co., Holyoke, Massachusetts), which

contained stubs of rent receipts for 1535 Serrano, Los Angeles, covering the period of May 1, 1967, through November 25, 1967. THOMAS M. WARE, 3344 Glenhurst Avenue, Los Angeles, was interviewed at his residence at which time he furnished the following information:

A photograph depicting a pair of duck-bill pliers containing the name of Rompage Hardware on the handle was exhibited to Mr. WARE. He was asked if he had ever seen such a pair of pliers. Mr. WARE related that he had ordered pliers such as were shown in the photograph from an unrecalled firm while he was manager of Rompage Hardware Store, 5542 Hollywood Boulevard, Los Angeles, California. He stated the pliers were seconds and were received by Rompage Hardware in an assortment of tools which were sold from a bargain bin.

Mr. WARE stated he was employed by Rompage Hardware from 1955 through February, 1967. He was manager of Rompage Hardware for approximately five years. He began ordering the assortment of tools for use in the bargain bin in approximately February, 1966, and continued reordering every three or four months until he terminated his employment with Rompage Hardware in February, 1967. ALLAN O. THOMPSON advised that he was the manager of the St. Francis Hotel, 5533 Hollywood Boulevard, Los Angeles, California. THOMPSON said that he lives at the hotel. 

During the early morning hours of April 12, 1968, Miss ANITA LOUISE KATZWINKEL was contacted at her residence of Apartment 9, 1727 North Garfield Place, and after being advised of the identity of the contacting Agents, she was interviewed regarding her background, associates, and knowledge of ERIC STARVO GALT.

KATZWINKEL stated she knew and had associated with a girl by the name of GINGER and another girl by the name of SUE. She identified GINGER as GINGER NANCE and SUE as SUE HARRIS, also known as Sue Flikied. She denied knowing anyone by the name of ERIC STARVO GALT. When asked to furnish the details surrounding her association with NANCE and HARRIS, she furnished the following information:

NANCE, HARRIS and she grew up together in Dixon, Illinois, and all three attended the same high school and ran around with the same "crowd". While still in high school, HARRIS' parents sent her to Los Angeles, California, to live with her aunt, Mrs. (FNU) GOSS, because her parents felt HARRIS was running with a wild crowd and that she would be better off in California.

During May or June, 1967, KATZWINKEL and NANCE decided to go to California and meet with HARRIS. They left Dixon, Illinois, traveling in a bronze colored 1960 or 1962 Rambler which belonged to CHARLEY DAY, NANCE's ex-husband. This car broke down on Highway 66 just outside Oklahoma City, Oklahoma, so they abandoned the car there. At this point they met two men who gave them a ride to San Diego, California. These men were from San Diego but KATZWINKEL could not furnish any additional information regarding them other than they were white males. From San Diego they obtained a ride to Los Angeles, California, and arrived in Los Angeles the Tuesday before Mother's Day in 1967.

Thereupon they took up residence in the Palms Motel, located somewhere on Sunset Boulevard in Hollywood, California.

KATZWINKEL and NANCE rented a room at the Palms Motel for approximately two weeks and thereafter moved to the Serrano Apartments, located at 1535 Serrano Avenue, Hollywood, where they rented Apartment 6. Both the room at the Palms Motel and the apartment on Serrano Avenue were rented in KATZWINKEL's name. They rented this apartment until about the middle of June 1967; however, KATZWINKEL stated that she spent only about one or two nights at this apartment because in the meantime she had met THOMAS HUNTER. Shortly after meeting HUNTER she moved into his apartment located at her present address of 1727 North Garfield Place. NANCE continued to reside in the Serrana Avenue apartment until the middle of June. Thereafter, she returned to Dixon, Illinois, and KATZWINKEL has not seen her since then.

Regarding NANCE, KATZWINKEL stated that while in Los Angeles she dated a Negro, whose name and further descriptive data was unknown to KATZWINKEL. KATZWINKEL stated that upon returning to Dixon, Illinois, NANCE was arrested by police authorities there on a bad check charge and was supposed to have served six months in prison. NANCE has been married a couple of times and goes by the name of GINGER DAY, GINGER NANCE or GINGER CUNNINGHAM. NANCE was the last name of one of her husbands, KENNETH NANCE. CUNNINGHAM is the name of her father, who was last known by KATZWINKEL to reside in Bellflower, California.

.According to KATZWINKEL, when NANCE left the apartment at 1535 Serrano, she left a number of her clothes and personal items in her apartment. She locked the door of the apartment and KATZWINKEL had to ask a friend of hers to help her open the door. Some boy friends of NANCE's in Dixon, Illinois, who might know her whereabouts at the present time are JIM LEIGH (phonetic), CHARLEY GULF, and TOM SHERIDAN.

Regarding SUE HARRIS, also known as Sue Flikied, KATZWINKEL stated that when she and NANCE arrived in California in May or June, 1967, they found HARRIS living in a common-law relationship with TOM FLIKIED at the Palms Motel. When asked whether or not HARRIS was operating as a prostitute, KATZWINKEL stated that she was. KATZWINKEL denied

working as a prostitute but did admit on occasions she would answer HARRIS' phone and set up dates for HARRIS. When asked whether or not TOM FLIKIED was gainfully employed, KATZWINKEL stated that she did not know his employment but that he was not a pimp for HARRIS. When asked if she had ever lived with HARRIS or FLIKIED, at their apartment at 1831 North Gramercy Place, KATZWINKEL stated she had not. When advised that the phone number at their apartment was listed in her name, KATZWINKEL stated that SUE HARRIS had obtained her permission to put the phone in her name because HARRIS owed the phone company a large amount of money on a previous phone under her own name. When asked whether GINGER NANCE had acted as a prostitute while in California, KATZWINKEL stated that she had not because "she was too fat and ugly".

When asked if she knew the present whereabouts of SUE HARRIS and TOM FLIKIED, KATZWINKEL stated that they were presently on a three-month vacation touring the Southern states. She advised that just prior to leaving they had purchased a 1967 Ford Thunderbird for this vacation from Cort Fox Ford in Hollywood. When asked if she knew where they obtained the money for this automobile, KATZWINKEL stated she believed HARRIS had paid \$500.00 of her own money as down payment for this car. She stated she last saw HARRIS and FLIKIED on the night of February 14, 1968.

When asked if she knew where HARRIS and FLIKIED were at the present time, KATZWINKEL stated that they wanted to be in Dixon, Illinois, by April 12, 1968, to visit HARRIS' mother there. KATZWINKEL described TOM FLIKIED as a white male American, 6', about 170 pounds, light brown hair, blue eyes, very Norwegian looking, well built, a very neat dresser, left-handed, and somewhat of a braggart. She also stated that he smoked, which she remembered to be Camel cigarettes, and drank Scotch and water.

After furnishing the above information, KATZWINKEL was asked again if she had ever known anyone by the name of ERIC GALT or anyone using the last name of GALT. She stated that she had not. She was asked if she knew anyone who owned

a white Ford Mustang. She stated she did not. She was then asked if she could ever recall having furnished her name and address on Serrano Avenue to anyone. She stated that she could not recall ever having done so. She was then advised that her name and her address of her apartment on Serrano Avenue had been located on the paper found in a white Mustang which had recently been recovered by the FBI in Atlanta, Georgia. She was then asked if she could give any reason or explanation as to why her name and address would have been on the paper located in this automobile. KATZWINKEL stated that she had no idea. When asked what the word "Oklahombe" meant to her, KATZWINKEL stated that she had no idea, other than it sounded like a misspelling of the word Oklahoma.

At this point in the interview the results set forth above were discussed once again with KATZWINKEL, and she was asked whether or not she could furnish any further information regarding any point covered above. She stated that she could not at this time remember or recall any further details surrounding her trip to California and her association with NANCE, HARRIS or TOM FLIKIED, nor the reason her name and address would have been on a piece of paper found in an automobile recovered in Atlanta, Georgia.

After relating the above information, KATZWINKEL made available to the interviewing Agents three colored snapshots. One was a snapshot of herself standing in front of the apartment house located at 1727 North Garfield Place; the second was a snapshot of SUE HARRIS in a bathing suit on a beach, and the third was a picture of TOM FLIKIED seated in a chair facing the camera with SUE HARRIS on his lap.

During the late afternoon hours of April 13, 1968, KATZWINKEL was contacted at her place of employment and was agreeable to being reinterviewed. She was interviewed in a Federal Bureau of Investigation automobile located in the 5300 block of Santa Monica Boulevard.

During the course of this interview she was asked to reiterate the details of her trip to California and her association with GINGER NANCE and SUE HARRIS. She was asked specifically how she and NANCE had obtained a ride from San Diego to Los Angeles. She stated that when they arrived in San Diego, NANCE telephonically contacted her father, Mr. (FNU) CUNNINGHAM, who picked them up in San Diego and took them to his trailer in Bellflower, California. They spent the first night at his trailer in Bellflower. The next morning he drove them to the Palms Motel on Sunset Boulevard, in Hollywood, California. There they met up with SUE HARRIS who, at that time, had an apartment at the motel with TOM FLIKIED. KATZWINKEL and NANCE rented room No. 7 at the Palms Motel and KATZWINKEL rented it in her name and paid for the room.

When asked where she obtained the money for the room, KATZWINKEL stated that while coming to California she called a friend of her brother's by the name of HOWARD CARLSON, and he sent her \$30.00. She called CARLSON from some place in Texas. CARLSON resides in Mendota, Illinois, and he agreed to send her \$30.00 by Western Union telegram. This money was sent to her at the Western Union Office in San Diego, California.

When asked why she chose the Palms Motel, KATZWINKEL stated that she had corresponded with SUE HARRIS prior to leaving Dixon and HARRIS had made reservations for her at the Palms Motel.

KATZWINKEL advised that they had stayed at the Palms Motel for two weeks. When asked how much rent they paid for their room and where they obtained the money for it, KATZWINKEL stated that the room ran them about \$20.00 a week and that she had filled "dates" at the motel on two or three occasions to obtain money.

When asked where she contacted these "dates", KATZWINKEL stated that she worked for SUE HARRIS and that HARRIS had the contacts. She was paid \$10 to \$15.00 per "trick" and this money was paid to KATZWINKEL and not to HARRIS. KATZWINKEL stated that HARRIS was running a call girl service by herself and that HARRIS would send those "dates" to her that she did not have time to fill herself.

During this time TOM FLIKIED, who was living with HARRIS, was employed by the Hollywood Carpets as an installer. KATZWINKEL stated she did not fill any "dates" with any persons from FLIKIED's place of employments and would recall doing so because she knew the people FLIKIED worked with. KATZWINKEL stated HARRIS took her to the Vegas Club located on Hollywood Boulevard and she met some of her contacts there. HARRIS, NANCE and KATZWINKEL went to the Vegas Club regularly, according to KATZWINKEL. When asked if she recalled a Negro guitar player there, KATZWINKEL stated that there was a Negro guitar player at the Vegas Club whose first name was TONY.

KATZWINKEL stated that after staying at the Palms Motel for about two weeks, she and NANCE moved to the Serrano Apartments and rented Apartment 6 in her name. She asked if she ever received any utility bills at the apartment, KATZWINKEL stated that her utilities were included in the rent for the apartment.

When asked whether or not she ever filled a "date" while living in the Serrano Apartments, KATZWINKEL at first stated she did not because although the apartment was rented in her name for about three weeks, she herself lived there one or two nights. After asking her to think over this question for awhile, KATZWINKEL stated that she did fill one "date" at the Serrano Apartments. Her customer was a man whose name she thought to be TOM REGGIE, who ran a laundry located on Sunset Boulevard. This "date" had been given to her by SUE HARRIS and was a regular customer of HARRIS'. REGGIE did laundry for HARRIS and was repaid by her favors rather than with money. KATZWINKEL described REGGIE as a white male, about 35 to 40 years of age, 5'10" about 250 pounds, black curly hair, possibly having a hairline mustache, and driving a white panel truck. KATZWINKEL stated that she met REGGIE at HARRIS' apartment and that he drove her and GINGER to the Serrano Apartments where she turned the "trick". Afterwards REGGIE took both she and NANCE to lunch in his white truck.

KATZWINKEL was then asked if she would be willing to furnish samples of her handwriting and she advised that she would be agreeable to do so. She was then given a white, lined tablet and asked to write various words in sequence on These words included her name, ANITA KATZWINKEL, the tablet. GINGER and DAY; the address 1535 Serrano, Oklahombe, and Apt. 6. After writing these words, she was then shown the colored photograph of a Kleenex box top on which appeared the writing "GINGER DAY & ANITA KATZWINKEL, etc." After looking at this photograph, KATZWINKEL stated that the writing depicted in the photograph appeared to be her writing but she could not recall ever having given her name and address to anyone. She stated that the word "DAY" appearing immediately above and after the word "GINGER" in the photograph was the last name of GINGER DAY, who is identical to GINGER NANCE. She stated she knew nothing whatsoever of the words "Oklahombe" and "Broult" which also appeared in the photograph. When asked whether or not Oklahombe was the name of a Negro guitar player at the Vegas Club, KATZWINKEL stated that she did not think so. When asked whether or not she could give any explanation as to why her name and address were found in an automobile believed to have belonged to ERIC GALT, KATZWINKEL stated that she had no idea whatsoever.

KATZWINKEL was then asked if she normally gave her name and address to her customers. She stated that she did not. She then advised that it was possible that she had given her name and address to a Negro male by the name of TOM WASHINGTON, whom she met at a bowling alley on two occasions. This bowling alley is located on Hollywood Boulevard. Both she and NANCE used to hang out at this bowling alley and this Negro man bowled in a league on either a Tuesday or a Thursday evening. He also drove a white Mustang convertible. KATZWINKEL further described this man as about 30 years of age, light complected, but she did not know where he was employed. She also advised that she never dated this man but did think it possible that she might have given her name and address to him.

KATZWINKEL was then shown an artist's conception of ERIC GALT and photographs of J. VERNON. She stated that she has never seen either of these two individuals. She was then shown the colored photograph of a green colored bedspread and stated that this did not mean anything to her.

When asked if she could furnish any further information regarding the above matter, KATZWINKEL stated that she could not; however, if she did recall anything as a result of these interviews, she would immediately contact the FBI Office.

LUCY PINELA, Manager of the Home Service Laundry and Dry Cleaning, 5280 Hollywood Boulevard, Los Angeles, advised SAs FRANCIS G. KAHL and DENNIS C. LE MASTER, after observing a color photo of the shorts and T shirt found in connection with this case, that she believed the shorts mights belong, or were the same type, to a former employee known only to her as JIM (last name unknown) or "Uncle". She said JIM worked at the laundry for a period of about one month during February and March 1968. She said JIM was a personal friend of J. W. VERNON, and was formerly employed by a garbage disposal firm, name unknown. She believed JIM was a former member of the U. S. Armed Forces, branch unknown. She described JIM as follows:

She commented the photo on his drivers license showed him with a large, full beard, which he did not have while working at the laundry. JIM had a girlfriend named DONNA (last name unknown), who was also a former employee at the laundry. JIM had no car.

She advised there were no employment records left at the laundry with which to further identify the former employees, since VERNON paid employees in cash and kept no payroll records of which she knew.

PINELA stated she last saw VERNON on March 27, 1968 at about 9:00 A.M. at the laundry. He gave no indication concerning his future plans. She advised VERNON had a girlfriend, DIANE WALL, who lives in Pasadena, exact address unknown.

PINELA advised she never saw VERNON or JIM in the possession of any type of gun. She said a large box of tools belonging to VERNON are now missing from the laundry. She advised she had the home address of DIANE WALL at her residence, and would make this information available later in the day. PINELA's home telephone number is 748-4260, and she would be home between 6:30 and 8:30 P.M.

Concerning the placement of the laundry marks on the garments in the photo, she advised this is where their laundry would place thermosseals to indicate that the clothing was not to be starched.

While Miss PINELA was cooperative, she said it would be difficult at this time to fully answer questions because of the continuous traffic of customers in and out of the store, requiring her attention.

PINELA furnished additional thermo-seal samples on cloth during this interview.

JEROME WALLIS VERNON, also known as Jay Wallis Vernon, 1246 Woodbury Court, Apartment B, was interviewed and furnished the following information:

VERNON advised that he has been employed by Lockheed Air Craft Company, Ontario, California since April 3, 1968 and exhibited to the interviewing Agents his identification card from Lockheed, which showed the date April 3, 1968.

VERNON advised that he operated the Home Service Laundry and Dry Cleaning Company, 5280 Hollywood Boulevard, Los Angeles, from January 16, 1968 to March 23, 1968. He stated that a man by the name of GALT was a regular customer at the laundry and he believed that he came in each Saturday afternoon. He first saw GALT on Saturday, January 20, 1968, and the last he recalled seeing him was on March 16, 1968. VERNON stated that it was his opinion that GALT always came into the store on Saturday afternoon, left a bundle of laundry which usually consisted of underwear, T-shirts, and dress shirts, and then would pick up the finished laundry the following Saturday. That is, he would leave a bundle and pick up what previously had been washed from the previous Saturday.

VERNON was shown a photograph of the T-shirt and shorts, which were recovered in Memphis, and he believed that they were similar to the ones that were brought in by GALT. He felt that the size of the T-shirt would be that which would have been worn by GALT. VERNON stated that he could not state for sure whether or not the two pieces of underwear belonged to GALT.

VERNON identified the laundry marking on the underwear in the photograph as being similar to the mark used at his laundry.

VERNON does not know GALT by his first name; however, entries in the laundry book, which were obtained from VERNON indicate that GALT's first name was given to the laundry as

VERNON stated that GALT usually wore bermuda shorts, a sport shirt with a T-shirt underneath when he came into the store. He said that GALT never wore glasses nor did he ever observe him to have sunglasses in his possession. VERNON could not determine what kind of foot wear GALT wore. He never observed GALT driving a vehicle nor did he ever see GALT inanyother location other than the laundry. GALT never furnished an address to VERNON or any of the other employees at the laundry.

VERNON described GALT as follows:

VERNON never noticed anything unusual about GALT's speech and stated that he would assume that GALT would come from the California area, as he had no noticeable regional accent.

VERNON was exhibited the two composites furnished by the Bureau, and he stated that the eyes, nose, and chin on the composite from Memphis should be placed on the composite of Birmingham and that this would be a good likeness of GALT.

VERNON stated that GALT always paid for his laundry in cash, using bills in the \$10 and \$20 denominations. GALT never mentioned to VERNON where he worked or anyother information concerning his background.

JEROME WALLIS VERNON was reinterviewed at the Los Angeles Office of the FBI, and he furnished the following information:

VERNON amended his previous description of GALT as being between 25 - 30 years of age, and approximately 160 pounds. He never wore bermuda shorts as he had indicated in the previous interview stating he was confused with another customer. He now recalls that GALT's dress was unusual in that it was not the California style. He could not place the clothing in any particular part of the country or from any foreign country, but did think it looked more like that of the English style. VERNON stated that after thinking over his knowledge of GALT, he now feels that GALT had a slight educated Southern accent.

VERNON advised that he could not elaborate on the wearing apparel of GALT. He had never noticed any type of jewelry which he might have worn nor did he ever engage in a conversation with GALT in which he could have learned anything of his background.

At this interview VERNON was shown a composite which was made up of the two composites from the description which he had previously furnished, and he stated this was not a true likeness. He thereupon took the forehead of the Birmingham composite and placed it on the one from Memphis and indicated that this now looked like GALT as he recalled him.

VERNON advised that he could furnish no additional information concerning GALT.

MARTA MARTIN was interviewed at her residence, Apartment 201, St. Francis Hotel, 5533 Hollywood Boulevard. MARTA MARTIN furnished the following information:

She first met ERIC GALT in the Sultan Room at the St. Francis Hotel, a bar where she is a cocktail waitress and serves beer. Her first meeting was about mid December 1967, when during casual conversation she asked GALT if he would take her home. GALT said he would take her home and then she told him she lived in New Orleans. She explained to GALT that her cousin, RITA STEIN, had to pick up her children in New Orleans and GALT then agreed to drive to New Orleans. Later the same evening, GALT either took her to RITA STEIN's residence or RITA was at the bar and took GALT to her residence to meet RITA's brother, CHARLES STEIN. MARIA MARTIN did not remember whether she was at the STEIN residence that evening. Later the same evening, when GALT learned that CHARLES STEIN would accompany him to New Orleans instead of MARIA or RITA, GALT made the statement to MARIA that "If its a set up I'll kill him. I have a gun". MARIA reassured GALT that it was not a set up but only RITA STEIN's need to get her children. GAIA then made the condition that RITA, CHARLES and MARIA had to register for GEORGE WALLACE in California and arrangements were made to register the next day. The following day, RITA, CHARLES and MARIA met at the Sultan Room and GALT picked them up in his Mustang. MARIA paid no attention to the conversation on the way to register for WALLACE, nor did she remember anything at the registration.

GALT's Mustang was believed to be forest green in color and very plain inside in that there were no extras, such as a console, FM radio or airconditioning. MARIA recalled one occasion when GALT told her he had had difficulty driving

through a Negro community because of the Alabama license plates on his car and that tomatoes had been thrown at it.

After GALT returned to Los Angeles from New Orleans, MARIA saw GALT in the Sulton Room about 30 times. During these occasions she made the following observations:

GALT usually drank straight vodka and maybe had a tap beer on occasion. She never saw GALT smoke, nor was the ashtray near him ever dirty. GALT may have eaten a bar snack called beef jerky once or twice, but did not have a habit of eating while drinking.

GALT had very clean hands, not calloused, fingernails clipped short and no rings or wristwatch were observed. GALT appeared to be pale and not tanned as if he were indoors a great deal. GALT's eyes were blue, sometimes appearing hazel when the pupils were very large. GALT's eyes were best represented by the composite drawing from Birmingham, Alabama, but no other composite came close. GALT's expression was always very solemn and showed no emotion.

She and GALT once played a game of pool but GALT was not good, although he had probably played before. On one occasion in February 1968, GALT stated that he had just finished a six-week bartender school course, but could only make a screwdriver. GALT gave the impression to MARIA that he had been married once just by his cool manner.

The last time MARIA saw GALT was when they traded television sets and MARIA and GALT carried his console television from his room in the St. Francis Hotel to her apartment in the hotel. GALT's room was very neat and seemed picked up at that time. Nothing was noted
