REFLECTED NO UNUSUAL ACTIVITY. RAYNES SUBSEQUENTLY INTERVIEWED AFTER THOROUGH CHECK OF THE PROPERTY, ADVISED HE IS SIXTYNINE, DOB: [REDACTED] WAS MARRIED TO LUCILLE MAHER NOW DECEASED. SEVEN CHILDREN WERE BORN TO THIS MARRIAGE WHICH RAYNES DESCRIBED AS FOLLOWS, BUT WAS FUZZY IN HIS ABILITY TO THINK, AND COULD NOT RECALL SPECIFICS. RAYNES DOUBTS ALL THE CHILDREN ARE HIS, KNOWS NOTHING OF JOHN, BUT IS SURE SUBJECT IS HIS OWN CHILD.

RAYNE RECEIVED TWO CALLS NIGHT OF FOUR NINETEEN LAST, ONE FROM CAROL, SECOND FROM MELBA EACH INDICATING THAT NEWS ITEMS HAD INDICATED JAMES INVOLVEMENT. AND THE FACT THAT KING WAS RESPONSIBLE FOR LOSS OF REVENUE BY BUSINESS ESTABLISHMENTS IN THE MEMPHIS AREA. LATCH AND LIBERTO ADVISED SIMILAR DISPARAGING STATEMENTS ARE PART OF GENERAL CONVERSATION AMONG CO-WORKERS IN AND AROUND PRODUCE COMPANY AND OTHER INDIVIDUALS RESIDING AND EMPLOYED IN THE MEMPHIS AREA.

EACH STATED THEY WORKED AT THE PRODUCE COMPANY ON APRIL FOUR, LAST, AND LIBERTO ADVISED HE DEPARTED FROM WORK AT APPROXIMATELY FOUR THIRTY PM AND WAS NOT AWARE OF KING'S DEATH UNTIL AFTER ARRIVING HOME. LATCH ADVISED HE DEPARTED WORK APPROXIMATELY SIX PM AND MAY HAVE HEARD KING'S DEATH REPORTED ON THE RADIO, ALTHOUGH HE IS NOT SURE.

EACH DENIED RECEIVING ANY TELEPHONE CALL WHERE MENTION IS MADE OF SHOOTING OF KING OR OF ANY REFERENCE TO KING. EACH STATED THEY HAVE NO KNOWLEDGE OF THE SHOOTING WHILE AT WORK AT THE PRODUCE COMPANY.

LIBERTO ADVISED HE FREQUENTLY MAKES TRIPS TO NEW ORLEANS, LOUISIANA, FOR STRAWBERRIES AND OTHER PRODUCE, AND ALSO BECAUSE ALL FAMILY MEMBERS RESIDE IN NEW ORLEANS.

LIBERTO STATED THIS IS COMMON KNOWLEDGE AMONG EMPLOYEES AND CUSTOMERS AT HIS PRODUCE COMPANY AS HE FREQUENTLY MENTIONS TRIPS TO NEW ORLEANS.

LIBERTO STATED MOST PRODUCE IS PURCHASED THROUGH TELEPHONE CONVERSATIONS AND THIS INEVITABLY INVOLVES TALKING ABOUT LARGE SUMS OF MONEY OVER THE TELEPHONE.

LIBERTO ADVISED HE HAS HAD NO INDIVIDUAL EMPLOYED RECENTLY AT HIS PRODUCE COMPANY FITTING DESCRIPTION OF UNSUB DESCRIBED BY MC FERREN(MC FERREN NOT IDENTIFIED TO LIBERTO), AND STATED HE ALWAYS EMPLOYS NEGRO MALES FOR HELP IN THE PRODUCE DEPARTMENT.

BOTH LIBERTO AND LATCH STATED THEY WOULD REMEMBER ANY CONVERSATION, OVER THE TELEPHONE ~~FOR~~ IN PERSON, WHICH ALLEGEDLY TOOK PLACE APRIL FOUR, LAST, AND INVOLVED THE DEATH OF KING, AND STATED THAT THEY WOULD HAVE NO REASON FOR BEING INVOLVED IN ANY ACTION OF THIS SORT.

LEADS BEING SENT TO NEW ORLEANS TO FURTHER CHECK STORY BY INTERVIEWING LIBERTO'S BROTHER.

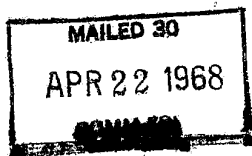
