STATUS OF INVESTIGATION

Investigation conducted to date by the San Francisco Division to locate JAMES EARL RAY, ERIC STARVO GALT, has not produced any information regarding his whereabouts.

The check of laundry marks has been completed. Samples of pertinent laundry marks were furnished to the FBI Laboratory who advised submitted specimens were not identical with questioned laundry marks.

Investigation at financial institutions, dancing schools, laundries, license checks, motor vehicles, voter registration, credit, and other public records has not provided an identification of RAY under the GALT or LOWMEYER/LOWMYER names.

Investigation of people with the name GALT has not provided any information regarding RAY.

Record checks at law enforcement agencies have not disclosed any current record of RAY, aka.

San Francisco is presently conducting investigation regarding HAROLD EDWARD NICHOLS - suspect as conspirator. The Bureau and Memphis will be immediately advised of the results of interview which has been authorized by the Bureau.

YOMAN IS FIFTYFOUR YRS OLD, W/M, LONG-TIME EMPLOYEE OF HERTZ AND WELL-KNOWN TO THIS OFFICE AND CONSIDERED COMPLETELY RELIABLE.

OLIVER VIEWED PHOTOS OF JAMES EARL RAY AND STATES BODKER NOT IDENTICAL. BELIEVES FACE IS THINNER THAN 'SIXTYEIGHT PHOTO OF RAY AND COULD NOT PICK OUT ANY FACIAL CHARACTERISTICS IN PHOTO OF RAY RESEMBLING BODKER.

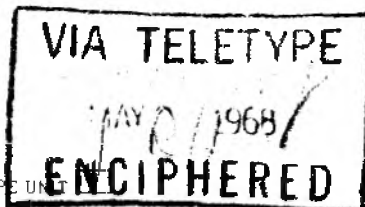

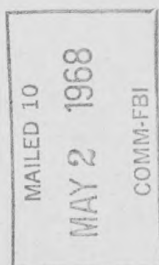
