SUMMARY OF INVESTIGATION CONDUCTED MAY TWENTYNINE INSTANT.

BILLY MACK WISDOM INTERVIEWED AT USP, ATLANTA, AT HIS REQUEST THIS DATE. STATED PERSON HE BELIEVED CLOSELY RESEMBLED SUBJECT IN ATLANTA SEPTEMBER DASH OCTOBER SIXTYSEVEN, AND SEEN AT REGENCY HYATT HOUSE BY WISDOM AND ONE BOB JONES, WHITE MALE, ABOUT THIRTY, NOW REPORTEDLY OPERATING NIGHT CLUB IN DAYTONA BEACH, FLA. STATES ONE "CHUCK" (LNU) ATTEMPTED TO SELL THIS PERSON A RIFLE IN ATLANTA EARLY DECEMBER SIXTYSEVEN. COULD NOT FURTHER IDENTIFY "CHUCK" OTHER THAN DRIVES SIXTYSIX RED MUSTANG CONVERTIBLE, WHITE MALE, BLOND, VETERAN, TWENTY TO TWENTYONE YEARS, NO KNOWN EMPLOYMENT. FIXED TIME AS BEFORE HE, WISDOM, WAS ARRESTED IN DECEMBER, VERIFIED FROM APD RECORDS AS DEC. ELEVEN SIXTYSEVEN AND RELEASED DEC. THIRTY SIXTYSEVEN. ALSO STATED TWO HIPPIES "WEASEL" AND "JOHN" WOULD KNOW "CHUCK", AND FURNISHED DIRECTIONS AS TO THEIR RESIDENCE. LANDLORD STATED TWO HIPPIES HAD RESIDED AT EIGHT SIX NINE ST. CHARLES, ATLANTA, FOR TWO WEEKS.

LEAVING JAN. TWENTYEIGHT, SIXTYEIGHT, GIVING NAMES AS MR. AND MRS. W. T. JONES. THIS IS IN CONFLICT WITH DATES FURNISHED BY WISDOM AND IT IS NOTED MEMPHIS HAS ESTABLISHED SUBJECT IN LOS ANGELES NOV. SEVENTEEN SIXTYSEVEN TO JAN. SIXTYEIGHT.

JAMES P. THORNTON, CURRENTLY RESIDING ATLANTA WITH JERRY Q. DUTTON, INTERVIEWED AND STATED HE ARRIVED ATLANTA MAY FOUR LAST FROM LOS ANGELES. PRESENTLY WORKING FOR PACIFIC FINANCE CO. THORNTON STATED HE RESIDED WITH PARENTS, MR. AND MRS. THOMAS A. RALEY, AT ONE TWO SEVEN THREE FIVE CARDINAL AVE., GARDEN GROVE, CALIF., FROM DATE OF DISCHARGE FROM U. S. ARMY ON JUNE FIFTEEN LAST TILL DEPARTURE TO COME TO ATLANTA. WORKED FOR TRANS-AMERICA CORP., LA PALMA AVE., ANAHEIM, CALIF., FROM TIME OF DISCHARGE TILL LEAVING CALIF. TRANS-AMERICA IS BRANCH OF PACIFIC FINANCE. STATED HE WAS TRANSFERRED TO ATLANTA AT OWN REQUEST BECAUSE HE LIKES THE SOUTH.

THORNTON STATED THAT PRIOR TO ENTERING U. S. ARMY JUNE FIFTEEN NINETEEN SIXTYFIVE, HE LIVED WITH PARENTS, HAVING MOVED TO LOS ANGELES FROM BIRMINGHAM OCTOBER NINETEEN SIXTYFOUR. FROM APRIL SIXTYFOUR TO OCTOBER SIXTYFOUR RESIDED WITH JAMES MC DANIELS, FORMERLY ASSOCIATED WITH NATIONAL STATES RIGHTS PARTY, BIRMINGHAM. FROM JAN. SIXTYFOUR TO APR. SIXTYFOUR,

LIVED AT NSRP HEADQUARTERS ON SOUTH BESSEMER RD. , BIRMINGHAM.

THORNTON ADMITTED PAST AFFILIATION WITH NSRP AND LATER WITH AMERICAN STATES RIGHTS PARTY AFTER HIS AND DUTTON'S SPLIT WITH NSRP. STATED HE GAVE UP ALL QUOTE POLITICAL ACTIVITY UNQUOTE WHEN ENTERING MILITARY SERVICE. ADMITTED HIS FEELINGS REMAIN ABOUT THE SAME AS PLATFORMS OF NSRP AND ASRP BUT STATED SUCH PHILOSOPHIES HAVE NO CHANCE IN U. S. TODAY. DEFINED SUCH PRINCIPLES AS QUOTE CONSERVATIVE UNQUOTE AND REPATRIATION OF JEWS AND NEGROES TO OTHER COUNTRIES. DENIED HE EVER HAD OR WOULD CONDONE VIOLENCE OR MURDER. DENIED DUTTON OR OTHER ASSOCIATES WOULD CONDONE VIOLENCE. STATED THAT JESSE B. STONER AND DR. EDWARD R. FIELDS, PAST AND PRESENT LEADERS IN NSRP WOULD NOT PERPETRATE VIOLENCE DIRECTLY BUT MIGHT MASTER-MIND OR PLAN VIOLENCE. DENIED KNOWLEDGE OF ANY VIOLENCE IN WHICH THEY WERE INVOLVED.

WHILE LIVING IN LOS ANGELES JUNE TO MAY ONE LAST, THORNTON WORKED PART TIME AT WALLACE FOR PRESIDENT HEADQUARTERS. WHEN FIRST WORKED THERE, THE HEADQUARTERS WERE LOCATED ON LINCOLN BOULEVARD, ANAHEIM. THE HEADQUARTERS CLOSED ABOUT JANUARY LAST AND A NEW HEADQUARTERS OPENED ON CHAPMAN BOULEVARD, ORANGE, CALIF., ABOUT ONE MONTH AGO. STATED HE HELPED BY DISTRIBUTING LITERATURE IN BEHALF OF WALLACE AND WORKED FOR A TIME AS A DEPUTY REGISTRAR. STATED JOHN ORTMANN, YORBA LINDA, CALIF.,

HARRY E. ANDERSON, President, L&A Supermarket #2, 800 Pennsylvania Ave., Savannah, Ga., advised his son, JAMES H. ANDERSON, was recently in Mexico but has been back in Savannah for about two weeks. He said his son, who is 33 years of age, left him to take care of the store without saying he was going and then after being in Mexico had to call back for money because some hotel down there refused to accept his credit card. He said his son has not been back in the store since his return to Savannah because of their differences.

Mr. ANDERSON advised that he and his son were in the store at the time MARTIN LUTHER KING, JR. was killed and that thereafter they went to a local restaurant with other employees in the store for a steak. J. C. DAVIS, a clerk in the L&A Supermarket, verified this matter without any prompting.

JAMES H. ANDERSON was interviewed by SAs WILLIAM J. ROEMER and CLAUDE M. O'HARA. He said he departed Savannah by Delta Airlines on about 4/30/68, and took Delta to Dallas where he was to take Braniff to Mexico City. He was just a few minutes late at Dallas and had to take a later flight on Pan American Air Ways to Mexico City. At Mexico City he registered at the Marie Isabella Hotel where he stayed

until Sunday, 5/5/68. He had to leave the hotel because of a convention. He then went to the Alfer (PH) Hotel where he stayed until about Wednesday. He left Mexico City on Wednesday via Mexicana Airlines at Madrias (PH) in the Yucatan Peninsula and spent one night at the Madrias Hotel. The next day he flew from Madrias to the Island of Iznio (PH) where he stayed for a week in the best hotel on the island. There is no telephone service on this island. When he got ready to leave, the hotel declined to accept his American Express or Diners Club credit cards. He had to go back to Madrias where he wired home for money to pay his expenses back to the states. He took a plane out of Madrias back to New Orleans and then back to Savannah arriving in Savannah either Wednesday or Thursday night, 5/15 or 16/68.

He denied having a pistol in his possession at any time.
