This is the case involving the murder of Martin Luther King, Jr.

The Royal Canadian Mounted Police (RCMP) advised us they received information from the Superintendent of Security, Department of Transport, Ottawa, to the effect that a female employee, who wishes to remain anonymous, had confided to her superior that she met with James Earl Ray on three occasions, once in the Laurentians, once in Ottawa, and once in Montreal. These meetings, according to the RCMP are believed to have taken place prior to the murder of Martin Luther King, Jr.

According to the RCMP, this woman recently received a telephone call from William Bradford Huie in Alabama. Huie, author, whose books include, "Three Lives for Mississippi" dealing with murder of the three Civil Rights workers in June of 1964, previously advised us that he entered into a contract with James Earl Ray to write the true account of Ray's activities and background concerning the assassination of King. Huie contacted this individual concerning her activities with subject, James Earl Ray, and she met Huie in Canada. Huie informed her that he was writing a book concerning Ray and paid her \$100 for information concerning her association with Ray and to be photographed.

She provided Huie with information concerning her activities with Ray, including the fact that she was intimate with Ray on one occasion and she knew Ray as Eric Galt.

She related to the RCMP that she was very concerned about the possibility of her name and photograph appearing in Huie's book and in this regard she was advised to consult a lawyer.

The RCMP has requested that this information be positived within the FBI and they are endeavoring to confirm the story of this individual.

ACTION: For information. The substance of the information concerning the anonymous woman appears in the November 12, 1968, issue of "Look."

Mr. Michael Swyers, 42 South Court Street, Athens, Ohio, furnished the following information to Extra-Duty Supervisor Mr. Wilburn K. DeBruler, 1:42 p.m., 10/26/68:

Swyers advised that he is an artist and that he is reasonably certain that a photograph of James Earl Ray wearing a Ku Klux Klan robe is contained in "Look" magazine dated 4/25/61, Volume 25, Number 9. He said that he had informed Mr. Tassillo of the "New York Times" today concerning his observation and felt he should also furnish this information to FBI Headquarters.

Swyers explained that he has worked in the past with Special Agent Mack Ellis, Resident Agent, Athens, Georgia. Swyers said he felt this information might be of importance should it develop that Ray was in fact a former Klansmen.

### ACTION:

The above issue of "Look" will be obtained and reviewed in an effort to resolve whether the person referred to by Swyers is identical with James Earl Ray.



At this time, I respectfully make a formal request of your office that you direct a request to the Portuguese Foreign Office that Fernando E. da Silva Pais, Director da Policia Internacional e de Defesa do Estado, be permitted to visit the United States of America in order to accompany witnesses to this country, who will be named in the next paragraph, in conjunction with the trial of the State of Tennessee against James Earl Ray, which trial is scheduled to begin in Memphis, Shelby County, Tennessee, United States of America, on November 12, 1968.

It is further respectfully requested that Senor Jose Manuel Da Cunha Passo and Antonio Rocha Fama, Passport Inspector with the National Police of Portugal, be permitted to visit the United States of America so that they may testify as witnesses for the State of Tennessee in the trial of the State of Tennessee vs. James Earl Ray It is also respectfully requested that Senor Passo bring with him the records pertaining to Ramon George Sneyd.

If permission is granted to allow the above-named persons to visit the United States, the State of Tennessee will pay their expenses as follows:

Payment for transportation from Lisbon, Portugal to the Point of Entry into the United States; then ten cents  $(10\phi)$  a mile from the Point of Entry into the United States to Memphis, Tennessee; plus five dollars (\$5.00) a day every day they are in attendance as witnesses; the State of Tennessee will pay the witnesses ten cents  $(10\phi)$  a mile from Memphis to the Point of Exit from the United States and then their transportation from the Point of Exit of the United States to Lisbon, Portugal.

I wish further to inform you that the said witnesses' lodging and meals during their stay here in Memphis, Tennessee will be paid for by the State of Tennessee.

When this office is notified to the effect that permission is granted and the witnesses are available to come to Memphis, Tennessee, I will arrange to have the funds forwarded to each witness to purchase a round trip airline ticket, tourist class, plus an incidental expense fund, in order to enable the witnesses to make said trip. This amount advanced will then be deducted from the total amount due the witnesses upon their being paid their additional witnesses' fees here in Memphis.

In view of our trial date being November 12, 1968, it is important for us to be notified as soon as possible whether the permission for these witnesses to enter the United States will be granted.

Although the trial date is set for November 12th, it is not expected that the persons named above will be needed on that date as it will probably take us some time to select a jury, and we will have other witnesses to offer in evidence prior to the need for the presence of the above-named persons. I estimate that it will be the early part of December before the presence of the above-named persons is needed, and when you notify us that permission has been granted for their attendance, we will give you and them approximately one week's advance notice in order that they might complete arrangements for their trip. It is anticipated that the presence of the above witnesses will not be needed in Memphis more than the time necessary for them to testify at the trial, and in no event will they be required for more than three or four days.

As you know, three of the men from this office recently visited Lisbon regarding pre-trial work in the instant case. Each of these three men was extremely complimentary and grateful for the treatment they received while in Lisbon, and I wish to express my personal and sincere appreciation to you, Mr. Harvey R. Wellman, and to Mr. Doyce Ray McNaughton for the assistance you have rendered this office.

### Doctor Reports Surgery On Patient Named Galt

HOLLYWOOD, Calif., Oct. 29. — (AP) — A man who identified himself as Eric Galt underwent plastic surgery in Hollywood "sometime before the assassination" of Martin Luther King Jr., an attorney for the physician said Tuesday.

The lawyer for Dr. Russell C. Hadley said the plastic surgery was minor, of the type which would not materially change the man's appearance. He declined to give any details. Hadley referred all questions to the lawyer, Bennet Olan.

Although James Earl Ray, held in Shelby County Jail at Memphis on a charge of killing Dr. King, used the name Eric Starvo Galt while attending a bartending school in Los Angeles, it was not determined that he underwent plastic sur-

The FBI reported that a man named Galt was graduated from the bartending school last March.

Olan said it was done "three or four weeks, I think" before the Negro civil rights leader was shot to death last April 4 in Memphis. He said Galt apparently asked the Los Angeles County Medical Association for the name of a qualified plastic surgeon in the Hollywood area because he told Dr. Hadley that the association had referred him.

"As soon as we discovered who the patient had been, the case was reported to the FBI," said Olan.

He said author William Bradford Huie had looked over Hadley's records after obtaining authorization from Galt. Without such authorization, he said, no one will be allowed to see the records.

The attorney said he doesn't think Hadley, a medical doctor, has been subpensed as a witness.

### Ray Article May Court Action

Possible contempt action against Alabama author William Bradford Huie was reported to be under consideration today following publication of a Look magazine article hinting of a conspiracy in the murder of Dr. Martin Luther King.

Members of Criminal Court Judge W. Preston Battle's legal advisory committee were planning to meet and discuss the story, it was learned by The Press Scimitar.

Meanwhile, in another legal move designed to assure a fair trial for James Earl Ray, accused of killing King, Judge Battle yesterday issued a new court order barring witnesses under subpoena from reading or listening to news accounts of the Ray case from the time the taking of testimony begins in the trial until they have completed their testimony or are excused by the court.

### **EXCEPTION**

Judge Battle added, however, that the order does not apply to Ray personally.

The magazine article brought no comment from Judge Battle. However sources described him as "very upset." It was understood that Judge Battle had given Huie permission to obtain information in writing from Ray through his attorneys on condition that nothing be published in advance of the trial, scheduled to start Nov. 12.

The Look article also brought "no c o m m e n t s" from state and defense attorneys.

### **RETURN FROM TRIP**

Robert K. Dwyer, executive assistant attorney general, declined to comment with a laugh. "I guess you can quote me as laughing," he added. "I don't know whether the court order forbids that or not."

Dwyer and another prosecutor in the Ray case. James Beasley, have just returned to Memphis from a weeklong trip to Canada and Europe, it was learned. The two state attorneys apparently were retracing Ray's alleged escape route and interview-

ing witnesses. They reportedly visited Mastreal, London, Lisbon and Paris.

It is expected that the state will summon a number of witnesses from out of the country to testify at the trial.

Huie has stated that he is Ray's official biographer by contract and that Arthur J. Hanes, Ray's attorney, has been cooperating by relaying the questions and Ray's answers between the writer and the defendant.

### WRITTEN ANSWERS

The Look article is based on written answers to questions submitted by Huie to Ray in his Shelby County jail cell, according to the writer. Huie said he was not allowed to interview Ray personally.

The article says Ray told Huie that he met a mysterious contact man named "Raoul" in Montreal, Canada, in August 1967 while he was being sought by U.S. police for his escape from the Missouri State Penitentiary

Ray went to Canada in hopes of getting a Canadian passport that would allow him to leave for a Latin American country, Huie wrote. In Montreal Ray assumed the alias of Eric.S. Galt, and took up residence on the waterfront, a district notorious for international crime.

In bars and cafes and

among merchant seamen Ray "sort of let the word get around that he had had a little trouble down in the States, that he was looking for ID (identification) and capital, and just might be available for activities that Date: didn't involve too much risk, Edition: the article said.

"This resulted in a contact. A man whom Ray calls Raoul and describes to me as being a blond Latin about 35, and whom Ray took to be a seaman, showed interest in him," the article said.

"They began cautious verbal exploration. With Raoul hinting that if Ray was willing to assist certain projects, Raoul might be able to provide Ray ID and capital.

Huie quoted Ray as saying that on subsequent meetings with Raoul in a waterfront bar called the Neptune Tayern, Raoul offered him \$12,000 to perform a mysterious mission, and he was asked to make several trips across the border carrying packages in his car. Afterward, he was to sell the car and go by train or bus to Birmingham. "There, Ray would lie low, take no risks, pull no holdups, accumulate little ID and wait for instructions by general delivery mail," the article continues.

Raoul would help him with living expenses and buy him a car in Birmingham, and then "after a few weeks or months, after a little joint activity, Raoul would pay Ray \$12,000 and give him a passport and other ID and help him go anywhere in the world."

Ray was quoted as saying the proposition was made to him on condition that he ask no questions. "Ray told me: 'Every time I tried to ask Raoul a question, he told me straight to remember that he wasn't paying me to ask questions," the writer said.

### STICKUP

The article also describes a stickup Ray says he pulled at a house of ill repute to get "capital." It also tells of a romance between Ray and an unnamed woman said to work for the Canadian government. Huie said he interviewed the woman in Montreal and found her to be "a cultivated, sensitive, efficient, tastefully dressed and coiffeured mature woman."

Of Ray himself, Huie says that "those who have called him stupid are mistaken. His doesn't look like a criminal but he thinks like one."

He said Ray expresses himself well, has a good memory and Ray draws accurate diagrams showing the location of motels, bars, rooming houses and other places he visited or saw while on the run.

Huie includes several samples of Ray's writing.

As in most installment articles, this one leaves questions hanging. Look said Huie's article is the first in a series dealing with Ray and the assassination of Dr. King.

## 6 More Join Trial Lineup

Reporter, Attorneys Added
To Witnesses List
For Ray Case

Subpena papers were turned on six more witnesses in the James Earl Ray case yesterday, including two attorneys and a newspaper resporter.

The new witnesses are Harv ey Gipson and William E Friedman, attorneys for material witness in the Ray case, Charles Q. Stephens, William B. King and Charles E. Stone, city firemen who manned the ambulance that took Dr. Martin Luther King Jr. to St. Joseph Hospital the night he was slain; Guy Canipe Jr., owner of an amuse ment company at 424 South Main where a high-powered fig. fle was found moments after the shooting, and Gregory Jaynes, a reporter for The Commercial Appeal.

## Ray May Have Had Plastic Surgery

HOLLYWOOD, Calif. — (AP) — An attorney says a man who gave his name as Eric Galt underwent minor plastic surgery before the assassination last April of Dr. Martin Luther King Jr.

The lawyer, Bennet Olan, declined Tuesday to give details of the surgery performed by Dr. Russel C. Hadley except to say it was of the type which would not greatly

change his appearance.

Investigation has reported Eric Galt was an alias used by James Earl Ray, now facing trial in Memphis on a charge of murdering King.

### **OPERATION**

Olan said he thought the operation was performed three or four weeks before the assassination on April 4. "It may have been on the 4th or the 11th of March. I forget which," he said.

The surgeon referred all questions to Olan. The law-yer said it's believed Galt sought out Dr. Hadley through the Los Angeles County Medical Association. At any rate, Olan said, Galt told the doctor the association had recommended him.

Assistant Attorney General Stephen J. Pollak called and stated that he had talked to Phil Canale, State Attorney General, Shelby County, who will prosecute Ray in state court. According to Pollak, Canale inquired whether the Bureau was doing a three dimensional mockup for Canale for use in his prosecution of Ray. Pollak said he was not making a request that such a mockup be prepared but merely wanted to know if in fact we were preparing one for Canale, so he could so advise Canale.

No request for such a mockup has been received in this Division and a check with the Exhibits Section revealed that no such request had been made of that Section.

In the absence of SAC Jensen, ASAC Halter of Memphis was contacted to determine whether Canale had ever made such a request of the Memphis Office. Halter stated that he personally was not aware of any such request but would check with SAC Jensen and see if Jensen was aware of any such request.

Subsequently SAC Jensen called and said the Memphis Office had received no request for the preparation of such an exhibit. Jensen said he had called Canale and determined that when D. Robert Owen of the Civil Rights Division of the Department had been in Memphis consulting with Canale on the prosecution of the case, Owen said he understood the Department was preparing a three dimensional mockup for Canale's use. Canale inquired yesterday (10/30/68) of Owen's secretary, who is in Memphis assisting Canale, of the status of the exhibit. She replied she did not know but would check on it and let Canale know.

# 2 Won't Talk In Ray Case

Two Me mph is lawyers subpoenced by the defense as witnesses in the James Earl Ray case today balked at testifying.

The witnesses, Harvey Gipson and William E. Friedman, filed a petition asking that Ray's attorney, Arthur J. Hanes, be required to show cause why they were subpoenaed.

If Hanes is unable to show cause why their testimony is needed, they will ask Criminal Court Judge W. Preston Battle to enjoin Hanes from

enforcing the subpoenas.

Gipson and Friedman represent Charles Q. Stephens, a key state witness now under police protection. Stephens reportedly saw the killer of Dr. Martin Luther King Jr. in the hallway of a rooming house at 422½ S. Main moments after the shooting.

Stephens was jailed earlier as a material witness at the state's request, but the two lawyers went to court and got him released.

So far, subpoenas have

been served on 10 defense witnesses, to testify at Ray's trial, scheduled to begin Tuesday, Nov. 12. The latest to receive process was Lloyd Jowers, a Veteran's Cab driver and operator of Jim's Grill on S. Main, near the shooting scene.

Several customers in the grill are reported to have seen a white Mustang parked out front the day of the murder. The state contends Ray made his getaway in a white Mustang after killing the civil rights leader with a high-powered rifle.
