Records of Auto Registration Section, Springfield, Ill., reflect that on 6/5/67, one GEORGE SEYMOUR HELLER, Chicago, Ill., sold 1959 Chrysler to JOHN LARRY RAYNS of Winnetka, Ill. License plates transferred from this car to 1962 Plymouth purchased by RAYNS 7/14/67, from Bundy Oldsmobile, Inc., East St. Louis, Ill. This Plymouth sold by JOHN L. RAYNS 8/25/67, to JERRY W. RYAN, Northbrook, Ill., who, in turn, sold it on 10/20/67 to GJERDIS DOROTHEA RAY of Deerfield, Ill. During August, 1967, subject associated with female employee Canadian government, but there is no evidence she used her official position to assist him. Investigation at Windsor, Canada, and Detroit, Michigan, fails to verify that subject paid customs duty on television set on 8/21/67; that he spent night of 8/21/67 near Gary, Indiana; or that he spent one night during early October, 1967, at Nuevo Laredo, Mexico; as stated in "Look" magazine articles by WILLIAM BRADFORD HUIE. Subject spent night of 8/26/67 at Granada Hotel, Birmingham, Ala., registered as JOHN L. RAYNS or RAYMS. One ERIC S. GALT spent night of 3/22/68 at Flamingo Motel, Selma, Ala. Guest registration card is in possession of ARTHUR HANES, subject's former attorney. Revolver found in subject's possession when arrested in London had been purchased in about October, 1967, from WALTER L. SPAIN, Birmingham, Ala. Information concerning RAY's Canadian passport and concerning his activities in Lisbon, Portugal, is set out.

AUTOMOBILES IN THE POSSESSION OF JAMES EARL RAY FOLLOWING HIS ESCAPE FROM THE MISSOURI STATE PENITENTIARY ON APRIL 23, 1967

On November 26, 1963, Mr. JOHN L. WEST, Salesman, Bundy Oldsmobile, Inc., 8th and Illinois, East St. Louis, Illinois, advised that records of his company indicate that JOHN L. RAYNS, 507 Chestnut, Post Office Box 293, Winnetka, Illinois, purchased a 1962 Plymouth, four-door, Sedan, VIN 2921165934, on July 14, 1967, as per invoice #6852. Mr. WEST advised that this invoice indicates that the price of the above car was \$200. In addition, there was sales tax in the amount of \$9.50 and a notary fee in the amount of 50 cents, bringing total price of the automobile to \$210. Mr. WEST further advised that his records indicate that RAYNS made a cash deposit of \$20, as per receipt #38466 dated July 14, 1967, and apparently returned shortly thereafter with the balance of \$190, as the records indicate receipt #33469 dated July 14, 1967, indicate RAYNS paid this amount. WEST pointed out that although he could not be specific as to the time element involved between the period of time that the \$20 cash deposit was paid and the balance of \$190 was paid, it was apparently only a metter of a few minutes to an hour, since there were only two receipts issued between deposit receipt and balance receipt given to RAYNS.

Mr. WEST pointed out that there was no trade-in involved in the transaction. He also advised his file on RAYNS indicates Illinois sales tax form #1978804, which was dated July 14, 1967, was completed on that date and this along with the license information was mailed to the Secretary of State's Office, Springfield, Illinois, on July 31, 1967. Mr. WEST stated that from his records he had to assume RAYNS transferred his license from a previously owned automobile to the 1962 Plymouth, inasmuch as he was able to find a receipt #463, in the amount of \$3.00, which is the fee normally paid for transfer of title. Mr. WEST stated if an individual purchases an automobile and applies for a new license, he would be charged a minimum of \$7.00.

Mr. WEST advised he recalled that the 1962 Plymouth was taken into Bundy Oldsmobile as the trade-in from an unrecalled Negro male who had purchased a new Cutlass, about a month prior to the transaction with RAYNS. WEST stated that the salesman who sold the car to RAYNS was GOBEL BIGGS.

Mr. WEST stated he could not specifically recall the sale of the automobile to RAYNS. He stated photographs of JAMES EARL RAY were unfamiliar to him. He likewise showed photograph to other sales personnel at Bundy Oldsmobile and they, too, stated that they could not recall RAY as ever having been in Bundy Oldsmobile. WEST did point out, however, that his business is primarily the sale of new cars and used cars of a higher quality than the automobile sold to RAYNS. Therefore, the transaction was somewhat insignificant and he was unable to recall any further specific details and was only able to furnish the above information as direct result of review of the receipts, invoices and orders set forth above.

Mr. GOBEL BIGGS, Salesman, Bundy Oldsmobile, Inc., East St. Louis, Illinois, after reviewing the invoice orders and other receipts pertaining to the sale of 1962 Plymouth. four-door, Sedan, VIN 2921165934, which he sold to JOHN L. RAYNS, 507 Chestnut, Post Office Box 293, Winnetka, Illinois, stated he could not recall this individual or anything of the transaction. Mr. BIGGS advised the transaction was rather insignificant and it involved the sale of a "junker" with \$200, and he could have possibly remembered more about the man had he sold the individual a new car or a used car in better Mr. BIGGS did state, however, that he still has in condition. his possession a "follow-up information card" for JOHN L. RAYNS with the address of 507 Chestnut, Post Office Box 293 Winnetka, Illinois, and he indicates on this card that RAYNS purchased a 1962 Plymouth on July 14, 1967. Mr. BIGGS stated it is the policy at Bundy Oldsmobile for all salesmen to send new car literature to individuals to whom they have sold automobiles in the past; and, based on this information card, he is relatively certain that he has sent such literature to RAYNS at the above address on at least seven or eight occasions, since the initial purchase of the 1962 Plymouth. He stated no has no way of knowing whether this literature was received by RAYNS at this address or whether it was returned by the Post Office. He stated if such literature would have been returned by the Post Office to Bundy Oldsmobile, it would have just been destroyed; therefore, he would have no way of knowing

whether or not it was actually received. BIGGS, upon viewing photograph of JAMES EARL RAY, stated he could not associate this individual with being identical with RAYES and was unable to furnish any other details as to the transaction, including the manner of payment, although he was certain from the invoice and receipts that this automobile was paid for in cash.

Mr. JAMES TABOR, Supervisor, Auto Registration Section, Secretary of State's Office, Springfield, Illinois, advised on November 27, 1968, that a check of records reflect that 1967 Illinois license LM-5942 was issued June 5, 1967, to JOHN LARRY RAYNS, 507 Chestnut, Box 293, Winnetka, Illinois, for a 1959 Chrysler, two-door, VIN M531108240, which was purchased used June 5, 1967, from GEORGE SEYMOUR HELLER, 7102 North Sheridan Road, Chicago, Illinois. Certificate of Title #B1178475 issued June 6, 1967, to RAYNS for this vehicle with no lien. On August 8, 1967, above-mentioned 1967 Illinois license transferred to RAYNS for a 1962 Plymouth, four-door, VIN 2921165934, which was purchased used July 14, 1967, from Bundy Oldsmobile, Inc., 711 Illinois Avenue, East St. Louis, Illinois. The application for this transfer reflects that above-mentioned 1959 Chrysler to be sold later. Certificate of Title #B1604563 issued August 8, 1967, to RAYNS for instant Plymouth with no lien.

Mr. TABOR also advised that 1967 Illinois license RT-5302 was issued 8/28/67 to JERRY W. RYAN, 2897 Techny Road, Northbrook, Illinois, for instant Plymouth, purchased used August 25, 1967, from JOHN L. RAYNS, 507 Chestnut, Winnetka, Illinois. Certificate of Title #B1777474 issued September 7, 1967, to RYAN for this Plymouth with no lien.

Mr. TABOR also advised that 1967 Illinois license SC-7905 was issued October 25, 1967, to GJERDIS DOROTHEA RAY, 1344 Hazel Avenue, Deerfield, Illinois, for instant 1962 Plymouth, purchased used October 20, 1967, from JERRY W. RYAN, 2897 Techny Road, Northbrook, Illinois. Certificate of Title #B2105425 issued November 6, 1967, to RAY for this Plymouth with no lien and has not been surrendered to date.

On November 29, 1968, Mrs. GENEVA JONES, Supervisor, Driver's License Section, Secretary of State's Office, Springfield, Illinois, advised she could find nothing in her files identifiable

with GJERDIS DOROTHEA RAY. Concerning JERRY W. RYAN she furnished the following:

On April 19, 1968, Mr. WILLIAM KAUFMAN, Illinois State Board of Probation and Parole, Springfield, Illinois, advised that one JERRY WILLIAM RAY, also known as JERRY WILLIAM RYAN, white male, date of birth at Quincy, Illinois, 5'10", 170 pounds, with brown hair and brown eyes, was the brother of JAMES EARL RAY.

#### FEDERAL BUREAU OF INVESTIGATION

GEORGE SEYMOUR HELLER, 1337 West Fargo, Chicago, Illinois, phone 262-4854, was interviewed at his place of employment, the Bernard Harwich branch of the Jewish Community Centers of Chicago, 3003 West Touhy, Chicago, Illinois, phone RO 1,-9100, where he is employed as a social group worker. Mr. HELLER advised that some time in the summer of 1967, he ran an ad in the "Chicago Tribune" for the sale of a 1959 Chrysler, green over white. He said that the manager of the Sunoco Station, Lunt and Western Avenue, Chicago, Illinois, named MAURICE (LNU), acted as his agent. the ad had been run in the paper, he réceived a call from MAURICE (LNU), telling him that a party had called about the car and would be at the gas station. HELLER went to the gas station and waited for the purchaser to arrive. first observed the purchaser alone walking into the gas sta-This individual was dressed in a green jacket, dressed almost as in a government issued fatigue jacket and green pants. He was neat and clean and had no unusual characteristics. Mr. HELLER was exhibited a group of nine photographs, three of which were photographs taken at different times of JAMES EARL RAY. Mr. HELLER picked out photo number 00416 dated January 4, 1966, and stated that this photograph would be the closest resemblance to the purchaser of his car; however, he could not state definitely that the individual represented by this photograph was identical to the purchaser. He also advised that he has seen numerous photographs of JAMES EARL RAY in the news media and has never once associated him with the purchaser of his Chrysler He was shown additional photographs of RAY and stated that he could not say that RAY was identical to the purchaser.

He said that his overall impression of RAY was that he was "lanky" and of the "hillbilly type". He commented that RAY was extremely quiet and said no more than a dozen words during their conversation, which was completely about the Chrysler. RAY made no comment as to his residence, employment, or any other matters of a personal nature. RAY also made no comment concerning the reason for the purchase of the car and in fact seemed to have very little interest

at HELLER's comments concerning the vehicle. RAY made no mention of utilizing the car for a long trip and asked no questions as to the roadability of the car. He appeared to be purchasing it merely for transportation. RAY also did not argue about the price and paid in cash the \$200, which was HELLER's asking price. HELLER further related that there was nothing unusual about the money, that he did not believe it was new currency, and he could not recall the specific denominations of the bills.

HELLER advised that the only thing that stuck in his mind concerning RAY was that he was very quiet. HELLER took the Illinois license plates off of the car and RAY drove it away. HELLER had no further contact with him.

FEMALE EMPLOYEE OF CANADIAN GOVERNMENT WITH WHOM JAMES EARL RAY WAS FRIENDLY DURING PERIOD AUGUST 4 - 20, 1967

The Royal Canadian Mounted Police advised that on October 8, 1968, information was received from the Superintendent of Security, Department of Transport, Ottawa, Canada, to the effect that a female employee who wishes to remain anonymous had confided to her superior that she had met with RAY on three occasions, once in the Laurentians, once in Ottawa, and once in Montreal. These meetings are believed to have taken place prior to the murder of Dr. MARTIN LUTHER KING.

Recently this woman has received telephone calls from WILLIAM BRADFORD HUIE in Alabama, asking her about her association with RAY. This person is now concerned about the turn of events and consented to be interviewed by a member of this Force relative to her association with RAY.

On October 15, 1968, this individual was interviewed and the following information was obtained from her:

"On the 4th of August 1967, my girlfriend and I went to St. Jovite, P.Q. to spend the long weekend. We arrived there at around 7:00 p.m. and registered at the "Petit Manoir" Inn. We had supper and then decided to go to the Grey Rock Resort for the evening. As we entered the lounge, we saw a man sitting alone at a table facing the Dance Floor. girlfriend said 'That man is alone, let's see if we can sit with him.' She approached him and he invited us to sit at his table. He introduced himself as Eric Galt and said that he was on holidays from Chicago and was staying at the Grey Rock. also mentioned that his brother and his sister-in-law had come up with him from Chicago and that they had left for Montreal. He said that he had been there for about one week and that he would be leaving within the next few days for Montreal to meet his brother. At around Midnight, my girlfriend said that she was not feeling well and she returned to the Petit Manoir. Eric and I went to the Manoir Pinoteau to see the entertainment. We returned to Grey Rock at around 4:00 a.m. and I spent the rest of the night with him in his room, I was intimate with him. I did not notice anything unusual about

him. He was quiet, polite, neat and reserved. The next morning, I left him at around 11:00 a.m., at which time he told me that he was leaving for Montreal. He said that he did not know where he would be staying in Montreal, but that he would like to see meagain and that he would call the Petit Manoir and let me know where he was staying. He was driving an old red Plymouth around a 1956 model. I did not look at the license plates.

He called around supper time and since we were out, he left a message with the desk advising to call a number in Montreal. I called and talked to a desk clerk at a hotel in the East end of Montreal. She gave me the address and the number of the room where Eric was staying. He was not in at the time. On Monday, the 7th of August, my girlfriend and I drove down to Montreal and went to the hotel to see Eric. I don't remember the name of the hotel except that it is around the corner from the Acapulco Club. We met Eric in the hall and he appeared pleased and surprised to see us. We shared his quarters during the two nights we spent in Montreal. He was not intimate with either of us in Montreal. He took us out to the Acapulco Club and to restaurants. He seemed to have money and appeared to pay for everything with Canadian \$20.00 bills. In fact, he gave me a Twenty before we left Montreal, in case I had car trouble. I gave him my address in Ottawa.

Some three weeks later, he called me and said that he was in Ottawa staying at the Town and Country Motel for the weekend. He stayed in Ottawa for two days and I showed him around Ottawa. I did not stay with him at the Town and Country. He did not appear to know anyone in Ottawa. I don't recall him saying where he was coming from, but I assumed it was Montreal. He did not have a car and probably came by train. He mentioned that he was working for his brother in Real Estate and that he did not do much but was paid well. He also said that he had no problems with money and could always get some.

He never mentioned any friends or associates besides his brother and I never saw him with anyone. He never mentioned the name Martin Luther King and never indicated any hatred toward any Negroes. I did not hear any more from him until around March 1968 when I received a letter from him postmarked Hollywood, California. I don't remember the address and have since destroyed the letter and envelope. The letter was short and did not contain much of interest. He was inquiring as to when I was taking my holidays and said if I write, to do it soon because he would not be at that address after a couple of weeks. I received the letter some three weeks before the assassination of Martin Luther King.

When I heard that Eric Galt had been arrested and was implicated in the murder of Dr. King, I panicked and destroyed the letter.

About one month ago, I received a phone call from one William Bradford Huie who said that he was writing a book about James Earl Ray and when he mentioned the names Grey Rock and Eric Galt, I knew that he must have gotten my name and address from Ray. I agreed to see him and we met for lunch at the Holiday Inn. At that time he showed me his credentials, his picture in Time Magazine with Ray's lawyer and some of his books. He was very charming and appeared to know all about my association with Ray, including the fact that I had been intimate with him. He appeared to be mainly interested in what I thought of Ray and I told him that as far as I was concerned, he was a normal man. He said that I would be the Mystery woman in his book and assured me that my name would not be mentioned. He had a photographer with him and I agreed to let him take smoky pictures which they assured me would show only shadows. He gave me \$100.00 for the information and invited me to go to New York at his expense, any time I felt like it, and to call him collect if I could remember anything else.

I have no other information to offer and the above is all I can remember about my association with James Early Ray alias Eric Galt."

The above information was obtained during several hours of questioning and our investigator is satisfied that it contains all that this informant knows about Ray.

She is very concerned about the possibility of her name and photograph appearing in Huie's book and in this regard she was advised to consult a lawyer.

The girlfriend mentioned has been contacted, however, she has no information of value to offer. She could not remember the name of the hotel where they stayed in Montreal and could not elaborate on any of the points covered by the informant.

The Royal Canadian Mounted Police (RCMP) advised they have again interviewed the female who met with James Earl Ray in Canada during the Summer of 1967, and she furnished the following information:

"Further to my statement dated October 15, 1968. I wish to state that James Earl Ray never mentioned anything about Passports to me. The first time the subject was mentioned was when William Bradford Huie came to see me. He said that Ray had told him that he intended to use me to obtain a Canadian Passport, but changed his mind because he figured that I would turn him in to the Police. In my position with the Department of Transport, I would not risk my job by helping someone fraudulently obtain a Canadian Passport. The article in "Look" Magazine is factual with a few minor discrepancies. I did not show Ray the RCMP Headquarters and only received one letter from him, not letters as mentioned in the article. After reading the article, I remembered that the name of the hotel where we stayed with him in Montreal was the Har-K on Notre-Dame Street. I have a sister who is employed by the Registrar of Citizenship, but I am positive that I never mentioned her name or employment to Ray. I told her about my involvement with Ray only after Huie's visit."

The RCMP also interviewed the sister and she stated as follows:

"I have been employed at office of the Registrar of Citizenship for the past three years. About one and a half months ago, my sister told me about her involvement with James Earl Ray. It was after Huie's visit to Ottawa to see her. At no time did my sister ever ask me to help her obtain a passport for anyone. In fact, she never mentioned the word passport during the course of our conversation. The reason that she came to me after Huie's visit was that she was very worried and needed to confide in someone close to her. My sister is a very honest and dependable person, and her only fault is that she is a little too naive."

The RCMP investigator advised:

"I am satisfied that Ray did not mention anything about Passports to the female. I am positive that she is an honest person, placed in a very embarrassing position by her association with Ray."

The girlfriend of the female who consorted with Ray advised the RCMP the following:

"During the first long weekend in August, I accompanied my friend to St-Jovite, P.Q., where we stayed at the "Petit Manoir" Inn. During the evening, we motored up to the Grey Rock Inn where we met a man who introduced himself as Eric Galt. I did not pay much attention to him and after a few drinks I went back to the Manoir. My friend stayed with him. I did not see Galt again until we visited him in Montreal the following Monday. Since it was impossible to find a room in Montreal because of Expo, we stayed with him during the two nights that we spent in Montreal. He took us out to the Acapulco Club. He seemed to have enough money to get along, but he did not strike me as being very prosperous. He never mentioned friends or associates and did not introduce us to anyone. He appeared to be a quiet and regular sort of a guy. He never mentioned the word passport to us. I never saw him again after we left Montreal. heard from my friend later that he had been to Ottawa to see her. After James Earl Ray's arrest, she called me and asked if I thought that he could be the man we had met. I did not think so at the time and was surprised when it turned out to be him."

Discreet inquiries at the Town and Country Motel, 1476 Richmond Road, Ottawa, revealed that ERIC GALT registered there on August 18, 1967, and left on August 20, 1967. He gave his address as 507 Chestnut Street, Chicago, Illinois, and was driving a Plymouth, License No. LM5942. He stayed in Cabin No. 30, which is not equipped with a telephone. Any calls made by him from one of the several pay phones at the

Motel would not go through the Motel Switchboard and be recorded. Although he registered as Mr. and Mrs. ERIC GALT, his female friend did not stay with him at the Motel, as mentioned in her statement dated August 15, 1968. The Desk Clerk on duty at the Town and Country Motel when RAY, alias GALT, registered, Mrs. EDYTHE COBLEY, is reported to be dying from terminal cancer and will not be interviewed.

TELEVISION SET ALLEGEDLY DECLARED AT U. S. CUSTOMS, DETROIT, MICHIGAN, ON AUGUST 21, 1967

An article by WILLIAM BRADFORD HUIE appearing in the November 26, 1968, issue of "Look" magazine quotes JAMES EARL RAY as saying that on August 21, 1967, he met one "RAOUL," otherwise unidentified, at Windsor, Canada, and on that date made two trips via automobile between Windsor, Canada, and Detroit, Michigan. According to this article, on one of these trips from Windsor to Detroit, RAY stopped at United States Customs and declared a television set which had been purchased in Montreal, Canada. RAY allegedly paid an import duty of \$4.50.

INVESTIGATION AT THE GRANADA HOTEL, FLAMINGO MOTEL, AND AT NUEVO LAREDO, MEXICO, AND GARY, INDIANA

An article by WILLIAM BRADFORD HUIE appearing in the November 26, 1968, issue of "Look" magazine quotes JAMES EARL RAY as saying that he departed Canada via Detroit, Michigan, on August 21, 1967, and spent that night in a motel about five miles east of Gary, Indiana.

This article further states that RAY spent the night of August 25, 1967, at the Granada Hotel, Birmingham, Alabama, and the night of March 22, 1968, at the Flamingo Motel in Selma, Alabama.

Additionally, this article describes a trip which RAY took to Nuevo Laredo, Mexico. While the exact dates are not given, HUIE states that RAY was in Nuevo Laredo, Mexico, after October 5, 1967, and prior to his arrival in Puerto Vallarta, Mexico. Previous investigation has determined that RAY arrived in Puerto Vallarta on October 19, 1967, and registered that date in the Hotel Rio.

All hotels and motels in Nuevo Laredo, Mexico, have been contacted, and no record was found to indicate that the subject RAY stayed at a hotel or motel in that town during the month of October, 1967, under either his true name or his aliases.

The following motels in the vicinity of Gary, Indiana, have been contacted, and their records for August 21, 1967, have been reviewed without success in locating a registration for the subject RAY under his true name or known aliases:

He stated he had no independent recollection whatsoever of the guest whom he had registered as RAYNS or RAYMS on August 26, 1967, but that his notation indicated the guest did not have luggage, and occupied Room 210 at a rate of \$4.50 per day, with only the guest being indicated as in the party. No telephone charges were made to the room and the method of arrival of the guest was unknown. The time of departure was not indicated in the records of the Granada Hotel.

Mrs. BESSIE BARRETT, owner and operator of the Flamingo Motel, Highway 30 East, Selma, Alabama, telephonically furnished the following information:

She recalls locating a registration card for one ERIC S. GALT, which she believed was dated March 24, 1968. She stated that she recalls locating this card because she was contacted by an ARTHUR HANES, who is an attorney from Birmingham, Alabama. She advised that Mr. HANES came to the motel and asked her if she recalled an individual by the name of GALT staying at her motel. She stated that HANES had indicated to her that this individual, by the name of GALT, had been identified as the killer of Dr. MARTIN LUTHER KING. She told HANES that she would never knowingly permit any individual such as this to stay at her motel and she could not recall any individual that looked like the photographs of this person, which appeared in the paper, as staying at the motel.

HANES requested that she review registration cards for the dates of March 1, 1968, through March 25, 1968, and after reviewing these cards she found a registration card for an ERIC S. GALT. HANES requested that she allow him to take this car with him. Mrs. BARRETT said she relinquished possession of the car to Mr. HANES and she believes it is in his possession at the present time.

Mrs. BARRETT stated that the bookkeeper for the motel is a Mrs. THELMA GARDNER, Services Unlimited, 1353
Madison Avenue, Montgomery, Alabama, and Mrs. GARDNER would have a "sheet record" of the motel occupants which would show the date, name of person, room he occupied, and charges; however, would not contain any information concerning make, model or license number of the individual's automobile or the address he listed as being his home.

Mrs. BESSIE BARRETT, owner and operator of the Flamingo Motel, advised as follows:

She and her husband maintain some handwritten notes relative to telephone billings of various individuals who stay at the motel and who might make a local or long distance call from his or her motel room. She reviewed these notes for March 22, 1968, when an individual named ERIC S. GALT occupied Room Number 3 at the motel for a one day period. She could find no record of this individual making any calls for which he was billed. She stated that she could not review the original registration card as it is still in the hands of ARTHUR HANES, an attorney in Birmingham, but a copy of this card appeared in a Look magazine article of recent date. She pointed out the copy in the magazine article and commented that on the edge of the card is marked only "Pd". She stated that if any additional charges were to be added to the room charges, the word "over" is usually placed on the edge of the card.

Mrs. BARRETT furnished the registration cards from the motel for the month of March, 1968. A review of all of these cards for March, 1968, failed to locate any name such as "RAOUL" or JOHN L. RAYNS.
