

ASSASSINATION OF MARTIN LUTHER KING, JR.

There is also correspondence in his file involving answers by the Division of Corrections of Missouri to Senator Thomas Eagleton of Missouri in response to inquiries prompted by letters Senator Eagleton received from Achter.

A Psychological Evaluation dated June 2, 1975 in Achter's file by James B. Gross, M.A., Clinical Psychologist III, includes the following information:

"...Achter admitted that he spends a great deal of time thinking about just how he would conduct the legal defense of James Earl Ray: 'I don't believe I would have any sweat whatsoever, easiest case I have ever seen.' Asked if this case might make him famous, inmate replied with great feeling: ' (obscene) ', yes, that would be THE publicity case of the world---that would be a big step in history; I've laid out a number of allegations, I've had the FBI here."

Gross noted in his report that Achter claims to be "legal-educated", but actually has had no formal legal training whatsoever, and his evaluation was: "Impression: Schizophrenia, paranoid type."

On Interview on May 20, 1976, Achter stated that he remains interested in the James Earl Ray case, and his interest has been stirred by recent news articles about Ray. He noted that Newsweek magazine had an article recently indicating that Ray was a "dope pusher" in the MSP while an inmate, and he asserted that he knew Ray and knew that he was not a "dope pusher" and never had any money as indicated by the article. He said he recalls Ray ran a few "parlay tickets" on a "penny-ante" scale. He asserted that one Joe Maloney, a newspaper reporter for a newspaper in Kansas City, Missouri, formerly an inmate in the MSP and editor of the inmate newspaper, was never associated with Ray and had no basis for any information he wrote in a recent article he had published in the newspaper on Ray. Achter volunteered that it is his theory that Ray, as a con, would never have pulled the trigger on Martin Luther King and then left the rifle where it would be found and his radio, bearing his inmate register number at the MSP, where it could be found, at the scene. He stated that he has no information as to what actually happened and no information that anyone employed at the MSP was involved in assisting Ray's escape at the MSP. He offered that a former inmate at the MSP named Joe Hedgewood,

Pursuant to our meeting on Wednesday, May 5, 1976, and your telephone call of today, May 10, 1976, I am forwarding this memorandum with attachments for your information and records.

As you know, the Attorney General has directed this Office to complete the review of all records in the Department, at Bureau headquarters, and in Bureau field offices in any way relating to Dr. Martin Luther King, Jr., his assassination, the Bureau's investigation of his death, in light of the Bureau's "systematic program of harrassment of Dr. King in order to discredit him and harm both him and the movement he led". (See Press Release Attached)

The Attorney General has directed that this review be completed "forthwith" and that my final report to him and Director Kelley provide answers to four specific questions:

1) "Whether the FBI investigation of Dr. King's assassination was thorough and honest" MAY 25 1976

2) Whether there is any evidence that the FBI was involved in the assassination of Dr. King;

3) Whether, in light of the first two matters, there is any new evidence which has come to the attention of the Department concerning the assassination of Dr. King;

4) Whether the nature of the relationship between the Bureau and Dr. King calls for criminal prosecutions, disciplinary proceedings, or other appropriate action".

I know you share with me the urgent need to guarantee that these four questions be addressed by a searching, systematic, full, complete, and determined review of all documents that bear directly or even remotely on the Bureau's intense interest in and investigation of Dr. King in life as well as at death.

You have met the present members of the Task Force assigned to complete this review, and I have advised you that Fred G. Folsom is the Task Force Leader. You should understand that Mr. Folsom's requests for personnel interviews, access, review, or delivery of documents will be made at all times in my behalf and for the Attorney General. Should you have any difficulties I am always available to assist in their resolution.

As I have orally advised you, the Attorney General, Director Kelley, and I attach the highest priority to the successful completion of this review.

If I can be of further assistance, please advise. I wish to thank you for your help.

The last two items were obtained from the Civil Rights Division about a week ago and are attached to the Request for Production of Documents which I filed on May 4, 1976, and delivered to Mr. Dugan's office that same day.

PURPOSE: To advise the degree of access to our files given the Department Task Force of the Office of Professional Responsibility (OPR) which is assigned to review our past investigations relating to Martin Luther King, Jr. (U)

SYNOPSIS: Correspondence from the Department indicates that the current review of our King investigations by the OPR Task Force is a continuation of the "partial review" recently concluded by the Civil Rights Division of the Department under the direction of Assistant Attorney General J. Stanley Pottinger. Therefore, in absence of any information to the contrary received from the Department to date, personnel conducting the OPR review will have the same access to our files that was afforded the Pottinger review group. Under instructions from the Attorney General the Pottinger group was allowed to review raw files pertaining to King, his family, relatives, friends, associates and the Southern Christian Leadership Conference (SCLC) as well as files relating to COINTELPRO actions, electronic surveillance, all intelligence files and our complete file on investigation of the assassination of King. Based on discussions with OPR Counsel Michael E. Shaheen, the Task Force will review the assassination file, King and related security files, the SCLC file and our file on Stanley David Levison, whose association with King served as the basis to investigate King. Informant files will not be made available for review. It should be noted that current review by the OPR Task Force will include cover pages of communications containing identities of some Bureau confidential sources and informants who were not afforded symbol numbers at that time and individuals who expressed or implied confidentiality. This review commenced 5/10/76 in Room 4171 of the JEH Building with review of our files pertaining to King's assassination.

RECOMMENDATION: For information. (J)

DETAILS: The Attorney General has instructed the Office of Professional Responsibility (OPR) of the Department to conduct a review of our past investigations relating to Martin Luther King, Jr. By letter dated 5/10/76, Michael E. Shaheen, Counsel of the OPR, defined the areas of concern in the review which will include perusal of all King related records in the Department, at FBIHQ and in Bureau field offices. The review must be completed "forthwith" and is to answer the following four questions: (1) Was the FBI's investigation of King's assassination thorough and honest? (2) Is there any evidence the FBI was involved in the assassination? (3) Is there any new evidence which has come to the attention of the Department concerning the assassination? (4) Does the relationship between the Bureau and King call for criminal prosecutions, disciplinary proceedings or other appropriate action? (U)

DETAILS CONTINUED:

Attached to the above mentioned letter was a copy of a letter to Shaheen from the Attorney General dated 4/26/76, outlining the previous review of the King matter by the Civil Rights Division and the basis on which the Attorney General decided to order a more complete review. In this letter the Attorney General indicated that the OPR review is a continuation of the "partial review" completed by the Civil Rights Division under direction of Assistant Attorney General J. Stanley Pottinger. (u)

Since correspondence to date from the OPR has not dealt specifically with file access by the OPR Task Force, it is concluded that personnel conducting the OPR review will have the same access to our files that was authorized at the outset of the Pottinger review. (u)

The material/files desired by the Civil Rights Division in its review were set forth in a letter from Pottinger to the Director dated 12/4/75. In this letter Pottinger indicated the Attorney General had instructed his Division to review all actions taken by the FBI against King. Requested were all materials concerning King that were provided to the Senate and House Select Committees on Intelligence; all COINTELPRO proposals, actions and results of actions; all requests, approvals and results, including tapes, transcripts and logs of electronic surveillances; all intelligence files; and our complete file on the investigation of the assassination of King. This letter further stated that the Civil Rights Division was interested "in reviewing every single item in your files which relates in any way to Dr. King, his family, friends, associates or SCLC." It is further noted that the Attorney General (letter dated 12/12/75) authorized Pottinger personal access to tapes, transcripts of tapes and other sensitive information concerning King and his case file. DETAILS CONTINUED:

Based on discussions between Mr. Shaheen and Deputy Assistant Director James O. Ingram, it has been agreed the Task Force members will review the King assassination file, his security file and King related files on the SCLC, and influence of communists in racial matters. One King associate file the Task Force will want to see is the file on Stanley David Levison whose association with King served as the basis for instituting investigation of King. The Task Force will not have access to informant files including our sensitive informant operation which obtained information regarding King's communist connections. ~~(S)~~ u

It is noted that the above outlined access will allow the OPR to review all raw files in our investigation of King. Included will be cover pages of documents containing the identities of some confidential sources and potential informants who were not concealed by symbol numbers according to our policy at the time. Cover pages will also contain identities of individuals who have furnished information to us on an expressed or implied basis of confidentiality. This review commenced 5/10/76, in Room 4171 of the JEH Building under the direction of Task Force leader Fred G. Folsom. The Task Force began reviewing files relating to our investigation of King's assassination. (u)

ASSASSINATION OF MARTIN LUTHER KING, JR.

On May 14, 1976, a representative of the Secret Service advised the San Juan Office of the Federal Bureau of Investigation (FBI) that Otis Humphrey Moore advised during interview on May 12, 1976, that in 1965, while drinking in a bar in Temple, Texas, two unknown males engaged him in conversation to the effect that Moore was offered \$50,000 to assassinate Martin Luther King, Jr.

Moore advised that he believes that he is in possession of significant information when coupled with the information in possession of James Earl Ray and Senator Edward Kennedy, will be able to "put it all together" and resolve the matter of King's assassination once and for all.

This Secret Service representative advised that Moore is scheduled to depart from Roosevelt Roads Naval Base, Puerto Rico, on Saturday, May 15, 1976, between the hours of 7:00 and 8:00 PM, destined by military flight, to Charleston, South Carolina. Moore is a retired military veteran and thereby eligible for stand-by status on military flights.

Moore then advised that he intended to make his way to Washington, D.C., by whatever means available and to thereafter sit in the office of Senator Edward Kennedy and badger the office personnel until he is allowed to see Senator Kennedy personally. In addition to Senator Kennedy, Moore stated that he would also attempt to see other members of Congress, mentioning by name Senator Wilbur Mills of his home state of Arkansas.

The following description regarding Moore was furnished by this Secret Service representative:

On May 15, 1976, Moore was interviewed at his residence by Special Agents of the FBI regarding the above-mentioned information. Moore again advised that he intended to obtain an interview with Senator Kennedy regarding the assassination of Martin Luther King, Jr. and President Kennedy. Moore advised that if Senator Kennedy is unavailable, he will attempt to interview Senators Dale Bumpers and Henry Jackson, in addition to contacting the Governor of Tennessee, to obtain an interview with James Earl Ray, whom Moore feels did not tell the true story regarding the assassination of Martin Luther King, Jr.

Moore furnished no additional information to that which was previously furnished to the Secret Service representative, supra, except to say that "a multi-millionaire lawyer from Dallas" was present when he was offered the \$50,000 to assassinate King.

Moore advised that he had additional information, but he would only give it to Senator Kennedy because he had contacted the FBI immediately after the offer had been made and, according to Moore, no action was taken.

A subsequent interview, same date, with Moore's wife, Lydia M. Moore, nee Torres, disclosed that Moore had been planning to take this trip for some time, but up until

now, she has been unable to talk him out of it. She further advised that until recently, her husband was under the care of a Dr. Garcia for a nervous disorder and was to have been hospitalized for treatment.

Mrs. Moore added that the night in 1965, when her husband came home with the assassination story, he was extremely drunk and did call the FBI.

Moore advised that he does not believe in violence, and that he has no weapon, nor does he have access to any weapons. Moore's wife advised that her husband is not prone to violence, and she is of the opinion that he would not resort to violence to accomplish his purposes.

E. H. Building and this week will complete review of all FBIHQ files pertaining to the assassination (44-38861). It is noted that the Task Force has been authorized access to all raw files in our investigation of King.

Mr. Fred G. Folsom, Jr., Task Force leader advised the group will be ready to review the WFO files on 6/7/76. He stated it would be convenient for his group if the files could be delivered from WFO to the Task Force's room in the J. E. H. Building.

Deputy Assistant Director J. O. Ingram of the Intelligence Division recently met with SAC Nick F. Stames of WFO. Stames advised WFO at the present time lacks monitoring personnel and space for the OPR review to take place at WFO. According to the FBI Identification Record for JAMES EARL RAY, FBI #405 942G, fingerprints were submitted by the SO, Kansas City, Missouri, on 3/28/55 and this was the same day RAY was photographed when placed in the Jackson County Jail. The arrest was for forgery of U.S. postal money order. The FBI Identification Record for WALTER TERRY RIFE, FBI #4 558 766, reflects RIFE's fingerprints were submitted by the SO, Kansas City, Missouri, 3/28/55 for forged U.S. postal money order.

A negative of RAY and RIFE being photographed together was obtained by SA RAYMOND B. HOWE and the negative actually reflects not only the photograph of RAY and RIFE, but also an extensive area of the Jackson County SO records section. The photograph when sent to Bureau and Memphis was trimmed so only the two individuals appear on the photograph. The negative is being retained by Kansas City Office.
