HE RODE IN THE AIRPORT LIMOUSINE, DESCRIBED AS A WHITE PONTIAC, FROM THE PEABODY-SHERATON HOTEL, MEMPHIS, TENN., AT ELEVEN FORTY AM, APRIL THREE, SIXTYEIGHT, THIS LIMOUSINE ARRIVED AT MEMPHIS AIRPORT ABOUT TWELVE TEN PM. 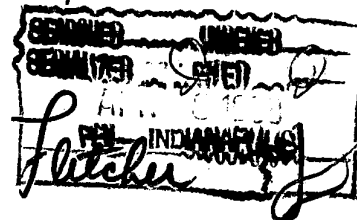

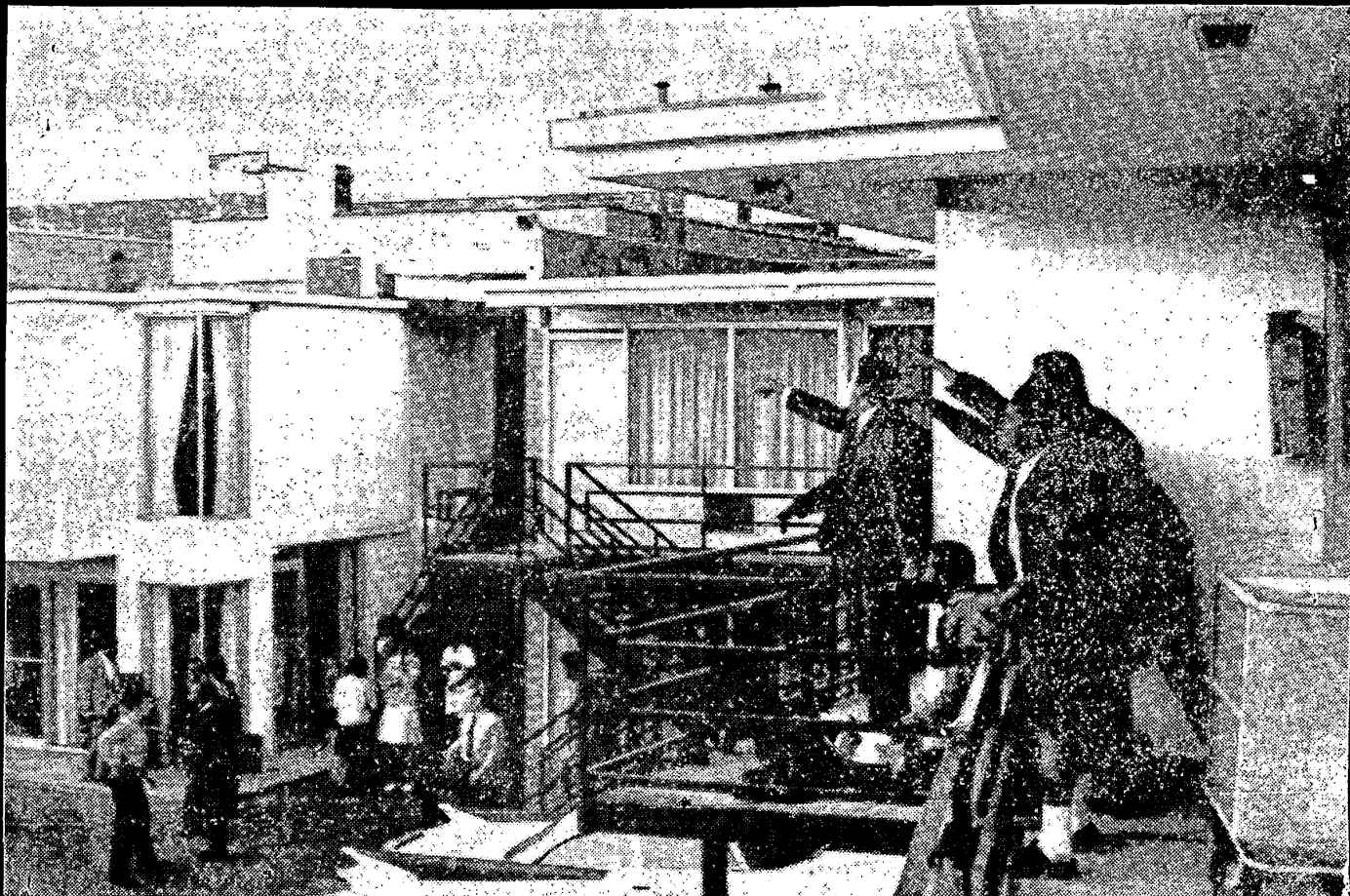
