AGENTS AND DEPUTY CHECKED THE AREA AND CAME ACROSS A SMALL CHURCH, THE DOOR WHICH APPEARED TO HAVE BEEN SLIGHTLY FORCED OPEN. THEY THEN ENTERED THE CHURCH AND DISCOVERED HACKER SLEEPING IN THE CHURCH. THEY WOKE HACKER UP, INFORMED HIM HE WAS UNDER ARREST. HACKER RESISTED SLIGHTLY AND HAD TO BE FORCIBLY SUBDUED. HACKER SUFFERED A SLIGHT WOUND TO THE HEAD WHICH WAS CAUSED BY HIS FALLING AGAINST A CHURCH PEW. THIS WOUND WAS TREATED BY AN INMATE ORDERLY AND NOTHING FURTHER HAS OCCURRED CONCERNING THIS.

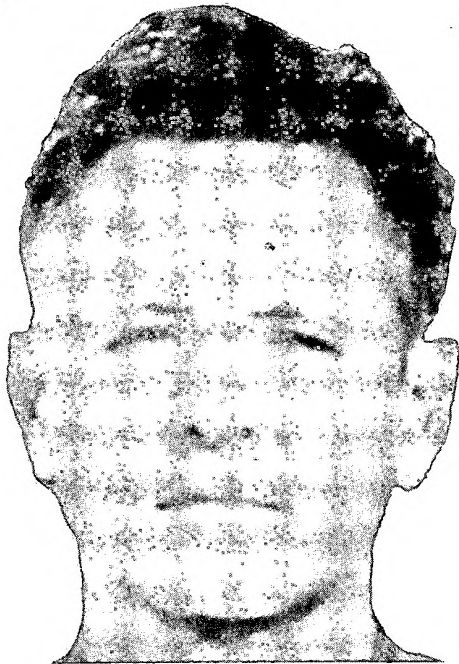

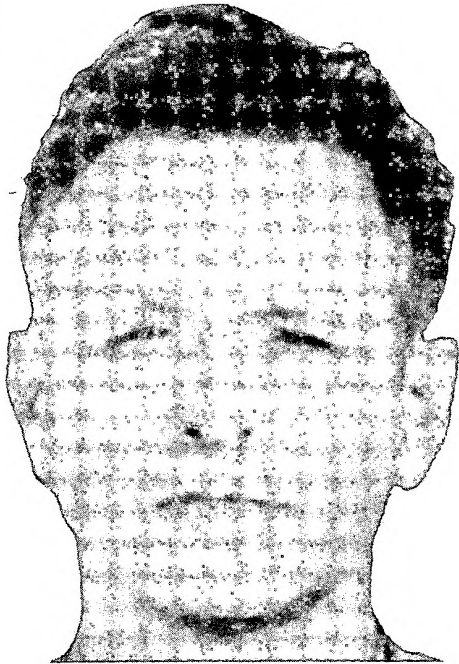
