JEWELL RAY, INTERNAL SECURITY, MEMPHIS PD, RECEIVED INFO FROM A FEMALE WHITE INFORMANT WHO BELIEVES THAT SHE MAY HAVE SEEN SUBJECT GALT IN MEMPHIS AROUND MARCH IWENTY TWO OR TWENTY THREE, SIXTY EIGHT, AND ON OTHER OCCASIONS AROUND LOUNGES, LAST TIME BEING AT CHENNAULT'S ON BELLEVUE. SHE HAS HEARD GIRLS IN THE LOUNGES CALL HIM "STEVIE." HE TOLD HER THAT HIS NAME WAS ERIC AND THE LAST NAME SOUNDED TO HER AS IF IT WOULD BE "GAULDEN," "GAULDING" OR GAULDET." SHE IS NOT SURE OF THE SPELLING BOT THAT IS THE WAY IT SOUNDS TO HER.

SHE DESCRIBES THE MAN AS BEING ABOUT THIRTY FIVE OR THIRTY
SIX YRS. OLD. ON FIRST MEETING HIM, YOU GET THE IMPRESSION HE IS A
MUCH YOUNGER MAN BUT AFTER STUDYING HIM, HE APPEARS TO BE AROUND
THIRTY FIVE. HIS EYES HAVE A STARE AND YOU FEEL LIKE HIS IS LOOKING
THROUGH YOU. HE IS STAND-OFFISH, HE DOES NOT MIX IN THE PARTY.
HE IS A SLENDER MAN, AROUND FIVE FT. TEN TO SIX FT. HE HAS DARK

HAIR THAT APPEARS TO BE A CREW CUT GROWNING OUT AS IT IS NOT EVEN ON HIS HAED. HE HAS A SIDE GRIN OR SMIRK ON THE LEFT SIDE OF HIS MOUTH, PULLS HIS MOUTH BACK LIKE A GRIN. SHE HEARD HIM MENTION NAME "JIM RUBINO," WHO IS SUPPOSED
TO BE A MEMPHIS MAN, AND THE NAME OF DUKE, WHO IS SUPPOSED TO BE
A MEMPHIS PARTY. FROM WHAT SHE COULD FIND OUT ABOUT HIM, HE IS
FROM AROUND BIRMINGHAM AND ATLANTA. HE TAKES GREEN PILLS AND

For the information of San Juan, the following is furnished:

Search of premises believed occupied by UNSUB who assassinated Dr. MARTIN LUTHER KING on 4/4/68, disclosed suitcase in which was located tee-shirt and undershorts bearing laundry mark on red tape with black lettering believed to be Thermo-Seal type, manufactured by Textile Marking Machine Co., Inc., Syracuse, N.Y. The tape is ½" wide and 1 1/16" long and bears letters and numbers C2B-6.

Experts at Textile Marking Machine Company advise type on this machine is unusual in that the first two characters are 15 point type and the last three characters are eighteen point type, with the middle character, the letter B, probably being narrow rather than regular type. The usual machine carries 15 point type for the first three characters and 18 point type for the last two characters.

Textile Marking Machine experts also stated this machine is defective in that it is producing a tape 1 1/16" long instead of 1 1/8" long and is not projecting the tape far enough resulting in cutting off a portion of the first letter. The code used in the Northeast part of the U.S. is as follows:

The first letter 0 stands for lot number; the first number 2 indicates the day of the week, two being Tuesday; the second letter indicates the first letter of the store name, this is the letter B; the last number is the bundle number, this is 6. Color coding of the tag may designate various things such as a different month or the identity of a store in a chain. Experts also state the use of this system on laundry items is unusual in that the system is normally used on garments being dry cleaned.

The Bureau has instructed that all textile machines using this type tape be located and machines using this code be identified.

DEWEESE said he had last worked as a stockroom man for Samsonite Corporation, 1050 South Broadway, Denver, Colorado. His check number was 15370, and he possessed a payroll slip which showed he was paid for the week ending 3/3/68. He said that he left Denver en route to Florida; stopped by Houston, Texas; then to New Orleans; then Mobile, Alabama. Then he went to Jacksonville, Florida. He said he left Denver on 3/2/68. He said he left on a Saturday of the last week he worked. He indicated that the work week at Samsonite ended on Sunday. He said he was married to MARTHA E. BROWN, a widow with two children, and that they were at the Lanier Road address in Jacksonville, Florida. He said he was unemployed at the time and that he had obtained his USCG Merchant Seaman's papers and was attempting to catch a ship out. He said he was a member of the National Maritime Union (NMU), and he was told in Jacksonville that it would be easier to catch a ship through the Norfolk NMU than the Jacksonville NMU. He also advised he took a round

trip to Baltimore and remained in Baltimore two days staying at the Roosevelt Hotel. That was between the time he arrived in Jacksonville, Florida, and the date he got married, which was 3/18/68. He indicated further that he traveled to Baltimore in his personally-owned automobile, a 1956 Chrysler New Yorker. He also stated that he stayed in Jacksonville, Florida, until Saturday, 4/6/68, at 4:15 PM, when he caught a bus from Jacksonville to Newport News, Virginia, arriving in Newport News on 4/7/68. He indicated he came to Richmond and then transferred to Newport News.

He possessed a card which indicated that he registered in the NMU Hall, Norfolk, Virginia, at 9:04 AM, 4/8/68. He said that when he arrived in Newport News on 4/7/68, he went to his sister's house and stayed with her and her husband, CHARLES H. JONES, 735 Westward Avenue, Hampton, Virginia.

He was observed smoking incessantly, and he said he had been smoking Winston cigarettes for many years. He was observed to have blue eyes and brown hair with a crewcut, which he said he had been wearing since he was 21 years old.

He was very emphatic and positive he had not been in Memphis, Nashville, Birmingham or vicinity during the latter part of March or first part of April, 1968. He was specifically asked if he had been in Birmingham on 3/28 - 30/68, which he indicated he had not. He was also asked about his whereabouts on 4/4/68. He claimed he was in Jacksonville, Florida, during thme pertinent periods. He said he was staying with his wife and their two children (his wife's children by another marriage). He said he had never been in Birmingham to his knowledge, and he went to Memphis one time several years ago.

He had in his possession a Navy identification card which indicated that he, MARVIN RAYMOND DEWEESE, was retired from the U. S. Navy on 7/9/65. He also had a Merchant Mariner's Permit Identification Card Number Z1250478. His description was: brown hair; blue eyes; 6'; 200 pounds; born \_\_\_\_\_, Narrows, Virginia; address - 1730 Merivale Road, Jacksonville, Florida.

Mr. DINKINS, Manager, Hunton YMCA, said that Mrs. ANITA ELLIOTT, Day Clerk, was the individual who thought DEWEESE resembled the artist's conception of the assassin.

On 4/7/88 MICHAEL CARGIA voluntarily appeared at the PBI RA, Gainesville, VIX. and furnished the following information.

GARCIA is a Private E-3, US Army. His serial number is RA 12689051 and he is from Tampa, Florida. He is to report to Ft. Lewis. Washington, on 4/20/68, for shipment to Viet Nam. He will be in Tampa, Fla. until it is time for him to report to Ft. Lewis.

GARCIA's father is MANUEL GARCIA, Attorney, Tempa. Florida.

On Saturday, 3/30/68, GARCIA left Pt. Benning, Ga. en route to Gainesville, Florida, where he was formerly a student at the University of Florida, GARCIA took State Road 26 out of Columbus, Georgia, en route to Interstate 75 at Cordele, Georgia. Several siles out of Columbus on 76, at an isolated spot, he picked up a hitchhiker who claimed he was going to Orlando, Florida. GARCIA described this hitchhiker, who gave his name as JACK or HARBY RUSSIAL as follows:

GARCIA advised this individual had a blanket roll which appeared to have some of his belongings inside. The blanket was pastel pink or green in color. He told GARCIA he was a "railstramp" and had arrived in the Columbus. Ga. area from Seattle by way of New Orleans and Firmingham earlier in the week. He talked as if he knew a great deal about train schedules and junctions. He commented a "rail tramp" is hardest kind of individual to eatch if he is on the run from

the law as he knows places to hide. He further claimed two Megroes threw him off of a train once causing him to have a concussion and causing his inner ear to fill with blood. He expressed a distinct dislike for Hegroes. WARCIA advised that during conversation with this individual he asked CARCIA where he was from. When CARCIA told him he was from Tampa he asked if GARCIA knew enything about the Mafia. GARCIA told him that his father, MARUEL GARCIA, an Attorney. had done some legal work for the TRAFFICARTES in Tampe. he teld GARCIA he was going to Orlando to do some work for the Mafia, for which he would receive a new Mercury end \$7089. He told GARCIA upon arrival in Orlendo he was to walk up and down a certain street, name unrecalled, in Orlando until someone contacted him. He further stated that from Orlando he was going to Mismi after which he would head north through Tennessee, to Idaho, and would feel better when he had a few G's in his pocket. He told GARCIA that his job had nothing to do with dope and indicated his job would be done in a week, after when he would be on his way to Idaho. He showed GARCIA a picture which he removed from his billfold of a place where he was going in Idaho. GARCIA recalls this picture showed anow covered mountains and a mountain lake. He claimed he was going to a small camp where he had "laid up" before. GARCIA recalls that he mentioned a waterfall at this place which gave off a spray revealing an image that looked like a reclining women.

GARCIA advised that this individual appeared to know quite a bit about weaponry and stated that he talked about the AE47. Chinese assault rifle, laser beam, and light anti-tank weapon.

SARCIA advised after arriving in Gainesville he let this individual off on West University Avenue where he claimed he wanted to wash his clothes in a washateris. GARCIA stated that on Sunday, 3/31/68, around noon, he saw this individual hitchhiking on Archer Road toward I-75. He stepped and asked GARCIA if he would give him a ride as far as I-75, but GARCIA was in a hurry and unable to do so. He Has not seen this individual since.

CARCIA stated that he did not give too much thought to the conversation he had with this individual until after the announcement of the assassination of Dr. MARTIN LUTHER KING. JR. on 4/4/68. He stated after this announcement he began to give thought to the conversation mentioned herein that he had with this individual, particularly to his expressed dislake for Megroes and he also mentioned the Communist element among Megroes and he therefore thought he should report this to the proper authorities.

GARCIA reviewed all the pending identification orders but was unable to make an identification. He was asked to study the identification order of ROBERT BOLIVAR DE PUGE, 10 04176, inasmuch as process is outstanding for DE PUCH in Seattle and the description of the hitchhiker scmewhat fits DE PUGE. After closely studying DE PUGE, GARCIA stated he could not state whether or not DE PUCH was identical with the hitchhiker, primarily in view of the fact the bitchhiker had such a full bush beard.

The above information is being submitted for the evaluation of the Hemphis Division in Connection with captioned matter and for evaluation by Seattle in connection with DE PUGH. Any leads to be set forth is being left to the discretion of the office of origin.

Information copies being sent to Atlanta, Miami, and Tampa, in the event it becomes necessary to request investigation by these offices concerning the individual described herein.

He further advised that the straight nose in the drawing is very similar to the hitchhiker's nose.

GARCIA stated he would be leaving for Ft. Lewis. Washington, between 4/18 - 20/68 and until time for him to leave, he will be staying at his parents residence, 4802 Woodmere Road, Tampa, Florida.
