The following investigation was conducted at Jacksonville, Fla., on 4/11/68 by SA JAMES R. MORRISON.

EARL J. GIBSON, 6956 Deauville was interviewed at his place of employment Turknett-Turnbull Printing Co., 439 E 8th Street and furnished the following information. He has not seen or heard anything from his brother CHARLES NELSON GIBSON in over 10 years and the only person he knows who possibly may know his brother's whereabouts is his mother Mrs MAUDE GIBSON of Red Springs, N.C. He said his brother has been roaming around the U.S. for years and as far as he knows does construction work. He telephoned his mother a short time ago and she did not mention having heard from CHARLES. He recalled that a number of years ago CHARLES spent the winters in Florida and the summers in Wisconsin but could not give any exact locations in either Florida or Wisconsin. In addition to the relatives named in reCharlotte teletype a sister Mrs W. L. MILLS lives in Jacksonville.

Mrs W. L. MILLS, 6224 W Bartholf Ave., informed she has not seen or heard from her brother CHARLES NELSON GIBSON in about 7 years. At that time he telephoned her while intoxicated, became abusive and she hung up on him. He has never contacted her since. She named the members of her immediate family all of whom are set forth in Reference Charlotte teletype. She said her brother is a "roamer" who has only maintained occasional contact with her mother Mrs MAUDE GIBSON. The last time her mother mentioned him was about a year ago when he telephoned her from somewhere in either Texas or California, place unknown.

Both EARL GIBSON and Mrs MILLS promised to contact the Jacksonville office if she learns anything about CHARLES NELSON GIBSON's whereabouts.

FBI Cancels 'Locate' Order In King Case

MEMPHIS (AP)—The FBI issued, then withdrew, a request that Florida police help locate Eric Starvo Galt, a white man, as the investigation of the assassination of Dr. Martin Luther King Jr. entered its second week.

Federal agents refused to say why they are seeking Galt, whose last known address was Birmingham, Ala.

The bulletin distributed yesterday on the statewide police teletype network in Florida said Galt was driving a white Mustang. Witnesses in Memphis told investigators earlier they saw a man in a white Mustang drive away from the rooming house from which King was shot April 4.

A source in the Dade County Public Safety Department in Miami said the FBI bulletin began: "Reference locate and notify no warrant issued Eric Starvo Galt," then described Galt and the Mustang. The message concluded: "If located notify Agent Charles Bell FBI Miami."

"This meant they wanted him spotted, not picked up," the Miami source said. It was reported originally that a pickup order was issued.

The FBI in Miami refused any comment.

At about the same time the locate order was sent in Florida, federal agents in Atlanta impounded a white Mustang parked since last Friday at a public housing project near the Georgia Capital in Atlanta.

The message, withdrawn with the explanation that it was released by mistake, described Galt as a white male, 36 years old, about 5 feet 11 and 175 pounds with blue eyes and brown hair.

This roughly matches the description circulated by federal authorities the night of King's slaying.

Special Agent John Hanlon of the Miami FBI office, who withdrew the locate order about four hours after it was issued, said "I cannot comment" when asked for further details.

The FBI in Memphis and Atlanta also refused to discuss the developments. In Washington, an aide said Atty. Gen. Ramsey Clark will have no comment.

The Florida teletype message said Galt was last seen driving a white 1966 Mustang hardtop, Alabama license 1-38993. Birmingham police said this tag was issued to Eric S. Galt of 2608 Highland Ave., Birmingham.

Rev. Ike Powell, minister of Inner City Methodist Church in Atlanta, said he told police about the abandoned Mustang yesterday morning after receiving a call from a member of his church.

"They sent two detectives over there and two more came while we were there," the Rev. Mr. Powell said. "They went over it, checked around and didn't appear too excited."

Later, he said, FBI agents arrived and were "all over the place."

Witnesses in Memphis who reported seeing a white Mustang pull away from the rooming house said the car had a red and white license plate. Alabama tags are red and white.

The Birmingham address given for Galt is a large white two-story house in what once was an elite residential area. A red neon sign flashes the word "rooms," but a knock on the door was unanswered.

A Birmingham newspaper, the Post-Herald, said residents of the rooming house confirmed that they were questioned by the FBI. It said the residents reported they have not seen Galt for about three months and can't recall what type car he owned.

King was killed as he stood outside his motel room about 200 feet from the bathroom window in the rooming house from which authorities say the fatal shot was fired. Witnesses said the assassin walked out of the rooming house, dropped a bundle including a .30.06 rifle in front of a business firm next door and then left in a white Mustang.

The Los Angeles Times said gun sale records of a dealer believed to have sold the rifle have been seized by FBI agents in Birmingham.

Using the rifle's serial number, agents obtained from the manufacturer, Remington Arms Co., the name of the wholesale distributor and apparently traced the retail sale to a Birmingham sporting goods store, the Times said.

The firm was not named.

how much rent Galt paid, whether it was paid lately or if Galt still had the room.

Another boarder said a room and two meals a day cost \$22 a week.

Cherpes probably knew Galt better than any other person who has been found in Birmingham. Cherpes accompanied Galt for his driver's license examination last Sept. 6, records show. Only last March 1, a duplicate driver's license was mailed on request to Eric Starvo Galt at the boarding house, 2608 Highland Ave.

Otherwise, Galt seems to be almost a phantom.

At dry cleaners, service stations, apartment houses and other places in the southside area of the boarding house, no one contacted by The Associated Press knew anything about Galt.

"The FBI has already checked our records," said a woman cashier at a cleaners on 26th Street. "I've been here two years and we have had no Galt as a customer."

The man called Galt said he was a seaman, out of work, but the Maritime Union has no record of his name. He established no credit in Birmingham, so far as is known, and maintained only a safe deposit box at a local bank — no checking or savings account.

A check of unemployment payment records in the State Department of Industrial Relations here disclosed no payments to Eric Starvo Galt.

Nor was there a trace of a man called Galt in state birth

records, Veterans' Administration files or police records. No one by that name has filed out an income tax return for the state back to 1963.

Most of the Birmingham hospital files were checked and show no Eric Starvo Galt.

There is one Galt listed in the city telephone directory: The Rev. Ralph M. Galt, a white minister of the United Church of Christ and instructor at Miles College, a predominantly Negro private school in Birmingham.

"We don't know a thing about this person," said Mrs. Ralph M. Galt. "We have checked all the relatives we can think of. We've checked pictures and this man's description doesn't ring a bell."

She said her husband's family came from Iowa where the name Galt was not uncommon. But she said the names Eric and Starvo were unusual. "We don't know anybody in our family by that name," she said.

Mrs. Ralph Galt was wondering aloud over the possibility of a fictitious name. There were others who speculated along that line.

A character in a James Bond novel, "On Her Majesty's Secret Service," has first and middle names of some possible similarity: Ernst Starvo Blofeld.

And Ayn Rand in her book title, "Atlas Shrugged," asks a strange question: "Who is John Galt?" This question, which was left unanswered for a long time in the book, is like that being asked in Birmingham:

"Who, and where is Eric Starvo Galt?"

Assassin Hunt Is Like Chasing Phantom

The refusal or inability of the FBI to release a composite drawing or picture of the man believed to be the assassin of Dr. Martin Luther King is posing a problem for law enforcement officers here and elsewhere who need the photo — if one exists — in order to effectively help track down the suspect.

The case of a Louisville, Ky., man arrested on West Beaver Street Saturday by Jacksonville police points up the problem.

Clyde Courtney, 33, was arrested by police and charged with vagrancy after several people told police he looked like a composite sketch of the assassin drawn by a Memphis, Tenn., newspaper artist. Courtney apparently had no connection with the assassination, a spokesman for the FBI field office here said late Saturday night.

Refuses to Elaborate

In stating that Courtney "presumably is not connected with the assassination" after an hour and a half interview by a federal agent at the city jail, the spokesman refused to

elaborate on any other aspects of the investigation which began with the murder of the Negro civil rights leader in Memphis on Thursday, April 4.

Courtney was arrested with a Jacksonville resident, Curtis Henderson, 39, who gave his address as 3757 Rogero Road, according to Patrolman Harmon L. Plunkett who was called to the 2100 block of West Beaver Street Saturday night by a group of men who said Courtney resembled the published sketches of the assassin.

Pair Arrested

Courtney and Henderson were arrested in the 2800 block of West Beaver Street as they began hitch-hiking to New Orleans, La., where they said they were going to seek employment on an oil rig in the Gulf.

Although the artist's sketch was not authorized by the FBI, residents of the neighborhood in Memphis, Tenn., where King was assassinated, reported last week that federal agents had shown them composite drawings

which were either the same or very similar to those printed by newspapers in Florida and elsewhere.

The FBI has repeatedly re-

fused requests for composite drawings of the man they are seeking in what is perhaps the most massive manhunt in modern times. They even re-

fuse to admit the existence of such a sketch.

Agents have a good physical description of the King assassin: 30 to 32 years old, 5 feet, 10 inches tall, weighing 165 pounds with a receding hairline and a long, thin nose.

They also have a good description of the white 1966 Mustang which witnesses said sped away from the Memphis rooming house minutes after King was shot as he stood on a motel balcony 205 feet from the rear of the rooming house.

A white Mustang was impounded Thursday night from an Atlanta parking lot where it had been parked since the morning after King's slaying.

The impounded car bore license tags issued in Birmingham, Ala., to Eric Starvo Galt, 37, who identified himself as an unemployed merchant seaman when he applied for an Alabama driving license last year.

FBI agents in Birmingham, Ala., Sunday were showing sketches of a man's face and asking about Galt, the mysterious object of a hunt linked to the probe of Dr. King's assassination.

What the agents have learned or what they want with Galt is a tightly kept FBI secret.

"No comment," is all the FBI will say. Not even the local police have been asked to help in Birmingham.

Some key sources have been told by the FBI not to discuss their knowledge of Galt with anyone.

Who is Eric Starvo Galt?

The name came up last Thursday on the Florida police teletype system from the FBI asking authorities to locate Galt. The message said Galt was driving a 1966 white Mustang hardtop with Alabama tag 1-38993.

At almost the same time the Florida alert went out, FBI agents in Atlanta were taking into custody a white Mustang with Alabama tag 1-38993, sold to Galt.

The getaway car after King's slaying was described by witnesses as a white Mustang with red and white license tags. Alabama and Arizona tags are red and white.

Eric Starvo Galt's name appeared in official state rec-

ords when he bought a white Mustang last Aug. 30 from a car salesman, William D. Paisley of Birmingham. Paisley would not talk about it.

Pays \$2,000

Sources said the man called Galt paid \$2,000 cash for the car.

When he applied for a driver's license, Galt put down "merchant seaman, unemployed." The application gave his birthdate as [redacted], and his description as 5-11, 175 pounds, blue eyes and brown hair — the same general description as a man seen fleeing a Memphis rooming house after the slaying.

Piecing bits of information together — and assessing the huge gaps, the phantom-like quality of the man — results in a sketchy picture of a neatly dressed man whose apparent absence of any kind of official records seems strange.

There has been speculation in the Birmingham News that a false trail was laid by the killer or killers.

But what of Eric Starvo Galt?

"My memory of him is so dim," said Charles Jack Davis, 26, a tile company employee who has a small second floor room in the boarding house where Galt lived at some time in the past year.

General Description

"I don't guess there's any such thing as a typical person," Davis went on. The best he could recall was that Galt's general description was brown hair and blue eyes, about 5-11.

Another boarder, 29-year-old Hill Hardy, who works the 3 p.m. to 11:30 shift at a paper plant, said he had lived at the stucco house since it opened last September. But he didn't remember ever seeing Galt.

Other boarders were unable to remember much if anything at all about the man who had occupied Room 14 on the ground floor, but was gone apparently for weeks or months at a time.

Owner-manager Peter Cherpes has turned his records over to the FBI and refuses politely to talk about Galt. He would not even say

Lonely Man Is Caught Up In Hubbub of Assassin Hunt

For a brief moment Saturday night the law enforcement apparatus of the United States leaned upon one lonely man in Jacksonville.

FBI agents scurried about, checking into Clyde Courtney's tale of his whereabouts on Thursday, April 4, the day Martin Luther King was cut down by a sniper's bullet in Memphis.

"This is fantastic," Courtney told a newsman as he was entering city jail. "I don't even kick my dog." Courtney was questioned by an FBI agent and apparently his story was verified.

A spokesman at the local FBI office Sunday said,

"There is no apparent connection between the vagrant arrested in Jacksonville and the slaying of Dr. King." The spokesman refused to make further comment.

Courtney says he was in a bar, "about five miles out of Cordele, Ga.," the day the civil rights leader was killed. He says he gave the FBI agent the name of the person with whom he was drinking.

Heard of Killing

"The lady at the bar told me that King was dead. I didn't know anything about it," he said Sunday.

Jacksonville Patrolman Harmon L. Plunkett arrested Courtney and a companion on vagrancy charges Saturday night after a group of men

told police Courtney resembled a published sketch made by a Memphis newspaper artist from descriptions of the assassin of King.

"He looked too much like the picture to let him go," Plunkett said. (See sketch and photo above.)

Courtney was held under \$100 bond in city jail.

Sunday he said he was walking out toward the city limits so he could start hitchhiking to New Orleans where he and his companion hoped to get jobs on off-shore oil rigs.

"I had a job here at the shipyard," Courtney said, "but I couldn't find any place to stay. I had no money to eat."

He had some clothes in a paper sack, seven bananas and twenty-five cents when Plunkett stopped him.

Left Louisville

Courtney left Louisville his hometown, early in the month, heading south. He says he hoped to find a warm climate which would suit his wife, who is in California.

"I miss my family. I have two beautiful children," he said.

Courtney said he'd had troubles before, "but never anything like this. Of all the people in the world, I have to look like him (King's assassin)."

"They asked me all kinds of

questions and I answered them. I've got nothing to hide.

"It's stupid, but it's funny in a way. I think I'll write a book about it" he said.

"The FBI man was nice. I guess he's just got a job to do.

"He didn't say much to me, but I don't think he believes I did it," said Courtney, referring to the assassination.

"All this attention doesn't make me feel important," Courtney said. "It's got me dumbfounded. And it worries me in a way, too.

"Suppose some nut decides I did it. He could kill me. And then my sisters and mother are going to be worried, too."

Courtney's hearing on the vagrancy charge is scheduled for this morning before Municipal Court Judge John E. Santora.

"I hope the judge goes easy on me," he said. "I haven't done anything.

"And I was on my out of town.

"I guess they had to charge me with something. A vagrancy charge isn't much, but it can get you some days."

Beaver St., along with one CURTIS HENDERSON.

The arrest, according to this report, was based on

of Dr. MARTIN LUTHER KING. Officer PLUNKETT located COURTNEY and HENDERSON and noted that COURTNEY did resemble this sketch.

PLUNKETT, according to the report, thereafter called Lt. RICHARDSON to the scene, who advised Officer PLUNKETT to book them and notify the FBI. The original criminal complaint number in this matter was shown as 30212.

CLYDE (NMN) COURTNEY, white male, age 33, Born [redacted], at Louisville, Ky., was interviewed at the Jacksonville PD, at which time he furnished the following information:

COURTNEY advised that in August, 1967, as he recalls, he was residing with his half-sister, Mrs. G. E. (ANN) SMITH, 3198 Cannes St., Riverside, Calif. He said during the period that he was residing there he was working for his brother-in-law, G. E. SMITH, as a plumber's helper. He said that his brother-in-law is a plumber and is employed for a subcontractor who holds service contracts for Sears, Roebuck and Co.

COURTNEY stated that he left Riverside, Calif., in approximately, November, 1967, traveling with his brother-in-law in his brother-in-law's car to the home of his mother, Mrs. LULA SENSABOUGH, 1012 Winkler Dr., Louisville, Ky. He said that after arrival in Louisville he first worked for the Louisville Ladder Co., located at 1163 Algonquin, Louisville, Ky. COURTNEY displayed a payroll check voucher slip dated 12/18/67, as evidence of this employment and stated he had been employed by the company for approximately 2 weeks.

COURTNEY stated that he quit this work and thereafter went to work as a janitor for St. Anthony's Hospital in Louisville, Ky., being employed there for approximately 1 month. He stated that the Department Head at St. Anthony's Hospital, a Mr. (FNU) KRAMER, quit work at St. Anthony's Hospital and went to work for the Jefferson Community Colleges in Louisville, Ky.

He stated that the Jefferson Community Colleges are under the University of Kentucky. He said that he left his job at St. Anthony's Hospital and went with Jefferson Community Colleges as a janitor under Mr. KRAMER. He said his pay was received from the University of Kentucky, out of Lexington, Ky. COURTNEY made available payroll slips as evidence of this employment.

He said that during his entire stay in Louisville, Ky., he stayed with his mother, Mrs. LULA SENSABOUGH, 1012 Winkler Dr.

COURTNEY said that on Wednesday morning, 4/3/68, he left Louisville, Ky., and rode with a neighbor in the neighbor's car to Cordelle, Ga. He said the neighbor was one Mr. (FNU) JAMES, 1010 Winkler Dr., Louisville, Ky. He said they arrived in Cordelle, Ga., on 4/3/68, at approximately 6 PM. He said he registered at the Peaceful Motel, Cordelle, Ga.

COURTNEY stated that he first heard of the death of MARTIN LUTHER KING at Mr. (FNU) PULLMAN's Bar, which he said was located 5 miles outside of Cordelle, Ga., specific address unknown. He said this was after dark on the evening of 4/4/68.

COURTNEY advised that while in Ga. he was in the company of one C. H. MASSEY practically all of the time. He said C. H. MASSEY lives on 10th St. in Vienna, Ga. He said that MASSEY is a long time resident, having lived there approximately 15 to 20 years and is a carpenter by trade.

COURTNEY said that he left Vienna, Ga., on 4/8/68, by Greyhound Bus and arrived in Jacksonville, Fla., on Tuesday, 4/9/68, about 6 AM.

He said he first stayed at the City Mission at the corner of Beaver and Laura Streets in Jacksonville, Fla., for 2 nights, after which he moved to 41 West Beaver St., Jacksonville, Fla.

He stated he had made application for a job at the Jacksonville Ship Yards and had been issued an Identification Badge which he displayed, but that since he was broke and could not find a place to stay and did not have enough money to eat on he and HENDERSON had started out to hitchhike to New Orleans, La., to obtain a job with a Mr. MC DERMITT on an oil drilling rig. He explained that if he could have reached New Orleans a job with the oil drilling rig would have paid room and board and made it possible for him to get along.

COURTNEY had in his possession a letter from Mr. LOWELL E. LATHROP, District Attorney, Domestic Relation Division, Court House, San Bernardino, Calif., dated 2/29/68. The letter was addressed to CLYDE COURTNEY, 1012 Winkler Dr., Louisville, Ky., and enclosed a payment agreement form wherein COURTNEY was agreeing to make child support payments in the amount of \$70 per month, payable \$35 on the second and fourth Friday of each month, beginning 3/22/68.
