## JAMES EARL RAY

James Earl Ray, a Missouri prison escapee who has been sought under the alias Eric Starvo Galt in connection with the gunshot slaying of civil rights leader Dr. Martin Luther King, Jr., is one of the FBI's "Ten Most Wanted Fugitives."

FBI Director J. Edgar Hoover ordered the special addition of Ray to the "Ten Most Wanted Fugitives" list, which already contains ten fugitives, to insure the widest possible dissemination of Ray's photograph and description to help effect his prompt location. Ray has been the subject of a massive search since the gunshot slaying of Dr. King on April 4, 1968, as he stood on the balcony of a Memphis, Tennessee, motel.

An exhaustive FBI fingerprint search, comparing latent fingerprints uncovered in the Dr. King case against fingerprints of over 53,000 persons on whom FBI wanted notices have been posted determined that Galt and Ray are identical.

A Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, under the alias Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a United States citizen. Ray, who escaped on April 23, 1967, from the Missouri State Penitentiary, is also sought for unlawful interstate flight to avoid confinement after conviction for armed robbery.

Possessing an arrest record dating back to 1949, Ray has been convicted of burglary, armed robbery and forging United States Postal Money Orders.

A 40-year-old white male, reportedly born in Illinois on. Ray is approximately 5'10" tall, weighs from 163 to 174 pounds, has blue eyes and short brown hair. He has a nervous habit of tugging at an ear lobe and his left ear protrudes noticeably.

Described as a "loner and "drifter," with a "rural" quality in his speech, Ray has worked as a baker, laborer and color matcher. He has taken dancing lessons and completed a course at a school of bartending.

Consider Ray armed and extremely dangerous. Report any information concerning him to the nearest FBI office.

THE CRIMES: Ray escaped from the Missouri State Penitentiary, Jefferson City. Missouri. on April 23, 1967, while serving a 20-year sentence for armed robbery and operating a motor vehicle without the owner's permission. He subsequently allegedly conspired, under the alias Eric Starvo Galt, to violate the civil rights of Dr. Martin Luther King, Jr., shot to death on the balcony of a Memphis, Tennessee, motel on April 4, 1968.

THE CRIMINAL: A 40-year-old white native of Illinois, who is known as a "loner" and "drifter" and has taken elaborate steps to establish a false identity, Ray has an extensive criminal record, including convictions for burglary, robbery and forging U.S. Postal Money Orders. Outstanding characteristics include a straight narrow nose, straight and even teeth, a noticeably protruding left ear and a nervous habit of tugging at an ear lobe. He has taken dancing lessons, attended bartending school, enrolled in a correspondence course in locksmithing and traveled widely in a 1966 Mustang recovered in Atlanta, Georgia, a week after Dr. King's murder. Ray likes western and country music, drinks vodka and beer and has worked as a baker, laborer and color matcher.

PROCESS: A Federal warrant issued at Jefferson City, Missouri, on July 20, 1967, charges Ray with unlawful interstate flight to avoid confinement for robbery. Another Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, as Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a citizen.

# Galt Bared As Ex-Con

WASHINGTON (A)—The elusive Eric Starvo Galt, who is wanted for the killing of Dr. Martin Luther King Jr., was identified by the FBI Friday as a 40-year-old drifter and ex-convict named James Earl Ray.

The FBI said Galt's real identity was traced through "a systematic and exhaustive search of latent fingerprints" developed in the King case argued the fingerprints of more man 53,000 persons for whom wanted notices are on file in the bureau's identification division.

Galt is only one of the names Ray has used in brushes with the law which began, according to the FBI dossier, when he was 21.

The FBI said he has used the names of James McBride, James Walton, W. O. Herron and James O'Connor.

## Two Scars

He was described as about 5 feet 10, weighing 163 to 174 pounds, with blue eyes and brown hair and two scars: a small scar in the center of the forehead and another on the palm of his right hand.

At the time King was shot and killed by a sniper in Memphis, Tenn., April 4, Ray was being sought on a jailbreaking charge.

The FBI said he escaped on April 23, 1967, from the Missouri State Penitentiary at Jefferson City, where he was serving a 20-year sentence for armed robbery in St. Louis.

Ray, who is now being sought on a Tennessee murder charge in the King slaying, has an arrest record dating at least to 1949 when he served time in Los Angeles on a burglary charge.

This followed his discharge from the Army. The FBI said he served as an enlisted man

The FBI said Galt's real from February 1946 to December 1948 when he received a systematic and exhaustive arch of latent fingerprints."

The FBI warned that Ray is armed and dangerous.

'His Army record showed a three-month sentence at hard labor for being drunk and breaking arrest, the FBI said.

The bureau's dossier en Ray indicates he has been a drifter since he left school in the 10th grade at Alton, Ill.

He has worked as a baker, laborer and color matcher.

In 1952, according to the FBI, he was convicted in Chicago for armed robbery and served two years in Joliet and Pontiac, Ill., state prisons. In 1955, the FBI said, he was convicted of forging U.S. postal money orders in Missouri and was confined to Leavenworth penitentiary until 1958.





A Federal warrant was issued on April 17, 1968, at Birmingham, Alabama, charging Ray as Eric Starvo Galt with conspiring to interfere with a Constitutional Right of a citizen (Title 18, U. S. Code, Section 241). A Federal warrant was also issued on July 20, 1967, at Jefferson City, Missouri, charging Ray with Interstate Flight to Avoid Confinement for the crime of Robbery (Title 18, U. S. Code, Section 1073).



Re Albany airtels 4/10/68 and 4/11/68, setting forth concerns who purchased Thermo-Seal marking machines, and Bureau teletype to Memphis, 4/12/68.

The FBI Laboratory advised that pillowcase and bed sheet were found in trunk of 1966 white Mustang registered to ERIC STARVO GALT, which was located at Atlanta 4/11/68. These items contain Thermo-Seal laundry tapes of approximately same size as tapes on items previously recovered, but are yellow in color and contain code, "20R-3." In opinion of Textile Marking Machine Company, Syracuse, New York, the tapes were produced by a different machine than previous tapes since the first three characters are 15 point type and the last two characters are 18 point type.

The Textile Marking Machine Company suggests the twenty in above code would be the lot number, the R may mean that this was a return of a batch of laundry, and the three is the bundle number.

This is to record that at 11:30 am, 4/23/68 I called SRA CLARK and advised him of the inquiry of Assistant Director ROSEN as set forth in ASAC's memo. I related Mr. ROSEN's instructions to CLARK.

CLARK subsequently advised he had contacted BARBARA FRYE, the only UPI representative in Tallahassee who stated that she had absolutely nothing to do with the story as reflected in the 4/23/68 edition of the "Florida Times-Union." As the only representative of UPF in Tallahassee, she was certain this story did not emanate from Tallahassee, She stated she fully understood the latest information from the FBI and was at a loss to understand how any UPI reporter could have printed the article as written. She inquired of UPI and determined the story emanated from UPI, Miami. The reason for the dateline "Tallahassee UPI" was based on a FHP broadcast.

CLARK further advised FHP radio dispatcher "routinely" utilizes the wanted flyers put out by the Bureau for items on their daily summary and this was what occurred in this instance. The wanted flyer on GALT was received in Jacksonville on 4/18/68, mailed on 4/19/68, and was received at FHP over the weekend. It was therefore "routinely" put out on the evening of 4/22/68.

CLARK said FHP is very concerned over the lack of judgment in this instance and has assured as soon as they receive the current wanted flyer on RAY they would make an amendment to the original broadcast.

At 11:45 am, I called Miami and in the absence of SAC and ASAC, spoke to Supervisor WAYNE SWINNEY. I advised him of Mr. ROSEN's inquiry and advised him of the above information. I suggested that Miami handle Mr. ROSEN's inquiry and emphasized the point that it should be handled by phone with nothing in writing. He advised he would contact SAC FROHBOSE and have the matter handled.

At 11:50 am, I contacted Assis tambe Director ROSEN and advised him of the above and in answer to his specific inquiry, told him Miami would handle his inquiry of us and telephonically advise him.
