On 5/1/68, Chief of Police CARL STUCKI, Atlantic Beach, Fla., telephonically contacted the writer and advised that he had a Mr. and Mrs. EDWARD P. CONNORS in his office and they both believed that they had observed subject, JAMES EARL RAY, at the Georgia Package Store Bar in Jacksonville Beach, Fla. at about 6:00 p.m. Mr. CONNORS had obtained a beer can the individual he felt was identical with RAY had been drinking from.

Mr. and Mrs. CONNORS were interviewed at the Atlantic Beach PD subsequent to receipt of this information by SAs MILTON T. CUMMINGS, JR., and GEORGE A. McBRIDE at which time Mr. CONNORS furnished the following information:

He and his wife, EDNA CONNORS, reside at 620 Plaza, Atlantic Beach, Fla., and he is employed at the Arlington Branch of the U. S. Post Office. His wife is employed as a day-time barmaid in the lounge at the Georgia Package Store at Jacksonville Beach. CONNORS said he went to the Georgia Package Store at approximately 5:00 p.m. on 5/1/68 to pick up his wife, however, she did not get off until 6:00 p.m. He said he had a beer while he was waiting for her and that before she got off work the individual whom he felt was identical with RAY entered the bar and ordered a beer. When his wife got off she came to the bar and sat down beside him and he pointed this individual out to her and she also felt he resembled RAY. CONNORS said he then left the bar and went to the men's room and on his return this individual had departed. He said he immediately obtained the beer can he had been drinking from and preserved it. He estimated the individual left the bar at about 6:15 p.m. He described him as being dressed in a white shirt, dark trousers with no tie or hat. He said he resembled the center picture of RAY on the Identification Order issued 4/20/68, with the exception that his hair was much longer than the crew cut appearance this picture gives. He added that the left ear of the individual at the bar protruded noticeably.

Mr. and Mrs. CONNORS identified other individuals in the bar as customers at this time as DOC TUTTLE, a college Professor who is in charge of the University of Florida's extension program at Jacksonville; JESSIE PACE, a retired Army man; The night bartender, JACKIE, and the girl who operates the package store at night whose first name is DOTTIE.

The beer can furnished by CONNOR was processed for latent fingerprints by SA McBRIDE with negative results.

Upon completion of the interview with CONNORS, DOC TUTTLE was located at his residence, 217 Oceanwood Dr., Neptune Beach, and JESSIE PACE, JACKIE LOWE and DOTTIE OAK were located at the Georgia Package Store. Each of these individuals was interviewed in detail and each observed photos of RAY with negative results. None of them felt they had observed RAY in the bar although all recalled Mr. and Mrs. CONNORS' presence in the bar at the time he had stated.

It is noted that PACE, upon seeing the pictures immediately identified them as being "Galt" and he was very positive in his statements that no one fitting subject's description had been in the bar.

On 5/2/68, subject's photograph was displayed to officers at the Jacksonville Beach PD and at the Atlantic Beach PD with the request that they be particularly alert for anyone in the area fitting subject's description. In addition, they were displayed to the day manager at the Georgia Package Store with negative results. There does not appear to be any additional logical investigation that can be conducted at this time on this lead.



On 5/2/68, Mrs. Gerry Baldwin, Detective Bureau, Tallahassee Police Department advised that they have no record of any cars being recovered that were stolen in Georgia during 3/23/68 --4/4/68.

With the assistance of JOHN PACE, Dispatcher, Switching Center, Department of Public Safety, FBP, Tallahassee, Florida a review was made of the teletypes that were sent from FBP to other states on recovery of stolen automobiles. It should be pointed out that no record is kept of the recovery of stolen automobiles and that the copies of the outgoing teletypes were not complete as most of them have been destroyed for questioned period. Search was made with negative results.

Mrs. Betty Townsend, Sheriff's Office, Leon County, Tallahassee, Florida advised on 5/3/68 that she could find no cars falling in the above category.

For the information of the Bureau and interested offices, the following investigation was conducted at Orlando, Florida, by SAs THOMAS J. WILKES and GORDON W. TINDLE. BAILEY SANDLIN, Insurance Adjuster, 1906 West Colonial Drive, Orlando, Florida, telephonically advised SA WILKES on 4/25/68 that at approximately 8:55 a.m., 4/25/68, he drove up in front of his office and noticed a man sitting in a 1967 or 1968 dark blue, 4-door Chevrolet. He stated the only numbers of the Florida tag he could recall were 7W-15 with rest of numbers unknown and he could not recall how many digits were in the tag number. He advised the Chevrolet was parked in the carport at his office. He said the man who resembled JAMES EARL RAY, pointed a snubnosed revolver at him, and said, "You ain't seen me" and drove east on Colonial Drive to the next street (Vern Drive) where he turned right. SANDLIN stated he got into his car and tried to follow the individual but never saw the Chevrolet again.

It was noted by SA WILKES during the telephone call from SANDLIN that his voice had been unusually hesitant between words and sentences, however, at the time it was believed to be due to excitement.

J. R. SMITH, Detective Bureau, Orlando, Florida Police Department, was immediately informed of the above by SA JAMES B. HAFLEY.

Upon arriving at 1906 West Colonial Drive, BAILEY SANDLIN was interviewed in person by SAs TINDLE and WILKES. As the interview progressed, it became evident through SANDLIN'S behavior and by his own admission that he was under the influence of liquor. He stated that he was an alcoholic and that during the morning of April 24, 1968, his girlfriend, CHARLOTTE McDANIEL had tried to commit suicide in his apartment at 77 East Amelia, Orlando, Florida. SANDLIN asserted he became upset at this and had been drinking beer and Vodka from the morning of April 24, 1968 through the time the agents contacted him in person.

Every effort was made to ascertain if there was any truth in SANDLIN'S statements, however, he continually changed his description of the suspect and varied the sequence of events as well as the times they were alleged to have occurred.

On April 25, 1968, Mrs. ANN WAGNER, 1904 West Colonial Drive, and Mrs. ALFRED PENKACIK, 1918 West Colonial, who are located immediately adjacent to SANDLIN'S office advised that from at least 8:00 a.m. until they were contacted by the agents there had been no other car in SANDLIN'S carport except his Dodge. Both women were positive no Chevrolet, described above, had been in or near SANDLIN'S office that day since at least 8:00 a.m.

On April 25, 1968, Mrs. MARGARET TAYLOR, widow of Deputy Sheriff PHILIP TAYLOR, 1113 Santa Anita, advised agents she is the secretary to SANDLIN and that she had received a call from him that morning. She stated he sounded very unusual and she wondered if he had been drinking. She asserted that SANDLIN had previously told her he was an alcoholic and was active in alcoholics anonymous. He has also told her that when he drinks, he has hallucinations thinking he has achieved great success. Mrs. TAYLOR further stated that SANDLIN told her during his phone call that morning that when he arrived at his office he had been accosted by a man in a car in the carport of his office who stuck a gun in his face. According to SANDLIN, this had caused him to be upset.

Mrs. TAYLOR also declared that she talked with the landlord and occupants of the other half of the building, in which SANDLIN'S office is located and Mrs. WILLIAM MURRELL, 1904 West Colonial Drive had advised her that she had arrived at the office at the same time as SANDLIN and there was no car in the carport at that time. During the afternoon of April 25, 1968, RONALD E. ZEIGLER, Ziegler and Associates, Insurance Adjustors, Deland, Florida, telephonically advised SA WILKES he was SANDLIN'S employer. He stated he had gone to SANDLIN'S office a short time previous that same day, in answer to a phone call from Mrs. TAYLOR where he found SANDLIN passed out due to drunkenness. He stated he closed the office, took SANDLIN home and put him to bed.

JAMES FULLER, Detective Sergeant, Orlando PD was apprised of the above.

About mid-morning, April 25, 1968, BAILEY SANDLIN, 1906 West Colonial Drive, Orlando, Florida, telephonically advised SA ROBERT C. BALL at the Orlando Resident Agency that he had previously telephoned the Orlando Residence Agency on the same morning and he had been contacted by two agents whose names he could not recall. He related he was recontacting the resident agency since the individual whom he had talked with the previous time had telephoned him and threatened him.

TP 157-3231

SA BALL contacted the Orlando PD and was met at 1906 West Colonial Drive by Sergeant STRAUB of the Orlando PD and during a short conversation with SANDLIN he stated he was fearful of his life since the previous described individual had threatened to return to his office and to kill him.

During the conversation with SANDLIN it was obvious to SA BALL that SANDLIN had been drinking and such opinion was confirmed by Sergeant STRAUB. SANDLIN was shown the identification order for JAMES EARL RAY and stated that the individual depicted thereon resembled the individual who had threatened him earlier that same day. Due to the obvious intoxicated condition of SANDLIN, no further attempt was made to interview him.

Due to the above set forth facts, no further action has been taken.

From SANDLIN's conversation, the writer gained the impression that he was either under the influence of alcohol or was possibly mentally disturbed.

SANDLIN advised on Friday, April 26, 1968, an individual whom he believes to be JAMES EARL RAY, the assassin of Dr. MARTIN LUTHER KING, pulled a gun on him at his carport in his office located at 1906 W. Colonial Drive, Orlando, Fla. SANDLIN advised he reported this matter to the FBI in Orlando and to the Ocala PD on that date, 4/26/68.

SANDLIN advised he resides at 77 E. Amelia St., Orlando, but that on 4/29/68, he came to Mt. Dora, Fla., because he was fearful of "getting his brains blown out".

SANDLIN then advised he was not a "nut" and he was getting tired of people saying he was a nut. He then stated that he had to get dressed and was going out to get something to eat.

SANDLIN stated he has a brother who is close to President JOHNSON and Vice President HUMPHREY in Washington, D. C., and that he intends to contact his brother to get some action.

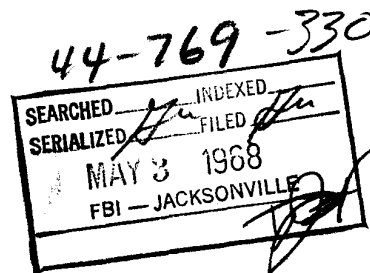

Recent Pictures of Ray Circulated by FBI**FBI Distributes 2 More Photos of Ray**

WASHINGTON (UPI) — The FBI distributed Tuesday two more photographs of the man accused of killing Dr. Martin Luther King — one of them "an extremely good likeness."

Both were snapshots of James Earl Ray, alias Eric Starvo Galt, an escaped convict accused of shooting King to death in Memphis April 4.

The "extremely good likeness" is a candid photograph of Ray in a business suit and tie and shows almost his full face, taken in late January or early February somewhere in California.

The other, which the FBI said was taken last November

somewhere in Mexico, shows him wearing sun glasses and what appears to be a white sports shirt. The FBI said Ray is known to wear sun glasses frequently.

The two new photographs — the FBI refused to say where or how they were obtained — are being displayed throughout the country along with three other pictures of Ray

which now appear on FBI wanted posters.

Ray was added to the FBI's list of 10 most-wanted criminals April 20. There have

been reports of the search extending to various foreign

countries, including Australia, and authorities along the U.S.

borders have been alerted to watch for him.
