Among these pictures were 3 of a group of people standing on an overpass above the procession. It was her impression that one of these individuals in the photographs resembled the FBI poster photograph of ERIC STARVO GALT.

She had furnished the above information to JERRY O'LEARY of the "Evening Star," who suggested that she contact the FBI.

photographs, which she stated were taken approximately ten minutes prior to the funeral procession passing the point in the photograph. Mrs. GUY pointed out one individual whom she believed may be identified as ERIK STARVO GALT. She also had blown-up shots of this individual.

Mrs. GUY's attorney was of the opinion that the individual mentioned by GUY was a much younger man than GALT. SAS JOHN J. CREAMER and JOHN BLAZEK observed these photographs and determined they did not resemble GALT's photograph as it appears on the wanted poster. Mrs. GUY advised that she did not wish to release her photographs, but stated they would be available in the future if a better likeness was obtained and appears to be the same as the individual in her picture.

WFO is taking no further action concerning photographs taken by Mrs. GUY of the unidentified individual, UACB.

t Bethany, Missouri:

on 4/22/68, DON STACKJELT, Sheriff, Harrison County, advised he was telphonically contacted by FRANCES TRAINER, owner, Trainer's Hotel, Bethany, and advised that two or three days after the King assassination, a suspicious individual came to her hotel and requested a room and thereafter left without registering. He said TRAINER telephonically gave him the information on 4/19/68, after seeing a photograph of TRAINER thought this individual somewhat remembled GALT. STOCKJELL said he has had no other similar calls by citizens. He related that TRAINER is a woman with a good reputation and appears stable.

On 4/22/68, FRANCES L. TRAINER, 1600 Central, Bethany, Missouri, was interviewed at length. The description she gave of the individual who came to her hotel on Friday, April5, 1968, did not fit that of GALT. She related the individual did not resemble the photograph of GALT which was displayed to her by writer (Photo on Manted Flyer 442).

FRANK JOSEPH GUINAN, MSP #09297, Mo. State Pen. Jefferson City, Mo., advised SA WEAVER, 4/23/68 JAMES EARL RAY was most closely associated in MSP so far as he knows with NEAL EDGAR AEBY. He said AEBY gave RAY the idea of escaping in a bread box from MSP and AEBY and RAY were in together on receiving barbituates and amphetamine at MSP, and he thought their source was a guard since fired, possibly named STOUT, whose wife operates a beauty parlor in Jefferson City Mo. GUINAN said AEBY seemed to be RAY's closest associate in the main kitchen at the MSP and RAY would have been aware of the names of AEBY's brothers and their general whereabouts and aware of the fact some of AEBY's brothers were, themselves, involved in narcotics. He said one of the brothers was arrested at Dallas, Tex. on a narcotics charge in about 1966, and he believes no conviction followed this arrest. He said his was possibly AUBREY AEBY. He mentioned that RAY stated that he had served time in the USP, Leavenworth, Ks., with one of AEBY's brothers, possibly BILL AEBY.

GUINAN said that he believes AEBY is presently on the streets as he had received a postcard about two weeks ago from NEAL AEBY mailed in Oklahoma City, Okla. He said that AEBY had told him before AEBY was extradited to Texas that he would try to get in touch with GUINAN's family in St. Louis, Mo., following his release.

GUINAN said that his mother is MILDRED GUINAN, 2728 Accomac, St. Louis, Mo., and his sisters are: DORIS STULHMAN, 10121 Jett Drive, and Mrs. RON (SHERRY) DZURIAN, 4065 Giles both St. Louis, Mo., and Mrs. LARRY (MILDRED) WARNER, 114 Marion Drive, Savannah, Ga.

GUINAN said he would have no idea where RAY might go but he liked bennies and amphetamine, and could possibly contact some of the AEBYs in Texas.

On 4/19/68 W. L. RUDDELL, Post Office Inspector, Kansas City Division, Kansas City, Missouri, advised that he had been the case agent of the Post Office case involving JAMES EARL RAY and WALTER TERRY RIFE. He stated that the file is somewhat in less than desired shape and should have been destroyed previously. From memory and the file in the office RUDDELL furnished the following information:

He stated that on 3/22/55 JAMES EARL RAY and WALTER TERRY RIFE were arrested in Hannibal, Missouri, by the Missouri State Highway Patrol and were charged with forgery of U. S. Postal Money Orders. Investigation revealed that these money orders had been stolen in a burglary at the Kellerville, Illinois, Post Office approximately 1:30 a.m. 3/7/55. At least 66 blank postal money orders and validating stamps were stolen. 34 of these money orders had been recovered and were cashed at St. Petersburg, Florida; Miami, Florida; Tallahassee, Florida; St. Louis, Missouri; New Orleans, Louisiana; Memphis, Tennessee; Hot Springs, Arkansas; and Kansas City, Missouri. Subjects had been driving a 1946-47 Nash, which they traded for a 1949 Lincoln, Amacker Motors, 135 Northeast 36th Street, Miami, Florida, on 5/14/55. Upon interview RAY and RIFE claimed to have obtained the stolen money orders from an unknown man in Quincy, Illinois.

Both subjects admitted to their guilt in a signed statement and were convicted in United States District Court. The following descriptive data was obtained through memory of RUDDELL and from the files:

SUBJECT:

I am in receipt of a letter dated 4/21/68 from MAURICE BLOCK, former PCI, now incarcerated at Leavenworth Federal Penalter revocation of parole for Post Office robbery. This letter, actually addressed to J. T. WILLINGHAM, Warden, states that BLOCK knew JAMES EARL RAY while he was in the pen at Jefferson City and RAY "did indeed have deep racial feelings?", RAY \$888 stating at one time that colored Lt. BILLY BALE should be dead.

BLOCK also wrote that RAY had two very near and dear friends whom he trusted and walked with, these being BOB POWELL and J. R. RUSSELL. BLOCK heard POWELL say that he wanted RAY to go to Doe Run, Mo. and beat up a woman named FRANKIE BARBARA. BLOCK indicated that POWELL also was a deep feeling guy (apparently of the racial question). BLOCK believed that RUSSELL was from Farmington, Mo. BLOCK wrote that the above friends of RAY helped RAY get out in the bread box. BLOCK worked with them and was somewhat trusted.

I furnished this info telephonically to SA ROWEN AYERS at Jefferson City on 4/24/68 and he said he had heard that POWELL helped RAY escape. SA AYERS said he planned to interview both POWELL and RUSSELL or set out leads to have them interviewed.

BLOCK in the first paragraph of this letter asked that these facts be furnished to SA MELTON and the Warden*s office at Leavenworth turned it over to SA OUSLEY and thus to SA MELTON.
