1. On the afternoon of September 22, 1964, the undersigned officer interviewed George Van Swearingen #09865, at the Missouri State Prison. Swearingen is an inmate of the Missouri State Prison. He is a white male subject, age 20, from Humansville, Missouri. He was sentenced for four years from Franklin County for car theft in November, 1961. In July, 1962, he received an additional three years for escape from Cole County. Swearingen's education was received mainly at the State Hospital at St. Joseph, Missouri, where he was an inmate for approximately four years. He is able to read and write poorly.

2. The undersigned officer advised Swearingen that he wanted any information that he could furnish with reference to the stabbings in the prison on June 8, 1964. Swearingen stated that he did have information concerning the stabbings and that he would testify against the subjects responsible in court. He further stated that after the stabbings he had been housed in the Cole County Jail for a period of time for his own protection, and that he still feared for his life.

3. Swearingen gave the following account of his actions and observations:

"Between 6:30 p.m. and 6:45 p.m., June 8, 1964, I was in a group of inmates in the tunnel between the control center and the chapel. We were coming from the recreation yards. As we went down the tunnel I saw Charlie Keen down near the corner and he was looking back toward us. He jumped around the corner and then I could not see him. We went on down the tunnel and around the corner and as I got close to the chapel door I stopped because the tunnel was already crowded with inmates. Billy Burke was on my right near the corner leaning against the wall. While stopped, I saw Billy Burke and Charlie Keen pull pillow slips over their heads. I noticed Billy Burke's mask had one hole for the eyes. Burke had a long knife leaning against the rail while he put the mask on. There was another guy with crossed eyes in the tunnel with Burke and Keen. He was holding something white in his hand. I don't know his name but he works in the tailor shop. I believe it was a white rag in his left hand. They were down near the corner of the tunnel. I mingled in the crowd there between the chapel door and the corner. I saw a fourth subject pull a white

cloth up over his face to his eyes. I do not know what this was. He looked past me toward Keen and Burke and shouted, 'Bring them on'. About this time I heard a colored guy yelling and he came running through the crowd. When I first saw him he brushed by me and I saw a bloody hole in the lower right side of his back. I think his name was Simmons. He was yelling, 'Oh, Oh, Oh'. After he went past me I saw the fourth fellow with the mask grab Simmons' right arm or side. Another fellow with a mask on up to his eyes came up from Simmons' back and made a motion. I don't know what he done. I looked back toward the corner and the crowd had blocked the tunnel. I could see motions and masked heads. One was tall. I think this was Burke. Then the colored man, Simmons, ran back by me and he broke through the crowd and went toward the control center gate still yelling. Then I saw Charlie Keen throw a black leather glove down on the tunnel floor. We all headed for F and G Hall".

4. At the end of the interview, Swearingen again stated that he would testify in court. He further stated he would do so even though he feared an attempt might be made to shut him up.

1. Since September 21, 1964, the undersigned officer has interviewed numerous inmates and prison personnel with reference to the stabbings which occurred at the prison on the evening of June 8, 1964. Witnesses were interviewed at the prison, at the Church Farm, and at the Medium Security Prison at Moberly, Missouri.

2. The above mentioned stabbings occurred in the tunnel leading from near the control center gate to F and G halls. The victims of the stabbings were four colored subjects - Ernest Franklin, #07447; James Parks, #03051; Robert Mitchell, #00844; and Roscoe Odester Simmons, #05711. Franklin, Parks, and Mitchell recovered from the stabbings and Simmons died shortly after the attack.

3. Numerous inmates claimed to be witnesses to the stabbings and all of these inmates were interviewed by the undersigned officer and reports of these interviews have previously been forwarded. Various suspects' names were brought out during these interviews. These suspects and the witnesses identifying them are listed below.

4. As indicated in the previous reports, these witnesses in identifying one suspect will have varied descriptions of the incident. These descriptions will differ as to the location of the stabbings, the type weapons used, and whether or not the suspects wore hoods, masks, or were bare-faced. In their interviews, the three living victims stated that all of the assailants were white, however, Franklin could identify no one. Parks could identify Billy Burke and Mitchell identified Burke and Eley. Robert Banks, who was with the four victims, was able to identify Burke, Eley, and Douglas. Some of the statements from the other witnesses were not clear and they would become vague in their answers as to the details of the attack which they claimed to have witnessed. Obviously, several of these witnesses made up their story after having heard conversations of others in describing what happened.

1. On the morning of September 28, 1964, the undersigned officer interviewed James A. Parks #03051, an inmate of the Missouri State Prison. Parks is a negro male, age 44, from Little Rock, Arkansas. He entered the penitentiary in July, 1961, to serve a twelve year term for sodomy from Cole County. He stated that he previously served an eight year term for rape and stealing in Ohio (Federal) in 1945. Parks has a first grade education, however, he has studied since entering the prison and is able to read and write. The interview took place in the prison office of Major Poiry.

2. Parks gave the following account of his activities on the evening of June 8, 1964:

"On Monday night, about 15 minutes until 7:00 p.m., we were going through the tunnel toward the hobby shop where I work. We had been to the ball field. As we turned the corner a fellow by me said, 'Look out', and gave me a shove. When he did this my shirt front was ripped by a knife. I looked up and there stood a white fellow with a hood over his head. He was tall about 5-11 or 6 feet. He had two holes cut in the mask for eyes and it was tied under his chin. He had a knife about a foot long in his right hand and had it drawn back to stab me. Before he could cut me I grabbed his wrist with my left hand and I hit him on the chin with my right hand. He dropped his knife in the tunnel and ran toward F and G Hall. We was fighting to get back toward the corner so we could move out the tunnel at the control center gate. There was eight to ten guys with masks. Just as we turned the corner before the fight started someone yelled, 'Let's kill all these black niggers', and the fight started. They stabbed Simmons, Franklin, and Mitchell all at the same time. Two guys grabbed Simmons but I don't know whether they both stuck him or not. There was a tall fellow holding Simmons' right side and he had a bloody knife in his right hand. The fellow on Simmons' left was shorter and heavier. They both had hoods on. I don't know who they was. I think one called Brother was there. I saw Banks holding both hands of a fellow with a hood on but I didn't see them fighting. I think Banks knows who all these fellows was. I bent over to pick up a knife and a tall fellow kicked me. I think this was Burke. While I was fighting I knocked a short fellow down and his mask was moved over to where I saw a scar that ran down along the edge of his right eye almost to his cheek bone.

He had short black hair and it was standing up. I could pick him out. There was another fellow with a hood there that I think I know. I don't know his name but he is small and he is left handed. He played first base on one of the ball teams. I could pick him out. It was just a bundle of men and knives. When we fought back to the corner I saw Mitchell holding onto the rail along the outside wall. He was bleeding from under his arms like water from a faucet. When I reached out to help him I got stabbed in the lower left back. I don't know who stabbed me or where he came from. When I looked around the fellow was laying on the floor. I don't know whether I hit him with my elbow or what happened. I got Mitchell and helped him down toward the tunnel opening. About up to the Commissary door I got hold of Franklin and helped them both to the gate where Captain Troyer opened the gate and let us through".

3. Parks stated he would testify in court to the above information, however, he indicated he strongly feared for his life and would like to be moved. Parks has little or no education but apparently is able to read and study the Bible and talks of this most of the time.

Dear Sir:

The following is a general resume of the circumstances and happenings of the evening of June 8, 1964, at the institution.

At approximately 6:50 p.m., June 8, I was advised from the Control Center that two, possibly three, colored inmates from F&G Hall had been stabbed as the line was returning from the recreational yard. As soon as possible I returned to the institution.

Arriving at the institution, I learned that inmates Ernest Franklin #07447-J, James A. Parks #03051-J and Robert W. Mitchell #00844-J had sustained serious stab wounds and that inmate Roscoe Odester Simmons #05711-J was stabbed and pronounced dead upon arrival at the hospital. All of these men are colored and had been assigned to F&G Hall during the week of June 3.

The evening of the 8th, F&G Hall and one side of A Hall were privileged to go into the recreational yard. In the past week there had not been one rumor or comment concerning the transfer of the eleven colored men from A Hall into the empty cells of F&G Hall. Last Friday, June 5, three of the colored men from F&G Hall went with the hall to the movie, sat in the middle of the area and no incident occurred. The acceptance of these men into F&G Hall seemed to be rather general and we were in the process of making more assignments.

It has been determined in talking with Captain Glen Troyer, Shift Captain, 3-11, that as the line was returning from the recreational yard, it was orderly and proceeding well. The Captain advised that no officer was leading the line or stationed in the corridor to the halls. Captain Troyer was assisting with the Canteen line from B&C Hall, but stepped into the corridor when the lines entered. He advised that just as the line turned left to approach the corridor leading to the hall he heard

a scream and that he immediately started in its direction. As he went down the line he heard another scream and then noted the colored inmates running back toward the Control Center area. He further noted that two of the men showed evidence of being stabbed and he took them for admittance into the hospital through the Control Center. The line formation had during this interval moved into F&G Hall. Near the turn in the corridor, two other colored inmates were found on the floor; these were removed to the hospital. It has been determined that these two men were inmate Parks and Mitchell, who had left A Hall to go to the Hobby Shop where they worked.

The colored inmates from A Hall returning from the recreational yard became cognizant of the incident and began assembling near the Control Center. To get them back into the hall necessitated the display of a weapon, however, they were housed and A Hall secured.

In searching the area near the assault, the officers recovered five (5) knives of varying sizes. Three of the knives showed evidence of blood. Also found were two hood type items. These were made from pillow slips with slots cut for vision. The hoods and knives have been retained in lock up.

The colored inmates assigned to F&G Hall were all taken from the hall and placed back in A Hall on outcounts. These men were questioned by you, Mr. Steinhauser, Associate Warden-Custody, Major B. J. Poiry, and myself. These men were: Orme #07393, Dunn #73326, Taylor #03277, Gratten #06723, Turner #08376, Collor #08408, Tinsley #08413, and Jackson #08419. Two or three of this group stated they did not wish to return to F&G Hall, the others indicated they would like to return. None of the group indicated that they had been mistreated, ridiculed or unjustly treated during the stay in F&G Hall. They indicated that they had been well treated and that the white men displayed no resentment of their transfer.

The officers assigned the 11-7 shift of June 8 were held over on the morning of June 9. A separate feeding was given the colored men and they were then returned to A Hall. The white inmates of the institution were then fed and returned to their cells. Work details were then called out, however, A Hall upon seeing numbers of white men leaving their halls refused to leave.

A group of colored inmates were called into the Control Center where in the presence of yourself, Mr. Steinhäuser, Major Poiry, and myself, the conditions existing were discussed and they were further appraised of the steps we intended to take in filling one section of F&G Hall with colored men and they were further informed of the steps we would take, should any disturbance develop between the colored and white inmates.

Another grouping of white inmates were called into the Control Center and there, with a representation from the colored hall, the data as dispensed at the earlier meeting was again reviewed. From the comments of both white and colored inmates, it appeared that neither group was interested in any fracas or continuation of this senseless racial retaliation. The colored men were appraised of the fact that the inmates in F&G Hall were placed on positive lock up and full restrictions and they expressed some contentment with this information.

All details were called out following the noon meals and feeding in the dining room was resumed, with this exception, F&G hall were and will be fed for an indefinite period following the normal main line feeding.

At approximately 12:15 p.m., accompanied by you, we went to the office of Mr. James Tice, Administrative Assistant to the Governor, and acquainted him with the general happenings, our decisions and possible procedures. At that meeting we were informed by Mr. Tice that in his contact with Mr. Wayne Waldo, Executive Office, we were to proceed with the details of the procedure as was outlined.

At approximately 2 p.m., we again called a group of inmates together, these from F&G Hall. The incident, our plans of transfer and vacating one cell block unit and the circumstances of the restriction on F&G hall were called to the attention of these inmates. Very little comment came from this grouping of inmates and this is recognized as resulting from their general involvement in the situation and the possibility of some friend of the aggressor being present during this session.

During the remainder of the 9th, general normal institutional programs and activities were resumed. After the final feeding at 5 p.m., evening activities were prohibited and we will follow this procedure for whatever time this is deemed necessary.

The morning of June 10, activities within the institution were resumed with a certain degree of normalcy.

Additional officers will be made available over the week-end of June 13-14 as a precautionary act. An extra officer will be assigned to Towers 4-5 and 6. The additional officers will be on the recreation yard and some held at the Control Center should an emergency condition develop.


Presently there is considerable feeling and tension inside, this must be expected for a time. Every conceivable effort is being made to discuss the problem with both inmates and personnel and where minor problems arise they are being handled by myself, Mr. Steinhauser and Major Poiry. Most of the custodial officers are well aware of conditions as they were briefed in the staff meeting the morning of Tuesday, June 9, with you present, and again briefed later that morning following our discussion with the inmate groups.

I feel that we can expect some occasional, spasmodic emotional problems and these will be handled as diplomatically as possible. It is without doubt that a few individuals may endeavor to keep the pot boiling. This will be dealt with as the instances occur.

Should any activity of a serious impact materialize, I can but assure your office that immediate, forceful steps will be taken to eliminate the occurrence.

I will keep your office and others advised of our investigation in the effort to determine the men responsible for the fatality and stabbings.

MAY HAVE MADE OTHER CALLS WHILE NOT IN STEIN'S PRESENCE. STEIN STATED ONE CALL HE OBSERVED MADE FROM PUBLIC COIN BOX PHONE BOOTH DURING NIGHT PRIOR TO ARRIVAL NEW ORLEANS, LOUISIANA.

STEIN ADVISED ARRIVED IN NEW ORLEANS ON DECEMBER SEVENTEEN LAST.

STEIN ADVISED HE AND LOUIS LOMAX DID NOT LOCATE PHONE BOOTH IN QUESTION, WHEN TRIP RETRACED BY THEM. FEELS THIS DUE TO FACT LOMAX TRACED TRAVEL IN REVERSE FROM WAY IT ACTUALLY OCCURRED. STEIN STRONGLY FEELS BY RETRACING TRIP ROUTE FROM LOS ANGELES TO NEW ORLEANS HE WOULD BE ABLE TO LOCATE PHONE BOOTH IN WHICH CALL WAS MADE BY GALT (RAY).

STEIN DENIED GALT EVER VISITED HIM AT THREE THREE FOUR ZERO FLOYD TERRACE, HOLLYWOOD, NOR EVER HAVING MET GALT BEFORE THEIR MEETING IN SULTAN ROOM, ST. FRANCIS HOTEL, HOLLYWOOD, NIGHT OF DECEMBER FOURTEEN LAST. DENIES EVER HAVING FURNISHED ANY TYPE DRUG TO GALT (RAY), OR EVER HAVING SEEN GALT(RAY) USE ANY.

STEIN ADMITTED PAST ARRESTS FOR POSSESSION BARBITUATES AND STATED WOULD KNOW A "DOPEHEAD" IF HE SAW ONE. STATED GALT WAS NOT A "DOPEHEAD", BUT POSSIBLE HE MIGHT HAVE TAKEN "PILLS", ALTHOUGH NEVER IN PRESENCE OF STEIN.

STEIN STATED HE WAS QUITE IRRITATED WITH LOUIS LOMAX, BECAUSE LOMAX USED HIM FOR PUBLICITY PURPOSES. STEIN EXPRESSED CONCERN FOR HIS LIFE FROM THE KILLER OF MARTIN LUTHER KING, JR., BECAUSE OF PRESS EXPOSURE GIVEN HIM BY LOMAX.

IT WOULD APPEAR THAT STEIN TELLING TRUTH AS BEST HE REMEMBERS OF HIS ASSOCIATION WITH GALT (RAY).

BUREAU MIGHT DESIRE TO CONSIDER RETRACING STEIN'S TRIP WITH GALT (RAY) TO NEW ORLEANS, WITH PURPOSE IN MIND OF LOCATING PHONE BOOTH IN WHICH STEIN PERSONALLY OBSERVED GALT (RAY) MAKING CALL. POSSIBLE SUCH RETRACING MIGHT BE PRODUCTIVE IF CONDUCTED IN LOGICAL MANNER AND MIGHT POSSIBLY BRING OTHER FACTS TO MEMORY OF STEIN.

STEIN ADVISED HE RECALLS THAT GALT (RAY), ON TRIP TO NEW ORLEANS, TOLD HIM NAME AND ADDRESS OF PERSON HE WAS GOING TO SEE. STEIN STATED NAME WAS ITALIAN SOUNDING, WAS A WELL-KNOWN NAME IN NEW ORLEANS, AND ADDRESS GAVE STEIN MENTAL PICTURE OF CHALMETTE-INDUSTRIAL CANAL AREA. STEIN ADVISED WHEN ATTEMPTING TO LOCATE PHONE BOOTH ON TRIP WITH LOUIS LOMAX, LOMAX ASKED HIM IF SAM RISCELLE (PHONETIC)

REINTERVIEW WITH RITA STEIN

RITA STEIN, AKA RITA ROSAS; SISTER OF CHARLES JOSEPH STEIN REINTERVIEWED TODAY SEPARATELY BUT SIMULTANEOUSLY WITH REINTERVIEW OF HER BROTHER. PURPOSE WAS TO REVIEW IN DETAIL WITH HER FACTS SURROUNDING ORIGINAL MEETING WITH ERIC GALT AND ATTEMPT TO FILL OUT ANY FACTS SHE MIGHT HAVE OVERLOOKED DURING ORIGINAL INTERVIEWS.

INFORMATION FURNISHED WAS IN AGREEMENT WITH INFORMATION ORIGINALLY FURNISHED. CLAIMS NEVER MET GALT PRIOR TO MEETING WITH HIM IN SULTAN ROOM BAR, IN ST. FRANCIS HOTEL, HOLLYWOOD, IN MID-DECEMBER SIXTY SEVEN, DAY BEFORE HE DROVE HER BROTHER TO NEW ORLEANS TO BRING BACK HER DAUGHTERS KIM AND CHERYL. STATES SHE WAS INTRODUCED TO HIM THAT EVENING BY HER COUSIN, MARIE MARTIN, WAITRESS IN SULTAN ROOM BAR. SHE SAID SHE TRIED TO MAKE HIM UNDERSTAND THAT IT WAS ESSENTIAL SHE GET HER KIDS BACK FROM NEW ORLEANS, AND QUOTE THIS WAS NO PLAY CLOSE QUOTES. AT LEAVENWORTH, KANSAS

A former inmate of the Missouri State Penitentiary, Jefferson City, Missouri, advised on April 30, 1968, that he had worked in the bakery at the Missouri State Penitentiary while JAMES EARL RAY was an inmate at the penitentiary and also a bakery worker. RAY was a friend of BOB POWELL and an inmate recalled only as J. R. RUSSELL, believed to be from Farmington, Missouri.

POWELL intimated that RAY was planning an escape from the penitentiary and his escape was finally effected with a large bread box--POWELL, RUSSELL, and possibly others assisting in the loading of the bread box containing JAMES EARL RAY. When the bread truck came in, a remark was made by POWELL about sending something to the farm, and a rather heavy bread box was loaded on the bread truck.

RAY on one occasion made the remark concerning a Negro guard known as Lt. BILLY BOB "That's one Nigger that should be dead." RAY on one occasion referred to a male Negro cook as "that black son-of-a-bitch."

RAY was characterized as a loner and one who seemed to live in his own world. RAY was known to purchase the physical favors of homosexuals while still in the Missouri State Penitentiary, although it was believed that RAY would seek sexual relations with women outside the prison walls.

Prior to the time that RAY escaped in the bread box, POWELL was overheard telling RAY that he wanted RAY to go to Doe Run, Missouri, where a girl named FRANKIE BARBARA (phonetic) resided. POWELL wanted RAY to "beat that bitch real good, but don't kill her." POWELL wanted RAY to tell FRANKIE that the beating had come from POWELL. Apparently FRANKIE BARBARA had been POWELL's girl friend, and when she stopped corresponding with POWELL, POWELL became quite upset.

It was also believed that RAY had stabbed one inmate while still in the Missouri State Penitentiary down on the dock by the garbage cans, but his identity was never discovered by prison officials. It was believed that POWELL held this inmate while RAY stabbed him with a knife. It was not believed that this was a mortal wound, but simply an assault with a knife.

It was indicated that RAY used to steal locks from different doors in the bakery and kitchen area and practiced picking these locks later.

RUSSELL was described as a white male, age 35, about 5'10", 160 pounds. POWELL was a nice-looking, well built, white male with black hair.

JEFFREY MERRITT aka Jeff, formerly incarcerated in Missouri State Penitentiary from June, 1962, to August, 1964 and from November, 1965, to December, 1967, interviewed by New York. MERRITT recalled subject RAY as being one of the inmates at the Penitentiary and said he and RAY had worked together on the loading docks there. He stated his knowledge of RAY was limited and he could not recall anything specific regarding his background, habits or description, which would be of value in locating RAY. He pointed out that RAY appeared to be a "loner" and associated very little with other inmates. Due to the policy of segregating white and Negro inmates in their living quarters, MERRITT was limited with contacts with RAY.

Following RAY'S escape from the Penitentiary, MERRITT could not recall having heard any comments among the prisoners as to where RAY might have gone.

MERRITT currently resides at 346 West 17th St., NYC, telephone 989-3100, and is employed as a mail handler at the National Maritime Union, 36 Seventh Avenue, NYC.

The following investigation was conducted by SA THOMAS H. WEAVER:

AT VERSAILLES, MISSOURI:

On 5/1/68, WILLIAM EARLESS MILLER, JR., also known as "PUNCHY" MILLER, who resides in care of Sheriff J. T. HULL, Morgan County Sheriff's Office, furnished the following information:

From 1959 to 1965, he was in and out of the Missouri State Penitentiary at Jefferson City on different convictions. He worked around the kitchen most of the time he was confined at the penitentiary and knew JAMES EARL RAY during that time. RAY was friendly with all the whites working the kitchen details, although he never said much to anyone. He never associated with any of the Negroes working in the kitchen insofar as MILLER could observe, but he never said anything to MILLER's knowledge to indicate how he felt one way or the other about race. He recalls RAY spoke of New Orleans, Louisiana, along the lines of wishing to go there sometime, apparently not having ever been there. He never heard him mention Oregon, Canada or Mexico. RAY played poker and took different types of "pep pills", but he never knew RAY to be involved in the sale of these pills to other inmates. RAY never listened to western and country music and claimed to despise that type of music, and when shows came to the penitentiary featuring that type of music, RAY would attend
