The following investigation was conducted in Oklahoma City by SAs DAVID J. LANG and MICHAEL F. HUTTER:

On 4/25/68, CARMEN E. RAMAGE, 1642 N.W. 12th, Apt. 1, advised that she first met ROBERT DALE PORTER five years ago in Kansas City in August. She stated that she had met him at the Belmont Bar, Kansas City, Mo., and they had spent the evening there at the Ship Bar. She advised that she had not seen PORTER since then to April 19, 1968. She stated that while he was serving time in the Missouri State Penitentiary (MSP) at Jefferson City, that numerous pieces of correspondence passed between them.

RAMAGE stated that PORTER had remained in Oklahoma City from 4/19 and she had last seen him approximately 10 AM, 4/23/68. She stated that he must have left town or else he would have been in contact with her.

RAMAGE stated PORTER had told her that he had been in Cedar Rapids, Iowa and had traveled around the State of Iowa and that he had left his home in Waverly, Iowa taking with him his mother's ring which he had pawned and sent her the pawn ticket. PORTER further told her that he had been released from the MSP on 12/8/67 and that he had known JAMES EARL RAY while in the penitentiary. He stated that while in the Penitentiary that RAY had escaped from the penitentiary in a guard's uniform while he was working in the dry cleaning plant and that RAY had obtained this uniform from a guard who has since been fired. He stated that RAY and this guard were very close friends. She further stated that PORTER told her that RAY had not escaped in a bakery truck as the newspapers had reported. RAMAGE stated that she had sent a check, in February, 1968, in the amount of \$23.00 to PORTER in Waverly so that he could obtain a bus ticket to come to Oklahoma City to see her. She stated that PORTER had called her from the bus depot in Oklahoma City approximately 7:30 PM 4/19/68 and told her that he was drinking with a person who had an amputated hand at the knuckles at Winnie's Bar which is located across the street from the bus depot.

RAMAGE stated that PORTER had possibly applied for employment as machinery operator at an automatic car wash in the 4000 block of North Pennsylvania or through the Key Personnel, 110 N. Robinson or at some Mortgage and Loan Company across the street from the city library. RAMAGE further advised that PORTER had told her that he had lost his luggage in Kansas City and was currently traveling without any luggage.

Continuous and intensive investigation was conducted to locate PORTER at Oklahoma City.

On 4/29/68, PORTER was located through an Oklahoma City PCI at the Blood Plasma Donor Center, 505 West Main, Oklahoma City and was subsequently interviewed furnishing the following information:

ROBERT DALE PORTER, temporarily residing at Hudson Hotel, Oklahoma City, stated that he had been in the Missouri State Penitentiary (MSP), Jefferson City, Mo. from June or July, 1961 through 9/1/62 and again from 3/2/64 until his

release on 12/8/67. PORTER stated that upon his release from MSP, that he had gone to Waverly, Iowa to live at the residence of his mother, CLARA PORTER, 103-1/2 E. Bremer, Waverly.

PORTER stated that he left Waverly in the latter part of February, 1968 and the following is approximately his itinerary.

Waterloo, Iowa - where he remained approximately 2 days.

Des Moines, Iowa - remaining 3 to 4 days.

Cheyenne, Wy. - remaining 3 days.

Pocahontas, Iowa - over night with uncle HANS NIELSON.

Humble, Iowa - over night with uncle HANS PORTER.

Aplington, Iowa - over night where he contacted his brother-in-law's mother and brother, LOUELLA and MELVIN ACKER.

Iowa City, Iowa - remaining approx. one week. While there he pawned a man's black face ring at the Hock-Eye Pawn Shop for \$7 on 3/11/68. PORTER resided he believes at the Berkley Hotel, where the bus station is located and left town on 3/11/68.

Storm Lake, Iowa - remaining approx. 2 days.

Red Oak, Iowa - over night. Porter resided at the hotel across the street from the Police Dept.

PORTER then hitchhiked to Barstow, Calif. leaving approx. 10 AM, one day and arriving in Barstow early the next evening. This ride was with a mechanic from Marshal Town, Iowa. That same date, PORTER hitched a ride to Visalia, Calif. with a girlfriend employed at Nellis AFB, Las Vegas, Nev., arriving Visalia that evening. PORTER stayed at Visalia approximately one week and visited with his daughter, VICTORIA RAY PORTER. He stated VICTORIA is residing with a JOSIE ACOSTA PORTER who is living with a CHUCK (LNU). JOSIE, PORTER's ex-wife, resides at 124 N.W. 1st, Visalia.

PORTER then spent two or three days hitchhiking to Nevada where he stayed over night.

Las Vegas, Nev. - where PORTER stayed at the McDonald Hotel, approximately 3 nights.

Salt Lake City - remaining 2 nights.

Laramie, Wy. - remaining one night.

Denver, Colo. - where PORTER visited with a BETTY LOU LUCAS, 3626 Perry Street.

PORTER hitchhiked from Denver to Colorado Springs, Colo. with a PHILLIP E. MEHL, 432 W. Bijou, where he remained for 2 or 3 days.

Albuquerque, N.M. - PORTER resided at Albuquerque for 2 to 3 days and contacted a ROSE SINKEY, who formerly resided in Waverly, Iowa.

Las Cruces, N.M. - PORTER spent approx. 2 days traveling from Las Cruces to Van Horn, Texas where he resided at the only hotel in town over night.

Fort Worth, Texas - PORTER resided for approximately 2 days at a cheap motel located near the bus depot.

Durant, Oklahoma - residing over night.

McAlester, Oklahoma - PORTER resided with a couple that live behind a cab stand for two days.

Canadian, Oklahoma - residing one day, while there PORTER helped an individual paint 55-gallon oil drums for use on his boat dock.

PORTER then went to Miami, Oklahoma where he resided one night at the St. James Hotel.

PORTER traveled by bus from Miami, Oklahoma to Carthage, Missouri stopping for approx. one hour in Joplin, Mo. While in Joplin, PORTER attempted to contact a ROGER ZINN, a former convict but stated he was unable to do so. PORTER stated that he recalls while waiting in the bus depot that he heard of the assassination of MARTIN LUTHER KING.

While in Carthage, PORTER contacted a BETTY ELLIOTT, 901 Fulton St., while attempting to contact a girl he had known in 1947.

PORTER traveled to Warsaw, Mo. staying overnight. While in Warsaw, he contacted a JACK LANPHERE by telephone and stated he wanted to see LANPHERE, that he wanted to borrow money from him. LANPHERE advised that he was unable to get into town because of his parole status.

PORTER traveled to Columbia, Mo. where he was a sleeper at the Police Dept. and the next day contacted an uncle, MARION MURRAY, 102 Thistledown Dr., Columbia.

PORTER then traveled to California, Mo. and attempted to locate a LEWIS BARGEON who had been in the MSP Maximum Security with PORTER. He was unable to contact him but stayed overnight at California, Mo.

PORTER then traveled to Maysville, Mo. where he resided at the Lincoln Hotel overnight and contacted Sheriff O. L. Maddox.

St. Joseph, Mo. - PORTER checked in at a small hotel but met a person, name unrecalled, in a bar and they then went to Kansas City, Mo. by car and stayed at the Gladstone Hotel. PORTER met with a MIKE COX at a bar on 9th St. in downtown, Kansas City, Mo. While with MIKE COX, he and COX drove on a Sunday to St. Louis, Mo. attempting to contact a LAWRENCE MOBLEY, a former convict described as a large Negro male. They were unable to contact MOBLEY. They contacted a Mrs. RICHARD PESEK, a sister-in-law of BETTY REITTER, the mother of a illegitimate son of PORTER by the name of THOMAS DALE REITTER.

COX and PORTER returned to Kansas City that evening which he believes was a Sunday.

PORTER then traveled from Kansas City to Oklahoma City hitching a ride with two young boys from Peculiar, Mo. PORTER stated he believes that this was on 4/19/68. PORTER resided with a CARMEN RAMAGE, 1642 N.W. 12th, Oklahoma City until approx. 4/23/68 when he left hitching a ride with a Naval Lieutenant to Long Beach, Calif.

PORTER stayed one day in Los Angeles at the bus depot and left Los Angeles on Friday.

PORTER arrived Oklahoma City Saturday night 4/27/68 where he stayed with a LLOYD HISE, 2728 N.W. 39th.

On 4/28/68, PORTER drove HISE and his pickup truck to Ft. Smith, Ark. and hitchhiked back arriving approx. 1 PM.

PORTER stated that while incarcerated in the MSP, that JAMES EARL RAY known to him as JIMMY RAY was involved in selling amphetamines to his fellow inmates. He stated that a JOHN STOUT, an ex-guard in the MSP was his source of these amphetamines. PORTER stated that STOUT and RAY were very good friends.

PORTER stated that RAY was extremely quiet, was a person who did not take much from anyone. He stated that to his knowledge RAY has taken amphetamines but had never taken any hard narcotics.

He further stated that whenever RAY was pushed around that he would retaliate fiercely. PORTER stated that on two previous occasions RAY had attempted to escape from the MSP - once by going over the wall and once when he hid in a ventilator shaft and subsequently broke his elbow. PORTER stated that RAY had never mentioned to him where he was from or where he would go when he got out of prison.

He further stated that RAY had never indicated that he disliked Negroes and to PORTER's knowledge was even associated with several while in the penitentiary. PORTER stated that he was leaving Oklahoma City on 4/29/68 and was hitchhiking to the home of his mother in Waverly where he would obtain work as a construction worker.

It is noted PORTER states he believes he was in Joplin, Missouri at the time of KING's murder, however, his presence 4-12-68 in Warsaw, Missouri has been verified. It would therefore appear from a review of PORTER's itinerary that he was possibly in Van Horn, Texas at the time of KING's murder. In the event it is ascertained by El Paso that PORTER was not in Van Horn, Texas at time of KING's murder, then El Paso should set out appropriate leads, from the itinerary furnished by PORTER, in order to establish his whereabouts on 4-4-68.

JAMES W. BROWN WAS REINTERVIEWED AT TALLADEGA, ALA., WHERE HE IS ATTENDING REHABILITATION STATE SCHOOLS FOR THE BLIND. HE IS BLIND IN ONE EYE. BROWN WAS UNABLE TO FURNISH ANY INFORMATION AS TO THE POSSIBLE IDENTITY OF THE COOLEY ORGANIZATION. HE DID SAY THAT THERE WERE FOUR OR FIVE PERSONS PRESENT WHEN RAY MADE THE REMARK THAT THE COOLEY ORGANIZATION WOULD PAY TEN THOUSAND DOLLARS TO GET MARTIN LUTHER KING KILLED AND HE WAS GOING TO KILL KING UPON HIS RELEASE. HE SAID JOHNNY VALENTI, NOONIE EDEN (PH), AND CHESTER EALEY (PH) WERE THE ONLY THREE NAMES HE CAN RECALL OF THESE PERSONS PRESENT. HE SAID TO THE BEST OF HIS KNOWLEDGE ALL THREE ARE STILL CONFINED TO THE MISSOURI STATE PENITENTIARY. HE SAID THIS WAS IN THE LATTER PART OF SIXTYTHREE. HE WILL TESTIFY TO THIS INFORMATION. HE ALSO SAID HE WOULD IMMEDIATELY FURNISH ANY INFORMATION HE DEVELOPS OR CAN RECALL TO THE FBI CONCERNING SUBJECT.

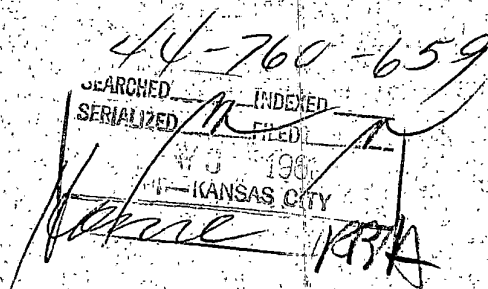

MARTIN LUTHER KING JR., UNEARTHED GREEN STAMPS THAT WERE ISSUED AS A RESULT OF A PURCHASE AT A BIRMINGHAM, ALABAMA GAS STATION IN MID-FEBRUARY OF 1968. THIS REPORTER LEARNED OF THE GREEN STAMPS WHILE HERE IN SAN ANTONIO AND WAS ABLE TO CONFIRM THE ITEM BY TELEPHONE. THE BIRMINGHAM GAS STATION OWNER SAID THE STAMPS WERE ISSUED AT HIS STATION, AND HE ALSO IDENTIFIED A PICTURE OF RAY AS THAT OF THE MAN INVOLVED IN THE TRANSACTION. THE STATION OWNER RECALLS THE TRANSACTION BECAUSE THE WHITE MUSTANG HAD A CLUTCH PROBLEM.

FBI REPORTS CONSISTENTLY PLACE RAY IN LOS ANGELES AS A STUDENT AT DANCING AND BARTENDING SCHOOLS AT THE TIME OF THE GAS STATION TRANSACTION. HOWEVER, THESE REPORTS ARE BOLDLY CHALLENGED BY THE STATEMENT OF THE BIRMINGHAM GAS STATION OWNER. THIS REPORTER DISCLOSED LAST WEEK THAT RAY DELIVERED A PACKAGE TO THE NEW ORLEANS FAMILY OF ONE OF HIS HOLLYWOOD GIRL FRIENDS DURING HIS LAST WEEK THERE. THE SEQUENCE OF EVENTS, THEN, IS CLEARLY IMPOSSIBLE. THE FBI INTERVIEWED THE FAMILY FOLLOWING MY DISCLOSURE OF THE INCIDENT AND CONFIRMED THAT RAY HAD DELIVERED THE PACKAGE. THE TRIP FROM LOS ANGELES TO BIRMINGHAM VIA NEW ORLEANS IS IN EXCESS OF 2,500 MILES. RAY COULD NOT HAVE DRIVEN THAT ROUTE, PARTICULARLY IN A MUSTANG IN THE SHORT PERIOD BETWEEN MARCH 27TH AND MARCH 30TH. THERE IS AN OUTSIDE CHANCE THAT THE TRIP COULD HAVE BEEN ACCOMPLISHED IF RAY HAD A DRIVING COMPANION AS HE DID IN DECEMBER. THERE HAVE BEEN NO INDICATIONS THAT HE DID HAVE A COMPANION.

--CONTRADICTIONS--

THESE CONTRADICTIONS AND CONFUSIONS ARE COMPOUNDED BY OTHERS THAT HAVE OCCURRED DURING THE INVESTIGATION INTO THE SLAYING OF DR. KING. THE FBI ISSUED A REPORT THAT RAY HAD TAKEN DANCING LESSONS IN NEW ORLEANS DURING A TIME THE AGENCY'S OTHER REPORTS AND RECORDS SHOWED THAT RAY WAS IN PRISON.

THE FBI HAS BEEN FORCED TO ADMIT THAT THE FINGERPRINTS, CIRCULATED DURING THE EARLY DAYS OF THE MANHUNT WERE NOT THOSE OF RAY. THE BLAME FOR THIS, ACCORDING TO THE FBI, MUST BE ASSUMED BY THE WARDEN OF THE MISSOURI STATE PENITENTIARY. THE WARDEN, THE FBI CLAIMED, ISSUED MISTAKEN FINGERPRINTS ON RAY WHEN THE CONVICT ESCAPED FROM PRISON IN APRIL, 1967. THIS MEANS TWO THINGS: (1) HAD RAY BEEN ARRESTED AFTER HIS ESCAPE FROM PRISON; HE WOULD NOT HAVE BEEN HELD BY THE LOCAL ARRESTING OFFICERS AS A FUGITIVE; (2) HAD RAY BEEN ARRESTED IMMEDIATELY AFTER THE SLAYING OF DR. KING THE MISTAKEN FINGERPRINTS WOULD HAVE CONFUSED THE INVESTIGATION AND POSSIBLY WOULD HAVE LED TO HIS RELEASE.

THE SIGNIFICANT FACT IS THAT THE GEORGIA BUREAU OF INVESTIGATION (CAPS G,B,I) HAD MISTAKEN FINGERPRINTS OF RAY UP UNTIL LAST WEDNESDAY. HAD RAY BEEN ARRESTED IN ATLANTA, THEN, ON THE DAY HE PARKED THE WHITE MUSTANG, THE GEORGIA AUTHORITIES WOULD HAVE BEEN ATTEMPTING TO IDENTIFY HIM BY MATCHING HIS FINGERPRINTS AGAINST A SET OF PRINTS THAT BELONGED TO SOMEBODY ELSE.

ALSO DID NOT OCCUR TO THE FBI TO INVESTIGATE THE POSSIBILITY THAT RAY WAS IN TELEPHONE CONTACT WITH NEW ORLEANS WHILE HE WAS STILL IN LOS ANGELES. THIS REPORTER LOCATED THE PHONE BOOTH USED BY RAY IN THE LOBBY OF THE ST. FRANCIS HOTEL LAST WEDNESDAY. THE WALLS OF THE BOOTH WERE COVERED WITH GRAFFITI. ONE LINE READ "DOWN WITH MEXICANS, NIGGERS, AND MARTIN LUTHER COON."

--FATAL OVERSIGHT--

THE MOST FATAL OVERSIGHT WAS THE FBI'S FAILURE TO UNCOVER THE CONSOLE TELEVISION SET RAY GAVE TO A HOLLYWOOD GIRL FRIEND IN RETURN FOR HER PORTABLE. THE SWAP OCCURED AROUND VALENTINE'S DAY--FEBRUARY 14--AND RAY TOLD THE GIRL HE WAS LEAVING TOWN. THIS REPORTER FOUND BOTH THE GIRL FRIEND AND THE TELEVISION SET. THE BACK OF THE TELEVISION SET CONTAINED HANDWRITING BELIEVED TO BE THAT OF RAY AND CAN BE MATCHED AGAINST THE GRAFFITI ON THE WALLS OF THE TELEPHONE BOOTH.

A CLEAR READING OF THIS MAKES IT ALL BUT CERTAIN THAT RAY TOOK THREE TRIPS TO NEW ORLEANS BETWEEN DEC. 15 AND THE END OF MARCH. THERE WAS THE TRIP OF DEC. 15 WHICH STEIN AND I ARE NOW RETRACING; THERE WAS A SECOND TRIP THAT BEGAN ON VALENTINE'S DAY. FINALLY THERE WAS THE TRIP THAT BEGAN A FEW DAYS BEFORE THE END OF MARCH AND CULMINATED IN THE DEATH OF DR. KING.

THE VALENTINE'S DAY TRIP EXPLAINS THE GREEN STAMP TRANSACTION IN THE MIDDLE OF FEBRUARY. IT ALSO EXPLAINS THE MYSTERIOUS PHONE CALL TO THE ALABAMA DEPARTMENT OF MOTOR VEHICLES REQUESTING THAT A DUPLICATE OF "GALT'S" DRIVERS LICENSE BE SENT TO A BIRMINGHAM BOARDING HOUSE. THE LICENSE WAS MAILED ON MARCH 1, THE DAY BEFORE RAY IS ALLEGED TO HAVE GRADUATED FROM A LOS ANGELES DANCING SCHOOL. IT IS CLEAR THAT RAY "DROPPED OUT" FROM THE SCHOOL FOR SEVERAL DAYS TO MAKE THE SECOND TRIP.

THE ONE UNASSAILABLE FACT IS THAT RAY DID MAKE THESE TRIPS. AND THAT HE WAS IN TELEPHONE CONTACT WITH SOMEONE IN NEW ORLEANS. RAY TOLD STEIN THAT HIS CONTACT WAS AN IMPORTANT PERSON, A CONTRACTOR AND BUILDER. THE KEY, THEN, LIES IN LOCATING THE PHONE BOOTH ALONG THE HIGHWAY FROM WHICH THESE CALLS WERE MADE. TELEPHONE COMPANY OFFICIALS BELIEVE THEY CAN TRACE THE CALLS IF THE BOOTH CAN BE LOCATED.

AT JEFFERSON CITY, MISSOURI:

On April 29, 1968, BOBBY FRED ASHE, MSP #01562, inmate, Missouri State Penitentiary (MSP), advised that he knew JAMES EARL RAY at the MSP, but was not well acquainted with him. He said he would doubt that anyone was "well acquainted" with RAY, as he was a quiet individual who did not become involved in any of the prison rackets. He stated he never knew of RAY to be involved in the sale of "pills" or amphetamine, or to operate or play in poker games. He advised that he never knew RAY to express strong opinions on any subject, including racial matters, and he never heard of a bounty mentioned regarding Dr. MARTIN LUTHER KING. He said he knows nothing of RAY's family, background or associates and has no information regarding his escape or plans following his escape. He advised that RAY was not known, so far as he knows, as a "kid" or a "punk" in the prison, and he doubts that RAY was ever a cellmate of JIMMY CARPENTER.

On April 29, 1968, Mr. BERNARD PESCHANG, Route 2, a cook at the Renz Prison Farm, Missouri State Penitentiary, advised that he had worked at the kitchen at the MSP in about 1963-64 when RAY was working there pushing a food cart, to the hospital. He recalled at the time that RAY was known as the "hide out guy" from a previous occasion when he hid inside the prison for some time before being found. He recalls that on a Sunday morning, during April, 1967, the bread truck arrived at the Renz farm when PESCHANG was there as the cook, and the bread was "messed up". RAY had hidden out again once while PESCHANG was at the Renz farm, and when he saw the bread box with the "messed up" bread, he thought then without knowing why, that "JIMMY RAY must be out again". He did not know at the time, he said, that RAY was working in the bread room at the main prison, and he has no idea who might have helped RAY escape on this occasion. When he heard later that RAY had, indeed, escaped, he recalled

the "messed up" bread and notified his superiors at the Renz farm. The bread box used to transport bread in an open truck from the main prison to the farm had contained sufficient bread to be used on the day it was received, but it was a large enough box that a man in a cramped position could have been hidden under some layers of loaves.

PESCHANG said that he has no idea who RAY's close friends were, and as he recalled, RAY "got along" but was not close to anyone. He knew RAY was unhappy in prison, from working with him at the kitchen at the main prison, and he had heard RAY say that he would "make it to South America" if he ever got out of prison. He said he never heard RAY make any statements to indicate he was unusually prejudiced against Negroes, and he did not seem to be the type to have it "in" for anyone, but was just "for JIMMY RAY". He said that the bread in the bread box on the day RAY reportedly escaped, was turned around and turned over, and not neatly stacked as it usually was on arrival at the farm. He does not believe any incidents at the time occurred which would indicate any guard had anything to do with helping RAY escape, and he could not be certain that RAY got out in the bread box, but it would have been possible.

On May 1, 1968, Missouri State Penitentiary (MSP) records were checked for RAY EUGENE WARREN. The following information was obtained:

RAY EUGENE WARREN was received at the MSP on June 9, 1955, to serve a 10 year sentence on charge of robbery first degree by means of a dangerous and deadly weapon under court case #1941-C. He completed this sentence and began an additional 20 year sentence on July 11, 1961, on charge of robbery first degree by means of a dangerous and deadly weapon, court case number 1945-C. He was assigned MSP number 69963. WARREN was discharged by commutation of sentence from April 13, 1968. Relatives listed on WARREN's correspondence and visiting list are wife DORIS WARREN, 3330 Sims, St. Anne, Missouri; brother-in-law BILL SCOTT, same address; sister, BETTY WARREN, Route 2, Box 187, Robertson, Missouri. Records reflect that WARREN was visited by his mother and brother, PAUL WARREN, Robertson, Missouri, and brother, SCOTT WARREN, Pomona, California. While WARREN was in the MSP, he was in the following cells:

From November 6, 1959, until January 4, 1960, G70;

From January 4, 1960, until July 1, 1960, G89;

From July 1, 1960, until August 31, 1960, C20;

From August 31, 1960, until October 31, 1960, E80;

October 31, 1960, until January 6, 1961, E33;

January 6, 1961, until March 17, 1961, F96.

Warden HAROLD SWENSON advised confidentially that WARREN had assisted his department in an investigation which had been conducted and that from November, 1965, until after JAMES EARL RAY escaped from the MSP, that WARREN was in solitary confinement being given maximum security for fear of his life. Warden SWENSON continued that if at all possible, WARREN should not be contacted as he is extremely nervous and fearful for his life. However, Warden SWENSON advised that WARREN is to be living with his brother, SCOTT L. WARREN at 17902 Edmond Place, Covina, California.

SINCE WARREN WAS SENTENCED TO THE MSP FOR A TOTAL PERIOD OF 30 YEARS ON CHARGE OF ROBBERY WITH A DANGEROUS AND DEADLY WEAPON AND IS EXTREMELY NERVOUS, HE SHOULD BE APPROACHED WITH CAUTION AND POSSIBLY CONSIDERED ARMED AND DANGEROUS.
