FBI Probed Klan, Minutemen After Assassination of King

WASHINGTON (AP) — The FBI investigated members of the Ku Klux Klan and the Minutemen in the early days of the search for Martin Luther King's assassin, newly disclosed FBI documents reveal.

Four days after King was slain in Memphis on April 4, 1968, FBI headquarters ordered an investigation of all known members of the Klan, the right-wing Minutemen, "other hate group members, rabble rousers and any other individuals known to have violent proclivities located within your territories."

The order was sent to FBI field offices in Memphis and Knoxville, Tenn., Birmingham and Mobile, Ala., Jackson, Miss., Milwaukee and Minneapolis.

The FBI paid special attention to some members of the Klan and Minutemen because of their past activities or because informers called attention to them, the memo disclosed.

For example, an informer identified as an ex-Klansman told the FBI about a Klan member in Greenville, Miss., whom he "believed capable of violence and believed possible he may have murdered King."

Another informer said that a Klan leader he met in a Savannah, Ga., bar "is an exact look-alike to the artist's conception" of the suspected assassin. The artist's sketch of the suspect had been widely published in newspapers.

Agents also focused on Byron Beckwith, who had been arrested for the 1963 murder of Civil Rights leader Medgar Evers in Mississippi. Beckwith was tried twice but neither jury was able to reach a verdict.

As for the Minutemen, the Boston field office reported that an unnamed informer said the right-wing group "had a general plan to foment civil strife by killing Negro leaders, Martin Luther King, Rap Brown and Stokely Carmichael and therefore, seize power in the confusion. No specific timetable was set."

FBI Surveillance Tapes On King Ordered Sealed

WASHINGTON (UPI) — A federal judge has ordered all the FBI's tapes of its surveillance of Martin Luther King Jr. sealed in the National Archives for 50 years.

U.S. District Judge John Lewis Smith issued the order Monday after hearing a damage suit against the FBI by Bernurd Lee, a former assistant to the slain civil rights leader, and the Southern Christian Leadership Conference.

Lewis Smith refused to order

the tapes destroyed, as Lee asked. But gave the FBI 90 days to give the archives all copies of the tapes and transcripts of its bugs and wiretaps of King and the SCLC offices between 1963 and 1968.

Lee also asked for damages but Smith ruled this was barred by a three-year statute of limitations which began to run at the time Lee and the SCLC first knew about the surveillance.

"Starting in the mid-1960s and reaching a peak in 1968 and 1969 ... the nation's leading newspapers were rife with accounts of buggings of Dr. King," Smith said.

"Under these circumstances, plaintiffs' avowal that they had no knowledge of the source of the tapes until (the) 1975 report by the Senate Select Committee on the FBI is not well taken."

The fact that the surveillance of King was personally ordered by then FBI Director J. Edgar Hoover came to light during the investigation.

Lee charged in particular that the FBI bugged conversations in King's room in Washington's Willard Hotel in 1963, sent a copy of the tape to Mrs. King in 1964 and later, as a harassment, sent King himself a copy.

The Select Senate Committee on Intelligence reported the FBI eavesdropped on King from 1963 until his murder in 1968, as part of a campaign to discredit him.

Smith's order covered all tapes and transcripts of wire-tappings and microphone surveillance of King in his home and "places of accommodation" and of the SCLC's offices in Atlanta and New York between 1963 and 1968.

Justice Department

Decides Ray Acted Alone In

King Death

WASHINGTON (UPI) — The Justice Department, concluding months of investigation, has concluded that James Earl Ray acted alone in assassinat-

ing Dr. Martin Luther King Jr., UPI learned today.

Reliable sources said the conclusion is contained in a 148-page report prepared by

Michael Shaheen, director of the department's Office of Professional Responsibility, at the direction of former Attorney General Edward Levi.

Publication of the report, the sources said, has been withheld apparently because of the Justice Department's concern not to appear to be interfering

in current House attempts to authorize a special committee to reopen the investigation of the murders of King and John Kennedy.

The department declined to comment on the report of Shaheen's investigation.

The House scheduled debate today on reconstituting its

Select Committee on Assassinations, which technically died at the end of the last Congress Jan. 3.

The night before House

debate, comedian and activist Dick Gregory and author Mark Lane led a group of about 200 people in an all-night vigil outside John F. Kennedy's birthplace in Brookline, Mass.

"This vigil is to let Tip O'Neill know we're watching him," said Richard Feldman, a spokesman for the group. "It seems funny to us that with all the frivolous spending in government, they should be so reluctant to let us know what's going on in this matter."

Lane authored the book "Rush to Judgment" about the Warren Commission report on the Kennedy assassination.

The House committee was originally created in the waning days of the 94th Congress, largely at the insistence of the congressional Black Caucus.

Former Rep. Andrew Young, a close associate of King's who is now ambassador to the United Nations, and other black congressmen, believe Ray was part of a conspiracy against the black civil rights leader.

But opposition developed at the start of the 95th Congress to continuing the panel and providing it with a budget of \$6.5 million a year, as requested by Staff Director and Chief Counsel Richard Sprague.

Sprague has said publicly his staff has amassed nearly a thousand unanswered questions, and several new bits of evidence relating to the deaths of both men.

Ray was apprehended in London traveling on two Canadian passports under the alias of Raymond George Sneyd on June 8, 1968.

'Thorough' Probe Says Ray Acted Alone in Killing of King

Compiled From Press Dispatches

WASHINGTON — A thorough FBI investigation indicates James Earl Ray acted alone in the 1968 assassination of civil rights leader Martin Luther King Jr., the Justice Department announced today.

"In all the years following the assassination, the investigation has failed to reveal any connection between any alleged conspirator(s) and James Earl Ray — including those alleged by Ray himself," the 201-page report of the investigation stated.

"Indeed, the overwhelming evidence indicates that Ray was almost totally alone during the year after his escape from Missouri State Prison" before he shot King from a flophouse bathroom in Memphis, the report said.

However, the investigation ordered by former Atty. Gen. Edward Levi was not able to determine the source of the funds Ray expended to buy equipment and then escape abroad before his capture, the report said. But it suggested the money came from robberies possibly committed by Ray.

The report, developed by the Justice Department's Martin Luther King Task Force, found that during Ray's imprisonment in Missouri State Prison he told

inmates he "hated Negroes" and vowed on several occasions he would kill King "if the price was right."

"The only new evidence that was developed related to details that did not affect the ultimate conclusion that James Earl Ray was the properly convicted murderer," the Justice Department announced in releasing the report.

Ray is serving a 99-year prison sentence in Tennessee.

The task force said it was "satisfied" after its review of the files "that the FBI did a credible and a thorough job in attempting to identify any possible conspiracy or persons who could have been involved in the murder."

The Justice probers found no evidence that the FBI was implicated in King's murder.

However, the FBI failed to check some leads which might have erased some lingering mysteries about the case, the report said.

As for the FBI's efforts to harass King and discredit him as a civil rights leader, the task force called the campaign clearly improper but recommended against prosecution of anyone involved.

Ex-Policeman May Name 'Plotters' in King Slaying

WASHINGTON — A former Louisville, Ky., patrolman is expected to name under oath Louisville and Federal lawmen he alleges conspired to kill Martin Luther King Jr. two years before the Civil Rights leader was assassinated.

Sources involved in the House investigation of the murders of King and President Kennedy said today that the Louisville allegation is the "top priority" in the King investigation, but congressional probes also have uncovered the following leads:

1. A Somerville, Tenn., businessman alleges that while in Memphis he overheard part of a telephone conversation two days before King was murdered there in April 1968, involving shooting someone on a balcony. The businessman has told investigators for the House Assassination Committee that he heard someone named "Roberto" tell

another party "to kill the bastard even if you have to shoot him on the balcony."

2. A female friend of Jack Ruby, killer of Lee Harvey Oswald, Kennedy's assassin, has told investigators that she has "got religion" and wants to testify about Ruby's activities prior to Kennedy's shooting in Dallas in 1963.

Committee investigators, led by chief counsel Richard A. Sprague, are in Tennessee today interviewing James Earl Ray, King's convicted killer. Ray and his brother, Jerry, are expected to be called before the committee to testify.

To complete the investigation of these and other leads that committee members say are promising, the panel states that it needs \$2.7 million for a 12-month probe. The committee is backing away from an earlier request of almost \$13 million to cover a period of two

years. The controversy over that request almost killed the committee.

COMMITTEE staffers have already interviewed the Louisville policeman about his allegations that three local Federal agents and three or four city policemen conspired in the mid 1960s to kill King. The patrolman said he twice was offered \$500,000 to kill King and claims he tape-recorded one of the offers.

Rep. M. Gene Snyder (R-Ky.), who passed the former patrolmen's information along to the assassination committee, said he heard a reproduction of the tape but much of it was inaudible. However, the committee's staff is believed to have the technological capability to improve the quality of the recording.

Sources said that the alleged Louisville King conspiracy preceded by several months what became an open and bitter controversy in the Kentucky city over "open housing," an issue which created deep hatred between the police and the black community.

The sources said King's brother, Rev. A.D. Williams King, was living in Louisville at the time, was active in Civil Rights and was pastor of a local church.

ASSASSINATION committee leaders met with the House Rules Committee yesterday to outline the new leads in an effort to win approval for continuation of the committee, now scheduled to end its work March 31.

Committee members stressed that the Louisville policeman, whom they decline to identify, has been checked and "he is a solid citizen." They said he has offered sworn testimony to the committee.

Informed sources say there is "no doubt" that Martin Luther King and not his brother who died in 1969 was the target of the alleged murder conspiracy. Informed sources said the committee regards the Louisville allegations as "hot." "They are placing it at the top," one commented.

The sources also said the committee intends to call "Roberto" as a witness, indicating the committee has determined his full identity.

Ray To Give Story To Investigators

PETROS—James Earl Ray met for more than two hours Tuesday with attorneys for the House Assassinations Committee to give a preliminary interview on his role in the murder of the Rev. Dr. Martin Luther King Jr.

His attorney said afterward that Ray was not under oath, but that he answered all questions put to him by Richard Sprague, the committee's chief counsel, and Robert Lehner, who is handling the King portion of the committee's probe.

"I don't see any great surprise information coming out until later," said Jack Kershaw, Ray's attorney. "If there are any surprises, they will not be the result of Ray's direct information."

Neither Kershaw nor Sprague revealed specific questions or answers from the interview.

Kershaw said Ray, who claims innocence in the King assassination despite his earlier plea of guilty, talked only about his own actions or actions of which he had direct knowledge.

"He really does not know what anybody else did," Kershaw said. "We hope their investigation to corroborate what he said will satisfy their goals and ours. As far as Ray is concerned, this is directed solely toward getting his day in court."

The meeting took place in the office of the captain of the guard at the maximum-security cellblock at Brushy Mountain State Prison here. Ray is serving a 99-year sentence in the prison after pleading guilty to shooting King in Memphis on April 4, 1968.

Sprague emerged from the session smiling, but told reporters as he entered his car that he would have no comment on the meeting. He said he would attend a committee meeting Wednesday morning in Washington.

The session included Sprague, Kershaw and three other committee staff members.

After Sprague and his staff left, Kershaw remained behind the walls briefly with his client.

Earlier, Kershaw had told reporters that Ray may be willing to take a lie detector test in connection with the assassination. But he said after meeting with Ray that no decision had been reached on the question.

Kershaw said reports that a mysterious Latin man named "Raoul" was Ray's brother are incorrect. Ray earlier said that he was in Memphis in connection with a supposed gunrunning scheme with Raoul when King was assassinated.

"Raoul is a breathing and talking human being," Kershaw said. "The committee is trying to find him now and so am I." Kershaw added that he believes Raoul is in the United States or Canada and that searches for him are being conducted in Florida, Alabama and Kentucky.

He said Ray met Raoul in Montreal while Ray was still a fugitive after escaping from prison.

"Ray is simply an unwitting tool and instrument in the assassination," Kershaw said. "Now only for the first time ever is there a climate of opinion that gives him a forum," he added, explaining Ray's willingness to talk to the committee officials.

Ray pleaded guilty to the King assassination, but three days later attempted to withdraw the plea, claiming he was forced by his original attorney, Percy Foreman, into making the plea.

Interview Ray Quickly and Clear Out, Warden Tells Assassination Probers

PETROS — I've told the committee to get in and get out as quickly as it could in the James Earl Ray thing," Warden Stoney Lane said today while awaiting arrival of House Assassinations Committee probers at Brushy Mountain State Prison.

The warden, who has custody of the confessed killer of Dr. Martin Luther King, specified that the deposition of Ray would be taken behind walls of Tennessee's maximum-security prison here.

"The closed-door interview will be behind a double-security iron gate in

the prison compound," said Lane. "It is to be conducted in the office of the captain of the guards."

The House group, expected here this morning, had to cancel a flight by private plane and fly commercial from Washington, delaying arrival here until mid-afternoon.

RAY, WHO since his conviction has insisted he is innocent of the assassination, would surprise his cellmates and guards if he were to tell the Richard Sprague lawyers anything new.

"Actually, Ray didn't tell the CBS-TV interviewers anything new," said Lane. "He probably hasn't said 500 words to anyone since being returned here from Nashville when Brushy reopened."

The No. 1 inmate here awaited arrival of the probers in his second-story lockup. He was to be escorted by guards to the ground level, where prisoners at times are allowed for exercise and movement from one facility to another. Warden Lane said he hoped the interview would be over and the prison returned to normal routine within two hours.

Lane waited for the Washington group at the first guard gate, where all prison visitors must stop for clearance. Media representatives, a mixture of newsmen and cameramen, were not permitted to tail the probers to the captain's office for the interview.

RAY, STILL fighting through Nashville lawyer Jack Kershaw for a new trial, was interviewed at Petros by this News-Sentinel writer when he was imprisoned here before the facility was closed during the Gov. Winfield Dunn administration. In that interview, Ray talked about prison life and his adjustment to it — but never alluded to the King assassination or any role he had in it. A few weeks later, he was caught

Ray's Story Taken Seriously, His Attorney Says

PETROS — Two significant themes emerged here after James Earl Ray answered House probers' questions for two hours late yesterday. They were:

1. An arm of Congress is seriously interested in Ray's version of what happened in the rifle-assassination of Dr. Martin Luther King Jr. in Memphis.

2. Federal investigation of the Civil Rights leader's killing — including an effort to confirm Ray's story — could lead to a new trial for Ray, sentenced to 99 years in prison but subsequently repudiating his confession.

Ray's dialog given general counsel Richard Sprague contained no surprises, but his attorney, Nashville lawyer Jack Kershaw, said that for the first time his client is receiving a forum that could help solve the King assassination and bring about justice for him.

Kershaw, only person in the closed-door interview who would talk with a massive media gathering, said afterward "there will be more interrogations of Ray, perhaps by members of the House Assassination Committee" at Brushy Mountain State Prison's maximum security facility here.

Sprague, so fleet of foot that television cameramen didn't get enough footage upon his arrival and obtained Warden Stoney Lane staff approval to film again when the counsel left the prison, was so mum not many heard his "no comment." He indicated through prison officials, as the press waited in a building outside the walls, that he might have a statement. An hour later, Sprague sent word he wouldn't.

KERSHAW, however, answered all questions, but the theme was the same:

Ray had been a pawn of conspirators in the King case, thinking he was helping in a gun smuggling scheme which took him to Memphis. The mystery name "Raoul" surfaced again and much of this theme filled the record as Sprague led his legal team in questioning Ray. Ray and "Raoul," a Latin not yet found, met in Montreal, Canada, after Ray escaped from prison. "Raoul" passed money to Ray, which Kershaw said Ray obviously used to flee the country by way of Canada after the assassination.

"Ray wasn't even in that motel when King was gunned down," said Kershaw. "He was gone to fix a flat tire on his car. And that business of guns in his possession is explained by his complicity in smuggling."

Kershaw said Ray was cooperative, answered every question, and that Ray was "pleased" with the deposition taken, even though it was not made under oath. Kershaw said, too, that Sprague, who only recently survived the House committee shakeup that saw its chairman resign, was satisfied with the outcome.

SPRAGUE got here late, causing postponement of questioning from 11 a.m. until 3 p.m. He left late, too, missing a commercial fight from McGhee Tyson Airport in Knoxville that departed for Washington at 5 p.m. He took a later plane, was to appear today before the House group — not to report on Ray's statements but to participate in the committee's pared down request for a \$2.5-million appropriation. Funds will be used for staffers probing both the King and President Kennedy slayings. Congress is yet to approve any budget.

Veteran newsmen, particularly those among the major television networks, complained they had wasted

time in covering a billed event that was a "flop." But not so Kershaw.

The Nashvillian had come here Monday for an hours-long huddle with Ray, perhaps coaching him for the deposition yesterday. Kershaw said pointedly that congressional interest in Ray would aid Ray's long fight for justice.

ing as snow swirled outside, got the last laugh. A helicopter ferrying TV film to station deadlines came and went. Sprague and staff came and went in a rig hired at the airport, which might explain something about requested funds for the probes.

BUT WHY, asked a newsman, should Ray speak out now?

"Because he's finally found a forum that will listen to his knowledge of what happened in Memphis," Kershaw answered. "For the first time, Ray has found the proper forum in a nation that wants the truth out. He's got that in this committee and in the free press represented here."

Should committee probers verify Ray's claims, Kershaw said, it would be a giant step toward his efforts to obtain a new trial and vindication in the slaying.

He said that he, as Ray's attorney, did not object to a single question put by the Sprague team, nor did Ray avoid any answer.

Ray will be willing to take polygraph tests and also make statements under oath, the lawyer said, once Ray appears before the committee. Kershaw said such events could take place in Petros, but that Sprague and his lawyers first would seek to confirm Ray's story. Kershaw said proceedings here were merely the first step.

Warden Lane and staff assisted the Sprague operation in every way possible and were most accommodating to the press, but newsmen were turned away at the main prison entrance as the interview was carried on in a tiny office of the captain of the guards within the compound walls.

Some media, peeved at Sprague's refusal to comment and weary of wait-

No Surprises Turned Up In Ray Case

PETROS — Substantial, but not surprising.

That was his lawyer's characterization of information James Earl Ray gave to the House Committee on Assassinations at Brushy Mountain State Prison Monday.

Jack Kershaw of Nashville said Ray went into great detail on events surrounding the death of civil rights leader Martin Luther King Jr.

He said Ray gave the committee factual matters to look into with some of the eight other lawyers who have represented him in the past nine years since he was charged and convicted in King's death.

The committee will spend the next two weeks verifying the evidence Ray gave them and return to the prison in April 4 to continue the interviews.

Chief committee counsel Richard Sprague had no comment concerning the day-long talks with Ray except to say: "We are continuing our interrogation."

As he emerged from the conference room after the six-hour session, he noted the gray skies, smiled and commented: "It's a wet day."

According to Kershaw, the principal topics of conversation were a letter written by a Louisville policeman and the identity of the mysterious "Raoul," who allegedly directed Ray's activities for a year before King was shot in Memphis.

He discounted speculation the mystery man is Ray's brother, Jerry Ray.

"He is the most impossible Raoul I have ever come across," the attorney said. "Jerry Ray is nothing but a jokester and a prankster."

He told the news conference he had provided the committee a copy of a letter written by Clifton Baird, a Louisville policeman, to Ray nearly a year ago.

In that letter, Baird allegedly revealed to Ray that he himself had been

approached by FBI agents and other federal employees about the possibility of assassinating King.

On the question of "Raoul," Kershaw said he was confident the character would materialize.

He said Percy Foreman, who once represented Ray, had phone numbers which would lead to Raoul's identity, but allegedly had lost them. He said Foreman claimed to have passed them to the late John Jay Hooker Sr., a Nashville attorney. But he added nothing had been found in Hooker's effects.

It was a long day for members of the press, who waited from approximately 9 a.m. until 4 p.m. to talk to the committee members and Kershaw.

While the committee met with Ray in a conference room in the main prison building, the press cooled its heels in a prison office in a nearby building, smoking cigarettes, drinking coffee and otherwise disobeying a sign
