Investigation at Locksmith Co., Little Falls, New Jersey earlier in evening 4/12/68 (see Atlanta tel to Bureau, BH, ME, LA and NE, 4/12/68 for background), determined that suspect GAULT had in fact enrolled at the locksmith school and in doing so had filled out an application which, among other things, required that he provide two references, which he did, as follows:

Mrs. ~~RITA STEEN~~, 5666 Franklin, Los Angeles and Mrs. ~~MARIE DENINNO~~, 5533 Hollywood Blvd., (St. Francis Hotel), Los Angeles. Occupation of STEEN listed as housewife and DENINNO as waitress, place not mentioned.

Application further reflected that GAULT had previously been taking a course at the American Business Consultants School, 15010 Crenshaw, Long Beach (7).

HELGESON stated that the above leads should be covered in AM, 4/13/68.

MR. AL THOMPSON, Room Clerk, advised ~~MRS. MARIE DENINNO~~ resides at the hotel and is employed as a cocktail waitress in the Sultan Room on the first or ground floor of the hotel. She was not in the hotel at the time of inquiry and THOMPSON's attempts to locate her were negative. THOMPSON said she was scheduled to report for work in the Sultan Room tonight at 6 PM. He also said she was acquainted with a man named GALT who formerly resided at the St Francis and frequented the Sultan Room.

Residence at 5666 Franklin, Hollywood, Calif, the reported residence of ~~MRS. RITA STEEN~~.

Above individual was not at the above residence when attempts to contact her were ~~made~~ made today. MR. FREDERICK DAVIS, 5668 Franklin advised he is the owner of 5666 Franklin which is occupied by a woman known to him as MRS. RITA ROSA. She has several children, is a widow, her husband having been accidentally killed recently, she is on welfare and is employed at some bookstore somewhere in Hollywood, address unknown to MR. DAVIS. He said RITA ROSA should be home late this afternoon. He said she is in her early or middle twenties and is a very neat housekeeper.

DOCUMENT ALSO REFLECTS THAT LESSONS WERE RECEIVED FROM GALT ON FEBRUARY FIVE, SIXTY-EIGHT, FEBRUARY TWO THREE, SIXTY-EIGHT, FEBRUARY NINETEEN, SIXTY-EIGHT, FEBRUARY TWO THREE (SIC) SIXTY-EIGHT, MARCH SEVEN, SIXTY-EIGHT, MARCH TWO SEVEN, SIXTY-EIGHT, APRIL ONE, SIXTY-EIGHT APRIL EIGHT , SIXTY-EIGHT, AND APRIL TEN , SIXTY-EIGHT. ACCORDING TO DURYEA, LESSONS FROM STUDENTS ARE DESTROYED AFTER GRADING AND ENVELOPES NOT RETAINED. HE FURTHER STATED LI DOES NOT MAINTAIN CORRESPONDENCE FILE RE STUDENTS.

DURYEA STATED THAT GALT HAS BEEN MAILED A LESSON WHICH HAS NOT YET BEEN RETURNED. A STOP RE THS LESSON WAS PLACED WITH DURYEA.

RECORDS PERSONALLY TRANSPORTED TO THE BUREAU APRIL THIRTEEN INSTANT.

ON MORNING OF APRIL ONE THREE, SIXTY-EIGHT, BUREAU ADVISED NO FURTHER ACTION NECESSARY BY NEWARK AT THIS TIME AND WOULD HANDLE LEADS.
