He further advised, upon additional inquiry, that he had lost money to these two individuals shooting pool this morning at the Playroom Bar. He stated that he was presently at the Playroom Bar and the two men had not returned.



STEVENSON, LAPD Intelligence who advised that a "source" which he could not devulge, had furnished him info that at 7:39 PM tonight, an individual who identafied himself as ERIC STARO GALT, placed at long distance telephone call from Los Angeles area code 213, telephone number 696-8632, to telephone number 205 (area code for stat@ of Alabama)881-9863 at the Ember Club for a Mr. EARL CAMPBELL. The Lt. stated he could provide nothing further.

Writer thereafter contacted General Telephone Company Special Agent JOHN GURZAK (protect) and requested listing info for this 213 area code number, supposedly in the Whittier area.

GURZAK called back advising that number lasted to ficker Motors Used Car Lot, at either 502 West Wannington Whittier Blvd., or 12540 East Whittier Blvd., Whittier.

Per instruction Supervisor NOLAN, writer shortly thereafter recontacted GURZAK in effort to obtain tell info regarding call. GURZAK called back advising tell record located at Pacific Telephone Company tell station in Whittier and that he had requested that the chief operator at this station give working writer the desired info.

Writer was thereafter called by the the chief operator at above station who advised as follows re this call:

Call was placed as advised above, at 7:39 PM, 4/18/68, from Whittier tel number indicated above, by man identifying self as CALT. Wanted talk collect to EARR CAMPBELL at Ember Club in Alabama, town not mentioned tel # 205-881-9863. CAMPBELL was described as an attorney at law. Ember Club was contacted by long distance operator who was advised that CAMPBELL was not at the club at present and is was not known when he would be returning. GALT thereafter cancalled the call.

The/Operator stated that the long distance operator that handled the call immediately recognized the GALT as the KING murder suspect and for this reason set the toll slip aside and called the special agent's office who advised her they would contact the FBI.

It is noted here that no call was received from the ########### special agent's office at Pacific by writer or SA ANDRESON on during evening and apparently the source referred to by Lt. STVENSON is the special agent's Office at Pacific who called the LAPD rather than FSI.

THIS SAME SCURCE ON A REGULAR BASIS FREQUENTS THE SAME CLUBS AND LOUNGES IN MEMPHIS AND HAS NEVER OBSERVED AN INDIVIDUAL FITTING THE DESCRIPTION OF GAULDEN.

ACCORDING TO THE INFORMANT WANDA WILKES HAS BEEN PRESENT WITH THE GROUP ON ALL OCCASIONS AND SHE HAS OBSERVED GAULDEN, AND SHE SHOULD BE ABLE TO IDENTIFY ERIC GAULDEN.
