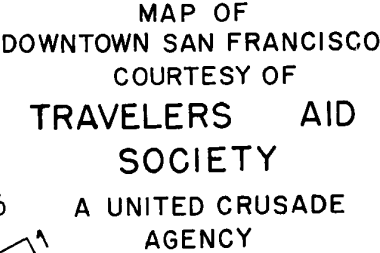

On 4/24/68, suspect's photograph and his description was furnished to JOHN DOLAS, manager and the following waitresses who are employed at Suts located at 5172 East 2nd Street, Long Beach: BEATRICE SLAYTON, LIL RUSSELL, HELEN KNAPP. These three waitresses were on duty when the restaurant opened on 4/21/68. None of these individuals were able to advise that they recognized the photograph or description of suspect as anyone they have seen in Suts.

Miss LILLIE MOCK, 1900 Myrtle Avenue, Long Beach, California, advised she is a domestic for JAMES J. CHAMORRO, who lives in apartment D at 301 Bay Shore Avenue, Long Beach. She said the photograph of suspect as displayed to her by the writer is not identical with CHAMORRO. She also showed the writer a picture of CHAMORRO and there was no similarity between the two.

ASAC J. T. SYLVESTER, JR., New Orleans, this date telephonically furnished the following from a news article by LOUIS LOMAX.

Block heading at the top of the article: "LOUIS LOMAX, who is identified in this news article as a regular reporter on Negro affairs, North American Newspaper Alliance. The news syndicate said he had established contact with the underworld and has been able to elicit facts in the KING assassination case not known to others."

"By LOUIS LOMAX, Beverly Hills, NA, NA.

"A startling new development in the hunt for the person or persons responsible for the assassination of Dr. MARTIN LUTHER KING, JR., now focuses on a mysterious Hollywood blonde and a New Orleans industrialist. The FBI let it be known Monday that they were in search of the Hollywood blonde but could not locate her. // news to no.

"This reporter located the blonde in question late yesterday afternoon. She is in her middle 20's and, as suspected, was a close confidante of JAMES EARL RAY, then known as ERIC STARVO GALT, and the suspected killer of Dr. KING. Investigation by this reporter revealed that the young woman was a habitue of the Sultan Room and a Rabbit's Foot Bar along Hollywood Boulevard. She used several names and was known as "Jeri."

"She spent several nights, perhaps weeks, with RAY (GALT). On the day he left Los Angeles on the trip that led him to Memphis, he purchased 'JERI' an airplane ticket to a midwestern city, where she is now visiting with her parents. There is certain evidence that RAY arranged to visit with the girl and her parents in the midwestern city 'after I take care of some business in the South.' This was the way RAY explained his mission to the girl in question. The FBI search for the girl

"girl still continues, and there is no indication that the agents are aware of the girl's whereabouts.

"'JERI' is important to the investigation because of her close relationship to RAY.while he was in Los Angeles. RAY (GALT) kept this quiet and, on the whole, remained to himself. However, 'JERI' was in his apartment on several protracted occasions, and the conviction is that she may well have information about the various contacts RAY was known to have made in the South, particularly in New Orleans.

"As important as 'JERI' is to the stalled investigation, she is overshadowed by additional information uncovered by this reporter about RAY's New Orleans contacts. These are the facts that can be published:

"On December 16, 1967, RAY was in telephonic contact with a major New Orleans industrialist, a man who is considered the economic and political 'killer' of the community.

"On December 17, 1967, RAY met in person this New Orleans industrialist. On the day of the meeting RAY was registered in a motel. Contact between RAY and the industrialist was made from this motel, and the meeting withheld in 'downtown New Orleans.' Investigators are attempting to zero in on the industrialist in the light of a disclosure from an inmate out of Missouri Prison where RAY once served time and where RAY expressed interest in an offer of \$100,000.00 put up by '7 businessmen' for anyone who would kill Dr. KING.

"This reporter has also been able to establish a time table for RAY that leads up to a few days before Dr. KING's assassination.

"On Valentine's Day RAY, who was then living in Room 408 of the St. Francis Hotel along Hollywood Boulevard, visited another girl friend - not the blonde - and offered his console TV set for her portable. The girl accepted the trade, and RAY loaded the portable set in his car and told the girl he was leaving town.

"Although they are tightlipped about it, the FBI has found the portable TV set, probably in a Birmingham, Alabama, rooming house.

"RAY was seen on the same day in a parking lot of the Los Angeles Sears Roebuck store on Pico Boulevard.

"Three days later RAY called upon a New Orleans family and delivered to them a package sent by their daughter. in Los Angeles. The published record then shows that RAY then drove into Alabama, finally into Memphis.

"The FBI is having major difficulty tracing both the blonde and the industrialist because the trail leads through the underworld and semi-underworld.

"However, this reporter is aware of how the telephone contact between the industrialist and RAY was established. A search is now on in local records which revealed both the industrialist's name and telephone number.

"Other information developed by this reporter indicated that 'JERI' spoke with a foreign accent and is probably from one of the Scandinavian countries."

On 4/24/68, DOROTHEA MERRILL, Manager, Hollywood Center Motel, 6720 Sunset Boulevard, Hollywood, California, was contacted by the writer and SA DENNIS C. LEMASTER, and during the course of this contact she furnished the following information:

She stated that Registration Card Number 1266 showed that ROBERT L. ALLEN, Sacramento, California, driving a 1968 Ford, occupied Room 24 at the motel during the evening and morning of 4/17-18/68.

She remembered checking this party into Room 24, sometime during the night of 4/17/68. She could not describe ALLEN further and stated she did not know there was a woman with him until informed so by the Coca Cola delivery man on the morning of 4/18/68.

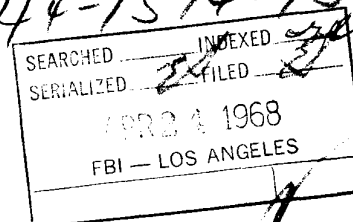
According to the delivery man, ALLEN looked like the photograph of JAMES EARL RAY. He told her that ALLEN did not appear as if he were trying to hid anything, but the girl did.

MERRILL advised that the above-described Registration Card will be retained for use in her permanent records.

Recently he had occasion to contact one FLORENCE HOLLOWAY SIMPKINS, 1232 W. 5th St., Los Angeles, and during the course of this contact she advised as follows:

Formerly she resided common-law with a man by the name of JOHN FISHER, whose true name is DONALD MARTIN BLAA. During July, 1967, FISHER had occasion to drive to Cleveland, Ohio. He stayed about one month and then returned to Los Angeles, via Kansas City, Missouri. While in KANSAS City, he met and drove to Los Angeles, two white men, who are brothers, whose first names are EARL and RAY. FISHER was driving a 1959 cream-colored Ford sedan, California license S B F 294.

Upon arriving back in Los Angeles, FISHER obtained lodging for EARL and RAY in Long Beach, California, near an area where sailors and merchant seamen "hang out." From October to November, 1967, FISHER lived with SIMPKINS at 1219 W. 4th St., Los Angeles. At the end of November, 1967, about two days after Thanksgiving, he moved in with EARL and RAY in their Long Beach residence. Sometime after this, and before Christmas, 1967, FISHER moved into the St. Francis Hotel, Pasadena, Calif. About the first of February, 1968, he again took up residence with SIMPKINS. Sometime around Valentine's Day, 1968, FISHER commented to her that EARL and RAY owed him some money and that he was going to meet them in the bar located at the St. Francis Hotel. On, or about 2/20/68, FISHER took SIMPKINS with him to this bar. There she met EARL and RAY, who were at the bar with another couple. The man of this latter couple is believed to be a musician, and the girl is one AVIS KIRKWOOD, who at that time resided at 908 Vuena Vista, Duarte, California, and who was employed at a hospital in Duarte. Her supervisor at the hospital was a Mrs. LESLIE.

According to DAMERELL, SIMPKINS told him that EARL fit the photograph of JAMES EARL RAY that she saw in the newspaper. She told him that EARL's face was not quite as full as the photograph showed him to be.

SIMPkins told DAMERELL she last saw FISHER at King Edward's bar, located 5th and Los Angeles Sts., Los Angeles. He has an ex-wife by the name of IRENE who is a waitress at the Teris Restuarant, Teris Hotel, 6th St., Los Angeles. FISHER is a former bartender, employed Lou's Wagon Wheel, on 7th St., across from the Commadore Hotel, Los Angeles.

DAMERELL stated SIMPKINS is an ex-alcoholic, former check writer, and according to her probation officer is "prone to lie." However, DAMERELL stated that she was hesitant in furnishing the above information, because she was admitting violation of her parole when she admitted associating with people of FISHER's nature.

DAMERELL stated that he attempted to assess whether or not SIMPKINS was telling him the truth when she furnished the above information. He advised that he could not really say whether she was telling him the truth or not.

DAMERELL described SIMKINS further as a white female, age 62.



Re Memo of SA J. CLARE WILLIAMS dated 4/18/68 (ser. 382).

On 4/22/68, the writer telephonically contacted ETHEL PHILLIPS, 294-9955, to obtain additional information to ascertain the name and working hours of the person believed to be identical with ERIC GALT. Mrs. PHILLIPS stated that since contacting the FBI originally, she and other workers have had the opportunity to observe additional photographs of the suspected killer of Dr. KING. She stated that she, as well as her co-workers, is certain that the person she referred to in her initial call is not GALT. She said that her original opinion was based upon the head shape and ears observed from GALT's photograph. She described her co-worker as a male Caucasian, approximately 30 years of age, 5' 6", 110 pounds, with brown hair and brown eyes. She said that the more recent and better pictures displayed in local newspapers and on TV no way resemble the man that works in her plant and, further, that this person has a full head of brown curly hair. She stated she has been unable to determine his name but that should she learn his name or any additional information, she will immediately contact the FBI in Los Angeles.
