Re Memo of SA J. CLARE WILLIAMS dated 4/23/68, Serial 643, which sets out that one WILLIAM SPRY, a patron of the Hunt Room Bar, Hollywood Inn Hotel, 6724 Hollywood Boulevard, Los Angeles, California, believed that a former bartender at this location, a JOHN RAY, might possibly be JAMES EARL RAY.

On 4/26/68, SA's G. J. MOOREHEAD and THEODORE M. GARDNER interviewed JAMES RILEY, 6638 Satsuma, North Hollywood, California, #766-6740, who is presently a bartender at the above-mentioned Hunt Room Bar and were advised as follows:

RILEY has been employed as a bartender at this location for over two years and during this time there has never been a JOHN RAY employed in this establishment. He stated that one JOHN BROOKINS (address unknown) had worked here for approximately two months until 4/8/68 when he was discharged for excessive drinking. RILEY's work schedule shows that BROOKINS was working until 6:00 p.m. on 4/4/68.

RILEY was shown photographs of JAMES EARL RAY and advised that BROOKINS did not resemble these pictures.

RILEY stated that the other employee (night man), SCOTTY NEIL, 62 years old, short, stocky and greying, was not absent from work on 4/4/68 and looks not at all like RAY.

On 4/29/68 Mr. WILLIAM DITTY, Station KFWB, 6419 Hollywood Boulevard, Los Angeles, California, telephonically furnished the following information.


DITTY advised that on 4/20/68 he was in National City, California, at Emma's Pancake House on E Street, when he noticed a man who fitted the description of JAMES EARL RAY having coffee at another table. He described this man as Caucasian, age 36-40, 5'10", 175-180 lbs., dark close-cropped hair, average build. He said one ear protruded from the head, but he could not recall which ear. According to DITTY, this man looked exactly like the 1959 photograph of RAY.

DITTY said he did not report this information sooner because he was in National City without his wife's knowledge, and he was afraid she might learn of this. He advised he saw the man leave Emma's Pancake House, but he did not see where he went or whether or not he had an automobile.

Re memo of SA J. CHARLES MERRIMAN, 4/25/68. (44-1574-705)

On 4/26/68 SAs J. CHARLES MERRIMAN and LESLIE F. WARREN interviewed DUANE HARDING ROBINSON at his residence, apartment #3, 5437 Maywood Avenue, Maywood, California.

It is to be noted that when ROBINSON telephoned the Los Angeles FBI Office on 4/25/68, he inferred that he wished to talk to an FBI Agent regarding the MURKIN matter, but declined to say so specifically.

ROBINSON advised SAs MERRIMAN and WARREN that during 1964 he, ROBINSON, became acquainted with a female employed at Dunkers Delight, a donut shop located in the 1200 block of South Western Avenue, Los Angeles (no longer in business), who at that time was associating with one BILLY JOE RAY, white male, age approximate 40. ROBINSON stated that the unknown female employee of ~~DUNKERS~~ Dunkers Delight could be located through records of Winchell's Donut Shops, Los Angeles. ROBINSON pointed out his reason for calling the FBI was that he thought there was a possibility the above mentioned BILLY JOE RAY was identical to the JAMES EARL RAY being sought regarding the murder of MARTIN LUTHER KING.

When ROBINSON noted that the BILLY JOE RAY to whom he referred was ~~residing~~ residing the Los Angeles area in 1964, SA MERRIMAN advised ROBINSON that JAMES EARL RAY was in prison in Missouri during 1964 and therefore could not be identical to BILLY JOE RAY. The interview with ROBINSON was terminated at this point.

At the outset of this interview ROBINSON/^{who is a white male} voluntarily displayed California driver's license #2540297 which bore a photo of ROBINSON, containing the following information:

Rememo of SA Martin Lauer dated 4/20/68.

On 4/23/68, one called "RAY" as reported by Benjamin Summers, was identified and checked out at The Roundup Bar, 6727 Long Beach Blvd., Long Beach, California.

Mr. and Mrs. Vernon B. and Ora E. NINO, owners of The Roundup Bar, readily acknowledged knowing "RAY" as RAY ESTELL, an oil field worker who has been patronizing their bar for the past 5 or 6 years. They both stated they worked at the bar on Friday 4/19/68, but had never observed anyone resembling ERIC RAY with whose picture they were familiar from press publications. They then viewed photographs of ERIC RAY and stated definitely that RAY ESTELL was not identical.

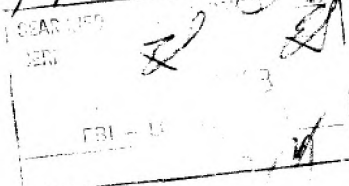
