



SA GEORGE E. AIKEN, R. requested that the writer ascertain whether Dr. THEODORE L. EVANS and his wife, DOLORES, had a bank account at "The Bank of Finance, 2651 South Western Avenue, Los Angeles, California.

On 4/23/68, while contacting J. DEVID DUNCAN, Vice President of the bank who has provided assistance in the past, the writer inquired concerning a possible account for the EVANS.

DUNCAN advised that he is a personal friend of Dr. EVANS and of EVANS' father. He said that he would like to know the nature of the inquiry before he could in conscience give out information concerning them. It was explained to DUNCAN that their name had come up during the course of an investigation, as do many names that may or may not be pertinent to an investigation, and that this was just such an instance. The writer stated that the FBI was not interested in the EVANS per se. At this point, DUNCAN's phone rang and he spoke for some minutes on bank matters; returning to the writer DUNCAN remarked that they do have an account with the bank. He added that he did not like to know the personal business of his friends and seemed to readily accept my explanation. He was asked to keep the inquiry in confidence and promised that he would.

On 4/18/68, SA ADAMS was dispatched to the Pawn Office of the Long Beach Police Department to contact Detective Sergeant ROBERT L. ITSON who had information regarding captioned matter.

On that date, Detective Sergean ITSON advised that he was contacted by the owner of Bill's Thrifty Swap Shop, 1201 m. Inaheim Street, Long Beach, California, who advised that on 4/17/68, a man entered his shop to purchase a revolver. He was told that he would have to wait five days before delivery could be made on the pun. The man paid for the gun, \$41.98 cash, and when he was asked for identification, the man stated he lived near there and would have to go home for some identification. The man did not return. The swap shop owner observed a photograph of ERIC GALT in today's Long Beach paper which appeared to resemble the man who attempted to purchase the gun.

The requisition for the pistol was signed by the name KKENEXEX DAVID WESELEY RICE, 11302 (lbertos (no city) who was described as being a white male, born \_\_\_\_\_, 5'll", 165 pounds, Black hair, and Blue eyes.

A review of the 1967 Edition of the Fenie Atlas of Los Angeles City and County disclosed an Alburtis Ave. in Norwalk.

A check with the Norwalk Substation of the Los Angeles Sount Sheriff Office disclosed that 11302 Alburtis was occupied by on e JOSEPH V. LANE.

SAS EUGENE W. ADAMS and CONEAD V. HASAEL interviewed Mr. JOSEPH V. LANE 11302 Alburtis Ave., at which time he advised that DAVID W. STLEY RICK is his brotherinlaw, his wife's brother. He stated that FICE arrived at his home on 4/13/68 from Illinois. He stated that FICE has lived at his home on prior occasions, but due to conditions at his home, Mr. LANE asked RICE to ret a place of his own. He recalled that RICK mentioned living somewhere on Candlewood St.

Re complaint of IC PHILIP S. ANDRIST 4/18/68 (file 44-1574-350).

The following investigation was conducted by the writer on 4/19/68.

Mrs. DOROTHY GRACE, manager of the Poinsetta Gardens Motel, 13921 South Normandie, Gardena, California, telephone DAvis 4-5863 related that she had observed a photograph of ERIC STARVO GALT in the Los Angeles Times, and she said that when she observed this photograph it "struck her" that this individual was very familiar. GRACE said that she then showed the photograph to EMMA CUMMINGS, a maid who works at this motel and asked CUMMINGS if this photograph looked familiar and if this man had ever stayed at this motel. Mrs. GRACE said that EMMA CUMMINGS told her that the photograph looked familiar indeed and when she had seen the photograph on television, it occurred to her that it could be similar to the man who stayed at the Poinsetta Motel in the past. Mrs. GRACE said that she, therefore, made a search of the registration cards at this motel and located a guest registration bearing the name of JOHN WILLARD.

This guest registration card is numbered 000233 and reflects that JAMES or JIM SILLES and a BILL SILLES... as well as a JOHN WILLARD had checked in to Room 130 at this motel on 10/7/67. The card indicated that they were driving a 1960 Thunderbird bearing Ohio license plate 7018TT or 7018T1. It was indicated on the card that they represented the firm of Murray and Sons, not further identified. This card reflected that these individuals checked out of this room on 10/14/67.

Mrs. GRACE recalled that the two men named SILLES had first appeared at the motel and had registered, in doing so had also registered for JOHN WILLARD but stated they were going to meet an airplane as he would be arriving in the evening. Mrs. GRACE said that it was her recollection that it was JIM SILLES who did the actual registering. She said that all three of these young men appeared to be very nice and polite and all were very well dressed. Mrs. GRACE said that they all appeared to be in their 20's and all were white men. She said she was

under the impression that the one named JOHN WILLARD was a little older than the SILLES brothers. She recalled that the individual named WILLARD seemed to remain in his room all of the time. She said that the three of them had very little luggage and had paid their room in either cash or travelers checks. Mrs. GRACE said that it might not mean anything, but she did feel that the artist's sketch made bore some resemblance to the JOHN WILLARD who had been in room 130 and for this reason she thought the matter should be brought to the attention of the FBI.

Mrs. JACKIE CLARKE, 1431 West 173rd Street, Gardena, California, telephone 329-8895, who is a maid at the Poinsetta Gardens Motel, having worked here since September 1967 found the artist's composite photograph familiar and remarked, "This is the one I saw in Room 130." Mrs. CLARKE said that she recalled that there were three men in Room 130, but she had only actually seen two of them. Mrs. CLARKE said that one of the reasons she recalled this incident was because one of the men had asked her to come in to have a drink which she said she refused. She said that this man had also asked her to go out with him. She said that she had declined. Mrs. CLARKE said that she recalled that these men had a Thunderbird automobile and they had told her they were going to San Francisco where they presumably had a job. She said that the two men she had observed had appeared to be very neat and clean and they wore nice clothes. It was her recollection that the Thunderbird automobile they drove had Ohio license plates and was about a 1960 or 1962 model which was a hardtop with bucket seats and in which one of the seats was torn. Mrs. CLARKE recalled that these men had spent sometime sitting around the swimming pool.

Mrs. CLARKE further related that she had observed the picture of ERIC STARVO GALT in the newspaper and kept thinking to herself that he looked familiar. She said that she felt that there was a very good possibility that the individual and ERIC STARVO GALT could in fact have been one of the men who occupied Room 130 back in October 1967.

Mrs. CLARKE recalled that after these three men had checked out of Room 130, she had gone in to clean it and had found an empty Vodka bottle and, as well as a Gin bottle with a small amount of Gin left in it. She said there was also a box of Jade Eash shaving lotion left in the room along with some sandwich spread, bologne, and mustard. She said that there was also a spray for sore throats left in the bathroom. She said that there was also some magazines such as Esquire, Life and some nude magazines. She said that she also recalled that the beds in the room were made when she went into clean it, and it was her recollection that one of these men had said something about driving to San Francisco, and had mentioned the fact that they had to have some work done on the car.

Mrs. CLARKE described the individual whom she believed to be possibly identical with ERIC STARVO GALE who had occupied Room 130 as follows:

On the basis of the above information a teletype was directed to the Cincinnati Division to check with the Department of Motor Vehicles on the above Ohio license plate in an effort to attempt to identify further the three occupants of Room 130.

Subject as ERIC STARVO GALT stayed alone at the Hotel Rio, Room 212, Morelos 86, Puerto Vallarta, Jalisco, Mexico, October 19 to November 6, 1967. On November 7, 1967, GALT checked into the Hotel "Tropicana" in Puerto Vallarta, occupied Room 417, and checked out on November 13, 1967.

There were no telephone toll charges for GALT at either hotel.
