Facts of complaint

Sgt. Rice received the following information from Officer BOCK, Accident Investigation, LAPD, and therefore had no further details than that listed below:

Officer BOCK (#12971) talked to one WILLIAM BATES, employed by Plant Security (which Sgt. Rice assumed to be a company), who said he was at the parking lot of Bank of America at Manchester and Broadway today at about 4:30PM when an ~~a~~ 1966 or 1967 Pontiac or Dodge drove up and the man who is described above asked him where he could find a cheap hotel. Mr. Bates ~~z~~ recommended the El Rey Hotel at 6th and San Pedro, Los Angeles, and the party left.

The auto was red in color. He was accompanied by a heavy-set female and another white man. In place of a license plate the car, on the rear, had letters spelling "Lost Tag." On the front of the vehicle (presumably the front window) was a sticker of the Baseball or Boxing Association of Atlanta.

Mr. CLEMENT L. MC GOWAN, JR., Civil Rights Section, telephoned at 8:35 AM, 5/5/68, with reference to an article by LOUIS LOMAX which had been submitted to the Bureau by the Los Angeles Office. LOMAX had commented that the Los Angeles Division had not yet requested assistance from the Los Angeles Police Department. MC GOWAN said he was concerned over this as he felt we had checked Los Angeles Police Department records and requested other cooperation.

He was referred to the SAC's telephone call and airtel to the Bureau 4/30/68 pertaining to the Los Angeles Times editorial which had stated the same thing and was apparently where LOMAX got the idea to mention it. MC GOWAN was unaware of this and stated he would immediately locate it at the Bureau. He stated that this apparently solved the matter.

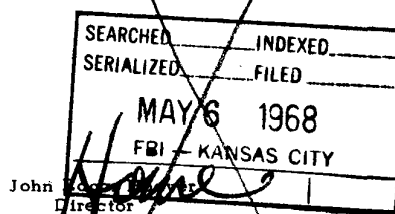
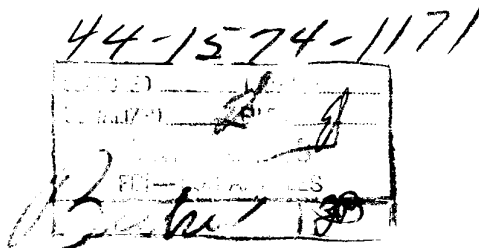

SUBJECT AND THEREAFTER STEIN TELEPHONICALLY CONTACTED HILL AIR FORCE BASE AND WAS ADVISED BY BASE LOCATOR THAT THEY HAD NO RECORD OF THE SUBJECT. STEIN STATES THAT SUBJECT AND EVANS PRESENTLY RESIDE AT ONE EIGHT FOUR THIRTEENTH STREET, APARTMENT FIVE O ZERO FIVE, OAKLAND.

AT ELEVEN P.M. MAY SEVENTH, LAST, STEIN TELEPHONICALLY CONTACTED LOS ANGELES OFFICE AND STATED THAT SUBJECT AND EVANS HAD JUST LEFT LOS ANGELES AIRPORT ON UNITED AIRLINES EN ROUTE BACK TO OAKLAND. STEIN ADVISED THAT HE HAS OBSERVED A PHOTOGRAPH OF SUBJECT JAMES EARL RAY IN U.S. POST OFFICE AND HE BELIEVES THAT CAPTIONED SUBJECT RESEMBLES RAY. STEIN IS NOT POSITIVE OF THIS IDENTIFICATION, BUT STATES THAT SUBJECT HAS A SMALL SCAR ON CENTER OF FOREHEAD SIMILAR TO SUBJECT RAY.

STEIN FURNISHED THE FOLLOWING PHYSICAL DESCRIPTION OF SUBJECT:

WHITE, MALE, AMERICAN, AGE THIRTY EIGHT,
, EXACT YEAR AND PLACE UNKNOWN, FIVE FEET TEN INCHES,
ONE HUNDRED SIXTY FIVE POUNDS, DARK BROWN HAIR, AND BLUE EYES.

CONTACT WITH OSI HAS DETERMINED THAT SUBJECT NOT ON ACTIVE DUTY AS COMMISSIONED PERSONNEL WITH U.S. AIR FORCE ACCORDING TO AIR FORCE REGISTER OF JANUARY ONE LAST.

AUSA, LOS ANGELES, FURNISHED PRELIMINARY OPINION AND IF SUBJECT OBTAINED SOMETHING OF VALUE AND/OR WAS A "REPEATER" AS TO ALLEGED WEARING OF UNIFORM, THEN HE MIGHT POSSIBLY CONSIDER AUTHORIZING TO TITLE EIGHTEEN SECTION SEVEN ZERO TWO, USC, HOWEVER, BEFORE AUTHORIZING HE WOULD WANT COMPLETE BACKGROUND INVESTIGATION CONDUCTED ON SUBJECT TO DETERMINE IF HE WAS CONTINUINGLY WEARING THE UNIFORM AND WAS A REPEATER.
