On 5/28/68 Detective CHARLES HUCHEL, Covina, California, Police Department, advised that the Covina PD had recovered a stolen 1967 Plymouth, California license UTW 102, which was stolen at Chula Vista, California. The Chula Vista PD relayed to them that the car was taken from a dealer's lot by (FNU) MARSHALL, who allegedly resembled JAMES EARL RAY.

The car was recovered on 5/28/68 in the 900 block of West San Bernardino Road, Covina, California, in the parking lot of Market Basket, apparently abandoned for several days.

ALLEN KRAUSE was interviewed by the writer at Covina, California, on 5/28/68 and was shown photographs of JAMES EARL RAY. He advised that the driver of the car was not identical with RAY.
