On 5/31/68 EDGAR EUGENE BRADLEY, 12208 Emelita Street, North Hollywood, California, telephonically advised SA JAMES MC CAULEY as follows:

BRADLEY said he had heard from friends in Tulsa, Oklahoma, and from relatives at Rudy, Arkansas, that FBI Agents had been making inquiries as to his whereabouts on 5/17/68.

Mr. BRADLEY said that, as he understood the situation, one REX BASINGER had alleged that BRADLEY had told BASINGER that BRADLEY was with ERIC GALT in Oklahoma on that date.

BRADLEY advised that he wished to volunteer that he had been a close childhood friend of REX BASINGER in Arkansas. However, he has not seen BASINGER since he was 15 or 16 years old and has lost track of him. He had heard that after World War II BASINGER had become a preacher. He said he had now heard that BASINGER had apparently had some mental problems, and the accusations against BRADLEY by GARRISON must have triggered a mental reaction.

BRADLEY said that, in fact, on 5/17/68 he was in North Hollywood, California, working on some accounts and making a bank deposit. He said he had talked with a number of people on that day, and his whereabouts can definitely be proved should it.



On 5/29/68 an attempt to contact a CHARLES WILLIAM BEAL 5606 Fostoria Street, Bell Gardens, California was made by SA JAMES E. FEENEM and SA ROBERT H. CLAUDIUS. No one was home. A: United States Navy insignia (retired) was noted on the mail box as well as the name BEAL. Inquiry at 5604 Fostoria Street determined that Mr. BEAL was a retired navy veteran and worked for the Parks and Recreation Department of Los Angeles County.

The following investigation was conducted by SA JAMES E. FEENEY:

On 5/29/68 the Parks and Recreation Department was contacted and it was determined that CHARLES WILLIAM BEAL was an employee of that Department since October 3, 1966, without interruption (Check made through Count Employment Verification Unit.)

On 6/3/68 CHARLES WILLIAM BEAL was physically contacted at his residence and it was determined that he is definitely not identical to JAMES EARL RAY, Aka. BEAL is about 5'6" and about 150 lbs. has many gold teeth and bears no physical or facial resemblance to RAY, except a crew cut (hair) similar to that worn by RAY in a 1960 photograph.

No additional investigation is being conducted in this

matter.

The following investigation was conducted by SA FINBARR M. O'CONNOR:

On 5/22/68, Mrs. GEORGE KARIAN, 4132 Kottler Drive, Whitemarsh Township, Pa., whose phone number is 247-2027, advised that following the previous contact, she and her husband rechecked all their phone numbers, outgoing and incoming, as best they could, and they have no record of any calls from the West Coast on 1/3/68.

She stated that from November, 1967, to March, 1968, her husband's mother, Mrs. SAMUEL KARIAN, was in the Los Angeles area, and several phone calls were made; however, they were all collect. A check of these calls failed to reflect a call on 1/3/68.

Mrs. KARIAN stated she asked her two children, PATRICIA and JANICE, if they recalled an incoming phone call on 1/3/68, and they both stated they did not remember any long-distance calls.

Mrs. SAMUEL KARIAN advised that on 1/3/68, she was at a relative's residence, Mr. and Mrs. AJDERIAN, 5913 Carlton Way, Hollywood, Calif., and did not make any calls to her son in Pennsylvania during that day. She does recall that she did phone her son on both Christmas and New Year, but they were collect calls and not from a phone booth.

On 5/23/68, Mr. GEORGE KARIAN advised that since the contact with his wife the previous day, they had rechecked all their phone calls, and did not have any calls other than specific calls from his mother from the West Coast. They did not have any incoming calls from the West Coast or outgoing on 1/3/68. The only toll calls from his phone on 1/3/68 were one to Tennessee, one to South Carolina, and one to Worchster, Mass.

Atlanta summary teletype of 5/24/68, requested advice concerning THORNTON who is now residing in Atlanta.

The following was obtained from the new closed file in the Birmingham Office relating to THORHTON (BH 157-631; Atlanta 157-770; Los Angeles 157-691, 157-855; and BUFILE 157-1660), which also has to do with the American States Rights Party, an off-shoot of the Matienal States Rights Party:

During 1963, THORNTON was residing in Garden Grove, California, and was assisting in the publication of the HBEP of California organ, "The Attack," P. O. Box 641, Santa Ana, California. On page 8, of the report of SA HARRY L. CRIFFIN, Los Angeles, 1/14/64, it appeared that THORNTON left for Birmingham, on 1/6/64. Birmingham file reflects he left Birmingham in November, 1964, to return to Garden Grove, California. Birmingham file relating to THORNTON was closed upon receipt of information from Los Angeles (157-691) that he had been inducted into the U. S. Army on 6/15/65, at Los Angeles, Serial No. 56386553, and assigned to duty at Ft. Polk, Louisiana. He is not known to have returned to Birmingham, and since NSEP headquarters had been moved from Birmingham, there would have been no reason for him to have done so.

From the above, it does/appear that any association of RAY with THORNTON could have occurred in Birmingham, since RAY was confined during the period of THORNTON's residence theme.
