Re FD-71 of SA ROBERT H. CLAUDIUS dated 5/24/68.

On 5/27/68 JOHN AUSTIN was contacted at his residence, 13759 Cohasset, Van Nuys, California. AUSTIN advised that he is a free-lance writer, and made available his business card which reads as follows: "Representing Screen Stars - Movie World Magazine - New York Macquarie Broadcasting Service - Australia Springer News Service - Hamburg - New York. John Austin. Motion Picture Columnist - Hollywood Editor."

AUSTIN continued that he has a "source" by the name of LORAN E. HALL, who can be reached at LA telephone 962-7404, and who AUSTIN has advanced considerable sums of money for information regarding the assassination of JOHN F. KENNEDY. According to AUSTIN, HALL describes himself as an "anti-Communist - Cuban freedom fighter." AUSTIN stated that on the basis of information furnished by HALL, he is convinced that the assassination resulted from a conspiracy. He noted that HALL recently returned from New Orleans, La. where he testified before a grand jury, at the request of New Orleans Dist. Atty. JIM GARRISON, supposedly to the effect that in early 1963 he attended a meeting in Los Angeles, also attended by EDGAR EUGENE BRADLEY and CLINTON WHEAT, at which the possibility of assassinating KENNEDY was discussed.

AUSTIN indicated that HALL recently told him that the same "forces" behind the assassination of KENNEDY are responsible for the death of MARTIN LUTHER KING. According to AUSTIN, HALL maintains that CLINTON WHEAT has used the name ERIC STARVO GALT in the past, and is part of a conspiracy which conceived the KING murder.

AUSTIN noted that he does not have any idea where HALL obtains his information. However, he stated that he felt that HALL "was on the right track."

Los Angeles indices reflect that LORAN EUGENE HALL is the subject of LA file 2-218, Bufile 105-78016, captioned IS-CUBA, which file reflects that when interviewed by the FBI in 1959, HALL claimed that he recently returned from Cuba where he trained men in the use of arms in preparation for an invasion of Nicaragua; and that when interviewed by the FBI in 1963, HALL claimed to be a captain in the Cuban Revolutionary Council in Miami, Fla., and that he was engaged in "counter-revolutionary" activities in Cuba.

LA file 89-75, Assassination of President JOHN F. KENNEDY, 11/22/63, Dallas, Texas, Misc. Info. Concerning, reflects that HALL, in early May, 1968, testified in New Orleans, La. in connection with New Orleans' Dist. Atty. JIM GARRISON's investigation into the assassination of KENNEDY.

Above information from AUSTIN re information furnished by HALL, discussed with Supv. WILLIAM J. NOLAN, who advised that in view of HALL's background and close association with New Orleans Dist. Atty. JIM GARRISON's investigation into the assassination of KENNEDY, this individual should not be interviewed re MURKIN.

At 2:41 p.m., the writer received an overflow telephonic complaint where the caller stated, "You are looking for me. My name is HAROLD THOME and you want to interview me concerning my discussions with MARTIN LUTHER KING. I talked to KING concerning the Bible. At the time KING was killed, I was at the Arlington Masonic Home". The caller was asked for an address where he could be contacted by an Agent to which he replied, "Good night, sir". He was then asked if he had a telephone number that could be used to reach him to which he replied, "Good night, sir" and hung up.

The above telephone call appeared to be long distance, probably distance dialing, as when the caller hung up, the tone on the telephone was similar to a disconnected long distance call.

Supervisor NOLAN was promptly furnished the above information.

At 9:31 AM, 6/4/68, SAC ROBERT G. JENSEN, Memphis Division, telephonically furnished the following information:

JENSEN initially stated that the Bureau had advised that Murkin cost data had to be submitted to the Bureau by Memphis prior to 2:30 PM Eastern Daylight Savings Time *this date*. JENSEN stated he realizes many offices have already sent in the information but because of mail delays this information may not reach Memphis in time. Therefore he requested that this information be telephonically furnished to him at once. He also requested that Los Angeles relay this information to Portland, Seattle and San Francisco and instruct those offices to contact SA GYLFE in Memphis who is coordinating the program.

JENSEN stated that recent information had been developed based on a request of the RCMP to check passport applications. He stated it would appear that JAMES EARL RAY, using the alias RAMON GEORGE SNEYD, had a Canadian passport photo taken on 4/11/68 in Toronto, Canada. On 4/19/68 it appears he resided at 968 Dundas Street, Toronto, where he remained for approximately three weeks. It is believed he took a flight to England on 5/6/68 and had a return reservation for 5/21/68. JENSEN stated it would appear that subject may now be residing in Toronto and an intensive, discreet investigation is underway in Toronto. JENSEN stressed that the above alias and reported activities of the subject are being guarded and that no undue dissemination of this information should be made.

JENSEN stated as of interest the passport application was examined by the FBI Laboratory and they indicate the handwriting is similar to subject's and they "like it." Also our legal attaches and the RCMP feel that the passport photo bears a striking resemblance to subject RAY. Further, that the above

Established sources at General Telephone Company, Santa Monica, California, and Pacific Telephone Company, Los Angeles, have advised that they are unable to locate any record of telephone calls made to Auckland, New Zealand, from San Bernardino, California, in March 1968 and from Santa Barbara, California, in April 1968, as reported in Auckland, New Zealand, press.

General Telephone source checked all calls to Auckland from Santa Barbara and San Bernardino during March and April 1968, however, was unable to locate record of instant calls.

Pacific Telephone source advised that without billed telephone number it is impossible to check overseas calls.

No further action being taken on Auckland calls by Los Angeles.

On 5/28/68, SAs G. J. MOOREHEAD and WALTER M. BRADY interviewed ADRIAN ROSE, 1140 Gower, Los Angeles, California, (Apartment 406). At the outset of this interview, ROSE gave the appearance of a very nervous and disturbed individual. He rambled on as to how "certain politicians" had conspired to blow up a man in Chicago and had also recently sought to kill him (ROSE). He stated that he would not care to continue speaking with the agents until we interviewed this unknown man from Chicago to prove what he was saying. ROSE continued that he was sounding like a "lunatic" and did not care to continue the interview.

He was admonished not to represent himself as a Federal Officer if such were ~~not~~ the case and he gave an incoherent response. There was nothing to be gained by pursuing the interview as ROSE was such a confused person. He did not appear to be rational, rambled incoherently, and terminated the interview by saying that he had no personal information concerning the murder of Reverend KING.
