Mr. T. EDWARD UMPHRES (confidential), Area Security Supervisor, Southwestern Bell Telephone Company, St. Louis, Missouri, advised Special Agent SPURGEON J. PETERSON on May 15, 1968, that St. Louis telephone number 781-8776 is issued to JAMES MICHELETTI, 1561 Kraft, St. Louis, Missouri.

JAMES MICHELETTI advised Special Agent JOHN O. TRETHEWEY, JR., on June 10, 1968, that he was not acquainted with anyone of subject's appearance as depicted in the IO displayed to him, or as noted in newspaper and television publicity in connection with this case. Subject's true name and aliases were likewise unknown to him, except through news media publicity. He was not acquainted with anyone who knew or had information concerning subject.

In early March, 1968, Mr. MICHELETTI received a telephone call from his daughter-in-law, LINDA MICHELETTI, in Los Angeles, to the effect that her husband (his son), DONALD JAMES MICHELETTI, was in trouble and in jail there for possessing narcotics, which necessitated his going to Los Angeles in an unsuccessful attempt to settle the difficulty. He had no reason to believe his son or daughter-in-law were in any way acquainted with subject, or had any knowledge or information concerning him.

FREDERICK JOHN SCHWARTZ

The files of the Passport Office, Department of State, reviewed by a Special Agent of the FBI on June 13, 1968, disclosed that Frederick John Schwartz was last issued Passport [REDACTED] at Los Angeles, California, on October 23, 1967, for proposed business travel of unstated duration to Britain, France, Italy, Germany, Austria, Switzerland, Holland, Denmark, and Spain. In his application dated October 23, 1967, at Los Angeles, he stated his intention to depart from Los Angeles by unnamed airline about October, 1967, not by organized tour. He stated that he expected to take another trip abroad within the year. According to a notice published in the Federal Register on March 16, 1967, this passport was valid for three years' travel to all countries except Cuba, North Korea, Mainland China, and North Vietnam.

This individual stated that he was born on [REDACTED] at Detroit, Michigan. The file shows that he was previously issued Passport [REDACTED] on May 21, 1962, but the previous portion of his file was not available for review at this time. He gave his permanent residence as 2754 Woodshire Drive, Los Angeles, California, and arranged to pickup his passport in Los Angeles. He listed his father as Frederick Drew Schwartz, born in Colorado in 1917, and his mother as Dorothy Kiefer, born in Detroit, Michigan, 1919.

He stated he was last married on February 1, 1963, to Normajean Marie Skibel Schwartz, who was born in Los Angeles, California, on [REDACTED] marriage not terminated. In the event of accident, he requested that Mrs. Dorothy Graves, his mother be notified at 10330 Monte Mar Drive, Los Angeles. He left a telephone contact number of HO4-9171.

On 6/10/68, CRACIELLA KERWER, 3624 South Overland, Apartment 2, Los Angeles, was interviewed partially in the English language and partially in the Spanish language.

KERWER advised that she believes she is psychic - in some respects and admitted she does have dreams and premonitions concerning certain events.

She advised that she had a dream about the possible location in Los Angeles where JAMES EARL RAY could have been. She said the dream told her that he had been in a house near a freeway on Sepulveda, Los Angeles.

KERWER advised that she has never seen RAY, and has no specific or definite information concerning his activities or past residences while he was in Los Angeles.

She felt that her dreams were significant in helping to determine this location but she failed to give any possible actual location that could be investigated.

KERWER admitted she was extremely nervous and that her husband, EDWIN KERWER, was also nervous and is easy to become upset.

At approximately 2:00am, April 18, 1968, an individual who identified himself as PAUL GIBRAN, 1850 North Whitley, Apt. 214, Los Angeles, California, telephone 461-2479, telephonically contacted the LA HQ Office and advised he observed a mail box in his neighborhood on which the name "GALT" appears. GIBRAN stated he accidentally saw this mail box which is located behind the residence of a female acquaintance of GIBRAN'S in the 1800 block of North Whitley. GIBRAN stated that at about 1:30am, April 18th, as he was standing in the front yard of his girl friend, a yellow cab stopped and a male Caucasian, 5'10", 170-175, wearing prescription glasses and carrying a briefcase got out of the cab and walked toward the rear of the house in front of which GIBRAN was standing. When GIBRAN'S girlfriend stated this gentleman was Mr. GALT, GIBRAN stopped Mr. GALT and asked him for a match. GIBRAN stated he got a good look at the man, allegedly Mr. GALT, and felt he should contact the F.B.I.. GIBRAN further stated he has assisted the Bureau in the past by having assisted SA DICK DOUCE in espionage work. GIBRAN desired that the photograph of GALT be shown him by the F.B.I..

On April 19, 1968, SA DICK DOUCE verified the fact that GIBRAN had furnished valuable information on Bureau cases in the past. In addition, SA DOUCE indicated GIBRAN is somewhat emotional, and would not intentionally furnish inaccurate information.

Lt. CLYDE GUARD, Cypress, Calif. PD advised telephonically to the Los Angeles Office 4/18/68 a Mr. WILLIAMS, telephone 596-7586, had telephonically contacted the Cypress PD and furnished the following information:

WILLIAMS stated he had seen a person looking like GALT on Green St., Los Alamitos, Calif. GUARD felt if this office contacted WILLIAMS perhaps he could furnish further information concerning the subject.

On 4/22/68 JERRY E. WILLIAMS, 4481 Marion Ave., Cypress, Calif. was contacted at his employment Geller's Ready Mix Co., Katella Ave., at Los Alamitos Blvd., Los Alamitos and related he had seen the subjects photo in the paper, (LA Times) 4/18/68, and when he delivered a load of cement to 3874 Green St., Los Alamitos, the same date, he thought he saw some one who resembled GALT working at that address on a new housing project.

He stated he could furnish no other information.

JAMES ENGLISH, superintendent, construction of Supermarket at the above address, contacted 4/22/68 was shown to photo of GALT and advised that he does not have that many men working on this project and he is positive no one resembling GALT has ever worked at this project.

Inasmuch as this is an open area and no logical neighborhood investigation could be conducted, no further investigation was conducted at the above location.

On 4/20/68 at 2:20 am Ident. Officer, BILL NEASE, Orange County SO, Santa Ana, Calif. telephonically advised they were holding latents processed by his department at his bureau, which were taken at the Colony Kitchen, Ortega Highway, San Juan Capistrano. He advised that these prints were taken from items known to have been handled by a man who had eaten at that location earlier that evening and who was identified by five people at that location as looking like subject JAMES EARL RAY, AKA. Fug.

NEASE advised he was advised by SA W. CARROLL to hold the latents picked up for the FBI and some one from the FBI would pick them up to be checked with the prints of RAY. NEASE advised that other than processing for prints, no further investigation was done by his department.

This agent had the week-end duty 4/20/68 and reviewed the OSO file which reflected the following:

The OSO on 4/19/68 at 10:50 pm contacted the following at the Colony Kitchen, San Juan Capistrano, who stated a man looking like subject RAY had just been in the bar. The report showed the subject came into the bar alone about 10pm, ate an omlet and proceed to down four "stingers". They advised the George Putnam TV News was on and when he finished discussing the murder of MARTIN LUTHER KING, the suspect jumped up and swore at Putnam and called him "a dirty son of a bitch".

Two other customers, unknown to OSO.

On 4/20/68, LARRY RICHARD GRAY, was contacted at his residence 404 C. Victoria St., San Clemente, and up on a telephone call, was joined by SHARON STEVENS, waitress, Colony Kitchen, who was staying overnight in San Clemente. They were both shown the photo of the subject and advised the above described man did look somewhat like the subject RAY, but admitted that "everyone was pretty drunk last night" and that when the subject, who was "very drunk" began to swear, they "all lost their heads".

They both agreed that they could not identify the man they had as a customer with the subject, especially since his hair was not dark, but a very light brown, almost blond.

It is noted that on 4/22/68, the latents obtained in this case by the OSO were compared with the fingerprint classification of subject JAMES EARL RAY by Ident Officer, BILL NEASE, OSO, who advised that the latents are good are not identifiable with RAY and that his department has not been able to identify the unknown suspect from their own latent and FP file.

He reiterated, however, that the subject is not ident to subject JAMES EARL RAY.

In view of the above, no further investigation was conducted to identify the suspect at the Colony Kitchen, San Juan Capistrano.
