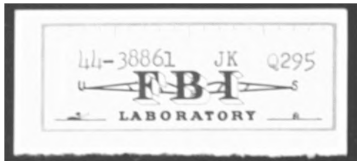

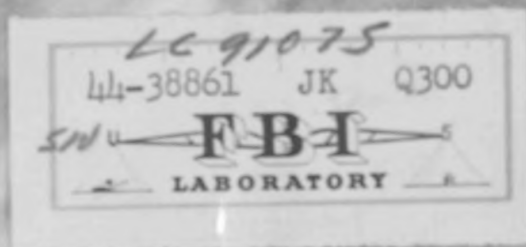

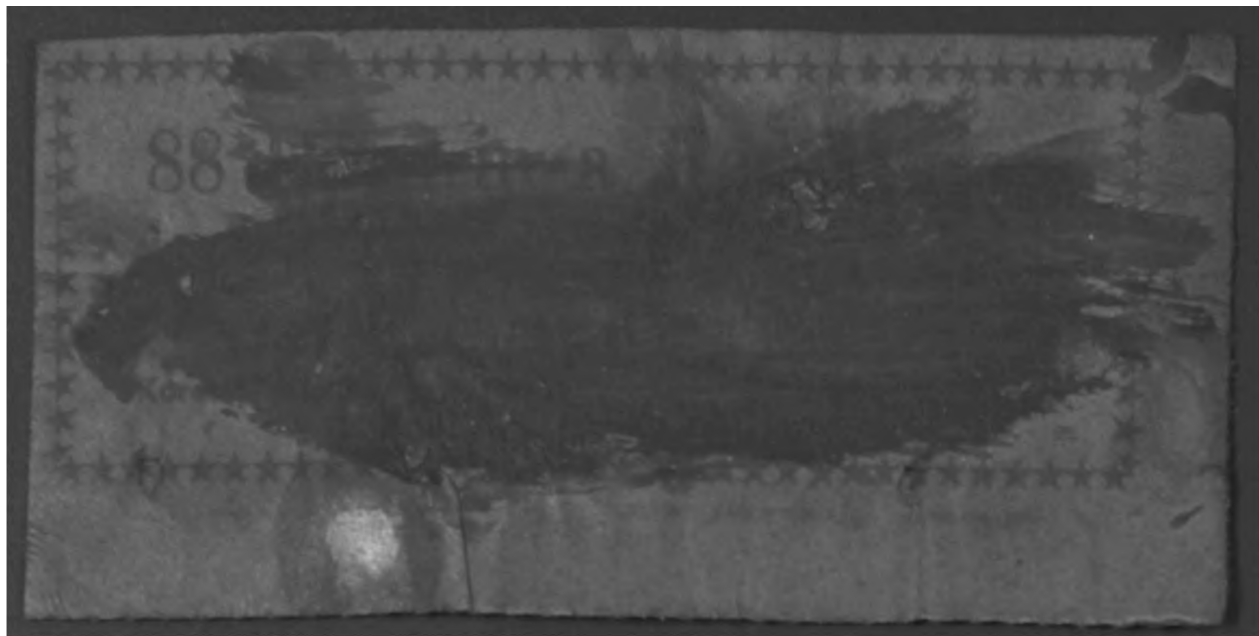
Welfare has not worked, Kennedy added: "We've tried government sponsored programs and jobs just do not come from the federal government, but from the private

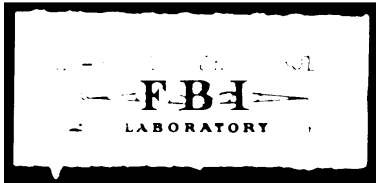
The difference, he said, was that "I think something should be done" and not just talked about.

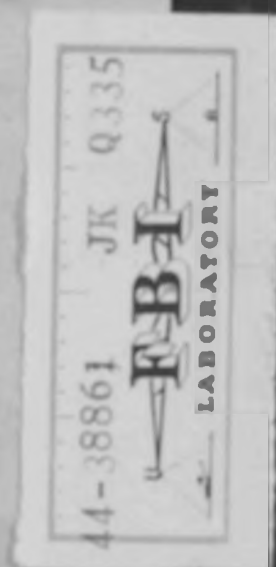

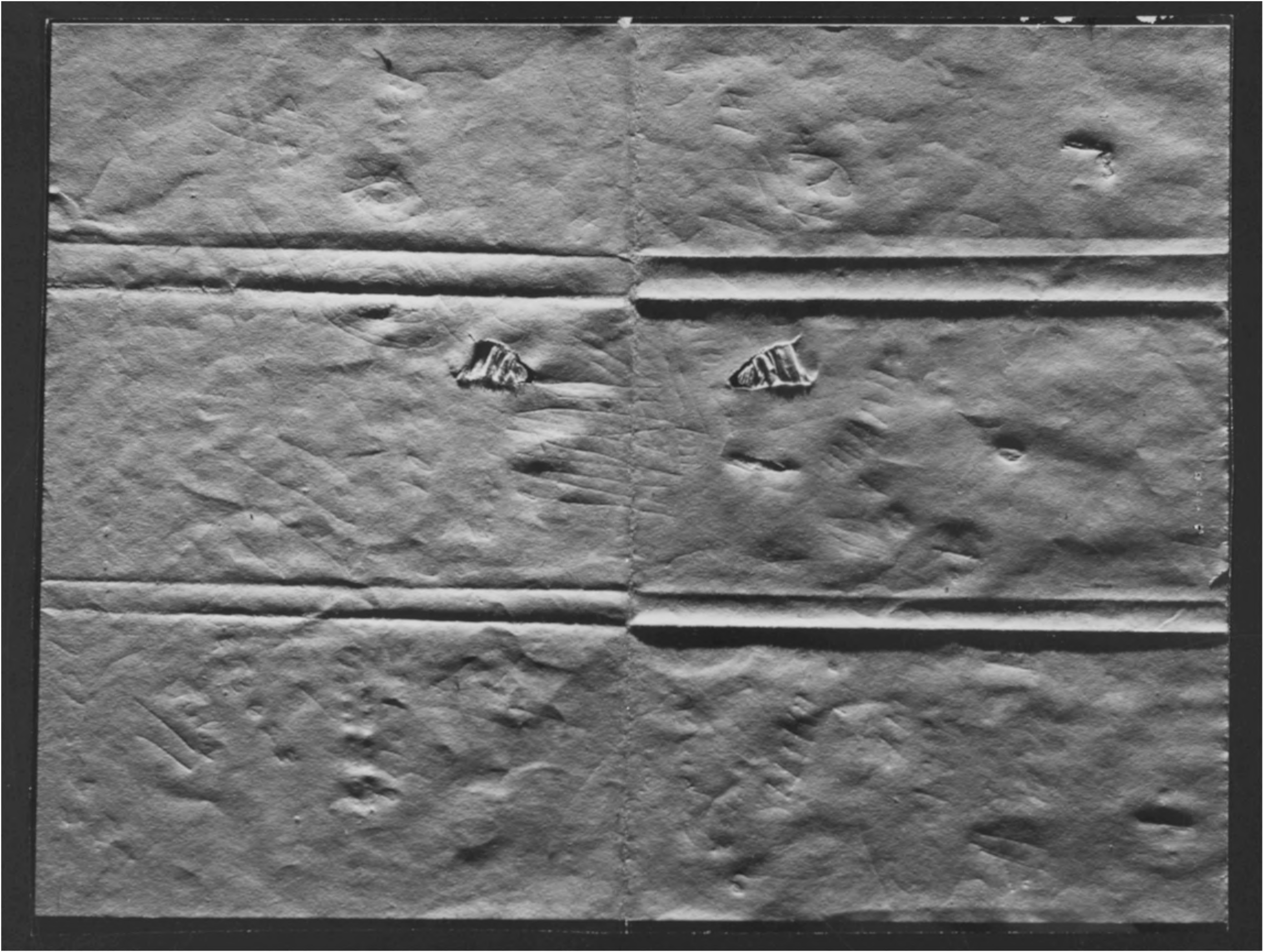
