BUTTERLY, a Caucasian, male, described himself as age 84. He said that in March, 1968, a man he knows only as "Woody" stayed with him for a short time. He described this man as a Caucasian, male, age about 50, height 5'7", weight about 135 pounds. He said "Woody" is a drifter and does odd painting jobs whenever he can find such work. He did some painting at the St. Francis hotel which is located in the same general area as his, BUTTERLY's residence. He also did some painting for BUTTERLY.

"Woody" left about one and one-half months ago, saying he had to go to Pheonix, Arizona where his sister had just died.

BUTTERLY said he knows nothing of any telephone calls from Fort Worth, Texas.

ROBERT KEELEY advised he is the Day Clerk at the St. Francis hotel, 5533 Hollywood Boulevard, Los Angeles (Hollywood), California.

He said that HARRY LUNSFORD, who used the nickname "Woody", did work as a painter and stayed for a short time at the St. Francis hotel in early 1968. He described "Woody" as a Caucasian, male, height about 5'7", weight 135 pounds, age about 50. He recalled the man talking about a daughter in Pheonix, Arizona and mentioning that he had other relatives in the State of Texas, possibly in Dallas or Fort Worth. He was unable to recall the names of any of these relatives and said he is not aware of LUNSFORD's present whereabouts.

KEELEY said he has not seen "Woody" for about one and one-half months.

WILLIAM FRENCH PAUL, Apartment 15, 5540 Hollywood Boulevard, Los Angeles, was interviewed at his residence at which time he furnished the following information:

Mr. PAUL related that he sometimes uses the telephone booths in the lobby of the St. Francis Hotel to call his mother, Mrs. HENRY EDGERTON, Pembroke, North Carolina, telephone 522-4689, and his sister, MARY FRENCHETTE, Mount Dora, Florida, telephone number EV 3-3254. Mr. PAUL related he has a telephone in his room which is HO 2-7053, but uses the telephone in the St. Francis Hotel lobby in order that he might tell the number of minutes he talks. By doing this, he related that he could keep his calls from being so long as they might otherwise be.

Mr. PAUL advised he patronizes the Sultan Room of the St. Francis Hotel. He usually goes to the Sultan Room, has a few beers, and then places his telephone calls. He was exhibited photographs depicting JAMES EARL RAY at which time he related the face appeared familiar as an individual he saw at the Sultan Room or the lobby of the St. Francis Hotel. He said he had never had any conversation with RAY and did not know anyone who might be acquainted with RAY.

JOE PETERS, Bartender, Sultan Room, St. Francis Hotel, 5533 Hollywood Boulevard, Los Angeles, California, advised that he had asked LOUIS LOMAX to remove himself and his business from the Sultan Room at the St. Francis Hotel. PETERS stated that LOMAX was interfering with the business at the bar.

PETERS stated that with regard to female associates of JAMES EARL RAY, also known as, Eric Starvo Galt, he remembered, there was a blond Caucasian female, with whom RAY engaged in conversation approximately in February. PETERS stated that this girl wears her hair short and combed back and goes by the name of "DARRELL". He said that he believes her to be a lesbian-prostitute. He said that she was a user of narcotics and also a heavy drinker. He said that recently she was living with a Spanish-American male who is known as "RAY". He said that "RAY" was a former boxer who was recently arrested. He stated that prior to "DARRELL's" association with "RAY", she was kept by JACK PENDLETON. PETERS described PENDLETON as a Caucasian male, with a crippled leg. He said that according to his knowledge, PENDLETON is presently in the Veterans Hospital, Los Angeles. PETERS said that PENDLETON pimped for "DARRELL". PETERS said that somehow he obtained word that "DARRELL" is presently in Milwaukee, Wisconsin, or Minneapolis, Minnesota. PETERS said that there are several women that frequent the Sultan Room and/or that particular area on Hollywood Boulevard, with the names, "HELENE", "HELENA", and/or "HELEN". He advised that there is a "HELENA" (Last Name Unknown), who is middle aged, that works at a Thrifty Drug somewhere in Hollywood, and that frequents the bars. He advised that there is a middle age woman named ALISA (phonetic) who has a daughter that is a go-go-dancer. He said that he believes ALISA is a dancer or was a dancer.

PETERS stated that he will attempt to develop information as to the identities of these individuals and will relate this information as soon as it is obtained.

PETERS stated he was a bartender at the Sultan Room, St. Francis Hotel, 5533 Hollywood Boulevard, until he terminated his employment on April 26, 1968. He stated that there were no fry cooks employed at the Sultan Room.

PETERS stated that a woman named DYRELL DENNIS and a man named RAY, whose last name he did not know, stayed in a room registered to JACK PENDELTON at the St. Francis Hotel. PETERS described RAY as a Mexican American, 5'2" or 3", 130 pounds, dark hair, dark eyes, and unkept appearance. PETERS described RAY as a wino and that he has no control over his physical excretion faculties which is obvious to those in his presence. PETERS continued that RAY sometimes worked at a hamburger stand in the vicinity of the St. Francis Hotel. He related that DENNIS and RAY were drunk most of the time.

PETERS stated that DENNIS and RAY stayed at the St. Francis Hotel room registered to JACK PENDELTON where they usually slept on the floor. PETERS stated that PENDELTON is presently in a hospital, the name of which or location of which he does not know, for the amputation of a limb.

CHARLES CALVIN BOOKMAN was contacted by FBI Agents at his residence, Apartment 201, 948 South Figueroa, Los Angeles. At the outset of the interview, BOOKMAN was advised that he was being requested to come to the Los Angeles Office of the FBI to be interviewed in connection with his knowledge of the activities of JAMES EARL RAY. BOOKMAN was also advised that his appearance at the FBI Office was strictly voluntary and he agreed to accompany the Agents to the office.

At the outset of the interview in the Los Angeles Office of the FBI, BOOKMAN executed a voluntary appearance; an Advise of Rights Form, which he acknowledged he read and understood. He stated that between 3:00 and 3:30 p.m. on April 19, 1968, he received a telephone call from a man he knew in Leavenworth Penitentiary as JIM RAY. BOOKMAN was displayed photographs of JAMES EARL RAY and selected a photograph with closed eyes as the best likeness of the man from whom he received the telephone call. He stated that the man identified himself in the call as JIM RAY and stated that he was "around town". The caller also stated that he needed money and when BOOKMAN stated he did not have any, the caller requested that if anyone asked about him BOOKMAN was to say that he had not seen him. The caller also stated that if BOOKMAN could furnish him no help, he was going to have to go to a mission possibly in San Pedro.

BOOKMAN stated that the only first name he has ever called RAY is "JIM", however, when both were serving time in Leavenworth he heard RAY called "RALPH" and "EDDIE".

BOOKMAN stated he first met RAY in the Trustee Farm, which was across the river from the main prison at Leavenworth Penitentiary. BOOKMAN stated he was transferred from Springfield to Leavenworth in the summer of 1956 and left there in May of 1957 when RAY was still there. BOOKMAN served as a cook in the Trustee Farm kitchen and RAY was serving food in the same kitchen. About two months before BOOKMAN left Leavenworth, a Negro was placed in charge of the Trustee Farm as Steward

At this time prison authorities also began integrating sleeping quarters which formerly had been segregated at the farm into two white dormitories and two Negro dormitories. At this time RAY requested a return to the main prison because he was opposed to integration. BOOKMAN stated that he knew RAY about two months in the farm and that they played dominos together and saw one another regularly.

BOOKMAN stated that the next time he saw RAY was in the Spring of 1961 when he met him in a Greyhound Bus Station which is part of the Pickwick Hotel in Kansas City. He saw RAY for about an hour and had a drink with him at a bar at the Pickwick Hotel. At that time, RAY stated he was living in Southern Missouri but did not say where. BOOKMAN continued on his bus trip and the last time he saw RAY was about August 20, 1967 in the Amber Room of the Figueroa Hotel in Los Angeles. BOOKMAN came in to the Amber Room and RAY was seated at a bar with a blonde woman, age 20 to 22 and "not too tall". During conversation with RAY and the woman, he gained the impression that RAY was living with the woman but could not recall the name of the woman or any other identifying data. During this conversation RAY stated he had been working aboard a ship not further identified and was currently unemployed. BOOKMAN gained the impression that RAY was working out of New Orleans. BOOKMAN stated that he stayed with RAY for about an hour and then left furnishing RAY his address and telephone number. He stated that he never saw RAY or the girl again. He knows that RAY was apparently fairly well off since he bought all the drinks while they were together.

While in Leavenworth, RAY was a close associate of "BINNY" BINNION who was currently behind the scenes owner of the Horseshoe Club in Las Vegas. RAY was also associated with WILLIE LEVINE while in prison, who was about 60 years old and serving time for a narcotics violation. LEVINE was from Los Angeles and BOOKMAN believes that he is deceased.

BOOKMAN stated that all baked goods for the Trustee Farm came from across the river in the main prison. BOOKMAN stated that he also cooked in the main prison kitchen before going to the Trustee Farm.

It was pointed out to BOOKMAN that RAY never went to the Trustee Farm at Leavenworth and BOOKMAN then stated that he might possibly have met RAY while in the main prison.

It was pointed out to BOOKMAN that RAY was in prison in the Spring of 1961 when BOOKMAN stated he had met RAY in Kansas City. BOOKMAN then furnished an account of his activities beginning in 1957 and concluded that it must have been August or September 1959 when he met RAY in Kansas City.

It was suggested to BOOKMAN that if he was mistaken in some details he might be mistaken about the identity of the person who called him on the afternoon of April 19, 1968. BOOKMAN stated that he had absolutely no doubt that the person who called him was identical with the photograph of JIM RAY which had been displayed to him. BOOKMAN was advised that it was a violation of Federal law to harbor a fugitive and that it was also a violation of Federal law to furnish material false information to Federal authorities. BOOKMAN conceded that there might be inaccuracies in some of the information he furnished but reiterated that he had received a phone call from JAMES EARL RAY on the afternoon of April 19, 1968. During the course of the interview with BOOKMAN it was noted that BOOKMAN is incased in a cast from his upper chest to the foot of his left leg. He advised that he had been in four accidents in his life in addition to being treated for numerous ailments including a diabetic condition, kidney and liver infections, and a congenital hip defect. He has been treated at United States Public Health Hospitals in Memphis, Tennessee; Baltimore, Maryland; Galveston, Texas; and San Francisco, California, as well as other hospitals which include St. Francis Hospital, Billings, Montana; County Hospital, Salt Lake City, Utah; Coronado Hospital, San Diego, California; Marine Hospital, Norfolk, Virginia; Community Hospital, Indio, California; Los Angeles County Hospital and John Wesley Hospital, Los Angeles.

He was involved in an accident while working in Glendive, Montana, and received \$5,700 in Workman's Compensation from a board in Helena, Montana, in May of 1957. He was involved in an accident in Jackson, Wyoming, when hit by an automobile

in July of 1958. He was hit by an automobile on the Coronado Ferry in San Diego in January 1963, and in October 1967, he was struck by an automobile driven by a priest in Indio, California, which resulted in a broken hip and other ailments for which he is still in a cast.

BOOKMAN furnished a personal history of his migrant activities. He has worked as a cook in numerous cities throughout the country mostly in the South and far West, usually for only a few days or weeks at a time. He stated that for the past ten years he has rarely worked and has made a living as a cardsharp when not hospitalized. He stated he was represented by Attorney MAURICE BOUDREAU in San Diego in litigation arising out of the accident on the Coronado Ferry. He also advised that he had been treated by Dr. LINDSTROM in Salt Lake City as a result of the accident in Jackson, Wyoming.

ALBERT LEWIS ABSTON, also known as Gilbert R. Abston and Hardrock was interviewed at the Los Angeles County Jail where he was then prisoner under booking number 688086. ABSTON, who stated he could always be contacted through LOUELLEN HILL, 1775 Freeman Avenue, Long Beach, California, telephone number 438-5210, advised as follows:

Pictures of the suspected killer of MARTIN LUTHER KING appeared in the April 13, 1968 issue of the "Los Angeles Times". The profile picture "fits to a tee" one WILLIAM LENNARD or LENNORD who, in 1957 or 1958, served time in Draper Prison, Elmore, Alabama with ABSTON. LENNARD was serving time on a manslaughter charge for the shooting of a Negro. LENNARD, ABSTON's cellmate, told ABSTON that prior to his, LENNARD's, arrest, he had followed KING from Bessemer, Alabama, to Tuscaloosa, Alabama, in hopes of getting an opportunity of shooting KING. LENNARD's talk centered around his hatred of Negroes. LENNARD was always figuring ways of "getting rid" of KING. He said he would do it if no one beat him to it. LENNARD's father, a gunsmith, made LENNARD a gun which could not be traced. During time LENNARD was ABSTON's cellmate the name of GALT was mentioned, although ABSTON could not recall details.

Mr. STEPHEN THOME was telephonically contacted at 355 West Acacia Street, Glendale, and was advised it had been learned his father, HAROLD J. THOME, had obtained a ride to Worthington, Texas, on March 9, 1968, allegedly to visit a son or son-in-law in that town. THOME stated he was positive his family had no relatives anywhere in Texas and had no idea whom his father might have visited.

THOME volunteered that his father had called him on Monday night, May 20, 1968, from an unknown location, paying for the call. He told his father the FBI wanted to talk to him and urged his father to contact them and clear the matter up. His father refused, stating he was afraid the FBI would kill him, just as the Los Angeles Police would do if they could find him. THOME stated this indicated the serious mental condition of his father. THOME also stated his father had been intensely interested in World Peace and Brotherhood since the start of his mental illness. He stated his father was sure there were warrants outstanding for him in California, and he would not return to California for that reason.

ALLAN O. THOMPSON, Manager, St. Francis Hotel, Los Angeles, California, advised that during a conversation with a Caucasian male, whom he refused to identify, certain events were recalled by him concerning JAMES EARL RAY, also known as Eric Starvo Galt. THOMPSON said this unnamed individual inquired about the relationship between JAMES EARL RAY and another Caucasian male of whom he heard GALT call "J.C." THOMPSON said this unnamed individual approached him in an effort to "get a piece of the action" concerning the reward money offered as a result of the assassination of Dr. MARTIN LUTHER KING. THOMPSON said that during March, prior to the departure of JAMES EARL RAY, he remembered receiving two, possibly three, long-distance telephone calls for ERIC GALT, while THOMPSON was operating the hotel switchboard. THOMPSON said that when he advised the caller that ERIC GALT had no telephone in his room, the man requested THOMPSON to leave a message for ERIC GALT to call JAMES C. HARDIN collect. This caller also provided the city and operator number. THOMPSON said he relayed this information to ERIC GALT on each occasion. He advised the telephone calls came from both Atlanta and New Orleans.

THOMPSON said that subsequent to these telephone calls, a person who identified himself as JAMES C. HARDIN, came to the St. Francis Hotel shortly after the last of the recalled telephonic contacts. THOMPSON said this individual did not reside at the St. Francis Hotel. He advised that HARDIN may have stayed the night at the St. Francis on an unofficial basis in that he believes he remembers observing HARDIN slip out the side door of the hotel early one morning shortly thereafter.

THOMPSON stated in reference to the telephone calls to ERIC GALT by JAMES C. HARDIN, that they all occurred within a few days of each other. He advised on one occasion, the operator was placing the telephone call for HARDIN. He said that on the other occasions, he believes HARDIN dialed directly.

THOMPSON said the individual who brought HARDIN to his attention does not wish to identify himself. THOMPSON said he believes the reason for this is that the individual is a subject of a local warrant. He said that when he suggested that this individual contact the FBI concerning any knowledge that he may have concerning the assassination of Dr. MARTIN LUTHER KING, the individual replied that he could not contact the FBI. THOMPSON was advised that he should recontact this individual and inform him that it is imperative that he be contacted by Bureau Agents. THOMPSON said that he would inform this individual of this request.

THOMPSON was further advised of the importance of this matter and that he must provide this unknown individual's name. He was also informed that it was possible that he would be subpoenaed to provide this information. THOMPSON refused and said that he made a promise to this individual, and he fully intends to keep this promise. THOMPSON said that it would take court action to induce him to identify this individual.
