ATTORNEY GENERAL RAMSEY CLARK ANNOUNCED TODAY THAT ERIC STARVO GALT IS BEING SOUGHT BY THE FBI AS A FUGITIVE ON A FEDERAL CHARGE ARISING FROM THE FATAL SHOOTING OF THE REVEREND DR. MARTIN LUTHER KING, JR., IN MEMPHIS, TENNESSEE, ^{on April} ~~1968~~ 4, 1968.

DIRECTOR J. EDGAR HOOVER STATED THAT A FEDERAL COMPLAINT WAS FILED BY THE FBI IN BIRMINGHAM, ALABAMA, TODAY CHARGING GALT ^T WITH CONSPIRING TO VIOLATE THE CIVIL RIGHTS OF DR. KING IN VIOLATION OF TITLE 18, SECTION 241, OF THE UNITED STATES CODE.

THE FBI COMPLAINT CHARGES THAT "ON OR ABOUT MARCH ²⁹ ~~1968~~ 1968, AT BIRMINGHAM, ALABAMA,...ERIC STARVO GALT AND AN INDIVIDUAL WHOM HE ALLEGED TO BE HIS BROTHER, ENTERED INTO A CONSPIRACY WHICH CONTINUED UNTIL ON OR ABOUT APRIL 5, 1968, TO INJURE, OPPRESS, THREATEN, OR INTIMIDATE MARTIN LUTHER KING, JR.,...IN THE FREE EXERCISE OR ENJOYMENT OF A RIGHT SECURED TO HIM BY THE CONSTITUTION OR LAWS OF THE UNITED STATES; NAMELY, THE RIGHT TO FREELY TRAVEL FROM STATE TO STATE. IN FURTHERANCE OF THIS CONSPIRACY, ERIC STARVO GALT DID, ON OR ABOUT MARCH 30, 1968, PURCHASE A RIFLE AT BIRMINGHAM, ALABAMA...."

ACCORDING TO MR. HOOVER, ^A~~4~~ 30.06 RIFLE EQUIPPED WITH A TELESCOPIC SIGHT WAS FOUND NEAR A ROOMING HOUSE ON SOUTH MAIN STREET IN MEMPHIS IMMEDIATELY AFTER THE FATAL SHOOTING OF DR. KING OCCURRED. THE ROOMING HOUSE OVERLOOKS THE LORRAINE HOTEL AND MOTEL WHERE DR. KING WAS STAYING.

MR. HOOVER SAID THAT FBI AGENTS DETERMINED THAT THE 30.06 RIFLE HAD BEEN PURCHASED FROM A GUN DEALER IN BIRMINGHAM, ALABAMA, ON MARCH

30, 1968. THE TELESCOPIC SIGHT ALSO WAS PURCHASED FROM THIS DEALER.

THE FBI DIRECTOR SAID THAT GALT, WHO HAS USED THE NAMES OF JOHN WIL

LARD AND HARVEY LOWMYER IN THE PAST, IS THE OWNER OF A 1966 WHITE MUSTANG BEARING ALABAMA LICENSE PLATES WHICH WAS LOCATED ABANDONED IN ATLANTA, GABRGIA, ON APRIL 11, 1968. INVESTIGATION DISCLOSED THAT GALT PURCHASED THIS CAR FROM A PRIVATE CITIZEN IN BIRMINGHAM ON AUGUST 30, 1967. THE MUSTANG'S ODOMETER SHOWED THAT IT HAD BEEN DRIVEN MORE THAN 19,000 MILES BETWEEN LATE AUGUST, 1967, AND EARLY APRIL, 1968.

ACCORDING TO MR. HOOVER, GALT'S TRAVELS IN THE MUSTANG INCLUDED TRIPS TO LOS ANGELES, CALIFORNIA; NEW ORLEANS, LOUISIANA; BIRMINGHAM, ALABAMA; UND MEXICO, AS WELL AS TO MEMPHIS, TENNESSEE, AND ATLANTA, GEORGIA. GALT WAS REPORTED TO HAVE BEEN IN MEMPHIS ON APRIL 3 AND ~~4~~⁶ 1968, AND TO HAVE DEPARTED FROM THERE FOR ATLANTA.

INTENSIVE INVESTIGATION BY THE FBI HAS DISCLOSED THAT GALT HAS CLAIMED TO HAVE BEEN EMPLOYED AS A COOK ON MISSISSIPPI RIVER VESSELS AND AS A MERCHANT SEAMAN. HE IS SAID TO BE AN AVID DANCER AND TOOK DANCING LESSONS IN NEW ORLEANS IN 1964 AND 1965; IN BIRMINGHAM DURING SEPTEMBER AND OCTOBER, 1967; AND IN LONG BEACH, CALIFORNIA, FROM DECEMBER, 1967, TO FEBRUARY, 1968.

GALT LEFT LOS ANGELES ON DECEMBER 15, 1967, AND DROVE HIS WHITE MUSTANG TO NEW ORELANS, WHERE HE CLAIMED HE CONTACTED EITHER AN ENGINEERING OR A CONTRACTING FIRM. HE LEFT NEW ORLEANS ON DECEMBER 19TH AND ARRIVED BACK IN LOS ANGELES ON DECEMBER 21, 1967.

WHILE IN THE LOS ANGELES AREA EARLY THIS YEAR, GALT TOOK A COURSE AT A SCHOOL OF BARTENDING AND WAS GRADUATED ON MARCH 2, 1968.

THE FUGITIVE IS DESCRIBED AS A WHITE MALE. HE IS APPROXIMATELY 5 FEET 8 INCHES TO 5 FEET 11 INCHES TALL AND WEIGHS BETWEEN 160 AND 175 POUNDS. HE IS SAID TO BE A NEAT DRESSER AND HAS A MEDIUM BUILD.

GALT HAS BROWN HAIR, WHICH HE WEARS IN A "BRUSH" CUT. HE REPORTEDLY HAS BLUE EYES; HIS NOSE IS STRAIGHT AND NARROW; HIS TEETH ARE STRAIGHT AND CLEAN; AND HE HAS GIVEN HIS DATE OF BIRTH AS

THE FUGITIVE IS SAID TO HAVE A NERVOUS HABIT OF OCCASIONALLY PULLING AT AN EAR LOBE WITH HIS HAND. HIS LEFT EAR PROTRUDES FARTHER FROM HIS HEAD THAN HIS RIGHT EAR.

ACCORDING TO MR. HOOVER, PERSONS WHO HAVE MET GALT DESCRIBE HIM AS A "LONER" AND STATE HIS LANGUAGE AND DICTION HAVE A "RURAL" QUALITY AND SUGGEST THAT HE PROBABLY DOES NOT HAVE A HIGH DEGREE OF EDUCATION. HE IS SAID TO DRINK ALCOHOLIC BEVERAGES AND HAS A PREFERENCE FOR VODKA AND BEER. HE IS A FAN OF WESTERN AND COUNTRY MUSIC.

GALT SHOULD BE CONSIDERED ARMED AND DANGEROUS. ANY INFORMATION CONCERNING HIM SHOULD BE FURNISHED IMMEDIATELY TO THE NEAREST FBI OFFICE.

At 10:50 AM on 4/18/68, DEAN SANDER, KJAC Radio, telephone 937-0110, called in the absence of the writer and inquired as to whether the story carried over radio station KFWB on the evening of 4/17/68 regarding an interview of JOHN WILLARD of Long Beach, whose name was one of the aliases used by GALT, was factual. WILLARD reportedly stated he was approached by the FBI and questioned not only after the assassination of Dr. KING but several months prior. SANDER desired to know if this was responsible reporting or not.

At 11:03 AM, SANDER was recontacted by the writer, and he was courteously advised that this office had nothing further to add to the press release issued on the evening of 4/17/68, which SANDER acknowledged he had received. SANDER reiterated his request but was courteously advised I had no further comment to make in this matter.

In view of the above, the case agent should set out hereinafter the complete identity of the WILLARD who was interviewed in Long Beach. The dates of the interview should be incorporated and a summary of the information he furnished. It should also be established if he was ever interviewed prior to 4/4/68 in any matter involving FBI jurisdiction, and if so, any such contact should be summarized.

IN CONNECTION WITH HIS ESCAPE FROM THE MISSOURI STATE PENITENTIARY, AN FBI COMPLAINT WAS FILED IN JEFFERSON CITY, MISSOURI, ON JULY 20, 1967, CHARGING RAY WITH UNLAWFULLY FLEEING FROM THE STATE OF MISSOURI TO AVOID CONFINEMENT. HE HAS BEEN A FEDERAL FUGITIVE SINCE THEN.

RAY SHOULD BE CONSIDERED ARMED AND EXTREMELY DANGEROUS. ANYONE HAVING INFORMATION CONCERNING HIM SHOULD IMMEDIATELY CONTACT FBI HEADQUARTERS IN WASHINGTON, D. C., OR THE NEAREST FBI OFFICE.

Stations stated that release advised the man arrested was an American citizen who had entered into Mexico through Nogales on 4/17/68, that his physical description ~~and photos~~ and appearance matched RAY's. Caborca was described as being approximately 80 miles south of Nogales, Sonora, Mexico.

Writer contacted Supervisor RICHARD S. BATES, Division Six, SOG and advised him of above. He stated that SOG has UPI ticker and nothing regarding above had been received on that ticker and that he was not otherwise aware of this situation except for call few minutes before writer's call, from another SOG Supervisor in Crime Records Division to the effect that he had received the same type of inquiry from local Washington, DC news agency.

BATES stated matter would be checked out.

James Earl Ray, a Missouri prison escapee who has been sought under the alias Eric Starvo Galt in connection with the gunshot slaying of civil rights leader Dr. Martin Luther King, Jr., has been added to the FBI's list of "Ten Most Wanted Fugitives."

FBI Director J. Edgar Hoover ordered the special addition of Ray to the "Ten Most Wanted Fugitives" list, which already contains ten fugitives, to insure the widest possible dissemination of Ray's photograph and description to help effect his earliest possible location.

Ray has been the subject of a massive and intensive search since the brutal gunshot slaying of Dr. King on April 4, 1968, as he stood on the balcony of a Memphis, Tennessee, motel. One rifle bullet, believed fired from the window of a nearby rooming house, felled the victim.

An exhaustive FBI fingerprint search, comparing latent fingerprints uncovered in the Dr. King case against fingerprints of over 53,000 persons on whom wanted notices have been posted in the FBI's Identification Division, succeeded in determining that Galt and Ray are identical.

A Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, under the alias Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a United States citizen. Ray is also sought for unlawful interstate flight to avoid confinement after conviction for armed robbery, based on a Federal warrant issued on July 20, 1967, at Jefferson City, Missouri. He had been confined at the Missouri State Penitentiary, Jefferson City, Missouri, in March, 1960, with a 20-year sentence following conviction for armed robbery and operating a motor vehicle without permission of the owner. In September, 1966, while serving the sentence, he was confined for a time in the maximum security ward at the State Hospital, Fulton, Missouri. He was reported missing from the Missouri State Penitentiary since April 23, 1967.

Ray, who has an arrest record dating back to 1949 and has been convicted of burglary, armed robbery and forging United States Postal Money Orders, has also been confined in the Los Angeles County Jail, the Joliet and Pontiac, Illinois, State Prisons and the United States Penitentiary, Leavenworth, Kansas.

He served in the Army between February, 1946, and December, 1948, received a three-month sentence at hard labor for being drunk and breaking arrest and was given a General Discharge due to ineptness and lack of adaptability for military service.

Ray is a 40-year-old white male, reportedly born in Illinois on [REDACTED] He is approximately 5'10" inches tall, weighs from 163 to 174 pounds, has blue eyes and brown hair which he has worn cut short. He has a small scar on the center of his forehead and a scar on the palm of his right hand. He has been described as having a straight, narrow nose and straight and even teeth and to have a nervous habit of occasionally tugging at an ear lobe. His left ear protrudes noticeably.

Acquaintances describe him as a "loner" and "drifter" whose language and diction reflect a "rural" quality and indicate he has had limited education.

He is reportedly a fan of western and country music, drinks vodka and beer, dresses neatly and claims past employment as a merchant seaman and cook on Mississippi River vessels. He is known to have worked as a baker, laborer and color matcher.

He is known as an avid dancer who has taken dancing lessons. He also completed a course at a school of bartending in the Los Angeles area early in 1968.

Ray should be considered armed and extremely dangerous. Anyone with information concerning this fugitive is requested to immediately contact the nearest office of the FBI, the telephone number of which may be found on the first page of local telephone directories.

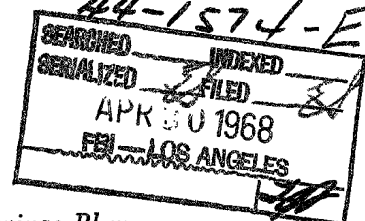

JERRY COHEN, LA TIMES, Phone 625-0471, called to advise that GARRISSON (New Orleans) told LAUREN HALL to tell COHEN that if he checked closely on the Wallace Headquarters at Lankershim Blvd., No. Hollywood, they would learn something significant to the Gault Case. Garrison alleged that BRADLEY and GAULT had been habitues of the Wallace Hq. on Lankershim.

COHEN said in checking he did learn that the Wallace Hq. on Lankershim is closed. He checked at Wallace Hq. in Bell Gardens and learned that Bradley was a Wallace fan and did attend Wallace rallies. He was unable to establish any association or acquaintance between Bradley and Gault but thought is significant that Gault was known at Wallace HQ in No. Hollywood and that Bradley was known at Wallace HQ in Bell Gardens.

HOUGHTON advised that he had received the letter from JERRY COHEN, a staff writer for the Los Angeles Times, who had brought the letter to Deputy Chief HOUGHTON in the hopes of being able to determine if it had any authenticity. Deputy Chief HOUGHTON advised that he desired to make this available to the FBI for examination, and also that COHEN had requested of him that COHEN be advised if the letter is authentic or the work of some prankster. Deputy Chief HOUGHTON has advised COHEN that he has turned the letter over to the FBI.

Dear Editor,

By the time that you get this letter I wont be in Los Angeles no longer. I am going to leave this city and go somewhere where no body is ever going to find me. There is no use for you to go to all the trouble of finding where I sent this or anything because since I killed the nigger leader and came out here I have not talked to any one and no body knows that I was ever here.

While I was in Los Angeles I went to see the movie In Cold Blood and I got all shook up and felt real bad because of the terrible crime that was done in Kanes a few years ago. I got real sick for myself too because I realized what I had done and that is why I am writting to you right now. I want you to put this in the papers or give it to the FBI because I want you to know how misserable I am . Did you know that the day after I killed King that I was so sick about what I had done that I actually threw up all over a hotel room? I am so sorry that I did it now and with my pictures all over the place I am sure that someday I still might get caught. I am afraid to look at anyone in the face anymore because I am afraid that they know who I am and they will tell the police. I will kill myself before I will get caught for I will never again spendmany time in no damn prison. But the reason that I am writting you this letter now, is because that I have to let someone know how x I really feel about what I did.

First of all I want to tell you that the only reason I did it was for money. If you really want to know I was hired to do it for \$3,000 dollars which seemed like a hell of a lot of money. I always hated Martin King like a lot of people do but it was because he was a rebel rouzer and because he tried to make a bunch of inferior people (the negroes) as good as every other american white person and even college professors have said that that is not true. Anyways I only did it for the money. I hate alot of people in the world like Cathy Norton who said I was clumsey in the newspapers, and some of the other son of a bitches who now want to put there two damn cents in every magazine saying what a rotten guy I am. But when they say it I promise myself that I will kill them to for saying those things about me. Why they didn't even know me, how can they say those things about me? The same goes for Hatold Swensen. He never took the time of day to give a damn about me. But now they all think they are big shots in the papers and magazines. They all make me sick. They are all a bunch ofphonies and if I ever get caught I can tell a few stories about some of those guys at the Missouri Penitentiary that would really shake some people up, just like I could tell you some things about the whites and niggers in those civil rights marches that you wouldn't believe. The whole thing is phoney. But I'm still sorry for what I have done for I once said to myself when I planned the job in Alton for which I got about two thousand dollars that I would never ever kill anybody. And now I killed a guy, and even though I hatted him with all my heart and for what he stood for I' would never do it again for even a million dollars. I am really sorry forwhat I have done. Somehow I hope it will be straightened around and I can pay some body back for what I did.

I just got all the rest of my \$3,000 dollars today and am leaving the place where I am at. But I am 100% positive that nobody could ever find me or recognize me in a million years. So if I have to leave something to my country and If you and everybody else in the world want to know my only thoughts about this whole thing all I can say is I am now sorry. I am really sorry that I did it at all. I could never kill again.

FBI Releases Two New Pictures of Suspect Ray

WASHINGTON (UPI) —The FBI has distributed two more photographs of the accused killer of Dr. Martin Luther King—one of them “an extremely good likeness.”

Both were snapshots of James Earl Ray, alias Eric Starvo Galt, an escaped convict accused of shooting King to death in Memphis April 4.

The “extremely good likeness” is a candid photograph of Ray in a business suit and tie and shows almost his full face, taken in late January or early February somewhere in California.

The other, which the FBI said was taken last November somewhere in Mexico, shows him wearing sun glasses and what appears to be a white sports shirt. The FBI said Ray is known to wear sun glasses frequently.

The two new photographs—the FBI refused to say where or how they were obtained—will be displayed throughout the country along with three other pictures of Ray which now appear on FBI’s wanted posters.

Ray, who escaped from prison April 23, 1967, by hiding in a truck, is wanted by the FBI for

illegal flight to avoid prosecution in Tennessee for King’s murder.

The civil rights leader was shot to death on a motel balcony, apparently by a rifleman 200 feet away in a rooming house bathroom.

Thirteen days later the FBI announced it had issued a warrant for Galt, but after checking some 53,000 fingerprints, the FBI said two days afterwards that Galt and Ray were the same man.

The two new photographs — the FBI refused to say where or how they were obtained — will be displayed throughout the country along with three other pictures of Ray which now appear on FBI's wanted posters.

One of the earlier photographs was taken when Ray was graduated from bartending school in Los Angeles early this year.

Ray was added to the FBI's list of 10 Most Wanted Criminals April 20. There have been reports of the search extending to various foreign countries, including Australia, and authorities along the U.S. borders have been alerted to watch for him.

Wall Street, Play by Play

Of all the things television does badly, the stock market may be the worst. Despite the fact that 24 million Americans now own stocks, TV coverage of the market is almost universally restricted to a brief and bewildering recital of the Dow-Jones averages and the ten most active stocks. But now, from the never-never land of UHF, comes a startling switch. Eight U.S. TV stations, most of them new, have gone on the air with a play-by-play account of market transactions from open to close, Monday through Friday.

Originated 18 months ago by Los Angeles' Channel 22 ("The Station That Means Business"), the programs run nonstop for six to eight hours, as computerized figures sweep constantly across the picture, reproducing the tapes of both the New York and American Stock Exchanges. Behind the figures, an announcer or a licensed stockbroker answers telephone inquiries from viewers and delivers a running commentary on market trends, business news and transactions on local exchanges.

The comments are not uniformly enlightened. Houston's Channel 16, which began broadcasting only two months ago, hired a former science reporter and a dark-haired young actress to keep its audience informed. "We are only now at the point," admits the show's MC, Jeff Thompson, "where we can spot trends and correlate what is happening." There are other dangers involved. To avoid SEC charges of stock manipulation, all stations forbid their commentators from paying particular attention to any single stock. They also discourage their employees from playing the market. Says News Director

Ben Larsen of Chicago's Channel 26: "I sold out all my stocks when we started. I'm scared to death of someone accusing me of jockeying a stock."

So far, the exchange programs seem to be accomplishing their intended purpose: to attract a marketable audience for potential advertisers. The fare obviously appeals to a large number of elderly people who otherwise would have to trudge downtown to the broker's office to watch the tape, although some studies show that the average viewer earns about \$15,000 a year and is between 38 and 45 years of age.

So enthusiastic is the audience that country clubs now keep their sets tuned to the market action, as do expensive bars, barbershops, beauty salons and doctors' offices. The most ebullient response, however, comes from businessmen's wives who suddenly find that they can talk intelligently about the market with their husbands. One overwhelmed Dallas woman recently wrote Channel 39 that "your stock-market show is the greatest thing that has happened to me since sex." And Seattle's Channel 13, which because of the time difference begins its Wall Street report at 7 a.m., received a telephone call from a housewife who said that "for the first time in 17 years, I had breakfast with my husband this morning."

The Assassination

According to Capote

On the rare occasions when writer Truman Capote agrees to submit to a television interview, it is usually because he has something that he wants to say. Last week, when he appeared (for the first time) on Johnny Carson's *Tonight* show, he wasted little time in



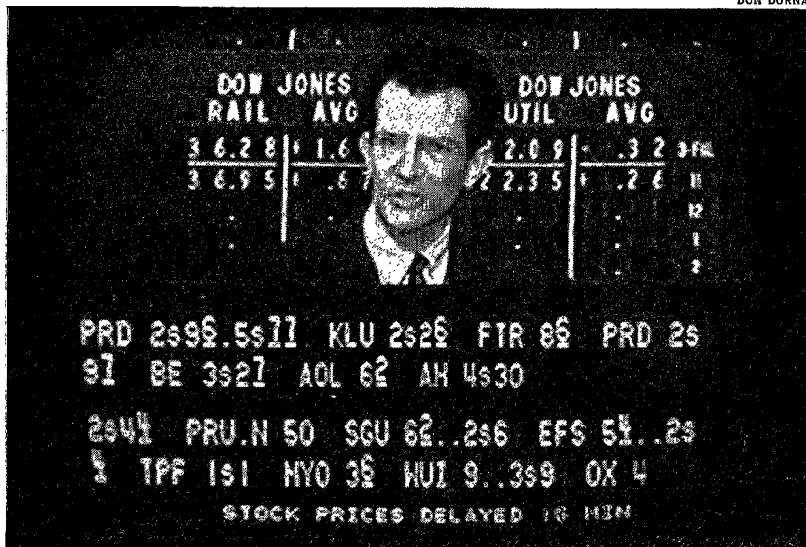
CAPOTE ON "TONIGHT" SHOW

getting to the point. "I have a theory," announced the author of *In Cold Blood*, "about the murder of Martin Luther King."

So, of course, does almost everybody else, but Capote's credentials make him worth listening to—wild though his theory may be. The FBI, he says, is looking for the wrong man. James Earl Ray, alias Eric Starvo Galt, was indeed in on the assassination plot—which Capote believes was carried out by "leftists, not rightists," for political gain. Ray did not, however, kill Martin Luther King. "I have studied his record very carefully, and in my experience with interviewing what I call homicidal minds [Capote has talked at length with 100 murderers in the past nine years], he's simply a man not capable of this particular kind of very calculated and cruel, and exact and precise kind of crime."

In Capote's reconstruction of the crime, in fact, Ray's only function was to throw the FBI off the assassin's trail, first by assuming the name of Eric Starvo Galt ("My theory is that there are two Eric Starvo Galts"), and finally by planting his fingerprints on the gun that was later to be used for killing King. "This was a setup," Capote believes. "The central factor of what happens is that, after the assassination, this assassin rushes out of the rooming house, and what does he do? He does a very amazing, unusual thing. He takes a suitcase and very carefully props it up in front of a store. And in this suitcase there is a shotgun, very carefully left. And what is on it is Mr. James Earl Ray's fingerprints."

And where was Ray at the time? "Dead." Capote believes he was killed "and disposed of" at least ten days before the assassination. "He didn't quite understand," said Capote with a grimace, "what his part in the plot was going to be."

According to our information, here were Ray's movements:

- 1 - The day before the shooting, Ray was picked up in Athens, Alabama, and was taken to Memphis.
- 2 - He registered in rooming house, ~~and was accompanied by~~ another man who registered as Samuel Lewis. (Lewis was supposed to be backup man, kill King at rally that night if Ray missed his chance on the balcony.)
- 3 - After shooting King, Ray walked two or three blocks to the getaway car, accompanied by a girl and a guy. The car is a new blue Buick, with Alabama plates. First digits are believed to be 14. Car is owned and was driven by Eddie Wilburn of Huntsville, Ala. It is equipped with a police radio. *(Second man stayed overnight, took early bus to Knoxville.)*
- 4 - Ray, two girls^s and a child were driven out of Memphis by Wilburn in the blue Buick. Went to Kansas City. Trip took 6½ hours. Girls, child, Wilburn all from Huntsville.
- 5 - In Kansas City, Ray stayed overnight at a home. It is a small, gray, shingled, one-bedroom house about three miles from central Kansas City. (We ~~xxx~~ have rough location.)
- 6 - At dusk the next day (April 5) Ray was flown to Belle Glade, ~~xxxxxx~~ Florida, in a private plane. Took off from private field, also used as training field for military. Ray arrived early April @ 6.
- 7 - Plane in which Ray was flown is owned by a William Pierce (Pearce?), a wealthy man who owns or operates an airport in Belle Glade, and once owned a contracting company in Cuba. Not known ~~xxxxxx~~ whether Pierce flew the plane. Pierce also owns motel in Belle Glade and cottages on the lake in nearby Okeechobee (or maybe on nearby Lake Okeechobee). Pierce said to be KKK member.
- 8 - Theory: Ray stayed in motel or in cottage. May be still there. Or in Cuba.
- 9 - On April 11, Ray got on yacht (probably charter boat) in Key West. Boat owned by Ben Thompson. (A Ben Thompson of Miami owns three fishing boats.)
