A review on April 12, 1968, of the personnel records, National Personnel Records Center (Civilian Personnel Records), St. Louis, Missouri, by IC EDWARD J. MERGEN, indicated that ERNEST SUMPTER GAULT, (also shown as EARNEST), was employed on March 18, 1942, as a Hospital Attendant with the Veterans Administration, at North Little Rock, Arkansas. This employment was terminated on July 13, 1942, as a Hospital Attendant, by reason of termination for failure to report for duty.

He was employed on December 5, 1947, as a Hospital Attendant (Mental) with the Veterans Administration, Veterans Administration Hospital, Ward, at North Little Rock, Arkansas. Effective October 14, 1948, he was suspended for a period of five days for making a false statement. This employment was terminated on August 12, 1949, as a Hospital Attendant (Mental), by reason or resignation because of leaving the State of Arkansas due to illness in the family.

He was employed on December 13, 1951, as a Deckhand, when actually employed, with the Department of Commerce, Inland Waterways Corporation, Federal Barge Lines, Marine Division, St. Louis, Missouri. This employment was terminated on January 28, 1952, as a Deckhand because of separation for abandonment of position - failed to return from authorized leave.

He was employed on March 4, 1952, as a Deckhand, when actually employed with the Department of Commerce, Inland Waterways Corporation, Federal Barge Lines, Marine Division at St. Louis, Missouri. This employment was terminated on July 21, 1952, as a Deckhand by reason of separation for abandonment of position - failed to return from authorized leave.

He was employed on May 25, 1953, as a Deckhand, when actually employed, with the Department of Commerce, Inland Waterways Corporation, Federal Barge Lines, Marine Division, St. Louis, Missouri. This employment was terminated on October 19, 1953, as a Deckhand, by reason of reduction in force "Action taken because of sale of Barge Lines necessitating abolishment of all positions in commuting area in accordance with provisions of an Act of Congress..."

The record contained a letter, marked CONFIDENTIAL, dated September 27, 1948, from the Civil Service Commission, to the Deputy Administration, Veterans Administration Branch Office #9, 420 Locust Street, St. Louis, Missouri, which is quoted as follows:

"Dear Sir:

"Reference is made to the case of ERNEST SUMPTER GAULT born [redacted] at Danville, Arkansas, who was probationally appointed subject to investigation, to the position of Hospital Attendant (Mental), at the Veterans Administration Hospital, North Little Rock, Arkansas, effective 12/5/47.

"Mr. Gault's case has been processed under Executive order No. 9835, Part 1, Section 3, and the information developed was favorable with the following exception: In his application dated December 5, 1947, Mr. Gault denied ever having been convicted, fined, imprisoned, placed on probation, or ordered to deposit bail, for the violation of any law, police regulation or ordinance (exclusive of minor traffic violations for which a fine of \$25.00 or less was imposed) since his sixteenth birthday. Information has been received by the Commission indicating that Mr. Gault has been arrested, since his sixteenth birthday as follows:

January 15, 1938, by the Police Department, Little Rock, Arkansas, for burglary and two (2) counts of Grand larceny. Turned over to Juvenile Court. No disposition shown.

July 20, 1939, by the State Police, Little Rock, Arkansas, for investigation. No disposition shown.

October 11, 1939, by the Police Department, Little Rock, Arkansas, for petit larceny. Discharge.

July 15, 1941, by the Police Department, Little Rock, Arkansas, for assault and battery. Discharged.

" January 24, 1947, by the Police Department, Saginaw, Michigan, for desertion. Placed on probation for ninety (90) days and required to pay \$3.75 costs.

"On August 18, 1948, this office called Mr. Gault's attention to the discrepancies in his application and requested an explanation. On August 26, 1948, he replied to our letter and admitted that he had intentionally falsified his application with respect to his arrest record. He stated he deliberately concealed the information to avoid having 'it all come out again.'

"In 1942, in connection with a prior period of employment at the Veterans Administration Hospital, North Little Rock Arkansas, this employee failed to admit his entire arrest record. The matter was called to the attention of the hospital authorities who decided no action should be taken against him and he was retained in the service. He subsequently voluntarily resigned.

"Inasmuch as this is the second occasion that this matter has been called to the attention of this employee, you are instructed to suspend him from duty and pay for a period of five (5) consecutive working days...."

On application for Federal employment he listed employment with Camp Joseph T. Robinson, North Little Rock, Arkansas, April 8, 1941, to July 10, 1941, as a waiter in the mess hall, however, personnel of this center were unable to locate such a record.

The record indicated that he was a student with the National Youth Administration, June, 1939, to September, 1939, taking a course in Welding. Personnel of this center advised that they could locate no records for this and stated that he was probably employed as a youth worker and these records have been destroyed per congressional authority.

A review of the Civilian Conservation Corps (CCC) records indicated that ERNEST SUMPTER GAULT was enrolled in the CCC on April 8, 1940, at Little Rock, Arkansas, and was assigned to a CCC Camp at Pierce, Idaho, performing Blister Rust Control Work. He was honorably discharged on September 23, 1940, at Little Rock, Arkansas, by reason of expiration of term of enrollment.

A review of the Army service records on file at the Military Personnel Records Center, St. Louis, Missouri, on April 15, 1968, by IC EARL M. RANEY for ERNEST SUMPTER GAULT, Army serial number [REDACTED], disclosed he was inducted August 11, 1942, at Little Rock, Arkansas, and entered on active duty on August 25, 1942, at Camp Robinsin, Arkansas. He was thereafter honorably discharged at Jefferson Barracks,

Missouri, on January 2, 1946. He served in the Enlisted Reserve Corps from January 3, 1946, to an honorably discharge on January 2, 1949. He reenlisted in the Enlisted Reserve Corps May 9, 1949, and was called to active duty on November 8, 1950, and he thereafter received an undesirable discharge on August 28, 1951, as a Private at Fort Bliss, Texas, because of unfitness due to undesirable traits of character.

A report of Psychiatric Examination at Fort Bliss, dated June 13, 1951, showed he was of the passive-aggressive personality type, manifested by habits and traits of character, alcoholism, unable to perform minimal requirements of duty, predisposition undetermined, impairment, moderate, severe. It was recommended that he be administratively separated.

While in service, he received six Summary and one Special Courts-Martial. He spent one year, five months and twentysix days foreign service. Among his decorations was the Purple Heart with Oak Leaf Cluster.

Mr. J. C. GAULT, also known as JAMES C. GAULT, Mac Arthur Hotel, 100 North Broadway, St. Louis, Missouri, advised that he is employed as a vendor by Missouri Sport Service, Inc., 350 Stadium Plaza, St. Louis, Missouri, and that his Social Security Number is [REDACTED]. He stated that he has not seen or heard from his brother, ERNEST SUMPTER GAULT, since 1958, that his whereabouts at this time are unknown to him.

He stated that in 1958, his brother telephonically advised him he was a seaman shipping out of Boston, Massachusetts. He did not know where his brother was then residing or by whom he was employed.

He stated his brother spent approximately one month in St. Louis in about 1952, when he was on vacation and that he stayed at his apartment.

He stated he did not know any friends of his brother and was not aware of whether or not his brother corresponded with any of the relatives in Little Rock, Arkansas. He suggested contact with his own son, BILLY GAULT, who resides on Sinora Drive in North Little Rock, Arkansas, and is employed by the Metropolitan Life Insurance Company there, for information as to the location of other members of the family.

The following reviews were made by IC EARL M. RANEY  
on April 11, 1968:

Review of the Army records on file at the Military Personnel Records Center, St. Louis, Missouri, disclose that J. WALLIS VERNON, Army serial number [REDACTED] enlisted in the United States Army at Los Angeles, California, and served from February 6, 1953, to September 4, 1954, and he received an Undesirable Discharge on the latter date as a Private at Fort Ord, California, due to unfitness, habit of character rendering retention undesirable.

A Certificate of Neuropsychiatric Examination dated August 4, 1954, at Fort Ord, California, shows a diagnosis of "anti-social personality. This condition is usually characterized by an inability to live by the rules other people live by and an inability to form loyalties to people or groups." It was indicated he used drugs, type not indicated.

He was seen again on August 4, 1954, due to homosexual experiences with an accuser, name not shown, which were denied. He made no effort to deny homo-sexual experiences in civilian life.

The following disciplinary actions were noted:

Special Court-Martial June 19, 1953, Fort Campbell, Kentucky, for absence without official leave, from May 2-6, 1953, and May 6-9, 1953. Received fifteen days restriction and forfeiture of \$64 pay.

Special Court-Martial December 16, 1953, Camp Carson, Colorado, for absence without official leave, from July 6, 1953, to October 25, 1953. He was sentenced to three months confinement at hard labor and forfeiture of \$150 of his pay.

Special Court-Martial, July 14, 1954, at Fort Ord, California, for absence without official leave from May 17, 1954, to June 21, 1954. He was sentenced to three months confinement at hard labor a forfeiture of \$165 of his pay.

His assignments were shown as Fort Ord, California; Fort Campbell, Kentucky; Camp Carson, Colorado; Fort Lewis, Washington; Las Vegas, Nevada, (surrendered to military authorities at Nellis Air Force Base, June 27, 1954); Camp Irwin, California; Lackland Air Force Base, Texas; Sheppard Air Force Base, Texas; Mather Air Force Base, California; and Travis Air Force Base, California.

A review on the same date of the Air Force Service Record of JEROME WALLIS VERNON, Air Force Service Number 19707383, disclosed he enlisted and served in the United States Air Force from August 18, 1961, to March 26, 1964. He was honorably discharged on the latter date as an Airman Basic, by reason of physical disability, diagnosed at the United States Air Force Hospital, Travis Air Force Base, California, by a Medical Board Report dated February 17, 1964, as follows:

"Schizophrenic reaction, chronic, undifferentiated type, severe, manifested by seeming episodes of disassociation, episodes that seem to be almost depersonalization, probably hallucinatory experiences, and in the past paranoid ideation."

The records revealed that on April 3, 1963, at Mather Air Force Base, California, VERNON attempted suicide by taking approximately "30 acetylsalicylic acid (atc)".

This record showed VERNON was a deserter and was apprehended by FBI Agents, October 18, 1963, at Las Vegas, Nevada.

No associates were identified in the service record.

April 10, 1963, reduced to Airman Basic, warranted 45 days extra duty as commanding officer punishment for disorderly conduct on March 31, 1963, at Non-Commissioned Officers open mess, Mather Air Force Base, California.

Summary Court-Martial, July 18, 1963, at Mather Air Force Base for being disorderly in a station and damaging military property as well as Pacific Telephone Company property. He was sentenced to be reduced to Airman Basic and given 30 restriction.

The following investigation was conducted by Special Agent JAMES A. DUFFEY:

Mr. JOHN VICKERS, retired postmaster, Ewing, Missouri, advised he recalled the RAYNES family as having drifted into this area during the depression era. Mr. JERRY RAYNES and his family lived on a farm one mile east of town. The family was large and very poor at the time. Mr. RAYNES tried to farm and did odd jobs. During the early 1940's, the family moved to Quincy, Illinois, and never returned to this town to his knowledge. Their closest neighbor and only person now living near where they lived is Mrs. JOHN LOSCHER.

Mrs. JOHN LOSCHER, Route 1, on April 22, 1968, advised she recalled the RAYNES family as living in a house nearby. This house has since been torn down. She stated the family of RAYNES was a large one as she recalled and very poor at that time. The father tried to farm and did odd jobs in the area. They lived here from the mid-thirties until they moved to Quincy, Illinois, during the early World War II period. She stated they did not neighbor with the RAYNES and she knows of no one who did. She stated she has not seen any of this family since they moved. She recalled that there were several small children in the family when they came here and that several more were born while the family lived here. She stated she could not recall the names of these children.

The following investigation was conducted by Special Agent JAMES A. DUFFEY:

Mrs. THELMA BALL, Principal, Ewing School, Ewing, Missouri, on April 22, 1968, advised school records reflect that JIMMY RAYNS (father JERRY RAYNS), born [redacted] place not given, entered the first grade at Ewing, Missouri, August, 1935. He attended until May, 1943, completing the eighth grade. Grades during last year were mostly "I"s (inferior). No record of transcript being sent anywhere.

Mrs. BALL also produced the record of the only other person with a similar name. It is the record for JACK RAYNES, parents JERRY and LUCILLE RAYNES, born [redacted] place not shown, entered this school in the first grade, August 28, 1939, and attended only until May, 1940.

JAMES EARL RAY - BACKGROUND

AT ST. LOUIS, MISSOURI

On April 22, 1968, BOB CRABILL, employee, McDonnell-Douglas Corporation, telephonically advised this Office his sister, Mrs. ORVILLE ROBBINS, 1680 Crowder, Florissant, Missouri, attended grade school with subject RAY. Mrs. ROBBINS has background information on the subject during his early years at Ewing, Missouri.

On April 22, 1968, Mrs. ORVILLE ROBBINS, 1680 Crowder, Florissant, Missouri, residence telephone - TEmple 7-0697, advised Special Agent WALTER C. JOHNSON between 1936 and 1943 she attended grade school with one JIMMY RAINES at Ewing, Missouri. She did not connect him with JAMES EARL RAY until her brother, MARTIN CRABILL, Ewing, Missouri, telephoned her on the night of April 21, 1968, that JIMMY RAINES was RAY.

Mrs. ROBBINS recalled that there were several children in the RAINES family but the only two members she was acquainted with was JIMMY and his younger brother, JACK. She said there were some smaller sisters but she did not know them. She had never met the mother but recalled the father, JERRY RAINES, and remembered him as being triftent and an individual who would not work and drew welfare all the time his family was residing in Ewing, Missouri. She recalled the boys, JACK and JIMMY, as well as the girls, all went by the last name of RAINES and never knew of the name RAY.

In 1943 after JIMMY finished the eighth grade he moved with his family to Hannibal, Missouri, where she understood the father had a job with a shoe company. This was the last time she had heard from the familv except some time ago her brother, MARTIN, indicated that one of JIMMY's brothers had driven off the Mississippi River Bridge at Quincy, Illinois, and had drowned.

She knew nothing further concerning the family's whereabouts and her last contact was in 1943.

A review on September 13, 1967, by IC EARL M. RANEY of the military service records on file at the Military Personnel Records Center, St. Louis, Missouri, for JAMES EARL RAY, Army Serial Number [REDACTED], indicated he enlisted in the U. S. Army on February 19, 1946, at East St. Louis, Illinois, and served on active duty until December 23, 1948, at which time he was given a general discharge as a Private First Class at Camp Kilmer, New Jersey, by reason of inaptness and lack of adaptability for military service.

The records indicated he was tried and convicted by a Special Court-Martial for being drunk in quarters and breaking arrest. He was sentenced to be confined at hard labor for three months and forfeit \$45 per month for four months.

The records also indicated he received treatment for gonorrhea and syphilis while he was a member of the military.

Disposition of the arrest was released to the Postal Inspector, Kansas City, Missouri. No photograph appeared in the file.

AT ST. LOUIS, MISSOURI

The following investigation was conducted on April 23, 1968, by Special Agent JOSEPH A. DUBYAK:

JOHN SHICKER, Postal Inspector, United States Postal Department, St. Louis, Missouri, advised the original postal office inspection reports of JAMES EARL RAY's and WALTER TERRY RIFE's postal money order passing activity in 1955 has been forwarded to the United States Post Office Department, Chief of Inspection, Washington, D. C. SHICKER provided a photostatic copy of the report for review by Special Agent DUBYAK.

A review of the report revealed on March 7, 1955, blank money order numbers 742, 239, 535 to 600 were stolen in a burglary of the Kellerville, Illinois, Post Office. On or about March 20, 1955, RAY and RIFE cashed eight money orders at Hot Springs National Park, Arkansas. RAY also cashed one postal money order at Tallahassee, Florida. Both were apprehended at Hannibal, Missouri, by the Missouri State Highway Patrol on March 23, 1955. On April 1, 1955, RAY and RIFE pleaded guilty to violating Title 18, Section 500, United States Code, for unlawful issuing, passing and uttering of stolen money order forms. RAY received a sentence of three and three-quarter years and RIFE was sentenced to three years.

The report revealed that RIFE admittedly wrote out the face side of all the money orders. The payee on the money order was WILLARD J. MC BRIDE, and the remitter on the money order was VERNON MC BRIDE. The name "WILLARD MC BRIDE" is that of a real person in St. Louis, Missouri, whose identification was purchased by RAY for use in cashing the money orders.

J. LEE SIMPKINS, Probation Officer, St. Louis, Missouri, advised St. Louis Postal Inspectors that JAMES EARL RAY was released from Federal custody on May 20, 1958. SIMPKINS stated RAY was

The then Chief of Police raised a question as to the propriety of WILLIS' actions in buying the car from a prisoner.

Chief ARLO BALDWIN, Police Department, Hannibal, Missouri, on April 22, 1968, advised that Officer ROY WILLIS resigned from this department August 1, 1957, and moved from town. Police records show that an inquiry by a prospective employer, B. F. Goodrich Company Store, 1300 North Collet Avenue, Minneapolis, Minnesota, was received December 3, 1957, No other inquiry since and it was Chief BALDWIN's recollection that he had heard WILLIS had been employed by this firm and was last known to be in Minneapolis.

The following investigation was conducted on April 24, 1968, by SA LAWRENCE B. CURTIN:

The file regarding JAMES EARL RAY was made available by JOHN L. BRENNAN, Chief, United States Probation Officer, St. Louis, Missouri.

A review of that file reflected the following information:

JAMES EARL RAY, Federal Records Center (Kansas City, Missouri) number 811041. Date of Birth was  at Alton, Illinois.

A classification study by officials of the United States Penitentiary, Leavenworth, Kansas, on August 10, 1955, reflected that RAY listed his mother and father as deceased and the only other relative listed is an aunt, LUCILLE RYAN, 801 North 12th Street, Quincy, Illinois. This study further reflects that the co-defendant in the case involving Post Office money orders was WALTER TERRY RIFE. In the section of the study under the heading "Previous Employment" RAY provided the name WILLIAM MAHER, 1118 East 7th Street, Alton, Illinois, although no explanation was given regarding this name. The study also reflects that when RAY had previously been in custody at the Illinois State Prison, he had been transferred to the Honor Farm where he worked in the kitchen.

An annual review of RAY by officials at the United States Penitentiary, Leavenworth, Kansas, in October, 1956, reflected that during the previous year RAY had worked at the fire department, paint shop, and bakery where he was considered an outstanding "bench hand." This review further reflects that the only family contact with RAY was through letters from his aunt, Mrs. LUCILLE RYAN, 701½ Washington Street, Quincy, Illinois. At that time RAY indicated that when he was released he planned to go to Denver, Colorado, as he felt the climate would be "better for his health."

On April 5, 1958, RAY was conditionally released from the United States Penitentiary, Leavenworth, Kansas, and at that time lived at the Blackstone Hotel, 817 Cherry Street, Kansas City, Missouri. It is noted that a handwritten letter attached to RAY's conditional release statement, from LUCILLE RYAN, 1135 South 10th Street, St. Louis, Missouri, and addressed to RAY at the Blackstone Hotel was signed "Your Aunt Lucille."

A handwritten notation by J. LEE SIMPKINS, United States Probation Officer, St. Louis, Missouri, indicates that on January 29, 1958, he visited LUCILLE RYAN at 1135 South 10th Street, and at that time found her living with a younger woman, who she introduced as her daughter, MELBA and an older woman whom she introduced as her mother.

Correspondence between the United States Probation Office at Kansas City, Missouri, and St. Louis, Missouri, reflects that after his release on April 5, 1958, RAY was dis-satisfied with life in Kansas City and repeatedly expressed an interest in coming to St. Louis, Missouri, so as to live with his aunt.

The following information was taken from the type-written work sheet of the Chief United States Probation Officer, JOHN L. BRENNAN, which is set up in chronological order:

On May 7, 1958, investigation by the United States Probation Officer reflects that LUCILLE RYAN presently resides at 1913 Hickory Street, St. Louis, Missouri, in a rooming house which she recently purchased. Lived at that address with her are three individuals as follows:

One mentally sub-normal and unemployable daughter, age 19, name unknown;

One employed daughter, age 17, name unknown.

LUCILLE RYAN's mother, age 76.

On May 15, 1958, supervision of JAMES EARL RAY was officially transferred from the United States Probation Office at Kansas City, Missouri, to the office at St. Louis, Missouri.

On May 15, 1958, JOHN L. BRENNAN advised RAY to go to the bakery union in St. Louis regarding employment.

In June, 1958, the record reflects that RAY had worked as a cook's helper for one day at the Glen Echo Country Club during the preceding month and was laid off. He was otherwise unemployed during this period.

On August 4, 1958, RAY indicated that when his supervision is terminated, he plans to get a job as a baker on a ship going to South America and he indicated that his occupation is a baker not a cook. The record further reflects during the time since his last contact, he was unemployed.

On September 4, 1958, RAY indicated that he had worked for four days in August at a bakery on North 18th Street, St. Louis, Missouri, but that he was otherwise unemployed during that month. He further indicated that when his conditional release expires in October, 1958, he planned to get a job as a baker on a boat and leave the United States.

On October 2, 1958, RAY's condition release expired and supervision by the United States Probation Office was terminated. The records reflect that there was no further contact with RAY since that date.

JAMES EARL RAY - ARREST - 1959

On May 6, 1968, a copy of St. Louis Police Department Summary Report of Complaint Number 222 015, was reviewed by Special Agent DEAN R. SHUMWAY. This report was originally prepared on October 10, 1959, by the St. Louis Police Department, Third District, regarding a hold-up which occurred on that same date at 8:45 a.m. The hold-up involved a Kroger Grocery and Baking Company at 3417 Ohio Avenue, St. Louis, Missouri. DONALD SCHAEFER of 723 Larkin Avenue, Ferguson, Missouri, is shown on this report as the co-manager of the store and as the complainant.

The details of this report reflect that two men appeared in the store and robbed the store of an undetermined amount of currency. The two men then fled from the store, making their escape in an old model Ford automobile, dark in color.

Later, at about 9:30 a.m. on the same date, St. Louis Patrolmen RALPH KING and EDWARD MC GRATH and Detectives HARRY CONNERS and EMMETT RIMMER placed under arrest at 2019 Park Avenue JAMES LOAMA OWENS and JAMES EARL RAY. OWENS, St. Louis Police Department LB Number 42884, was described as a white male, date of birth - [REDACTED] at Elvins, Missouri, age - forty, 5 feet 3 inches, 152 pounds, brown hair, blue eyes, marital status - single, occupation - barber, address - 4023 Olive Street.

JAMES EARL RAY was described as a white male, age - thirty, born in Illinois, marital status - single, occupation - baker, address - Room # 5, 2023 Park Avenue, St. Louis.

The above arrests were effected after Patrolmen JOSEPH SHORMAN and HAROLD SIEFERT, of the Seventh District, who had been originally dispatched to the scene of the robbery, obtained information that the hold-up men, after fleeing from the scene of the crime, entered an old model Ford, bearing Missouri License [REDACTED]. The description of this automobile was broadcast to all St. Louis Police Department Units.

Additional information was then obtained by store manager DONALD SCHAEFER which reflected that the two bandits had switched automobiles, abandoning the previously mentioned Ford at Indiana and Potomac Street, St. Louis, and then entered a 1958 Plymouth, Missouri License [REDACTED]. The subjects were last seen in this automobile heading west on Wyoming Street in St. Louis.

This same auto was later observed by Patrolmen KING and MC GRATH parked in front of 2017 Park Avenue, St. Louis, headed in a westerly direction and unoccupied. Assistance was requested by these patrolmen and thereafter a white male, who entered this automobile and prepared to drive away, was placed under arrest. Upon arrest, he identified himself as JAMES LOAMA OWENS. The vehicle was then searched and no weapons were found.

Under questioning, OWENS readily acknowledge that he had committed the armed robbery, advising that his partner in crime was on the second floor of the rooming house at 2023 Park Avenue, as well as both of the guns used in the hold-up.

The investigating officers then proceeded to the second floor of this house and at the top of the stairs observed a white male coming from the bathroom at the end of a hallway. This individual was commanded to halt and to raise his hands, whereupon he turned, began cursing and ran back toward the bathroom from where he had come. RAY was overtaken by the investigating officers and placed under arrest, after a scuffle in which RAY was struck over the head with the service revolver of one of the officers.

The prisoner was then escorted to his room but broke away and began to run toward the end of the hallway where he was initially subdued. At this time Detective CONNERS fired one shot from a service revolver in the direction of the fleeing suspect, at which time the prisoner halted and submitted to arrest without further resistance.

A search of the subject's room, located a .765 caliber Belgium Browning Automatic, Serial Number [REDACTED], which contained one live cartridge in the chamber and five live cartridges in the clip. A second .38 caliber revolver, "American Double Action," five shot revolver, Serial Number 249, was also located and found to contain three live cartridges in the cylinder.

Upon questioning, JAMES EARL RAY admitted that he was the owner of these weapons and made the statement to the officers, "I guess you want me for that Kroger Store stick-up." RAY was thereafter conveyed to City Hospital for examination and found to be suffering from a laceration of the scalp, which was not considered to be serious, and with no other apparent injuries. He was thereafter conveyed to the Police Station where he was charged.

The second individual involved in the burglary, JAMES OWENS, was conveyed directly from the place of apprehension to the St. Louis Police.

The 1958 Plymouth sedan used in the commission of the robbery was determined to be the property of JAMES L. OWENS and was towed away from in front of the Park Avenue address and held in custody by local police.

When questioned further at the District Station, OWENS stated he had first become acquainted with JAMES EARL RAY about three months prior to the offense, having met him at the St. Louis Rescue Mission located at 4023 Olive Street. Both eventually began speaking to each other of financial difficulty and eventually came to an agreement to pull a hold-up.

OWENS advised that in the early p.m. of October 9, 1959, he and RAY "cased" the store, which they eventually robbed on the following day. OWENS admitted that JAMES EARL RAY had given him the snub-nose revolver which he had used in the hold-up and that he had driven RAY to a place where he let RAY out of his 1958 Plymouth automobile for the purpose of stealing a second automobile to use in the hold-up.

Both automobiles were then driven to the intersection of Indiana and Potomac Streets in St. Louis. The stolen car, the previously mentioned Ford, was then driven to the scene of the crime, and the store was entered by both men.

RAY proceeded to a small office located in the front of the store, where he pointed the automatic pistol he was carrying at the man in the office, commanding him to open the safe. OWENS remained close to the front door where he acted as a look-out and, according to OWENS, left his revolver in his coat pocket. OWENS stated after RAY failed to get the man in the office to open the safe, he pointed the automatic pistol at a woman cashier, ordered her to step aside, and then reached into the open cash drawer, removing an unknown sum of currency. Both men then left the store and departed in the stolen Ford automobile.

A switch was thereafter made and both men then drove to RAY's home in OWENS' 1958 Plymouth.

Upon arrival, they proceeded to the bathroom of RAY's home where OWENS returned RAY's revolver and RAY gave OWENS \$60.00 in six \$10.00 bills, which constituted OWENS' share of the money taken in the robbery. OWENS then left RAY's residence and proceeded to his automobile where he was placed under arrest.

RAY, when interviewed, refused to make any statement, but OWENS later viewed RAY and positively identified him as the man who had accompanied him to the Kroger Store and assisted him in the commission of the hold-up.

Both individuals were thereafter charged with robbery with a deadly weapon and operating an automobile without the owner's consent. An additional charge of resisting arrest was placed against RAY.

The St. Louis Police Department, Bureau of Records, had no information on JAMES EARL RAY, but the report reflects
